WHEREAS by section 11 of the Land Act, 1933-1938, the Governor may resume, for any of the purposes specified in section 29 of the said Act, any portion of land held as a Conditional Purchase Lease: And whereas it is deemed expedient that the portion of Conditional Purchase Lease 15621/68 (Melbourne Location 2602), as described hereunder, should be resumed for one of the purposes specified in paragraph f of section 29 of the said Act, that is to say, for School Site: Now, therefore I, Sir James Mitchell, Lieutenant-Governor as aforesaid, with the advice of the Executive Council, do by this my Proclamation resume portion of Conditional Purchase Lease 15621/68 for the purpose aforesaid.

PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency Sir James Mitchell,

WHEREAS it is enacted by section 15 of the Wheat Products (Prices Fixation) Act, 1938, that the Governor may from time to time, on the recommendation of the

Wheat Products Prices Committee as constituted by the said Act, by Proclamation fix minimum and maximum prices at which substances included in the definition of flour or in the definition of wheat products may be sold in the State, or in any specified part of the State, by any person: And whereas by Proclamation dated the 9th day of March, 1939, and published in the *Government Gazette* on the 10th day of March, 1939, amongst other things the Lieutenant-Governor fixed the prices therein at which flour, bread, and the other substances therein specified may be sold by any person in the various portions of the State specified therein, and such Proclamation is still in force and operation: And whereas by a subsequent Proclamation dated the 11th day of May, 1939, and published in the *Government Gazette* on the 12th day of May, 1939, the Lieutenant-Governor varied the first-mentioned Proclamation in the manner mentioned in the last-mentioned Proclamation: And whereas the Lieutenant-Governor by a further supplementary Proclamation dated the 25th day of May, 1939, and published in the *Government Gazette* on the 26th day of May, 1939, which was to be read as being supplementary to and not in amendment or variation of the Proclamation dated the 9th day of March, 1939, as varied as aforesaid, temporarily increased the prices fixed in relation to best bakers' flour and standard wheatmeal by and under subparagraph (A) of paragraph 1 of the said Proclamation dated the 9th day of March, 1939, as varied as aforesaid by a supplementary addition thereto in every case of the sum of five shillings per ton of 2,000 lbs.: And whereas it is now deemed expedient to revoke and cancel the said supplementary Proclamation dated the 25th day of May, 1939, and published in the *Government Gazette* on the 26th day of May, 1939, without in any way affecting, varying, or amending the said Proclamation dated the 9th day of March, 1939, and published in the *Government Gazette* on the 10th day of March, 1939, as varied by the Proclamation varying the same dated the 11th day of May, 1939, and published in the *Government Gazette* on the 12th day of May, 1939, and so that after the revocation and cancellation of the said supplementary Proclamation the said Proclamations dated the 9th day of March, 1939, and the 11th day of May, 1939, respectively (hereinafter referred to as "the principal Proclamations"), shall continue in force and have effect according to the tenor thereof, and so that the prices

in respect of best bakers' flour and standard wheatmeal as fixed by and under the principal Proclamations shall, after the issue of this present Proclamation and until the issue of a subsequent Proclamation, be the only prices fixed for the time being in respect of the said substances under the said Act: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council, and in accordance with the recommendation of the said Wheat Products Prices Committee, and in exercise of the powers in that behalf conferred upon me by the said Act, do hereby, as from and after the date of the publication of this present Proclamation in the *Government Gazette*, revoke and cancel the hereinbefore-mentioned supplementary Proclamation dated the 25th day of May, 1939, and published in the *Government Gazette* on the 26th day of May, 1939, whereby the prices previously fixed in relation to best bakers' flour and standard wheatmeal by the principal Proclamations as aforesaid were temporarily increased by a supplementary addition thereto of five shillings per ton of 2,000 lbs., and I also declare that as from the date of the publication of this present Proclamation in the *Government Gazette* the principal Proclamations shall continue in operation and have effect according to the tenor thereof, and that until the issue of a subsequent Proclamation affecting the same the prices in respect of best bakers' flour and standard wheatmeal as fixed by and under the principal Proclamations shall be the only prices fixed for the time being in respect of the said substances, and I lastly declare that this Proclamation shall take effect as from and after the publication thereof in the *Government Gazette*.

The Traffic Regulations, 1936, are amended as follows:—

1. Division 3 of Part 2 of the said regulations is deleted and in lieu thereof a new Division is inserted as follows:—

Division 3—Certificates of Registration.

26. (a) Every licensing authority shall keep a register of all licenses for vehicles and trailers drawn thereby, also locomotives and traction engines and carts and carriages, in Form No. 18, prescribed in the Second Schedule of these regulations, and shall enter therein the particulars of such, and then issue a certificate of registration, which shall be for the term of such license.

(b) The certificate of registration to be issued to the owner of a licensed vehicle shall be in accordance with Forms numbered 21-40, prescribed in the Second Schedule to these regulations, and shall be issued free of charge.

(c) Every certificate of registration shall be kept affixed to the windscreen of the vehicle in the prescribed position, or, if the vehicle has no windscreen, shall be placed in and kept in a holder issued by the Licensing Authority which issues such certificate, and such holder, with the certificate of registration placed therein, shall be affixed and kept affixed to the vehicle in respect of which the certificate is issued, in the manner prescribed by and in accordance with these regulations.

(d) Every licensing authority, if so required by the owner of a vehicle in respect of which a certificate of registration is issued by such authority, shall supply to such owner, on payment of a fee not exceeding one shilling and sixpence, a holder, which has been supplied for such purpose by the Minister to such licensing authority.

(e) No person to whom a certificate of registration has been issued shall place or keep such certificate in any holder other than that supplied to him in accordance with paragraph (d) hereof by the licensing authority which issued such certificate. Provided that, if any person already possesses a holder properly supplied to him under paragraph (d) hereof by any licensing authority, it shall not be necessary for him to obtain another holder from another licensing authority subsequently issuing a certificate of registration when in respect of the same vehicle upon which such holder is affixed as required by these regulations.

(f) A certificate of registration issued in respect of a vehicle shall be in the form prescribed for each class of vehicle, and shall be issued and shall have effect only for the duration of the particular license in relation to which it is issued, and shall be printed in the colours shown hereunder for the respective vehicles:—

- (i) Certificates for motor cars, when licensed for the full year, shall be printed in black on a yellow ground, with a transparent figure 0;
- (ii) Certificates for motor cars, when licensed only for the first half-year, shall be printed in black on a yellow ground, with a black vertical stripe and a transparent figure 0;
- (iii) Certificates for motor wagons, locomotives, and traction engines, when licensed for a full year, shall be printed in black on a blue ground, with a transparent figure 0;
- (iv) Certificates for motor wagons, locomotives, and traction engines, when licensed only for the first half-year, shall be printed in black on a blue ground, with a black vertical stripe and a transparent figure 0;

- (v) Certificates for motor cycles, when licensed for the full year, shall be printed in black on a white ground, with a figure 0;
 - (vi) Certificates for motor cycles, when licensed only for the first half-year, shall be printed in black on a white ground, with a black vertical stripe and a figure 0;
 - (vii) Certificates for horse drawn vehicles, when licensed for a full year, shall be printed black on an orange ground, with a figure 0;
 - (viii) Certificates for horse drawn vehicles, when licensed only for the first half-year, shall be printed black on an orange ground, with a black vertical stripe and a figure 0;
 - (ix) Certificates for trailers or semi-trailers, when licensed for the full year, shall be printed black on a blue ground, with a figure 0;
 - (x) Certificates for trailers or semi-trailers, when licensed only for the first half-year, shall be printed in black on a blue ground, with a black vertical stripe and a figure 0;
 - (xi) Concession certificates for motor cars licensed under section 10 of the Act, when licensed for the full year, shall be printed in black on a yellow ground, with a green diamond in the centre, and with a transparent figure 0;
 - (xii) Concession certificates for motor cars licensed under section 10 of the Act, when licensed only for the first half-year, shall be printed in black on a yellow ground, with a green diamond in the centre, and with a black vertical stripe and a transparent figure 0;
 - (xiii) Concession certificates for motor wagons, locomotives, and traction engines licensed under section 10 of the Act when licensed for the full year, shall be printed in black on a blue ground, with a green diamond in the centre and with a transparent figure 0;
 - (xiv) Concession certificates for motor wagons, locomotives, and traction engines licensed under section 10 of the Act, when licensed only for the first half-year shall be printed in black on a blue ground, with a green diamond in the centre and with a black vertical stripe and a transparent figure 0;
 - (xv) Concession certificates for motor cycles licensed under section 10 of the Act, when licensed for the full year, shall be printed in black on a white ground with a green diamond in the centre and a figure 0;
 - (xvi) Concession certificates for motor cycles licensed under section 10 of the Act, when licensed only for the first half-year, shall be printed in black on a white ground, with a green diamond in the centre and with a black vertical stripe and a figure 0;
 - (xvii) Concession certificates for horse drawn vehicles licensed under section 10 of the Act, when licensed for the full year, shall be printed in black on an orange ground, with a green diamond in the centre and a figure 0;
 - (xviii) Concession certificates for horse drawn vehicles licensed under section 10 of the Act, when licensed only for the first half-year, shall be printed in black on an orange ground, with a green diamond in the centre and a black vertical stripe and a figure 0;
 - (xix) Concession certificates for trailers or semi-trailers licensed under section 10 of the Act, when licensed for the full year, shall be printed in black on a blue ground, with a green diamond in the centre and a figure 0;
 - (xx) Concession certificates for trailers or semi-trailers licensed under section 10 of the Act, when licensed only for the first half-year, shall be printed in black on a blue ground, with a green diamond in the centre and with a black vertical stripe and a figure 0;
- (g) The licensing authority shall at each subsequent issue of a license for any vehicle, issue a new registration certificate, as prescribed under these regulations.
- (h) The certificate of registration, or the certificate of registration and the holder containing it, in any case where the vehicle has no windscreen (hereinafter together referred to as the "Holder and Certificate"), shall be affixed to and carried on the vehicle for which the certificate of registration is issued, as hereinafter prescribed:—
- (i) On a "motor cycle" the holder and certificate should be affixed on the off-side of the handle bar or on the off-side front fork, and the front of the certificate shall face towards the front of the motor cycle;
 - (ii) On a "trailer" the holder and certificate shall be affixed on the off-side of the tray not more than twelve inches from the front of the tray, and the front of the certificate shall face outwards from the trailer towards the off-side of the road;
 - (iii) On a motor car or motor omnibus the certificate or holder and certificate, as the case may be, shall be affixed in such a position that the centre of the certificate is not more than six (6) inches from the bottom off-side corner of the windscreen, and the front of the certificate shall face towards the front of the vehicle;
 - (iv) On motor wagons, locomotives, or traction engines or any other vehicle not already specified, the certificate holder and certificate, as the case may be, shall be affixed by the bracket attached to the holder, on the off-side of the vehicle, not less than two feet six inches and not more than five feet above the level of the ground, and not more than eight and not less than four feet from the most forward part of the vehicle, and the front of the certificate shall face towards the front of the vehicle.
- (i) In all cases the certificate or the holder and certificate shall be carried on the particular vehicle for which it is issued so as to be clearly visible to a person directly facing the certificate within six feet thereof.

(j) The licensing authority shall, upon the issuing of the certificate of registration under this regulation, write upon such certificate the particulars of the vehicle, trailer, locomotive, or traction engine so registered as indicated in Forms Nos. 1 to 4 of the Second Schedule.

(k) Any person who on any road drives any vehicle registerable under this regulation which does not carry the certificate, or the holder and certificate, as the case may require, issued for that vehicle under this regulation, or which carries the said holder and certificate otherwise than in conformity with all the requirements of this regulation, shall be guilty of an offence and liable to a penalty, for a first offence, not exceeding ten pounds, and for a second or any subsequent offence, not exceeding twenty pounds.

(l) A fee not exceeding five shillings may be charged for a duplicate of a certificate of registration.





IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

Industrial Agreement No. 8 of 1939.

(Registered 18/5/1939.)

AGREEMENT made between the Western Australian Cleaners, Caretakers, Lift Attendants, Window Cleaners, Attendants, and Watchmen's Industrial Union of Workers, Perth, and The Trustees of the Public Library, Museum, and Art Gallery of Western Australia.

This Agreement, made in pursuance of the Industrial Arbitration Act, 1912-35, this 1st day of May, One thousand nine hundred and thirty-nine, between the West Australian Cleaners, Caretakers, Lift Attendants, Window Cleaners, Attendants, and Watchmen's Industrial Union of Workers, Perth (hereinafter called the "Union"), of the one part, and the Trustees of the

Public Library, Museum, and Art Gallery of Western Australia (hereinafter called "the employer"), of the other part, witnesseth that the parties hereto mutually covenant and agree the one with the other as follows:—

1.—Area.

This Agreement shall operate over that portion of Western Australia coming within the jurisdiction of the Trustees of the Public Library, Museum, and Art Gallery of Western Australia, and situated at Perth, within Class A Reserve, Number 3521.

2.—Scope.

(a) This Agreement shall apply to the head-attendant-caretaker and the cleaner attendants employed at the Public Library, Museum, and Art Gallery of Western Australia.

3.—Term.

(a) This Agreement shall remain in force for a period of three years from date thereof: provided that at any time or times after the expiration of the first twelve months either party shall have the right to demand a review of the Agreement or any part thereof by giving one month's notice in writing to the other party.

(b) In the event of the parties failing to agree in regard to any items on which a variation is sought, it is agreed that such items shall be referred to the Cleaning Industrial Board for settlement.

4.—Definition.

"Head attendant-caretaker" shall mean a male adult worker in whose duties are included the responsibility for the supervision of cleaning, and who is engaged as caretaker of the premises.

"Cleaner-attendant" shall mean a male adult worker employed cleaning the offices and rooms of the employer and performing the duties of an attendant in either the Public Library, Museum, or Art Gallery.

5.—Weekly Hiring.

(a) Except for relieving hands, the contract of hiring shall be deemed to be by the week, and when the services of a worker are terminated such worker shall be given one week's notice. Such week's notice cannot be continued from week to week.

(b) A worker employed in a relieving capacity for any period exceeding one week shall be deemed to be a relieving hand, and shall be paid not less than the minimum rate of wages herein prescribed for the class of work performed.

6.—Time and Wages Book.

The employer shall keep a time book or time sheets, properly posted each week, showing the times worked by each employee and the wages paid to each employee covered by this Award. Such time book or time sheets, with all entries therein, shall on demand be produced at any reasonable time during the day by the employer for inspection by the secretary of the Union or by a duly authorised official of the Union.

7.—No Discrimination.

In the employment of persons under this Agreement, no discrimination shall be exercised against the members of the West Australian Cleaners, Caretakers, Lift Attendants, Window Cleaners, Attendants, and Watchmen's Industrial Union of Workers, Perth. Provided that, where a worker other than a member of the Union is engaged, such worker shall within fourteen days of engagement make application for membership of the Union, and if accepted shall complete such application, and whilst working in the Industry shall continue such membership.

8.—Hours of Labour.

The hours of attendants in the Public Library shall be forty-four (44) hours per week, which shall be worked between the hours of 7 a.m. and 10 p.m. on week days and 2 p.m. to 5 p.m. on Sundays.

The hours of attendants in the Museum and Art Gallery shall be forty-four (44) hours per week, which shall be worked between the hours of 8 a.m. to 5 p.m. on Monday to Friday, inclusive, and 7 a.m. to 5 p.m. on Saturday and 2 p.m. to 5 p.m. on Sundays.

9.—Overtime and Sunday Time.

(a) All time worked outside the usual rostered working hours shall be paid for as overtime, as follows:—For the first two hours—time and a half rates; thereafter, double ordinary rates.

(b) All work performed on Sundays shall be paid for at time and a half rates, with a minimum payment of two and a half hours at that rate, but the extra half rate shall stand alone and be paid apart from the ordinary week's work. Provided that no part of this clause shall apply to the head attendant caretaker.

10.—Post Agreement.

A copy of this Agreement shall be posted in a suitable place in Library, and Museum and Art Gallery, where it shall be accessible to each and every employee. The secretary-treasurer of the Union may post notices relating to Union business in the place where a copy of the Agreement is posted.

11.—Holidays.

The following days shall be observed as holidays and all workers shall be paid for such days:—New Year's Day, Anniversary Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Christmas Day, and Boxing Day. Any worker required to work on any of these days shall have added to his annual leave, to be paid for, time equivalent to that employed.

12.—Annual Leave.

After the completion of each twelve months' service, all workers shall be granted two week's leave at the ordinary rate of pay, and workers of less service than 12 months, whose services are terminated, shall be paid *pro rata* leave.

13.—Sickness.

No worker shall be entitled to be paid for absence from employment, on the ground of personal ill-health, for more than six days in any year of service. Before becoming entitled to payment, the worker shall, if required, furnish the employer with satisfactory proof that his absence from employment was the result of ill-health.

14.—Long-Service Leave.

(a) After completion of seven year's continuous service, all workers shall be entitled to three months' long service leave, and for each subsequent period of seven years' continuous service after return from the first period, three months' leave shall be granted.

(b) A worker dismissed from the employ shall not be entitled to payment of long service leave, other than for leave that had accrued due to him prior to the date of the offence for which he was dismissed.

(c) A worker who retires, or is retired through ill-health and who has served for at least twelve months next before such retirement, shall be paid for long service leave *pro rata* accrued in respect of service to date of retirement.

(d) If a deceased worker who had served for at least twelve months next before his death leave a widow, children, mother, or invalid sister, who were dependent upon him, payment *pro rata* of long service leave accrued in respect of service up to the date of such worker's death shall be granted to such widow, or dependants.

15.—Wages.

(a) The minimum rates of pay and conditions of employment shall be:—

Head attendant caretaker:	Per annum.
First year	£240
Second year	£250
Third year	£260

with quarters, light, fuel and water, for which no deduction from these amounts shall be made.

(In regard to head attendant-caretaker, if during the currency of this Agreement the Arbitration Court of Western Australia should prescribe a basic wage differing in amount from that now prescribed, then the marginal differences between the present basic wage and the minimum rates herein prescribed shall be deemed to be increased or decreased, as the case may be, to the same extent as the present basic wage may be decreased or increased by the said Arbitration Court as aforesaid, to the intent that the rates herein prescribed shall remain constant.)

(b) The minimum rate of wages per week shall be:—

Workers employed as relieving attendants shall be paid at a daily rate 10 per cent. above the rate set down for the class of work performed: Provided that, where the worker so employed is engaged for a period in excess of one full week, this extra rate shall not apply.

16.—Higher Duties.

A worker called upon to perform work carrying a higher minimum than his regular rate of pay on any day, shall be paid such higher minimum whilst so employed: Provided that acting time less than twenty minutes in any one day shall not be counted.

Should any worker be required to perform work in a lower grade for portion of a day, his wages shall not be reduced whilst employed in such capacity for that day.

17.—Materials.

All workers under this Agreement shall be provided with the necessary tools and materials free of charge.

18.—No Reduction.

Nothing contained in this Agreement shall entitle an employer to reduce the wage of any worker who at the date of this Agreement is being paid a higher rate of wage than the minimum prescribed for his class of work.

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1935, this twentieth day of April, one thousand nine hundred and thirty-nine (1939), between A. Victor Leggo and Company, of Wiluna (hereinafter called the employer), of the one part, and the Australian Workers' Union, Westralian Goldfields Mining Branch Industrial Union of Workers (hereinafter called the Union), of the other part, witnesseth that, for the considerations hereinafter appearing the parties hereto mutually covenant and agree the one with the other, as follows:—

No. 1.—Term.

The currency of this Agreement shall be for one year from the first day of September, one thousand nine hundred and thirty-eight.

No. 2.—Area.

This Agreement shall operate over the Arsenic Plant at Wiluna.

No. 3.—Wages.

No. 4.—Hours.

(a) The hours of employment shall average alternate weeks of thirty-six (36) and forty-two (42).

(b) The hours worked per shift shall be as set out hereunder, according to the classification of the worker:—

Roaster-men—Six hours per shift, crib-time inclusive.

Screw-men—Six and one half hours per shift, crib-time inclusive.

Paeker-men—Six and one half hours per shift, crib-time inclusive.

Rousabouts—Six and three quarter hours per shift, crib-time inclusive.

Fuel-carriers—Eight hours per shift, crib-time inclusive.

Pipe-fitter—Eight hours per shift, crib-time inclusive.

Change-room attendant—Eight hours per shift, crib-time inclusive.

No. 5.—Overtime.

(a) No overtime shall be worked, excepting to effect repairs (this clause not to apply to roaster-men, when relief man fails to turn up at change of shift).

(b) All work done beyond the ordinary hours of duty on any ordinary working day (Monday to Saturday) shall be paid for at the rate of time and a half for the first two (2) hours and double time thereafter.

(c) All work done on Sundays shall be paid for at the rate of time and a half up to six hours (6), and double time thereafter.

No. 6.—Public Holidays.

All work done on public holidays shall be paid for at double time.

No. 7.—Annual Holidays.

Annual and public holidays shall be the same as those operating under the terms of the Mining Award, at the time the holidays occur.

No. 8.—Resumption of Work after Holidays.

Where a worker is not notified prior to taking his holidays that no further work is available, he shall be re-engaged upon his return.

No. 9.—Holiday-pay.

In the event of a worker leaving or being dismissed, he shall receive holiday-pay due to him, payable on a *pro rata* basis, according to the number of shifts he has worked. This clause to operate regardless of the circumstances surrounding the termination of his employment.

No. 10.—Accident Pay.

In the event of a worker meeting with an accident during the course of his shift, or being required to attend to one who has met with an accident, he shall have been deemed to have rendered duty during the whole shift and shall be paid accordingly.

No. 11.—Full Payment for Shift.

(a) After beginning a shift workers shall not be paid less than for a full shift, unless they leave of their own accord or are dismissed for misconduct.

(b) If before a worker leaves the works at the end of the shift, and because he is not so informed, he attends the next shift ready to work it, and there is no suitable work which he is allowed to perform, he shall be paid the wages he would have been entitled to if he had worked the shift he was ready and willing to work.

No. 12.—First-aid.

A suitable first-aid kit shall be supplied by the employer and shall be accessible at all times.

No. 13.—Drinking Water.

Drinking water, cool and free from dust, shall be provided by some approved method other than by water-bags.

No. 14.—Showers.

A suitable change-room with hot and cold showers shall be provided.

No. 15.—Working Clothes and Equipment.

The following articles shall be supplied by the employer when necessary to the welfare of the workers, and shall be laundered and kept in good repair by the employer:—Gloves, goggles, masks, overalls, bloomers.

No. 16.—Quick Shifts.

No worker shall be required to report for work unless he has had at least eight (8) hours off duty since his previous shift.

No. 17.—Retrenchments.

Should the occasion arise to reduce the number of men employed, the company shall give full weight to the consideration of length of service, and shall retain those who have been longest in their employ, all things being equal.

No. 18.—Casual Labourers.

Any worker employed for less than one week shall be considered casual and shall be paid two shillings per shift (2s.) above the rate specified for the work.

No. 19.—Preference of Employment.

Preference of employment shall be given to members of the Australian Workers' Union.

No. 20.—Time and Record Books.

These books shall be kept by the employer and shall be open to inspection by the Union representative, when required.

All labour other than that specified in the Agreement shall be paid the rates as prescribed in the current Mining Award.

No. 21.—Definitions.

No worker shall work for a longer period than six (6) hours in any one shift within the confines of the Arsenic Works proper.

No. 22.—Fluctuations of Basic Rate.

(a) Whatever the actual increase above the present basic wage of four pounds fifteen shillings and two-pence (£4 15s. 2d.) per week for male adults at Wiluna is, shall be added to the agreed rates as set out in this Agreement.

(b) In the event of the basic wage decreasing from the present figure of £4 15s. 2d., the employer may proportionately lower the daily rate of the worker, until the base basic rate of £4 7s. per week at Wiluna is reached, when no further reduction may take place.
