PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell, K.C.M.G., Lieutenant-Governor in and over the State of Western Australia to the common-leading of Australia wealth of Australia.

WHEREAS under section 2 of the Native Administration Act, 1905-1941, Native Institution means and includes any mission, reformatory, orphanage, school, home, station, reserve, or other institution for the benefit, protection, or care of the native inhabitants of the State declared by Proclamation to be a Native Institution for the purposes of this Act: Now, therefore I, the said Lientenant-Governor, hereby declare the Native Mission Farm, Roelands, to be an institution within the meaning of the said section.

GAME ACT, 1912-1913.

Premier's Office, Perth, 8th October, 1941.

HIS Excellency the Lieutenant-Governor in Council, acting pursuant to section 24 of the Game Act, 1912-1913, has been pleased to amend in the manner mentioned in the Schedule hereunder the regulations made under the said Act and as consolidated and reprinted in the Government Gazette on the 28th day of June, 1940.

Schedule.

The abovementioned regulations are amended by repealing regulation 32 thereof and inserting in lieu of the said regulation 32 a new regulation as follows:—

- 32. (1) Every person who at the close of any open season for opossums is in possession of any opossum skins shall, not later than fourteen days after the expiration of such open season, furnish to the Chief Guardian of Game, at the Fisheries Department, Perth, a statutory declaration in respect of the following matters, that is to say—
 - (a) the number of opossum skins taken or bought by him during the open season;
 - (b) the number of opossum skins sold or consigned, forwarded, or delivered for sale to any corporation, firm, or person during the open season and after the close of the open season and before the date on which

the said declaration is made, and the name of the corporation, firm, or person to whom such skins or any number of them were sold or consigned, forwarded, or delivered for sale;

- (c) the number of opossum skins still in his possession on the day on which such declaration is made.
- (2) No person shall, after the expiration of fourteen days from the day on which any open season for opossums expires, have in his possession, or sell or consign, forward or deliver to any person, corporation, or firm, whether acting as principal, agent, broker, or factor, any opossum skins in respect of which the prescribed royalty has not been paid and which do not bear the imprint of the brand prescribed in the Form G in the Appendix to these regulations.
- (3) No person, corporation, or firm, whether acting as principal, agent, broker or factor, shall, after the expiration of fourteen days from the day on which any open season for opossums expires, buy or accept for the purpose of sale any opossum skins which do not bear the imprint of the brand prescribed in the said Form G, unless they shall have been consigned, forwarded, or delivered not later than the fourteenth day after the day on which such open season expires.
- (4) Any person, corporation, or firm receiving any opossum skins later than fourteen days after the day on which any open season for opossums expires, shall, if such skins do not bear the imprint of the brand prescribed in the said Form G, forthwith give notice of such receipt to a collector of royalty, and shall not sell, dispose of or otherwise deal with such skins without the written consent of such collector or another collector.
- (5) In this regulation the term "open season for opossums" means, in relation to a defined locality, any period during which such defined locality is exempted from the operation of any declaration relating to opossums made under section 6 of the Act as provided for in the proviso to the said section.

FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934. NOTICE is hereby given that the following Stay Orders have been issued in accordance with section 7, subsection (1) of the Farmers' Debts Adjustment Act, 1930-1934, which reads as follows:

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for breach of covenant under any mortgage or other security for money, or under an agreement for sale and purchase of lands, or other process or proceedshall be commenced or proceeded with, or put in force against the farmer or any of the farmer's assets, whether utilised in connection with or forming portion of the assets comprised in his farming business or not, during the operation of such Stay Order: Provided that, by leave of a Judge, any action may, notwithstanding the Stay Order, be instituted and/or carried on against the farmer but not beyond judgment.

RECLASSIFICATION OF THE TEACHING STAFF OF THE EDUCATION DEPARTMENT FROM 1st JULY, 1941.

THIS Classification of Teachers has retrospective effect from the First day of July, 1941, and replaces the old salary scales as follows:-

There is a dual basis for the computation of the salaries of classified teachers in the Primary Schools-

The position held by the teacher.

The personal classification of the teacher, based upon examinations passed and practical efficiency in teaching.

The portion of salary allotted on the former basis is termed the "Position Quota." The portion allotted on the latter basis is termed the "Qualification Quota."

Basic Wage Adjustment.

1. (a) Adult Male Teachers:—The classified salaries contained herein shall be adjusted by the addition of such salary allowances as will ensure that adult male teachers shall receive as from the 1st July, 1941, the same salary increments as have been granted to adult male civil servants employed under the Public Service Act between the 1st July, 1926, and the 1st July, 1941.

(b) Adult Female Teachers:—The classified salaries of adult female teachers shall be adjusted from the 1st July, 1941, by the addition of 80 per cent. of the salary allowances payable to adult male teachers in receipt of similar classified salaries.

(c) Teachers whose salary rates are less than £185 per annum shall be adjusted pro rata with the

adult male minimum of £185 per annum.

2. (a) The salary rates for adult male teachers shall be subject to adjustment at the rate of £5 per annum for every variation of 1s. 11d. per week in the basic wage declarations made by the Court of Arbitration, except that teachers whose salary is in excess of £699 per annum will be subject to adjustments only when the basic wage fluctuation represents in the aggregate, either up or down, an amount of 7s. 8d. per week, when an adjustment of £20 will be made.
