WHEREAS by sections 222 and 227 of the Municipal Corporations Act, 1906 (6 Edwardi, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the Government Gazette, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge, or thoroughfare, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a publie highway, within the meaning of any law now or hereafter in force: And whereas the City of Perth Municipal Conneil has requested that certain land, named and described in the Schedule herennder, which has been used for a street or way within the Municipality of the City of Perth, be declared a public highway: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said land to be a public highway, and such land shall from the date of this Proclamation be absolutely dedicated to the public as a highway, within the meaning of any law now or hereafter in force.

WHEREAS it is provided by contracting (2) 2 2 2 11.

WHEREAS it is provided by subsection (2) of section 100 of the Factories and Shops Act, 1920-1937, that the day on which all shops except those mentioned in the

Fourth Schedule and registered small shops, shall close at one o'clock shall be Saturday: Provided that the Governor may by Proclamation at any time and from time to time on the petition (according to the form in the Sixth Schedule) of the majority of the keepers of such shops in any district or specified locality not within the district, substitute in that district or locality for Saturday any other week day, and may at any time on the like petition, revoke any such substitution: Now therefore 1, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred upon me in that behalf by subsection (2) of section 100 of the Factories and Shops Act, 1920-1937, do hereby repeal and revoke the Proclamations issued under the said section in respect of shops in the Waroona Shop District and published in the Government Gazette on the 2nd day of June, 1933, declaring Wednesday to be the day on which such shops should close at one o'clock.

ORDER IN COUNCIL.

WHEREAS by section 45 of the Pearling Act, 1912-1935, it is made lawful for the Governor to close any portion of a pearl-shell area and to prohibit the gathering, collection, or removal of any pearls or pearl-shell within or from the portion so closed, for a specific period: And whereas it is deemed expedient that the whole of that portion of the Shark Bay Pearl-Shell Area known as the south passage section, other than those portions held under Exclusive License, shall be closed and that the gathering, collection, or removal of pearls or pearl-shells within or from that portion so closed shall be prohibited: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, hereby directs that the abovementioned portion of the said Pearl-Shell Area shall be closed, and that the gathering, collection, or removal of pearls or pearl-shells within or from the portion so closed shall be prohibited for a period of twelve (12) months from the 14th day of December, 1941.

Workers' Compensation Act, 1912-1939.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1939, that it shall be obligatory for every employer to obtain from an incorporated insurance office, approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may by Order in Council exempt such employer from the operation of the said section: And whereas Millars' Timber and Trading Company, Limited, of St. George's House, Perth, being an employer within the meaning of the said section, has, in accordance with the regulations, duly made application that it be exempted from the operation of the said section, and has proved to the satisfaction of the Minister that it has established a fund for insurance against the liability to pay compensation and the satisfaction of the Minister that it has established a fund for insurance against the liability to pay compensation with the said of the s sation under the said Act to all workers employed by it, and has deposited at the Treasury securities (to wit, the sum of £5,000) charged with all payments to become due from the said Company under the said liability: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, doth hereby exempt the said Millars' Timber and Trading Company, Limited, as such employer aforesaid, from the operation of section 10 of the Workers' Compensation Act, 1912-1939, for the period which shall end on the 15th day of September,

THE Court of Arbitration of Western Australia doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties:-

AWARD.

1.—Area.

The Award shall operate over the land and premises owned or used by the Goldfields Firewood Supply, Limited, in connection with its operation or incidental thereto.

2.—Term.

The term of this Award shall be for two (2) years The term of this Award shall be for two (2) years from the commencement of the pay period next following the date hereof: Provided, however, that at any time after the expiration of two (2) months from such date, either party may apply to the Court to join any other party to the Award, and to amend clause 1 (Area) hereof, and such other terms of the Award as may be deemed necessary in the case of such added party or parties parties.

3.-Wages.

The minimum rates of wages payable to adult workers shall be:--

Provided, however, that nothing herein contained shall be deemed to reduce the rates now paid to any junior worker employed at the date of the Award.

(d) Notwithstanding that the rates above are expressed in weekly amounts, it is hereby declared that the contract of service is a daily contract subject to clause 31.

4.—Hours of Duty.

(a) Forty-four (44) hours shall constitute a week's work, to be worked as follows:—Eight (8) hours on each day, from Monday to Friday, inclusive, and four (4) hours on Saturday, except in the case of quad drivers, who shall work the forty-four (44) hours to snit the requirements of the employer's business. But in no case shall such quad driver be required to be on duty no case shall such quad driver be required to be on duty for more than twelve (12) hours on any day without payment for overtime for such day: Provided, further, however, that overtime shall not be cumulative.

(b) By agreement between the union and the employer, the forty-four (44) hours may be worked in five (5) days, Monday to Friday, inclusive, of eight (8) hours forty-eight (48) minutes each.

5.—Overtime.

(1) Subject to subclause (2) hereof, all work performed beyond the specified hours of duty on any ordinary day shall be paid for at the rate of time and a half for the first two (2) hours and double time thereafter. Except for the services referred to in clause 24 hereof, work done on Sundays and holidays shall be paid for at the rate of double time. When computing overtime the district allowance shall not be computed as an addition to the day's pay.

(2) When work is done in connection with repairs to

machinery which has broken down and caused a stoppage of operations, workers acting as assistants to the fitter, or fitters engaged on the work, shall be entitled to the margin usually paid to a fitter's assistant, but the rate for overtime shall be the same as that prescribed in the Engineering Award for work done in such cir-

cuinstances.

6.—Subcontracting.

(a) All the terms and conditions hereinafter set forth, as far as applicable to them respectively, shall be observed and carried out by the employer itself, and by its subcontractors, and also by the workers, anything which herein may be read to the contrary notwit. standing.

(b) For the more effectively securing the due observance and performance of the last preceding clause, and the carrying out of the terms and conditions hereinafte mentioned, the employer, so far as concerns its own acts, and so far as permitted by law, agrees that no subcontractors under it shall be allowed to operate on or use the lines, lands, and/or places under the control of the employer for the purpose of supplying firewood, without such person or company first having agreed in writing to the terms and conditions of this Award.

(c) Before any subcontractor shall be allowed to com-

mence operations on or use any of the said lines, lands, and/or places controlled by the employer, he shall notify in writing the secretary of the union whose members are affected that such subcontractor has agreed in writing to the terms and conditions of this Award.

7.—Holidays.

The following shall be holidays—Christmas Day, Labour Day, and Easter Monday.

8.—Annual Holidays.

(a) Subject to the proviso herein, a fortnight's holiday on full pay shall be granted once in each year to every worker: Provided he has worked two hundred and ninety-eight (298) working days at ordinary rates of pay. Should he have worked on less than two lundred and ninety-eight (298) working days, when the said holiday is taken, or at the termination of his employment, he shall be paid for or allowed a proportionate number of holidays. Payment for the said holidays shall be at the rate of pay the worker is receiving immediately before the holiday is taken or employment terminated.

(b) Pieceworkers shall be entitled to be paid, when on

holiday, the minimum rate for their grade.

(c) Should any worker take part in a strike, including a slow strike, he shall thereupon be deemed to have forfeited any right to holidays accrued to the date of the commencement of the strike under this clause.

(d) Where a worker is dismissed for wilful miscouduct, he will not be entitled to the benefits of this clause.

9.—Stores and Supplies.

The employer shall, during the currency of this Award, sell stores and supplies to the workers at Kalgoorlie cash the representative of the workers and the head store-keeper, on behalf of the employer, on the basis of information obtained by them from the Traders' Association. tion at Kalgoorlie and the principal business firms of Kalgoorlie. Meat prices to be similarly regulated and revised on the basis of the cash prices as obtained from the principal butchers of Kalgoorlie.

10.—Horse Drivers.

(a) Where twelve (12) or more horses are in any

camp a feeder shall be employed.

(b) Where the number of horses is more than two (2) and less than twelve (12), a leading driver shall be employed for the purpose, with a margin at the rate of one pound ten shillings (£1 10s. 0d.) per week on a daily contract of service.

11.—Water.

Good drinking water shall be supplied free to all workers, and, in the case of bush workers, shall be delivered into tanks along the line where the men are working, and in no case shall the distance between tanks be more than half (½) a mile.

12.—Piecework.

- (1) An employer may make a contract with a worker or group of workers for payment by results by piecework.
- (2) All disputes between the employer and workers, or groups of workers, or between the employer and the union, concerning any matter relating to piecework rates, shall, in default of agreement, be referred to a Board of Reference for determination.

(3) The rates appearing in the Schedule hereto shall be continued until altered or revised pursuant to the pro-

visions of this clause.

- (4) All contracts for piecework shall be fixed on the basis that they shall be sufficient to yield to a worker of average capacity over a period of three (3) months, using reasonable effort during the whole of the prescribed working day or week, the time worker's rate plus at least ten per centum (10%) and, in addition, thereto a tool allowance, in the case of the cutters, at the rate of seven shillings (7s.) per week. Any increase or decrease in the basic wage as proclaimed from time to time shall be taken into account in ascertaining whether this condition is fulfilled.
- (5) A worker working under any system of payment on piecework shall receive at least the time rate of pay which he would have been entitled to under a contract of daily service (overtime, if any, not included) at the rates prescribed herein. For the purpose of ascertaining whether a pieceworker is receiving less than the minimum rate under this subclause, the total earnings of such pieceworker for the period of the lest prescribe. such pieceworker for the period of the last preceding three (3) months shall be averaged.

(6) In the case of a worker who has not had three (3) months' experience, the minimum rate guaranteed under the preceding subclause hereof shall be such as may be mutually agreeed upon between the representatives of the union and the bush boss in each ease, and, in the event of their disagreement, may be referred to the Resident Magistrate for the district for final determination. Each such inexperienced worker shall during this term be deemed to be an apprentice. At the end of each period of six (6) months the employer shall furnish the Registrar with a return showing the number of workers employed nuder this subclause and the wages and/or other payments made to each.

13.—General Conditions of Piecework.

(a) Except in the case of wheel or curve blocks, the minimum frontage shall be two (2) chains for each man in any one party, with a maximum frontage of six (6) chains, irrespective of the number of men in the party. In the case of double banking, the original cutter shall have the choice of ends.

(b) Cutting or splitting shall be left to the option of the cutters so that they shall not be idle whilst firewood is being earted from the back of their blocks.

(c) When a team or teams are carting wood for entters who have ent out their blocks, such team or teams shall not be withdrawn until all the firewood of the

cutter has been cleaned up.

(d) If two (2) or more parties of cutters require blocks at the same time, they shall draw lots for precedence, and the bush boss shall conduct the drawing and measure out the blocks and distribute them between the Subject to the order of drawing, cutters shall be supplied with new blocks as soon as they have ent out their old blocks: provided their services be required. No cutter shall take a block on his own authority.

(e) In the event of trees being unsuitable to cutters, such trees need not be felled. If a dispute arises as to what constitutes unsuitable trees, the bush boss and the workers' representative shall decide the question. If they cannot agree, the trees in dispute shall be felled and cut and loaded by the cutter at the rate of two shillings

(2s.) per hour.
(f) Camps shall be placed so that cutters shall not have to walk more than a mile to the front of the block where they are working. In the case of large blocks, tanks shall be placed so that the water shall be available within one and a half $(1\frac{1}{2})$ miles from where the cutters are working.

(g) Wood shall be trucked within five (5) weeks from the time the blocks are cleaned up, and, so far as possible, in the order in which it is carted.

(h) (i) Wood burnt on the line shall be paid for at seven shillings (7s.) per load for green wood and eight shillings (8s.) per load for dry wood to the woodentters, and at the rate of one shilling (1s.) per load for green wood and one shilling and threepence (1s. 3d.) per load for dry wood to the drivers.

- (ii) Wood burnt on trucks shall be paid for at tonnage rates, based on the average weight of the rake.
- (i) Wood belonging to each cutter or party to be loaded into trucks separately as far as practicable, except when cleaning up the line.
- (j) Cutters shall peg their blocks from a point to a line as directed by the bush boss and the employer shall clear the tip.
- (k) Cutters who are desirons of leaving their blocks shall give the employer notice, and their wood shall be trucked and paid for within four (4) days after carting, and payment forwarded, when necessary, by registered letter to any address left by the worker. This shall also apply to cutters who have severed their connection with the employer. nection with the employer.
- (1) Cutters may obtain advances in each or stores from the employer up to seventy-five per cent. (75 per cent.) of the estimated value of the sum coming
- cent.) of the estimated value of the sum coming to them for wood lying out on their blocks, or on the line; the value of such stores or supplies shall be taken as payment or part payment for any such firewood.

 (m) (i) The wood shall be cut in accordance with the following extracts from the mine specifications, viz.—The employer shall supply firewood of locally grown timber, other than black oak, in lengths of five (5) feet, with a diameter, if nusplit, of not more than ten (10) inches nor less than three (3) inches at either and, but, if the firewood exceeds ten (10) inches at end, but, if the firewood exceeds ten (10) inches at both ends but does not exceed twelve (12) inches at both ends, the same shall be split in half, and, should the firewood exceed twelve (12) inches at both ends, shall be split in four (4) pieces.
- (ii) All cutting shall be done in a face either from the back of block inwards or from the front outwards. All suitable timber shall be cut into firewood lengths and sizes as specified herein.

- (iii) In the event of the cutter having unsplittable logs on hand, the price for same shall be arranged between the bush boss and the workers' representative, who shall also decide, if necessary, the question of whether any log is nusplittable or not.
- (n) (i) Drays shall be supplied to clean up blocks as soon as possible after they have been cut out. as soon as possible after they have been cut out. It cutters are idle for more than one day whilst waiting for drays, or to shift camp, the employer shall find work for such enters, for which they shall be paid at the rate of sixteen shillings ten and ten-elevenths pence (16s. 10 10/11d.) per day of eight (8) hours. In the event of the employer being mable to find work for such cutters, the cutters shall nevertheless be entitled to receive sixteen shillings ten and ten-elevenths pence (16s. 10 10/11d.) per day of eight (8) hours for each day thus kept waiting for drays or to shift camp after the expiry of the first twenty-four (24) hours.
- (ii) Cutters shall be supplied with two (2) teams if carting beyond a mile, provided the block is cut out satisfactorily.
- (iii) In the event of cutters being required to walk more than three (3) miles to load wood they shall receive an extra one shilling and twopenee (1s. 2d.) per day for each additional mile or part of a mile over three (3). If called ont to load on Sundays, cutters shall be allowed wages at double the ordinary rates.
- (iv) (a) The term "culled bush" shall be deemed to mean a block from which firewood or mining timber has previously been removed to such an extent as to leave the block so deficient in firewood as to militate against the average firewood cutter's ability to produce approximately his normal output. Any dispute on the question whether the block is culled bush shall be referred to a Forestry Inspector, whose decision shall be final and in accordance with any Forestry regulations, when such are prescribed for the district.
- (b) A firewood cutter required to work in culled bush shall be paid at the rate of not less than threepence (3d.) per ton extra. Any dispute arising out of the application of this portion of the subclause (iv (b)) shall be determined in accordance with the provisions of clause 18 of this Award.
- (o) Engine wood cutters shall have their blocks
- cleaned up at least once per month.

 (p) Horsedrivers' camp shall be so situated that the drivers shall not have to travel more than one mile from the camp to the front of the block.
- (q) (i) Facilities shall be provided for watering horses at crib time on the job.
- (ii) If drivers are required to travel more than a quarter of a mile from the front of the block to water their horses at crib time, travelling time to be paid both
- ways at the rate of twenty (20) minutes to the mile. (r) The cutter shall place his wood in heaps convenient for the driver.
- (s) Horses shall be supplied to the drivers in a fit
- condition to do the work. (t) Tips to be cleared and levelled by the employer.
- (u) (i) The employer shall provide a sufficient number of trucks for loaders. For any time lost owing to an insufficiency of trucks, loaders shall be paid waiting time at the rate of two shillings and the six-elevenths of a penny (2s. 0 6/11d.) per hour, and the check clerk shall keep an account of the time so lost, but this clause shall not apply in the case of a breakdown or for any other cause beyond the control of the employer.
- (ii) Loaders shall be started by 8 a.m. They shall also leave camp not later than one and a half (11/2) hours from the time of their arrival at the camp for lunch. In the event of the loaders being delayed beyond either of the abovementioned times, they shall be paid waiting time at the rate of two shillings and the six-elevenths of a penny (2s. 0 6/11d.) per hour: Provided, however, that if the delay was caused through no fault of the management, the waiting time to be paid for shall not commence until a further half an hour has elapsed.
- (v) A van or truck shall be attached to trains to bring loaders home from work.(w) Loaders prevented from loading by wet weather

shall be returned to the home camp as early as possible.

(x) Loaders required to travel more than six (6) miles from the camp to the place of working shall take their

crib and be paid one penny (1d.) per ton extra.

(y) The employer shall deliver all stores required three (3) times per week. Present arrangements for delivery to camps shall continue. In any place where stores are left at or near the railway line, to be taken delivery of by the workers, a suitable safe or other receptacle protected from weather and sun shall be provided by the employer for the reception and protection of such stores.

In the case of goods delivered from the employer's bush stores other than by train, the employer shall pro-vide some person to distribute the goods to the men's éamps,

(z) (i) Loads shall be tipped not closer to the nearest rail than three (3) feet and not further away from the said nearest rail than eighteen (18) feet.

(ii) Truck loaders on piecework rates shall load six (6) trucks per day Mondays to Fridays and four (4) trucks on Saturdays,

14.—Mixed Functions.

Any worker carrying out work classified at a higher minimum than his ordinary rate shall be paid at the rate of such work for the whole of that shift.

15.—Casuals.

All men not employed for the full working week shall be considered easins and shall receive ten per cent. (10%) in addition to the rate specified. This clause This clause shall not apply to pieceworkers.

16.—Payment of Wages.

Pay day shall be at least once every month, not later than the second Saturday of the month.

Any worker leaving or being discharged shall be paid the full amount of wages due to him within one (1) hour from the time of his application at the employer's office during office hours.

17.—New Classes of Labour.

Should men be employed on a class of labour not specified in the Schedule, the amount of wages to be paid for that class of work shall be mutually arranged between the employer and the union.

18.—Board of Reference.

- (a) The Court appoints, for the purposes of the Award, a Board or Boards of Reference. Each Board shall consist of a chairman, who shall be a person appointed by the Court or a person selected by the representatives of the parties, if such may be agreed upon, or, failing such agreement, the Resident Magistrate, if agreeable and willing to act, and if not, the Inspector of Forests for the district, and two (2) other representatives, one to be chosen by the employer and the other a representative of the union, appointed for such purpose by the union. A representative may be changed at any time by the party appointing him, upon notification to the other party and the Registrar.
- (b) There shall be assigned to such Board, the functions of:-
 - (i) deciding matters specifically referred to in the Award as being the subject-matter of a decision of the Board;
 - (ii) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award, or any of them;
 - (iii) deciding all matters and questions referred to in the Award as being the subject of untual
 - agreement, if not agreed upon;
 (iv) deciding any other matter that the Court may refer to such Board from time to time.
- (e) An appeal shall lie from any decision of such Board, in the manner and subject to the conditions prescribed in the Regulations to the Industrial Arbitration Act, 1912-1935, which for this purpose are embodied in and form part of this Award (regulation 92).
- (d) There shall be no cessation of work pending the reference to and the settlement of any dispute by the Board.

19.—Weighing of Wood.

The employer shall cart the wood to the railway line and load it into wagons. Wagons shall be taken across the weighbridge and weighed in the presence of the workers' representative. The weight then ascertained workers' representative. shall be taken as final. Delivery between the cutters and the employer shall be completed when the wood has passed the weighbridge and the weight has been ascertained, unless otherwise agreed to.

20.—Spark Arresters.

In order to safeguard the wood from being burnt, the employer shall employ men as spark arresters.

21,-Under-rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the union and the employer.

(b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference

for determination.

(c) Pending the Board's decision, the worker shall be entitled to work for or be employed at the proposed

(d) The wages of under-rate workers shall rise or fall on a pro rata basis, in conformity with the rise or fall in the basic wage.

22.—First Aid.

The employer shall provide at each of its stores, ineluding branch stores and on its railway trains, first-aid equipment, and keep same fully and efficiently sup-plied. The employer shall also, wherever it may be done without loss or expense or undue interference with its operations, facilitate the efforts of its workers to acquire

a knowledge of first-aid and ambulance work.

If no person possessed of recognised first-aid qualifications is at present employed at each camp at or in the vicinity of which upwards of fifty (50) of the employer's workers are engaged, the employer shall, when engaging workers, give preference to at least one worker so qualified, if he is competent to perform the service required by the employer.

23.-Mining and Sawmill Timber.

Cutting of mining or sawmill timber may be done by day workers at a margin rate of thirteen shillings (13s.) per week; if done by piecework, the piecework rate shall be such as may be mutually agreed upon. Should a difference arise on this question the matter shall be determined as provided by clause 18 of this Award Award,

24.—Shifting Camps,

When for the purposes of the employer's operations workers are required to shift their own camps, they shall be entitled to an allowance for the time necessarily occupied in dismantling, loading, travelling, unloading, and re-erecting their camps, not exceeding one half (½) day's pay, at their prescribed ordinary day work rates. If required to shift camps and/or equipment other than their own, they shall be entitled to payment at their prescribed ordinary time rate for such time as they are so engaged.

25.—Sanitary Arrangements.

The employer shall provide reasonable facilities, in the nature of sanitary arrangements, for persons carried on its trains, either by erection and maintenance in pro-per order of adequate structures alongside the line, at intervals not exceeding ten (10) miles, at which the train shall stop as and when required, or, alternatively, it shall make some provision ensuring privacy on a suitable part of the train itself.

26.—Wet Pay.

Any worker on day work required to work in wet places shall be paid one shilling (1s.) per shift extra. Wet places shall mean places where the water is over

the worker's boots.

27.—Travelling Accommodation.

When the employer supplies a motor quad to convey navvies to and from their working place, they shall travel in their own time.

When the employer supplies a kalamazoo to convey navvies to and from their working place, they shall travel one way in their own time and one way in the employer's time.

28,--Preference.

(1) Preference of employment shall be given to financial members of the Australian Workers' Union or to persons who give to the employer an undertaking in writing to make application to join such union within one month of accepting employment: Provided that—

(a) there are members of the said union or intend-

ing members applying as aforesaid, equally qualified with other workers offering their services to perform the particular work required to be done and ready and willing to undertake the same; and

(b) the rules of the union shall permit any worker of good character coming within the scope of this Award to become a member of the union upon payment of the subscription and/or entrance fee prescribed by the registered rules.

(2) Where a worker, not having been a member of the said union at the time of his engagement, applies for membership of the union within one month after his engagement, it shall be deemed that no question of preference has arisen unless and until his application is

rejected for good cause.

(3) If during the continuance of this Award anything in the nature of a strike occurs in the industry hereby regulated, or if there is any restriction in output by the workers or any section thereof acting in concert, the benefit of this clause shall thereupon cease and deter-For further assurance and without modification of or prejudice to the foregoing provisions of this sub-clause, the employer may at any time apply to the Court, upon giving seven (7) days' notice to the union, for a declaration hereunder and the consequential cancellation of this clause, and the Court, upon cause being shown, shall make a declaration and order accordingly.

(4) The provisions of this clause shall not apply to

junior workers or apprentices.

29.—Record.

The employer shall keep or cause to be kept a record showing the names of each worker, the shifts worked and the wages and allowances paid. Such record shall be open for inspection to a duly accredited representative of the union, during the usual office hours, at the employer's head office or other convenient place, and he shall be allowed to take extracts therefrom.

30.—District Allowance.

In addition to the basic wage and the margin mentioned in clause 3, each of the adult workers employed in any portion of the employer's operations conducted at a distance of ten (10) miles or more from the Kalgoorlie Post Office shall be entitled to a district allowance at the rate of six shillings (6s.) per week, payable for each day upon which the worker is so employed or is available and willing to work. This allowance shall also apply to pieceworkers.

31—Full Payment for Shift.

- (a) After beginning a shift a worker shall not be paid for less than a full shift, unless he leaves work of his own accord, or is dismissed for misconduct. This shall not apply in matters beyond the control of the management.
- (b) If before a worker leaves the works at the end of his shift he is not informed that his services are not required, and because he is not so informed he attends at the next shift willing to work it, and there is not suitable work which he is allowed to perform, he shall be paid the wages he would have been entitled to as if he had worked the shift he was willing to work.

(c) This clause shall not apply in matters beyond

the control of the management.

32.—Existing Customs.

All existing customs and conditions prevailing at the time of this Award and not altered by this Award shall not be varied, unless by mutual consent of the parties thereto, and the workers and the employer shall not be deprived of any privileges or rights hitherto enjoyed, nor shall any new conditions detrimental to the interests of either of the parties be imposed unless specifically mentioned herein.

33.—Junior Worker's Certificate.

Junior workers, upon being engaged shall, if required, furnish the employer with a certificate containing the

following particulars:—
(1) Name in full.
(2) Age and date of birth.

No worker shall have any claim upon an employer for additional pay, in the event of the age of the worker being wrongly stated on the certificate. If any worker shall wilfully misstate his age in the above certificate, he alone shall be guilty of a breach of this Award.

Piecework Schedule.

(a) The following rates were fixed on a basic wage of four pounds five shillings (£4 5s.) per week. withstanding any alteration in the basic wage, the pieceWoodcutters:-

work rates herein prescribed shall remain constant: Provided, however, that on every rise or fall in the basic wage above or below four pounds five shillings (£4 5s.) per week, the daily earnings of the pieceworker shall be increased or decreased, respectively, to the extent of two-elevenths (2/11ths), in the case of a six (6) day week, or one-fifth (1/5th), in the case of a five (5) day week, of such rise or fall.

The Goldfields basic wage, which applies to the area at present covered by the employer's operations, being at this date five pounds five shillings and sevenpence (£5 5s. 7d.) per week, the carnings of pieceworkers shall be increased by one pound and sevenpence (£1 0s. 7d.) per week or a proportionate amount for a lesser period, until the next variation in the basic wage is declared by the Court.

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1935, this twenty-third day of October, 1941, between the Commissioners of the Fremantle Harbour Trust (hereinafter called the employers), of the one part, and the Coastal Dock, Rivers, and Harbour Works Union of Workers (hereinafter called the employees), of the other part, witnesseth as follows:—

1. That Clause 4—Rate of Pay—of Industrial Agreement No. 6 of 1934, be deleted and the following inserted in lieu thereof:—

4.—Rate of Pay.

Basic wage—£4 10s. 5d. per week.

The rate of pay shall be £6 14s. 1d. per week, which amount shall be computed as follows:—Basic wage plus three-elevenths and margin over basic wage 19s. per week.

2. This Agreement shall be read and construed in conjunction with Industrial Agreement No. 6 of 1934, dated the 14th day of June, 1934.

IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

(No. 173 of 1941.)

In the matter of the Industrial Arbitration Act, 1912-1935, and in the matter of a dispute between the Metropolitan Superphosphate and Chemical Works Industrial Union of Workers, Applicant, and Cuming, Smith, and Mt. Lyell Farmers' Fertilisers, Limited, and Cresco Fertilisers (W.A.), Limited, Respondents.

ON the 31st July, 1941, I delivered a decision in respect of an extra allowance to be paid to certain workers whilst handling a new type of phosphatic rock, colloquially termed "Egyptian." The reasons appear in the said decision. Since this decision was delivered, the union of workers has complained that the circumstances under which the inspection was made were such as to prejudice the claims of some workers other than those to whom the extra allowance was granted, and accordingly

the parties requested that I should again inspect the works and decide upon the claims for an additional allowance to workers under the following headings:—

Item No. 2-Rock tunnel men.

Item No. 3-Trimmers (including scoop-men).

Item No. 8-Rock crushing millmen.

Item No. 28-Men working mixer in super plant.

Item No. 29-Hot super den men working excavator.

Item No. 30-Hot super belt conveyor men.

Item No. 67—Other workers not specified. (If assisting or cleaning up about mill or mixers whilst Egyptian rock is being used.)

I have accordingly again inspected the works and as a result of the second inspection I have come to the conclusion, for the reasons set out in the previous judgment, that extra allowances should be granted as follows:—

Name of Worker. Place. Amount of extra Payment per Day.

Penn .. Cresco Works, Bassendean .. 1s. 6d.

Wood .. ", ", ", 1s. 6d.

With regard to another worker named Sweeney, employed at Cuming, Smith's Works, Bassendean, I was mable to inspect the exact place in the tunnel where he complained of difficult and unusual conditions of dust, so as regards him I can only say that if his conditions are comparable with and equivalent to those of the other workers mentioned he should receive an allowance also.

A difficulty may arise owing to the fact that not all workers whose ordinary work comes within the same item in the wages schedule of the Award would be entitled to an allowance, and this is because different systems are employed in the various works, and also because the unusual conditions which would merit an allowance in the case of the workers whose names are specially mentioned in this decision do not occur in the case of other workers paid in accordance with the same item in the Schedule. This decision, therefore, must be taken as applying to the workers specially named, or to any workers employed in their place and carrying out duties similar to the work being done on my inspection.

I was pleased to note the efforts being made by the employers in the way of new and enlarged flues and fans and frequent and regular cleaning out to mitigate any disability that might be caused by gases, etc., and these precautions have undoubtedly done a great deal to free the work from what would otherwise be difficult conditions for the workers. I hope that this system of care for the health and comfort of the workers will be continued in the future. I desire to add that from a report received from the Government Analyst, exposure to the odom emanating from the rock could lead to no disability.
