NATIONAL SECURITY (SUPPLEMENTARY) REGULATIONS.

Intoxicating Liquor (Restriction) Order.

WHEREAS by regulation 45 of the National Security (Supplementary) Regulations (as amended by Statutory Rule 1942, No. 132) it is provided *inter alia* that notwithstanding anything contained in the law of any State, where the Premier of the State is of opinion that it is in the interests of the defence of the Commonwealth or the effectual prosecution of the war that limitations or restrictions on the sale, supply, disposal, possession or use of intoxicating liquor in the State additional to or different from the limitations and restrictions prescribed by the laws of the State should be imposed, he may by order published in the Government Gazette of the State prohibit, restrict, control or regulate the sale, supply, disposal, possession or use of intoxicating liquor in the State and that any such order may be made so as to apply either throughout the State or to any area or premises therein, may make different provisions with respect index different classes of premises, may provide for exempting premises (either absolutely or conditionally) from any of the provisions of the order, and may contain such incidental and supplementary provisions as appear to the Premier to be necessary or expedient for the purposes of the order; and whereas I, John Collings Willcock, M.L.A., Premier of the State of Western Australia, acting by virtue of the powers conferred by the said regulation 45 made and issued—(a) an Order (hereinafter called the "principal order") dated the 27th day of August, 1942, which was cited therein as the Intoxicating Liquor (Restriction) Order No. 1 and was published in the Government Gazette of Western Australia on the 28th day of August, 1942; (b) an Order dated the 17th day of December, 1942, which was cited as the Intoxicating Liquor (Restriction) Order No. 2, which was expressed to be read as one with the Intoxicating Liquor (Restriction) Order No. 1 and was any of the provisions of the order, and may contain such toxicating Liquor (Restriction) Order No. 1 and was published in the Government Gazette of Western Auspublished in the Government Gazette of Western Australia on the 18th day of December, 1942; (c) an Order dated the 11th day of January, 1943, which was cited as the Intoxicating Liquor (Restriction) Order No. 3 which was expressed to be read as one with the Intoxicating Liquor (Restriction) Order No. 1 and in conjunction with the Intoxicating Liquor (Restriction) Order No. 2 and was published in the Government Gazette of Western Australia on the 15th day of January, 1943, and (d) an Order dated the 25th day of February, 1943, which was cited as the Intoxicating Liquor (Restriction) Order No. 4 which was expressed to be read as one with the Intoxicating Liquor (Restriction) Order No. 2 and the Intoxicating Liquor (Restriction) Order No. 3 and was published in the Government Gazette on the 26th day of February, 1943; and whereas it is now deemed desirable and expedient to amended as aforesaid: Now, therefore I, the said John Collings Willcock, M.L.A., as such Premier aforesaid acting by virtue of the authority conferred by the said regulation 45 do hereby make the following Order:—

- 1. This Order may be cited as the Intoxicating Liquor (Restriction) Order No. 5 and shall be read as one with the Intoxicating Liquor (Restriction) Order No. 1 (the principal Order) as amended by the Intoxicating Liquor (Restriction) Order No. 2, the Intoxicating Liquor (Restriction) Order No. 3, and the Intoxicating Liquor (Restriction) Order No. 4 hereinbefore mentioned.
- 2. Clause 5 of the principal Order is amended as follows:
- (a) by deleting from paragraph (1) the word "ten" where it appears in line 8 of the said paragraph, and inserting in lieu thereof the word "eleven;"
- (b) by deleting from paragraph (1) the word "six" where it appears in line 9 of the said paragraph, and inserting in lieu thereof the word "seven;"
- (c) by deleting from the proviso to paragraph (1) (inserted by Intoxicating Liquor (Restriction) Order No. 2 and amended by Intoxicating Liquor (Restriction) Order No. 4) the word "ten" where it appears in line 3 of the said proviso, and inserting in lieu thereof the word "eleven;"
- (d) by deleting from the same proviso to paragraph) the word "six" where it appears in line 4 of the said proviso, and inserting in lieu thereof the word "seven;"

(e) by deleting from paragraph (2) the word "six" where it appears in line 3 of the said paragraph (2) and inserting in lieu thereof the word "seven;"
(f) by deleting from paragraph (2) the word "ten" where it appears in line 4 of the said paragraph and inserting in lieu thereof the word "eleven."

3. This Order shall come into operation and take effect on the 16th day of July, 1945, or on the date of the publication of this Order in the Government Gazette of Western Australia, whichever of the said dates shall be the later. be the later.

Bayswater Health District—Amendment of By-Laws. THE Bayswater Road Board, being the local authority for the Bayswater Health District as constituted under and for the purposes of the Health Act, 1911-1944, and having pursuant to section 321 of that Act by a resolution published in the Government Gazette on the 23rd March, 1945, adopted the Model By-laws Series A as prepared under section 321 of the said Act and reprinted with amendments in the Government Gazette on the 4th December, 1944, as the by-laws for the said Bayswater health district, now acting pursuant to section 133 of the said Act doth hereby amend its said by-laws, being the Model By-laws Series A aforesaid in manner following, that is to say:—

1. A new by-law, to stand as by-law 28A, is inserted in Part I after by-law 28 of the said by-laws as follows:—

28A. (1) The occupier of any premises situate within that portion of the district defined in paragraph (2) of this by-law shall not keep a cow in or upon such premises unless and until there is provided and maintained thereon for such cow a cow bail which in its construction and otherwise complies with the following requirements:—(a) The cow bail shall not be any less distance than 20 feet from any dwelling house, and the situation of the cow bail shall be subject to the approval of the Health Inspector; (b) the walls shall be constructed of brick or stone, or alternatively of brick to a height of 4 feet and then asbestos or wood above; (c) the roof shall be of iron or other approved impervious material; (d) the overall area of the floor shall be not less than 8ft. x 6ft.; (e) the minimum height of the front walls shall be 7ft. 6in. in front rising to not less than 8ft. at the back; (f) the upper surface of the floor shall be raised at least 3in. above the surface of the surrounding ground and shall be constructed of granolithic cement or concrete or of brick grouted in cement and shall have a fall of 1 in 100 to a drain, which shall be connected to a properly

trapped sump constructed of bricks laid with open joints, the top of which shall be at least 6in. below joints, the top of which shall be at least 6in. below the level of the ground; (g) there shall be provided outside the cow bail a receptacle for manure which shall be not less than 4ft. x 4ft. x 2ft. height and which shall be constructed of brick faced with cement or other approved impervious material; it shall be provided with a tight fitting cover and shall be emptied at least once a week; (h) all manure produced on the premises shall be collected daily and placed in the recentacle for manure; (i) the cow bail shall be on the premises shall be collected daily and placed in the receptacle for manure; (i) the cow bail shall be washed down daily and shall be lime washed when ordered by a health inspector; (j) the cow bail shall not be ergo and unless and until plans and specifications and the site of the proposed cow bail have been approved by the local health authority.

(2) This by-law shall apply to the following area, namely:—That portion of the Bayswater Health District which as part of the Bayswater Road District as constituted under the Road Districts Act, 1919-1943 is zoned and gazetted as a residential area un-

1943, is zoned and gazetted as a residential area under the provisions of the Town Planning and Development Act, 1928, and is comprised within the following boundaries:—Commencing on the south side of the district at the Belmont Railway Bridge, thence along the Swan River to the boundary between the Bayswater and Perth Road Board Districts; thence along the district boundary on the west and north to its junction with Coode street; thence along Coode street to the intersection of Greenford road; along Greenford road to the intersection of Drynan street; thence along Drynan street and Clavering road to the intersection of Bassendean road; thence along Bassendean road to the intersection of River road; thence along River road to the railway line; thence west along the railway line to the junction of the Belmont branch line; thence along the Belmont branch railway line to the Swan River to the starting point. INDUSTRIAL AGREEMENT.

No. 6 of 1945. (Registered 26/6/45.)

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1941, this Fourteenth day of June, one thousand nine hundred and forty-five, between the Merchant Service Guild of Australasia, Western Australian Section, Union of Workers, Fremantle; the Coastal Dock, Rivers and Harbour Works' Union of Workers; and the Seamen's Union of Western Australia, Industrial Union of Workers, Fremantle (hereafter called the employees), of the one part, and The Shell Company of Australia, Limited (hereafter called the Employers) of the other part; Witnesseth that for the considerations hereinafter appearing, the parties hereto mutually covenant and agree the one with the other as follows:—

1.—Area.

This Agreement shall operate over, and be limited to, the area comprised within a radius of 150 miles of the Post Office, Onslow.

2.—Term.

This Agreement shall operate for a period of twelve months from the date hereof.

3.-Wages.

(e) The above rates shall be increased in accordance with the provisions of War Risk Bonus Order "D" (Order No. 28) made under the National Security (Maritime Industry) Regulations, but shall be subject to any amendment of such order.

4.—Engagement or Dismissal.

All employment shall be by the month. A month's notice on either side shall be given to terminate the employment or the employer shall pay one month's wages in lieu of such notice, subject to the right of the employer to dispense with the services of the employee for misconduct, insobriety or negligence without notice at any time.

5.—Payment of Wages.

- (a) All wages other than money for overtime will be paid weekly.
- (b) Money for overtime will be payable on the pay day of the second week following that on which it was earned.

6.—Sickness and Accident.

If a seaman belonging to a ship, for which articles are signed in Australia, is landed and left at any port by reason of illness, or accident in the services of the ship, incapacitating him from following his duty, he shall be entitled.

- (a) If landed at his home port—to receive wages at the rate fixed by this Agreement up to the expiration of one week after the date of his recovery, as certified by his medical attendant or by a medical inspector of scamen, if the employer at his own expense requires an examination. Provided that, in cases where his engagement expires within one month from the date he was left on shore, the time for which he shall be so entitled to be paid shall not exceed a period of one month, and in other cases it shall not exceed a period of three months from the date he was left on shore.
- (b) If landed and left at a port other than his home port, to receive wages until his recovery, certified as provided in the preceding subclause (a) and until arrival at his home port, at the rate payable to him when he was landed, and after his recovery (certified as aforesaid), to a free passage to his home port. Provided that, if after recovery the seaman rejoins his ship or takes other employment, or is offered and refuses employment on some other vessel proceeding to his home port at a similar rate of pay to that received by him immediately prior to his being left ashore, and with right of discharge from that vessel on arrival at his home port, his right to continue to receive wages under this subclause shall then cease.
- (c) If the medical inspector of seamen at an outport certifies that the seaman shall be landed at that port for treatment, and the master requires the seaman to return to his home port prior to recovery, either before or after being so landed, such seaman shall, after arrival at his home port, be treated in respect of wages, medical expenses, maintenance, etc., as if he had not been returned to his home port.
- (d) The illness, hurt or injury which shall entitle a seaman to the benefits provided for in this clause shall:—
 - (1) be such as to wholly incapacitate him from performance of his duty;
 - (2) be, or appear to be of such a nature that it is considered by the master advisable in the interests of the seaman to leave him ashore;
 - (3) so far as can be ascertained, be an illness contracted on board any ship of the employer, or in the service of any such ship or of the employer, or a hurt or injury sustained in the service of any such ship or of the employer, in either case under the existing or any preceding articles of agreement not separated from the next succeeding articles by an interval of more than a week (except so far as it includes time off or leave granted under this Award) nor by any time of employment for any other employer. Provided that, if the illness is due to his own wilful act or default, or to his misbehaviour, or to a venereal disease, the employee shall not be entitled to the benefits provided for in this clause.

- (e) The expense of providing the necessary medicines, surgical, and medical advice, and attendance to a seaman belonging to a ship while suffering from the effects of sickness contracted, or injury received in the service of the ship or of the owner, or from any illness, not being venereal disease, or an illness due to his own wilful act or default, or to his own misbehaviour, and of the seaman's conveyance to the home port after recovery, shall be paid by the employer without any deduction from wages on that account, until he is cured or dies, or is brought or taken back to the port where he is entitled to be discharged or such other port as is mutually agreed upon with the approval of the proper authority. This subclause is subject to the proviso to subclause (b) of this clause.
- (f) While being returned to the port above referred to under the provisions of this clause, the seaman, if he is not being maintained by or at the expense of the employer, shall be entitled to a sustenance allowance at the rate of 9s. per day whilst awaiting and during such transportation.

7.—Hours.

- (a) Except as hereunder provided the ordinary hours of labour in port shall be any eight consecutive hours exclusive of meal hours between 7 a.m. and 5 p.m.
- (b) In any case when a tug and/or lighter proceeds to sea the employer shall work the crew in watches which shall be set and commenced from the time the vessel leaves the berth or anchorage to proceed to sea, provided that when the ship is at sea the watches shall be of four hours' duration with intervals of eight hours off duty.
- (c) Outside the hours of labour and without payment for overtime, any work shall be done that is required for the safety of the tug and/or lighter.
- (d) Forty-four hours shall constitute the ordinary hours of duty for a week and such hours, in port, shall be worked between 7 a.m. Mondays to 12 noon on Saturdays.

8.—Overtime.

- (a) All work performed outside of or in excess of the hours prescribed in clause 7 shall be paid for at the rate of time and a-half of the ordinary rate.
- (b) All work performed in port on Sundays or holidays double ordinary rates shall be paid and as for at least four hours.
- (e) Where the period of a voyage includes time between noon on Saturdays to midnight on Sundays or holidays as defined in clause 16, the following provisions shall apply:—
 - (i) For each watch (as defined in clause 7 (b)) and in lieu of payment of overtime rates, the employee shall be entitled to four hours' leave at ordinary rates of pay, such ordinary rates to mean the rates obtaining under clause 3 (a), (b) and (e), provided that such leave shall be allowed to accumulate and to be granted cumulative to the annual leave at the home port of the employee. Accumulated leave, irrespective of when taken, shall be paid for at the rate ruling when incurred.
 - (ii) Should the employer so choose, he may instead of giving or deferring, or accumulating such additional leave, treat the employee as having worked overtime in the week in respect of which such leave accrues and pay overtime accordingly.
 - (iii) In addition to subclauses (i) and (ii) of this clause each employee shall, in lieu of payment, be entitled to a rest period of equivalent time for watches worked up to four hours on Saturday afternoon and eight hours on Sundays or holidays, this to be granted at the discretion of the Master within 14 days thereof; provided that if this is not granted within the above period, the employer shall pay to the employee ordinary rates of pay for the rest period or periods not granted.
 - (iv) This clause does not apply to an employee in respect of the time in which he is proceeding to any port as passenger.
- (d) Where employees having left the vessel at night are called back, a minimum of two hours' overtime will be paid for each call back (irrespective of the number of jobs); provided that:—

- (i) Where time of duty runs into or extends beyond the day's work, overtime payment shall be made only for the actual time worked prior or subsequent to ordinary hours, as the case may be.
- (ii) Broken time will be counted to the nearest quarter hour on a give and take basis.
- (e) Where there is a second call back on any night, and the break from the expiration of the first two-hour period to such second call back is less than two hours, overtime shall be allowed continuously as if no break occurred.
- (f) Provided, that subclauses (d) and (e) do not apply when the vessel proceeds to sea.
- (g) Notwithstanding anything contained in any previous provisions of this Agreement, the employer may cause an employee to remain on board for the purpose of shipkeeping, such shipkeeping to be paid for at the following rates of pay:—
 - (i) From 5 p.m. to 7 a.m. the following day an amount equal to (1) one day's pay.
 - (ii) From 7 a.m. to 5 p.m. (or any hours between those hours) payment at the appropriate ordinary rates of pay calculated on an hourly basis.
 - (iii) The duties of shipkeeper shall be so far as possible apportioned to all tug and lighter personnel upon a rotary basis.

9.—Meals (in Port).

Breakfast.—Any consecutive 60 minutes between 7 a.m. and 9 a.m.

Dinner.—Any consecutive 60 minutes between 12 noon and 2 p.m.

Where it is necessary in the opinion of the Master or Officer in charge of the tug for the purpose of shifting ships or to enable the vessel to start a job during a meal hour, an employee may be called upon to curtail his meal hour or portion of it, subject to the following provision: If the time curtailed exceeds a half an hour payments shall be made as for 1 hour at overtime rates, but where the time is a half an hour or less payment shall be made as for a half an hour at overtime rates.

10.—Victualling.

All employees shall be victualled at the employer's expense provided however that when working outside a radius of 15 miles from the G.P.O., Perth, the employer shall be entitled to deduct an amount equal to the difference between the Metropolitan and the rest of the State Basic Wage.

11.—Annual Leave (subject to the provisions of Clauses 4 and 15).

- (a) All employees shall be granted 28 consecutive days' leave of absence on full pay for each year worked. After three months' service leave shall be granted pro rata for each completed month of service.
- (b) By mutual consent this leave of absence may be taken in whole or in part and the unused leave accumulated, but it may not be postponed beyond the second year.
- (c) Where an employee serves continuously for a period of 12 consecutive months or more the expense of return to the home port and then back to the job shall be borne by the employer. Such leave shall commence the day after arrival at the home port and shall terminate at the home port twenty-eight days from that date.
- (d) A fortnight's notice of intention to give the holidays to the employee shall be given to the employee whenever practicable. If it is impracticable in the opinion of the Master to give the fortnight's notice, as much notice as can reasonably be given must be given to the employee.

12.—Raising Steam and Banking Fires.

It is assumed that the time required for raising steam and warming up engines is one hour in a day, and that the time required for banking fires and shutting off steam is a-half an hour in a day, and any portion of such time as falls within overtime hours to be paid for accordingly, provided that, when having finished the day's work steam is required for tows more than once in a night, half an hour's overtime payment for raising steam and banking fires on the second of such occasions shall be allowed.

13.—Disputes.

There shall be no stoppage of work for any cause or reason whatsoever. Should any dispute arise between any employee and the employer the matter will be referred to a Board consisting of a representative of the employers, a representative of the Union, and the chairman to be mutually agreed upon by those representatives; failing their agreement, the Registrar of the Industrial Arbitration Court of Western Australia or his deputy shall act as chairman. The decision of the Board shall be final and binding to both parties.

14.—Utensils and Bedding.

- (a) The employers will provide, for the use of the seamen, all necessary utensils, to be of enamelware or of a similar nature thereto, but not of tin, free of cost, to the seamen, and also bedding consisting of a mattress, pillow, pillow-cover, two sheets, two blankets and a third blanket to be supplied on application in cold latitudes; the pillow-cover and sheets shall be changed as required and the blankets washed as required; provided that, in the event of the failure of any seaman to return in good order any of such utensils or bedding as may have been issued to him, the employers may deduct any sum, being not more than 75 per cent. of the value of such utensils or bedding not returned, from any moneys due to such seaman on the termination of his employment. The mattresses supplied to be of flax or other fibre and not of straw or tow.
- (b) All the necessary eating and messing utensils including washing cloths and drying towels, shall be supplied by the employer prior to the commencement of a voyage.

15.—Repatriation.

The Master may discharge any employee at any port other than the home port by giving the required notice, but such discharge shall be subject to the following conditions:—

- (a) The employer shall provide the employee with free conveyance from the port of discharge to his home port, but may require that conveyance to begin at any time between the giving of the notice and the time at which the discharge is to occur.
- (b) The employer shall pay to the employee all wages and overtime due up to the discharge, and also wages at the prescribed cash rate for the time which in the ordinary course elapses in travelling to the home port:—
 - (i) In the case of employees whose home port is Fremantle, within one clear day of the head office being open for business after the arrival.
 - (ii) In the case of others, as soon as is practicable by using the usual methods of post.
- (c) The employer shall forthwith provide for the employee's keep during the time which will in the ordinary course elapse before he arrives at his home port.
- (d) Provisions of subclauses (a), (b) and (c) of this clause shall not apply to an employee dismissed for misconduct, insobriety or negligence.

16.—Holidays.

The following days shall be observed and paid for as holidays:—New Year's Day, Good Friday, Easter Monday, Labour Day, Christmas Day.

17.—Casual Employees.

A "casual" is an employee who is employed for less than two consecutive weeks and such employee shall be paid twenty-five per cent. in addition to the rates prescribed in clause 3.

18.—Discrimination.

The employer shall not discriminate against any members of the Unions which are parties to this agreement, and who bear good conduct records and are qualified to perform the work to be done.

$19. {\rm -\!Definitions}.$

- "Engineer-Fireman" means qualified marine engineer in charge of engines whose duties include attention to boiler.
- "Fireman-Driver" means fireman who during the couse of his duties has to be in charge of engines when the engineer is off duty.
- "In Port" means from the time of arrival to the time of departure at Learmonth.

"Shipkeeping" means remaining on board for the purpose of being available should it be necessary to perform any duties which may arise.

"Home Port" means the port of engagement, or in the case of employees who also manned the vessels for

the voyage to Onslow, the Port of Fremantle.
