PROCLAMATION

WHEREAS it is enacted by section 4 of the Vermin Act, 1918-1942, that "Vermin" means and includes any animal, bird or insect mentioned in the Third Schedule to the said Act and such other animals, birds or insects the names of which the Governor may by proclamation add to the said schedule and that any proclamation whereby the names of other animals, birds or insects are added to the said Schedule may be restricted in its operation to any portion of the State to be defined by the proclamation; and whereas it is deemed desirable and expedient that the bird of the parrot species "Polytelus Anthopeplus" commonly known as "Smoker" parrot shall be vermin for the purposes of the said Act within the boundaries of the Broomehill Vermin District: Now therefore I, the said Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act do by this proclamation add to the Third Schedule to the Vermin Act, 1918-1942, the name of the bird of the parrot species "Polytelus Anthopeplus', commonly known "Smoker" parrot and declare that this proclamation shall apply and have effect only in that portion of the State which is comprised within the boundaries of the Broomehill Vermin District as constituted under the said Act.

AT a meeting of the Executive Council held in the Executive Council Chambers at Perth on the 14th day of November, 1945, the following Orders in Council were authorised to be issued:—

Water Boards Act, 1904-1942.
Brunswick Water Area.
ORDER IN COUNCIL.

P.W.W.S. 148/38.

WHEREAS by the Water Boards Act, 1904-1942, the Governor is empowered to alter or extend, by Order in Council, the boundaries of a Water Area: Now therefore His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby extend the boundaries of the Brunswick Water Area in accordance with the Schedule hereto.

This Order in Council shall take effect on the 2nd day of November, 1945.

Brunswick Water Area—Extension 1945. Schedule.

All that portion of land, bounded by lines starting from the centre of the weir wall of the Beela Pipe Head Dam on the Brunswick River, and extending 80deg. Omin., 39 chains; thence 118deg. 30min., 175 chains; thence 122deg. 30min., 86 chains; thence 53deg. Omin., 93 chains; thence about 109deg. 40min., about 244 chains, to the north-eastern corner of Wellington Location 3052; thence east, about 218 chains to a point situate south of a 4-mile post situate about 4 miles westerly from location 2611; thence about 31deg. 45min., about 153 chains, to the 5-mile post; thence about 332deg. 45min., about 218 chains; thence 26deg. 30min., 190 chains, to Gregory's 16-mile tree marked T.7; thence about 266deg. 53min., about 201 chains, to the 12-mile post on road No. 1896; thence generally westerly, along the northern side of the said road, to a corner post marked A.30; thence about 238deg. 27min., about 15 chains 25 links, to the north-western corner of location 2758; thence about 254deg. 52min. about 45 chains; thence 186deg. 32min., 180 chains, to the centre of Mornington Trigonometrical Station; thence about 255deg. 35min., about 80 chains; thence 328deg. 38min., 80 chains, to the junction of the northern side of the road No. 58, with the western side of road No. 1233; thence generally westerly, about 14 chains along the former side, to an angle post in said road; thence about 209deg. 32min., about 218 chains 63 links; and thence about 103deg. 0min., about 75 chains, to the starting point. Workers' Compensation Act, 1912-1944.
ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1944, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under the said Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may by Order in Council exempt such employer from the operation of the said section; and whereas the New Zealand and Australian Land Company, Limited, of Yathroo Station, Dandarragan, in the State of Western Australia, being an employer within the meaning of the said Act, and as such subject to section 10 of the said Act, and as such subject to section 10 of the said Act, has duly, in accordance with the regulations, made application for exemption from the operation of the Minister that it has established a fund for insurance against its liability under the said Act and has deposited with the Treasury a security, to wit, Australian Inscribed Stock of the amount of £5,150, already held by the Treasurer, charged with all payments to become due under the said liability: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, doth hereby

exempt the said the New Zealand and Australian Land Company, Limited, from the operation of section 10 of the Workers' Compensation Act, 1912-1944, for a period of two years commencing on the 1st day of November, 1945.

ORDER IN COUNCIL.

P.W. 1337/37.

WHERAS section 74 of the Constitution Act, 1889, provides that the Governor in Council may vest in Heads of Departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Departments of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Department) should be vested in William Cyril Williams, and that the power vested in Norman Leslie Hodgson should be revoked: Now, therefore, His Excellency the Lieutenant-Governor by and with the advice of the Executive Council hereby vests in William Cyril Williams and any persons appointed to act temporarily in their place the appointment of foreman and all other persons employed on such works at a daily rate of wages, and doth hereby revoke the power vested in Norman Leslie Hodgson.

Bulk Handling Act, 1935-1943. ORDER IN COUNCIL.

WHEREAS it is enacted by section 26A of the Bulk Handling Act, 1935-1943, that from and after the date on which the management and control of the business of the Co-operative Bulk Handling, Limited, referred to in the Act as the Company, shall be handed over to the growers, as defined in the Act, in terms of a deed of trust bearing date the 24th day of October, 1933, made between the Company on the one part and a trustee for the growers on the other part, there shall, subject to the proviso mentioned in subsection 2 of section 22A, be paid to the Company by every holder of a warrant, as defined in the Act, on surrendering the same to the Company, in respect of all wheat delivered to it a toll of five-eighths of a penny per bushel; and also that the Governor may from time to time by Order in Council fix the amount of such toll at such lesser sum than as aforesaid; and whereas such management and control was so handed over on the 28th day of October, 1943: Now, therefore, His Excellency, acting with the advice and consent of the Executive Council and in exercise of the power in that behalf conferred upon him by section 26A, subsection 1 of the Act doth hereby fix such toll at three-eighths of a penny per bushel as from the 10th day of November, 1945, until further order.

Vermin Act, 1918-1942. ORDER IN COUNCIL.

WHEREAS it is enacted by section 14 of the Vermin Act, 1918-1942, that the Governor may by Order in Council inter alia constitute any defined portion of the State a Vermin district for the purposes of the said Act, specify the boundaries of any such district and assign a name to any such district, and by section 15 of the said Act that for every vermin district there shall be a board, and by section 45 of the said Act that the Governor may appoint the board of any road district to be the board of any vermin district the boundaries whereof are the same as those of the road district; and whereas it is deemed expedient to constitute that portion of the State comprised within the boundaries of the Hall's Creek Road District as now constituted under the Road Districts Act, 1919-1943, a vermin district to be known as "Hall's Creek Vermin District" and to appoint the Hall's Creek Road Board to be the board of the said Hall's Creek Vermin District: Now, therefore, His Excellency the Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the powers conferred by sections 14, 15, and 45 of the Vermin Act, 1918-1942, doth hereby for

the purposes of the said Act—(a) constitute that portion of the State comprised within the boundaries of the Hall's Creek Road District as now constituted under the Road Districts Act, 1919-1943, a vermin district to be known as the "Hall's Creek Vermin District"; and (b) appoint the Hall's Creek Road Board as constituted under the said Road Districts Act, 1919-1943, to be the board of the said Hall's Creek Vermin District.
