### PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency Sir James Mitchell,  
TO WIT. } K.C.M.G., Lieutenant-Governor in and  
JAMES MITCHELL, over the State of Western Australia  
Lieutenant-Governor. and its Dependencies in the Common-  
[L.S.] wealth of Australia.

F. & S. 343/45; Ex. Co. 1509.

WHEREAS it was enacted by section 101 of the Factories and Shops Act, 1920, and is now enacted by section 99 of the Factories and Shops Act, 1920-1937, that the Governor might and may constitute any defined portion of the State to be a shop district, and specify the boundaries of such district, and might and may abolish any such district; And whereas the Governor, by a Proclamation issued under section 101 of the said Factories and Shops Act, 1920, and published in the *Government Gazette* on the 11th day of February, 1921, constituted that portion of the State comprised within the boundaries of the Mingenew Road District to be a Shop District for the purposes of the said Act, to be known as Mingenew Shop District; And whereas it is now deemed desirable and expedient to abolish the said Mingenew Shop District and in lieu thereof to constitute two new separate and distinct Shop Districts: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by section 99 of the Factories and Shops Act, 1920-1937, do hereby abolish the Mingenew Shop District as heretofore constituted as aforesaid, and in lieu thereof do hereby constitute two new Shop Districts for the purposes of the said Act as follows, that is to say:—(a) all that portion of the State situate within the boundaries of the Three Springs Road District, and known as the Three Springs Road District, and being portion of the part of the State at present comprised in the Mingenew Shop District, shall be a Shop District to be known as the Three Springs Shop District; and (b) all that portion of the State comprised in the Mingenew Shop District as proclaimed, defined, and published in the *Government Gazette* of the 11th day of February, 1921, except that

portion of the State now comprised in the Three Springs Shop District as constituted under paragraph (a) hereof shall be a Shop District to be known as the Mingenew Shop District.

WHEREAS it is provided by the Game Act, 1912-1913, that the Governor may, by proclamation, declare from time to time that any bird or animal indigenous to Western Australia shall be at all times strictly preserved either generally throughout the State or in any one or more portions thereof, and that the Governor may in like manner exempt from the operations of any such declaration under the said Act any defined locality; and whereas by a proclamation dated the 30th day of July, 1924, it is provided that the portions of the State and localities defined in the Schedule thereto shall be a reserve for Grey Kangaroos, known scientifically as *Macropus giganteus*; and whereas it is desirable to exempt from the operations of the said proclamation a defined locality: Now, therefore I, the said Lieutenant-Governor, in exercise of the powers aforesaid, do hereby, by and with the advice and consent of the Executive Council, exempt from the operations of the aforesaid proclamation and the declaration contained therein all those localities mentioned and defined in the Schedule

hereto as from the date of the publication of this Proclamation in the *Government Gazette* until April 30, 1946.

Schedule.

All that part of the Gingin Road District lying to the west of the Midland Railway Line.

Marketing of Onions Act, 1938.

PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency Sir James Mitchell,  
TO WIT, } K.C.M.G., Lieutenant-Governor in and  
JAMES MITCHELL, } over the State of Western Australia  
Lieutenant-Governor. } and its Dependencies in the Common-  
[L.S.] } wealth of Australia.

WHEREAS it is enacted by section 4 of the Marketing of Onions Act, 1938, that the Governor may at any time, on the application of the Western Australian Onion Marketing Board, provide and declare by Proclamation that the property in all onions belonging to growers shall forthwith upon the date of publication of the Proclamation, or on or from some other date specified therein, be divested from the growers thereof and become vested in and be the absolute property of the said Board as the owner thereof, and that any onions belonging to the growers thereafter coming into existence within a time specified in the Proclamation shall become vested in and be the absolute property of the said Board, and may by such Proclamation make such further provision as will enable the Board effectively to obtain possession of such onions, and to deal with the same, as may be deemed necessary or convenient, in order to give full effect to the objects and purposes for which the Board has been constituted; and whereas the said Board has made application for the issue of a Proclamation accordingly, and it is deemed desirable and expedient that such a Proclamation shall be issued: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council, and pursuant to the application of The Western Australian Onion Marketing Board, and in exercise of the powers conferred by section 4 of the said Act, do hereby provide and declare, for the purposes of the said Act, that forthwith, upon the date of publication of this Proclamation in the *Government Gazette*, the property in all onions then belonging to growers within the meaning of the said Act shall, subject to all lawful exceptions and to any exemptions which may be lawfully granted by the said Board, be divested from the said growers thereof, and shall become vested in and be the absolute property of the said The Western Australian Onion Marketing Board as the owner thereof, and also that, subject to the exceptions and exemptions aforesaid, any onions belonging to the said growers after the date of the publication of this Proclamation in the *Government Gazette* and coming into existence within the period commencing on the said date and ending on the 30th day of November, 1946, shall, as from the time when they come into existence as aforesaid, become vested in and be the absolute property of the said Board, and that as from the date of publication of this Proclamation in the *Government Gazette*, and whilst it continues in operation, the Board may, but subject to the regulations at any time or from time to time in force, do such lawful acts and things, and take such lawful means, as the owner thereof to obtain effectively possession of the onions which by virtue of this Proclamation are the absolute property of the said Board and to deal with the same, as the Board may deem necessary or convenient, in order to give full effect to the objects and purposes for which the said Board has been constituted.

The Land Act, 1933-1939.

ORDER IN COUNCIL.

Corr. No. 6797/21.

WHEREAS by section 33 of the Land Act, 1933-1939, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient that reserve No. 17953 should vest in and be held by William James West, John Russell Flynn and Walter Hubert Manby in trust for the purpose of an Agricultural Hall Site: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserve shall vest in and be held by William James West, John Russell Flynn and Walter Hubert Manby in trust for the purpose aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

ORDER IN COUNCIL.

P.W. 1337/37.

WHEREAS section 74 of the Constitution Act, 1889, provides that the Governor in Council may vest in Heads of Departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Departments of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Department) should be vested in Redvers Harry Kitchener Hall, and that the power vested in John Malcolm Arcus should be revoked: Now, therefore, His Excellency the Lieutenant-Governor by and with the advice of the Executive Council hereby vests in Redvers Harry Kitchener Hall and any persons appointed to act temporarily in their place the appointment of foremen and all other persons employed on such works at a daily rate of wages; and doth hereby revoke the power vested in John Malcolm Arcus.

Workers' Compensation Act, 1912-1944.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1944, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may by Order in Council exempt such employer from the operation of the said section; and whereas The National Bank of Australasia, Limited, of St. George's terrace, Perth, being an employer within the meaning of section 10 of the said Act and as such subject to the provisions of the said section 10, has duly, in accordance with the regulations made under the said Act, made application for exemption from the operation of section 10 aforesaid, and has proved to the satisfaction of the Minister that it has established a fund for insurance against its said liability under the said Act, and has deposited at the Treasury securities, to wit, a bond for £5,000, charged with all payments to become due under the said liability: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, doth hereby exempt the said The National Bank of Australasia, Limited, from the operation of section 10 of the Workers' Compensation Act, 1912-1944, for a period of two years, commencing on the 1st day of January, 1946.
