WHEREAS by section 10 of the Fisheries Act, 19051940, it is provided that the Governor may, by proclamation, prohibit all persons from taking any fish whatsoever in every or any specified portion of Western Australian waters, by means of fishing nets and fishing
lines, or either of such means of capture, or by any
other specified means of capture, for any specified term:
Now, therefore I, the said Lieutenant-Governor, by and
with the advice and consent of the Executive Council,
do hereby in exercise of the powers aforesaid and of with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—That all those portions of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets as from January 1, 1946, until December 31, 1948, inclusive.

# IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No. 115 of 1945.

In the matter of an Award made on the 1st day of November, 1934, Nod. 8 of 1934, as amended by Order, Nod. 324 of 1937, between the Western Australian Government Electric Tramways, Trackless Trams and River Ferries Employees' Union of Workers, Perth, now known as the Western Australian Government Tramways, Motor Omnibuses and River Ferries Employees' Union of Workers, Perth (hereinafter referred to as "the Union"), applicant, and the Commissioner of Railways of Western Australia, respondent, and in the matter of an application by the Union for further amendment of the said Award.

HAVING heard Mr. F. E. Chamberlain on behalf of the Union and Mr. E. McKenna on behalf of the said Commissioner of Railways of Western Australia, and by consent, the Court, in pursuance of the powers contained in Section 92 of the Industrial Arbitration Act, 1912-1941 (as reprinted) doth hereby order and declare that Award, Nod. 8 of 1934, as amended by Order, Nod. 324 of 1937, be and the same is hereby further amended as follows:—

1.-Clause 12-Holidays.

Delete the whole of Item (c).

2. Add the following clause to the Award:-

# 24-Payment for Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-half (½) day for each completed month of service: Provided that payment for such absence through such ill-health shall be limited to six (6) days in each calendar year. Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) No worker shall be entitled to the benefits of this clause, unless he produces proof to the satisfaction of the Commissioner, or his representative, of sickness, but the Commissioner shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(c) No payment will be made for any absence due to a worker's own fault, neglect, or misconduct.

Between West Australian Local Governing Bodies Officers' Association Union of Workers, Perth, Applicant, and the City of Perth, Respondent.

HAVING heard Mr. T. C. Winter on behalf of the applicant and Mr. G. D. Browne on behalf of the respondent, and by consent, the Court, in pursuance of the powers contained in Section 92 of the Industrial Arbitration Act, 1912-1941 (as reprinted), doth hereby order and declare that Award, No. 3 of 1932, as amended by Order, No. 71 of 1944, be and the same is hereby further amended as follows, such amendment to take effect as from and including the 5th day of November, 1945:—

# Clause 2—Hours of Duty.

Delete the existing clause and insert in lieu thereof the following:-

"The hours of duty, except in special cases where different hours are stipulated, shall be from 8.45 a.m. to 5.21 p.m. on Mondays to Fridays inclusive, with a break of one hour for hunch which shall be taken between the hours of 12 noon and 2 p.m., provided that those officers supervising other employees of the Council whose hours of work are not identical with those of the aforesaid supervising officers shall work the same hours as the workers they are supervising, excepting that such supervising officers and all other officers mider this Award may be required to perform public duty on Saturday as may be required to the satisfaction of the Council, and provided further that all officers under this Award who may be required to perform duties on Saturday may be allowed equivalent time off during the hours prescribed for duty, excepting that it shall not interfere with their attendance at Committee or Council meetings, the attendance at which, as required by the Council, to be considered as part of their ordinary duties."
