in section 29 of the said Act, or for the like or other public purposes to be specified in such order, and with power of sub-leasing; and whereas it is deemed expedient that reserve 14584 (Manjimup Lots 153, 316 and 369) should vest in and be held by the Manjimup Road Board in trust for Recreation, Infant Health Centre, War Memorial, Road Board Buildings and Water Storage: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserve shall vest in and be held by the Manjimup Road Board in trust for Recreation, Infant Health Centre, War Memorial, Road Board Buildings, and Water Storage, with power to the said Manjimup Road Board, subject to the approval of the Governor in Executive Council being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding twenty-one (21) years from the date of the lease.

#### ORDER IN COUNCIL.

Corr. No. 1871/33.

WHEREAS by section 34 of the Land Act, 1933-1945, it is made lawful for the Governor by Order in Council, without issuing any deed of grant, to place any reserve under the control of any municipality, road board, or other person or persons, as a board of management, and to empower such board to make, repeal, and alter by-laws for the control and management of such reserves, and prescribe fees for depasturing thereon, and for other purposes, such by-laws to be approved by the Governor and published in the *Government Gazette*; and whereas it is deemed expedient that reserve 21456 for Recreation at East Witchcliffe should be placed under the control of the Augusta-Margaret River Road Board as a board of management: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby place the before-mentioned reserve under the control of the Augusta-Margaret River Road Board as a board of management, and doth empower such board to make, repeal, or alter by-laws for the control and management of the said reserve; for prescribing fees for depasturing thereon; for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

Sandalwood Act, 1929.

#### ORDER IN COUNCIL.

F.D. 1478/29.

WHEREAS under the provisions of section 2 of the Sandalwood Act, 1929, the Governor may from time to time by Order in Council limit and restrict the quantity of Sandalwood that may be pulled or removed from Crown land and alienated land during the period therein stated; and whereas it is desirable to limit and restrict the quantity of Sandalwood that may be pulled or removed from Crown land and alienated land during the period from the 1st day of July, 1946, to the 30th day of June, 1947, to 1,000 tons: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, doth hereby limit and restrict the quantity of Sandalwood that may be pulled or removed from Crown land and alienated land during the period from the 1st day of July, 1946, to the 30th day of June, 1947, to 1,000 tons, exclusive of Sandalwood required for oil distillation purposes within the State.

#### LAND AND INCOME TAX ASSESSMENT ACT, 1907-1936.

##### Land Tax—Notice to Make Returns.

NOTICE is hereby given that every person who was at noon on the 30th day of June, 1946, the owner, within the meaning of the said Act, of any land whatsoever in Western Australia and who is liable to land tax, is hereby required to make and furnish to me at the office of the Commissioner of Taxation, Perth, on or before the 31st day of August, 1946, a land tax return in the prescribed form.

A return form G.A. in lieu of return form A should be lodged by a land owner (not liable for Federal land tax) who has bought or sold land, or who has effected or varied improvements on land since 30th June, 1945. Where there have been no such changes, a further return will not be required.

Penalty for not furnishing a return—not less than £2 nor more than £100; penalty for making a false return—not less than £2 nor more than £100 and treble tax.

Taxpayers may obtain return forms at the Taxation Department, Perth, or at any Post Office in Western Australia.

We, The Honourable Sir John Patrick Dwyer, Chief Justice, The Honourable Albert Asher Wolff and The Honourable James Leonard Walker, Puisne Judges of the Supreme Court of Western Australia acting in pursuance of the powers contained in the Supreme Court Act, 1935, and of every other power enabling us in this behalf do hereby amend the Divorce and Matrimonial Causes Rules, 1909, as made by the Judges of the said Court on the 21st day of April, 1909; the 23rd day of December, 1942; the 1st day of July, 1943; the 1st day of May, 1945, and the 7th day of June, 1945, and published in the *Government Gazette* respectively on the 26th day of April, 1909; the 1st day of January, 1943; the 9th day of July, 1943; the 4th day of May, 1945, and the 15th day of June, 1945, in the manner herein-after mentioned, that is to say:—

1. Rule 1 is amended by adding at the end thereof the following paragraph:—

The petition shall set out the relief claimed, together with a reference to the particular statutory enactments under which the petitioner's claim is made and shall contain a statement in summary form of the material facts relied on, and also specify the following:—

- (a) When and where the marriage was celebrated and the age of the contracting parties if minors;
- (b) the respective domiciles of husband and wife at the time of marriage and their domicile since;
- (c) the places of residence, if any, of the parties after the marriage outside Australia and of their last matrimonial home in Australia and the relative periods therein;
- (d) the period of residence of the person seeking relief in the State where proceedings are instituted, and the places of residence during the two years preceding petition;
- (e) the date and circumstances of final cessation of co-habitation;
- (f) the children of the marriage and dates of their birth;
- (g) the grounds on which the relief claimed is sought;
- (h) particulars of any prior or current matrimonial proceedings (if any) between husband and wife and of decrees, judgments and orders made therein.

2. Rule 2 is amended by adding at the end thereof the following words:—

“And such affidavit shall negative connivance, collusion and condonation. The petitioner shall also depose therein as to the existence or otherwise of any order of any competent court or any agreement or arrangement written or oral for separation or payment of maintenance for the wife or children of the marriage and whether such payments have been duly made; and the grounds of belief in facts not in the deponent's knowledge and the facts on which domicile is alleged shall also be stated.”

This Order shall come into operation forthwith upon publication thereof in the *Government Gazette*.

venient employment of the third platoon: Now, therefore, the Court, having been advised by the parties through their respective agents that they are now in a position to employ the third platoon, the Court doth hereby order and declare that the said Order No. 157 of 1945 shall commence to operate as from the twenty-fourth (24th) day of June, 1946.

# IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No. 10 of 1946.

Between West Australian Branch Australasian Meat Industry Employees' Union Industrial Union of Workers, Perth; Coastal District Committee Amalgamated Engineering Union Association of Workers; The Metropolitan and South-Western Federated Engine Drivers and Firemen's Union of Workers of Western Australia; Federated Coopers of Australia W.A. Branch Industrial Union of Workers; and Australian Workers' Union, Westralian Branch, Industrial Union of Workers (hereinafter known as "the Unions"), Applicants, and The Wyndham Freezing, Canning, and Meat Export Works (hereinafter known as "the Management"), Respondents.

The Court of Arbitration of Western Australia doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties:—

## AWARD.

1. This Award shall apply in respect of the rates of wages and conditions of labour in connection with the tasks hereinafter mentioned at the Wyndham Meatworks.

## Definitions.

2. In this Award, unless the context otherwise indicates, the following terms have the meanings respectively set out against them, that is to say:—

(a) "Week-days"—Mondays, Tuesdays, Wednesdays, Thursdays, and Fridays.

(b) "A Week" shall mean Monday to Saturday, inclusive.

(c) "A day's work" shall mean eight hours on week days and four hours on Saturdays.

(d) "Shift work" shall mean work done in time preceding, during, and following ordinary working hours by separate relays of employees.

(e) "Mutually agreed" or "mutual arrangement" implies agreed between the Management of the Works and the Union or its representatives, in writing.

## I.—GENERAL CONDITIONS.

3. Clauses under this heading are to be operative except where otherwise provided herein.

4. Any worker carrying out work classified at a higher rate than the rate pertaining to his recognised task shall be paid for that day at the highest rated of such tasks.

5. Wages shall be paid fortnightly in cash.

6. Day wage employees shall be paid in the Management's time, and contract and tally men within reasonable time after ceasing work.

7. The Management shall give the delegate reasonable notice of workers required to work overtime. The delegate shall then be responsible on behalf of the Union for supplying such workers. The Management shall give due regard to distribution of overtime.

8. The employment and rates of pay of boys shall be a matter for mutual arrangement.

9. Employees shall be provided, without charge, with accommodation in the quarters erected for that purpose, including stretcher, mattress, and pillow.

10. Each employee who boards at the Works canteen shall have the amount of 25s. per week deducted from his wages fortnightly.

11. When employees under this Award are temporarily required to work away from the Works (outside of a two-mile radius) they shall be paid a victualling allowance of six shillings (6s.) per day, provided it be found inconvenient to send a cook out with such employees.

12. All delegates shall be officially recognised by the Management.

13. Being responsible for the quality and condition of products, foremen may attend personally to such of the operations as they may consider necessary to insure satisfactory results. Such operations include the making-up and attention to cold and hot pickles; the pumping and filterpressing of soups, and the finishing off of extracts; the setting and supervision of tinshop dies; the refining and weighing of tallow and edible fats and other processes of a like nature.

14. Shifts of eight hours may be worked in departments where operations are continuous or where they require attention for more than twelve hours in the twenty-four.

15. Except as provided in this clause and clause 108, shift workers shall be entitled to the prescribed overtime rates for work done during Sundays, holidays, meal times or smokos. Notwithstanding the provisions of clauses 23 and 24, shift workers shall only be entitled to rate and a half for any time worked in excess of eight hours per shift, but in any case where such excess is caused through sickness, non-arrival or late arrival of relieving shiftmen or in connection with the change over or rotation of shifts, ordinary rates shall apply.

16. (a) For the purpose of convenience, the wages in certain sections are set forth on a weekly basis, but subject to the provisions of clauses 34, 38, 40 and 105, if for any reason whatever during any portion of the working hours of any week, no work is available or performed, the employee shall only be paid for the time or tally actually worked at the rates of pay as herein prescribed, apportioned to the time or tally actually worked during the week; and

(b) Notwithstanding that the rates of pay in certain sections are set forth on a weekly basis, there shall be no obligation on the part of the Management or the employees to give a week's or any other notice to determine the employment, the position being in respect the same as if the employee were employed at a daily wage; but subject to paragraph (c) of clause 19, nothing in this paragraph shall affect the right of an employee under clause 38 (relating to guaranteed service) or under clause 40 (relating to waiting time).

## Preference.

17. Subject to clause 18, preference of employment in respect of tasks for which rates of wages are specified in this Award shall be given to members of the Unions who are parties to this Award, provided they are competent and qualified workmen, and do their work to the satisfaction of the Management. The Management may require a medical certificate of fitness in respect of any applicant for employment. The cost of obtaining such certificate to be borne by the Management.

18. With respect to the employment of watch-keeping engineers, the Management reserves the right to employ members of any union or organisation who are qualified to perform the duties of watchkeeping engineers.

19. Subject to preference to members of the Unions who are parties to this Award, the Management shall have the right—

(a) to select employees with due regard to their qualifications for their respective tasks;

(b) to allot to employees their respective tasks;

(c) to dispense with the services of any employee for incompetence, drunkenness, misconduct, or unsatisfactory work.

Employees shall be selected from the lists supplied by the Unions that are parties to this Award.

## Transfer.

20. The Management may transfer employees from one department to another. In this case the rates payable shall be those specified for the task performed. In the case of alleged unreasonableness, the local Joint Board of Unions can discuss with the Management.

## Hours of Labour.

21. Excepting as provided in clauses 75, 86 and 87, or unless otherwise specifically mentioned, forty-four (44) hours shall constitute a week's work, divided into six (6) working days, as follows:—

5 week-days, each eight (8) hours—40 hours.

Saturday, four (4) hours—total, 44 hours.

22. Except as provided in clauses 2 (d), 14, 48, 75, 76, 87, 108, 113, and 115, or otherwise mutually agreed, ordinary starting time shall be 7.30 a.m. and ordinary ceasing time 4.30 p.m. on week-days, and 11.30 a.m. on Saturdays.

22A. In the event of the Court of Arbitration of Western Australia delivering a decision reducing the standard hours to be worked by industry in Western Australia, liberty is reserved to any party bound by this Award to apply for an amendment of clauses 14, 15, 21, 22, 25, 26, 27, 29, 48, 76, 77, 86, 87, 108, 111, 113, 114, 115 and 118 hereof.

23. Except where otherwise provided herein, "ordinary working hours" shall comprise the hours between the ordinary starting time on any day and the ordinary ceasing time, excepting meal times and smokos.

24. Except as provided in clauses 2 (d), 14, and 108, "outside ordinary working hours" on any day means between midnight and ordinary starting time, and (or) between ordinary ceasing time and midnight, also meal hours and smokos.

#### Meal Times.

25. Except as provided in clauses 48, 75, 77, 87, 114 and 115, or otherwise mutually agreed, meal times shall be—

6.30 a.m. to 7.30 a.m.  
11.30 a.m. to 12.30 p.m.  
4.30 p.m. to 5.30 p.m.  
11.30 p.m. to 12.30 a.m.

This clause shall not apply to engine and boiler room shift workers.

#### Smokos.

26. Except as provided in clauses 27, 75, 87 and 118, or otherwise mutually agreed, smokos of fifteen minutes each shall be allowed and paid for as working time, as follows:—

9.30 a.m. to 9.45 a.m.  
2.30 p.m. to 2.45 p.m.

and one smoko after every two hours' continuous work done outside ordinary working hours.

This clause shall not apply to engine and boiler room shift workers.

27. For employees when loading out frozen beef the smokos shall, unless otherwise mutually agreed, be—

9.30 a.m. to 9.50 a.m.  
2.0 p.m. to 2.20 p.m.  
7.30 p.m. to 7.50 p.m.  
9.45 p.m. to 10.5 p.m.  
2.15 a.m. to 2.35 a.m.  
4.45 a.m. to 5.5 a.m.

28. When reasonably required by the Management, owing to exigencies of work, employees shall forego their smoko until a convenient time.

#### Cribs.

29. (a) Employees engaged on loading and discharging steamers will be supplied with cribs, as follows:—

One crib at second smoko after commencing work after tea.

One crib at second smoko after commencing work at 12.30 a.m.

(b) Shift workers engaged on 4 p.m. to midnight and midnight to 8 a.m. shifts will be supplied with one crib during their shift.

#### Overtime Rates.

30. Except as provided in clauses 15, 57 (b), 75, 84 (b), 89, 92, 96 (b), 104, 108, and 11, overtime rates shall be paid in respect of all work done—

(a) After ordinary ceasing time (clause 22) and up to ordinary starting time (clause 22), rate and a half: Provided that in case of "shift work" outside of ordinary working hours, ordinary rates and conditions shall apply.

(b) During meal hours and smokos, except as provided in clauses 31, 75, 107, 116, 120, and 128, double ordinary rates.

31. Provided that ordinary rates and conditions shall apply during ordinary working hours, and rate and a half for one hour or portion thereof before ordinary starting time or for one hour or portion thereof after

ordinary ceasing time, to men doing preparatory or finishing work in preserving, cook-room, cellar men handling meats for canning purposes in any place set aside for curing purposes, open air boners, retort and traymen, chillroom men, and other work of a like nature. Employees doing preparatory and/or finishing work shall be provided with a minimum period of one half hour's work or shall be entitled to payment for such.

#### Sunday and Holiday Work.

32. Except as provided in clauses 14, 75, 86, 108, and 126, or otherwise mutually agreed, employees called out to work on Sundays and holidays shall be provided with a minimum of 4 hours' work at holiday rates or shall be entitled to payment for such.

#### Minimum of Overtime.

33. Except as provided in clause 32, and subject to any mutual arrangement, employees called back to work after the meal time following ordinary ceasing time shall be provided with a minimum period of two hours' work, or shall be entitled to payment for such.

#### Holidays and Holiday Rates.

34. The following days shall, except as provided in clause 75, be paid holidays—

Good Friday,  
Labour Day,  
Wyndham Cup Day,  
Christmas Day,  
Boxing Day, and  
New Year's Day.

Work performed on these days and on Sundays shall, except as provided in clauses 75, 88, 108, and 111, be paid for at double ordinary rates.

Paid holiday rates shall be at the rate pertaining to each employee's task.

In the event of the Court of Arbitration of Western Australia delivering a decision increasing the standard holidays to be granted by industry in Western Australia, liberty is reserved to any party bound by this Award to apply for an amendment of this clause.

#### Annual Leave.

35. (a) Period of Annual Leave.—A worker after 12 months' continuous service (less the period of annual leave) shall be entitled to two weeks' leave on full pay.

(b) Annual Leave, exclusive of Public Holidays.—The annual leave prescribed by this clause shall be exclusive of any of the holidays prescribed by clause 34 of the Award, and if any such holiday falls within an employee's period of annual leave and is observed on a day which, in the case of that employee, would have been an ordinary working day, there shall be added to that period one day for each such holiday falling as aforesaid.

(c) Proportion of Annual Leave.—All workers, other than casuals, who have not served the full calendar year, shall be entitled to the same proportion of holiday leave or payment in lieu thereof as their length of service is to the full period of leave for the twelve months.

(d) Time of Taking Leave.—At least one week's notice shall be given to the worker prior to his going on his annual leave as mentioned in subclause (a) hereof: Provided, however, that when the employer or his representative and the worker so agree, a shorter notice will be sufficient.

(e) Calculation of Service.—(i) Subject to paragraph (ii) hereof, approved periods of absence from work owing to special necessity or owing to sickness in excess of that allowed under clause 35A shall not be considered breaks in continuity of service, but such periods shall not count as service for the purpose of computing annual leave.

(ii) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first month only of any such period shall count as service for the purpose of computing annual leave.

(f) Payment for Period of Leave.—Each employee, before going on leave, shall be paid such wages in respect of the whole of the period of leave to which he is entitled under this clause. Wages shall be at the rate prescribed by this Award for the occupation in which the employee

was ordinarily employed immediately prior to the commencement of his leave, or the termination of his employment, as the case may be.

(g) Commencement of Leave Rights.—Annual leave rights under this clause shall commence to accrue as from the 1st day of February, 1946.

(h) Liberty to Apply.—In the event of the Court of Arbitration of Western Australia delivering a decision increasing the standard holidays to be granted by industry in Western Australia, liberty is reserved to any party bound by this Award to apply for an amendment of this clause.

#### Absence through Sickness.

35A. (a) (i) A worker shall be entitled to payment for non-attendance on the grounds of personal ill-health for one-half ( $\frac{1}{2}$ ) day for each completed month of service.

(ii) The liability of the employer shall in no case exceed one (1) week's wages during each calendar year in respect of each worker.

(iii) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(b) The clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act, 1912-1944.

(c) No worker shall be entitled to the benefit of this clause unless he produces proof satisfactory to his employer or his representative of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three consecutive working days or more.

(d) No payment shall be made for any absence due to the worker's own fault, neglect or misconduct.

#### Travelling.

36. Each employee (excepting those engaged at Wyndham) shall be entitled to—

(a) Passage from place of engagement to Wyndham and travelling time allowance.

(b) Passage (and travelling time allowance) by first available steamer from Wyndham to place of engagement after termination of work in his department, or when his services are not further required by the Management; provided that his duties have been performed to the satisfaction of the Management.

37. Travelling time allowance referred to in clause 36 shall be at the rate of 7s. 6d. per day, and shall accrue from day of embarkation to day of landing, both inclusive.

#### Guarantee.

38. (a) Subject to clause 19 (c), a guarantee of 16 weeks' work from date of commencement of slaughtering is given to each employee brought from Perth or Fremantle. The rates applicable under this guarantee shall be the rates for the respective tasks allotted.

(b) Every employee shall be engaged on the express condition that he will perform at least 16 weeks' work from such date of commencement, and at the rates for the respective tasks allotted to him, and will continue to work for such additional period as in the opinion of the Management is necessary to fulfil the season's operations.

39. The date of commencement of slaughtering shall be determined by the Management, but one clear day (not including the day of arrival) shall elapse between the date of arrival of seasonal operatives and the date of commencement of slaughtering operations.

Waiting time allowance defined in clause 40 shall not be payable on the day of arrival or the day after arrival of seasonal operatives.

All employees, including seasonal operatives, shall, if so required by the Management, do any work other than slaughtering available between the date of arrival of seasonal operatives and the date fixed for the commencement of slaughtering under this clause. Work performed shall be paid for at the rate pertaining to the task performed.

For the purpose of this clause, seasonal operatives shall be defined as those Australasian Meat Industry employees who customarily reach Wyndham by the vessel immediately preceding the commencement of operations.

#### Waiting Time Allowances.

40. When owing to completion or interruption or reduction of all or any of the operations from any cause beyond the control of the Management, no employment is available for any employee who has been brought from Perth or Fremantle, such employee shall be paid a waiting time allowance for each ordinary working day (excluding Sundays and holidays) as follows:—

(a) Day Wage Employees.—Ordinary working hours for the day at half their respective task rates.

(b) Contract Slaughtermen.—Half the minimum payment prescribed in clause 52 (b).

(c) Slaughterhouse Assistants.—Half the minimum rates prescribed in clause 61.

41. When no employment is available for an employee at his usual task, such employee shall, if so required by the Management, do any other work available and be paid the rate pertaining to his recognised task.

42. When an employee who is receiving Waiting Time Allowance is required to work "outside of ordinary working hours" (clause 24), he shall be paid (in addition to waiting time allowance) the overtime rates applicable to the work done.

#### Basic Wage Adjustment.

43. All wages in this Award are calculated on a basic wage of £4 7s. per week for males and £2 7s. per week for females.

#### Disputes.

44. Should any dispute arise as to the construction or meaning of this Award, or touching anything arising out of its operation, the work is nevertheless to be carried on without any interruption, and the matter in dispute shall be submitted to a conference between the Management and representatives of the Union concerned, such conference to be held at the Meatworks as soon as can be arranged.

45. Should no settlement be arrived at by the above conference, the matter in dispute shall then be discussed between the Management and the local Joint Board of the Unions.

46. In the event of a settlement not being arrived at by discussion (referred to in Clause 45) the matter in dispute shall be submitted to the arbitration of an umpire at Wyndham, to be chosen by one representative appointed for that purpose by the Management, and one representative appointed for that purpose by the Unions who are parties to this Award, and the decision of such umpire shall be final and conclusive. The umpire may determine by whom the costs of the arbitration shall be paid and may fix such costs.

47. In the event of the representatives referred to in clause 46 failing to agree on an umpire, the matter in dispute shall be referred to a Board of Reference consisting of the Industrial Registrar of the Court of Arbitration of Western Australia as chairman, and two representatives, one to be nominated by each of the parties.

## II.—BEEF SLAUGHTERING DEPARTMENT.

48. Unless otherwise mutually agreed, slaughtering shall commence at 6.50 a.m. on week days and Saturdays, resuming after lunch on week days at 11.50 a.m.

50. Work to be performed by slaughtermen in dressing of freezing cattle shall be—Knocking down, sticking, footing off, grounding, backing off, taking out offal, sawing down, dropping hides, finishing off and wiping up.

51. The slaughtering gang shall, if so required by the Management, slaughter up to—

- 55 cattle per slaughterman per day on week days, and  
30 cattle per slaughterman on Saturdays.

#### Minimum Pay to Slaughtering Gang.

52. On days on which killing is done, the Management shall provide the minimum numbers of cattle indicated hereunder, namely:—

(a) During the period of guarantee—40 cattle per slaughterman on week-days; 20 cattle per slaughterman on Saturdays.

(b) After expiry of guarantee—30 cattle per slaughterman on week-days; 17 cattle per slaughterman on Saturdays,

or shall pay the slaughtering gang as for such numbers.

53. Three calves shall be reckoned as two cattle. Actual works grading shall determine the definition of "calf."

#### Beef Slaughterhouse Assistants.

55. Subject to the provisions of clauses 59 to 61 as to the minimum wages per day, and subject also to clauses 30, 34, and 35 as to the overtime and holiday rates, beef slaughterhouse assistants shall be paid on tally rates based upon the numbers of cattle treated per slaughterman (*i.e.*, grounders and backers of the contract gang).

56. The tally rates specified hereunder are at per head of cattle treated per contract slaughterman, and relate to work done in ordinary working hours.

#### Tally Rates.

57. (a) Tally rates in respect of all cattle treated up to and including—

Thirty cattle per slaughterman on a week day, and/or seventeen cattle per slaughterman on a Saturday—

58. Beef slaughterhouse assistants cutting up condemned bodies shall be paid at the rate of 1s. per body, such payment to be divided equally between the number of assistants so engaged.

#### Minimum Daily Wage for Slaughterhouse Assistants.

59. When for any day on which killing is done, and on which the minimum number of cattle is not available and the wages earned by a beef slaughterhouse assistant at the tally rates specified in clause 57 are less than the minimum daily wages specified in the following tables, the respective minimum rates shall apply to that day's work. These minimum rates shall be proportionately increased for work done outside of ordinary working hours or on holidays, as per clauses 30, 34 and 35.
