WHEREAS by paragraph (c) of subsection (2) of section 3 of Part VIA of the Police Act, 1892-1945 (as inserted by the Police Offences (Drugs) Act, 1928), it is provided that if it appears to the Governor that any new derivative of morphine or cocaine or of any salts of morphine or cocaine or any other alkaloid of opium or any other drug of whatever kind is or is likely to be productive, if improperly used, of ill-effects sub-

stantially of the same character or nature as or analogous to those produced by morphine or cocaine, the Governor may by proclamation published in the *Government Gazette* declare that Part VIA of the said Act shall apply to that new derivative or alkaloid or other drug in the same manner as it applies to the drugs mentioned in paragraph (a) of subsection (2) of section 3 of Part VIA of the said Act; and whereas it appears to the Governor that the drug isonipeccaine, identified chemically as hydrochloride of 1-methyl-4-phenyl-piperidine-4-carboxylic acid ethyl ester (also known as "Dolantin," "Demerol" and "Pethidine"), is or is likely to be productive, if improperly used, of ill-effects substantially of the same character or nature as or analogous to those produced by morphine: Now therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred on me by paragraph (c) of subsection (2) of section 3 of Part VIA of the said Act, hereby declare that Part VIA of the said Act shall apply to the drug isonipeccaine, identified chemically as hydrochloride of 1-methyl-4-phenyl-piperidine-4-carboxylic acid ethyl ester (also known as "Dolantin," "Demerol" and "Pethidine") in the same manner as Part VIA of the said Act applies to the drugs mentioned in paragraph (a) of subsection (2) of section 3 of Part VIA of the said Act.

WHEREAS it is enacted by section 4 of the Vermin Act, 1918-1942, that "vermin" means and includes any animal, bird, or insect mentioned in the Third Schedule to the said Act and such other animals, birds or insects the names of which the Governor may by proclamation add to the said Schedule; and that any proclamation whereby the names of other animals, birds or insects are added to the said Schedule may be restricted in its operation to any portion of the State to be defined by the proclamation; and whereas by proclamation published in the *Government Gazette* on the 13th day of October, 1944, the name of the animal or bird known as "Emu" was added to the said Schedule and it was declared that the said proclamation should operate and have effect generally throughout the State; and whereas by a further proclamation published in the *Government Gazette* on the 9th day of August, 1946, it was declared that the proclamation published in the *Government Gazette* on the 13th day of October, 1944, should be restricted in its operation to all those portions of the State which are not within the boundaries of the Vermin Districts specified therein; and whereas it is expedient to vary the said proclamation by adding to the Vermin Districts specified therein the name of the Augusta-Margaret River Vermin District: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act and of all other powers herein in that behalf enabling do hereby vary the said proclamation published in the *Government Gazette* on the 9th day of August, 1946, by adding to the Vermin Districts specified therein the name of the Augusta-Margaret River Vermin District and the said proclamation shall be read and construed accordingly.

ORDER IN COUNCIL.

WHEREAS by section 34 of the Land Act, 1933-1945, it is made lawful for the Governor, by Order in Council, without issuing any deed of grant, to place any reserve under the control of any municipality, road board, or other person or persons, as a board of Management, and to empower such board to make, repeal, and alter by-laws for the control and management of such reserves, and prescribe fees for depasturing thereon, and for other purposes, such by-laws to be approved by the Governor and published in the *Government Gazette*; and whereas it is deemed expedient that reserve 22591 for Recreation at Northampton should be placed under the control of the Northampton Road Board as a Board of Management: Now, therefore, His Excellency the Governor, by

and with the advice and consent of the Executive Council, doth hereby place the before-mentioned reserve under the control of the Northampton Road Board as a board of management, and doth empower such board to make, repeal, or alter by-laws for the control and management of the said reserve; for prescribing fees for depasturing thereon; for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

ELECTORAL ACT, 1907-1940.
