WHEREAS by section 9 of the Fisheries Act, 1905-1940, it is provided that the Governor may, by Proclamation, prohibit all persons from taking fish of any specified species, by any specified means of capture for any specified term: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council do hereby in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—

That all that portion of Western Australian waters defined in the Schedule hereto shall be closed against the use of prawn nets, other than dip nets held in the hand and prawn nets operated by wading, for a term of three years as from December 15, 1946 until December 15, 1949.

#### Schedule.

All that portion of Peel Inlet and the estuaries of the Murray River comprised within the area bounded by lines starting from the North-Eastern corner of Murray Location 393, and extending generally South-Westerly along boundaries of locations 393, 207 and 206 to a South-Western corner of the last-mentioned location

opposite Goongoolup Island; thence South about 7 chains to the shore of Peel Inlet; thence West about 35 chains; thence North to the common boundary of the Murray and Cockburn Sound Land Districts; thence generally South-Easterly along the said boundary to a point situate in prolongation Northerly of the Eastern boundary of location 393 aforesaid; and thence South-erly to the starting point. (Plan 380A/40, B2.)

That all those portions of Western Australian waters defined in the Schedule hereto shall be closed against

the use of fishing nets for a period of three years as from the 1st day of January, 1947.

#### Schedule.

Eyre River—The whole of the waters of the Eyre River and its tributaries from its entrance into the Southern Ocean upwards to its source.

WHEREAS by section 10 of the Fisheries Act, 1905-1940, it is provided that the Governor may by Proclamation prohibit all persons from taking any fish whatsoever (by means of fishing nets) in any specified portion of Western Australian waters for any specified term: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the power aforesaid and of any other power enabling me in this behalf proclaim and declare as follows:—

That all that portion of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets for a term of three (3) years as from and inclusive of December 1, 1946.

The Proclamation dated February 6, 1946, published in the *Government Gazette* on February 15, 1946, is hereby cancelled.

#### Schedule.

All that portion of the Moore River between its junction with the sea and Boobabbie Bridge situate approximately eight (8) miles by water from the mouth of the said river.

#### PROCLAMATION

WESTERN AUSTRALIA, { By His Excellency Sir James Mitchell,  
TO WIT. } K.C.M.G., Lieutenant-Governor in and  
JAMES MITCHELL, over the State of Western Australia  
Lieutenant-Governor, and its Dependencies in the Common-  
[L.S.] wealth of Australia.

WHEREAS it is enacted by section 3 of the Abattoirs Act, 1909-1941, that the said Act shall be in force only in such portions of the State as the Governor may from time to time by Proclamation declare to be districts for the purposes of the said Act and that the Governor may, by Proclamation, suspend the operation of the said Act in any district; and whereas it is deemed expedient that the said Act shall be in force in that portion of the State hereinafter described but that the operation of the said Act should be suspended until the first day of April, 1947: Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the power conferred by section 3 of the said Act do hereby declare that all that portion of the State in and around the town of Albany comprised within the circumference of an imaginary circle having a radius of 25 miles from the Post Office in Albany aforesaid as the centre thereof shall be and is hereby constituted a district within the meaning and for the purposes of the Abattoirs Act, 1909-1941, with the intent that the said Act shall be

in force in such district, but that the operation of the said Act shall be suspended until the first day of April, 1947, on which date the said Act shall come into operation in such district.

WHEREAS by section 33 of the Land Act, 1933-1945, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient that reserve No. 8096 should vest in and be held by the Port Hedland Road Board in trust for the purpose of Mechanics' Institute: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned Reserve shall vest in and be held by the Port Hedland Road Board in trust for the purpose aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

#### ORDER IN COUNCIL.

Corr. No. 7134/03.

WHEREAS by section 33 of the Land Act, 1933-1945, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order, and with power of subleasing; and whereas it is deemed expedient that reserve "A" 8800 (Goomalling Lot 9) should vest in and be held by the Goomalling Road Board in trust for a Park and Rest Room: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserve shall vest in and be held by the Goomalling Road Board in trust for a Park and Rest Room with power to the said Goomalling Road Board, subject to the approval of the Governor being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding forty (40) years from the date of the lease.

The previous Order in Council dated the 2nd May, 1946, respecting this reserve is hereby superseded.

#### ORDER IN COUNCIL.

M.W.S. 310/46.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works and Stormwater Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by

the Governor-in-Council: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.

Subiaco and Leederville Districts.

Division of Main Gravitation Sewer—Section 1, Pumping Station and Rising Main from Lake Monger to the Subiaco Main Sewer.

Proposed pumping station, comprising underground concrete tanks, with brick and tile superstructure, electric pumps and all apparatus connected therewith; 30 inch diameter reinforced concrete rising main from pumping station to Subiaco Main Sewer; 30 inch diameter pipe connection to pumping station; and 30 inch diameter pipe overflow to Lake Monger, as shown in blue on Plan M.W.S.S. and D.D., W.A. No. 6850.

This Order in Council shall take effect from the 20th day of December, 1946.

## Amendment of Model By-laws Series A.

HIS Excellency the Lieutenant-Governor in Council acting pursuant to section 321 of the Health Act, 1911-1944, has been pleased to amend the Model By-laws Series A as prepared under the said Act and reprinted with amendments to date in the *Government Gazette* on the 4th day of December, 1944, and further amended by amendments published in the *Government Gazette* on the 26th day of January, 1945, and the 30th day of November, 1945, in the manner mentioned in the Schedule hereunder.

## Schedule.

The above-mentioned Model By-laws Series A are amended as follows:—

A new section is added to Part IX. after section S as follows:—

## Section T.—Knackeries.

1. For the purpose of this section of these by-laws the term “knackery” shall include any premises or portion thereof on which equine stock is slaughtered or held for slaughter, but shall not include any reserve or portion thereof used for zoological purposes.

2. No premises shall be registered as a knackery unless every portion of such knackery is at least 100 feet distant from any street or thoroughfare and at least 200 feet distant from any dwelling house or dairy or other premises wherein food is prepared for sale.

3. Every occupier of a knackery shall cause sufficient means of ventilation to be provided in, or in connection with the premises, and shall keep such at all times in proper order and efficient action, so that the ventilation shall be by direct communication with the external air.

4. The occupier of a knackery shall provide a killing pen in which all slaughtering shall be conducted, and such pen shall comply with the following conditions:—

(a) The floor shall be constructed of concrete not less than 9 inches in thickness trowelled to a smooth surface, with a fall to a surface gutter in such manner that all liquids falling on such floor shall be conducted by such gutter to a drain inlet situated outside the building. Suitable provision for the final disposal of such liquids shall be made to the satisfaction of the inspector.

(b) It shall have a floor area of not less than 150 square feet.

(c) The walls shall be not less than 10 feet in height, constructed of brick or concrete, with the inner face rendered in cement and trowelled to a smooth surface.

(d) The roof shall be of galvanised corrugated iron provided with guttering and downpipes and provision shall be made to carry storm water clear of the building.

5. Fly Proofing—When required to do so by an Inspector the occupier shall provide self-closing fly-proof doors and cover all external openings in the killing pen with fly-proof gauze wire.

6. No person shall use a vehicle for the transport of horseflesh unless such vehicle conforms with the following conditions:—

(i) The vehicle shall be completely enclosed so as to protect the horseflesh from flies.

(ii) The vehicle shall be constructed of wood or metal and all internal surfaces shall be finished to a smooth face.

7. No person shall use for the transport of food intended for human consumption any vehicle which is used for the transport of horseflesh.

8. The occupier of a knackery shall provide an incinerator, plans and specifications of which shall be submitted to and approved of by the Commissioner, in which all inedible offal and refuse shall be treated so as to render it innocuous, inoffensive and non-injurious to health.

9. Water Supply—The occupier of a knackery shall provide a wholesome water supply to the satisfaction of the local authority.

10. The occupier of a knackery shall not slaughter any equine stock at any time on a Sunday or on any other day except between the hours of 8 a.m. and 5 p.m.

#### BUSH FIRES ACT, 1937-1945.

By-laws of the Nungarin Road Board relating to the establishment, maintenance and equipment of Bush Fire Brigades for the Road District of Nungarin.

##### Establishment of Brigade.

1. On the resolution of the Board to establish, maintain and equip a Bush Fire Brigade under the provisions of the Bush Fires Act, 1937-1945, and regulations thereunder, the Brigade shall be formed in accordance with these by-laws; and a name shall be given to the Brigade and application accompanied by a copy of these by-laws shall be made to the Minister for Lands for its registration accordingly.

A bush fire brigade may be established for the whole of the road district or for any specified area thereof. Provided that, unless the resolution of the Board establishing a bush fire brigade specifies therein only a part of the district as the area for which such brigade is established, the brigade shall be deemed to be established for the whole of the said road district.

##### Appointment of Officers.

2. The Board shall appoint a captain, a first lieutenant, a second lieutenant and such additional lieutenants as it shall deem necessary to act as officers of the Brigade, and who, in the Board's opinion, have the necessary qualification and knowledge of the district required in such capacities.

3. The secretary of the Board or such other person as the Board may appoint, shall be the secretary of the Brigade.

4. The Board may appoint an equipment officer who shall be responsible for the custody and maintenance in good order and condition of all equipment and appliances acquired by the Board for the purposes of the Brigade. Such officer may station such equipment at a

depot approved by the captain where, if possible, motor trucks can easily be called upon. If there are more than one such depots in the area, the equipment officer shall appoint at each depot a person to look after the equipment and have it ready for immediate use when required.

5. The Board shall appoint bush fire control officers in accordance with the requirements of the district and may prescribe the area over which each such officer shall have jurisdiction. The employment, dismissal and payment for services of persons (other than officers) employed for duties under this Act, shall be vested in the chairman and secretary of the Board conjointly.

##### Duties of Officers.

6. The duties of all officers appointed under these by-laws shall be as laid down in the provisions of the Bush Fires Act, 1937-1945, and each officer so appointed shall be supplied with a copy of the Act and Regulations. The captain shall have full control over the members of the Brigade whilst engaged in fire fighting and shall issue instructions as to the methods to be adopted by the fireman. In the absence of the captain, the first lieutenant; and in the absence of the first, the second lieutenant or senior officer of the Brigade present at the fire shall exercise all the power and duties of the captain. The captain shall when so directed by the Board instruct all land owners or occupiers to plough a break or breaks on all cleared land or land under pasture.

##### Membership of Brigade.

7. (1) The membership of a bush fire brigade may consist of the following:—(a) subscribing members; (b) fire fighting members; and (c) associate members.

(2) Subscribing members shall be those persons, who, being interested in forwarding the objects of the Brigade, pay an annual subscription to the funds of the Brigade at the following rates:—

(i) owner or occupier of land within the Brigade area—minimum subscription of .. .. .	10	0
(ii) other persons—a minimum subscription of .. .. .	5	0

(3) Fire fighting members shall be those persons, being able-bodied men over 18 years of age who are willing to render service at any bush fire when called upon, and who sign an undertaking in the form contained in the First Schedule to these by-laws.

(4) Associate members shall be those persons who are willing to supply free motor transport for fire fighters or equipment, or are prepared to render other approved assistance, and who sign an undertaking in the form contained in the Second Schedule to these by-laws.

(5) No fees or subscriptions shall be payable either by fire fighting members or associate members, and the enrolment of persons as such members shall in every case be subject to the approval of the Board.

(6) A subscribing member shall be eligible for enrolment as a fire fighting member.

##### Finance.

8. The expenditure incurred by the Board in the purchase of equipment, etc., payment for services and generally for the purposes of this Act, shall be a charge on the ordinary revenue of the Board, but the secretary shall keep a separate record of the expenditure incurred under this Act.

9. Meetings of Brigade—As considered necessary.

These by-laws under the Bush Fires Act, 1937-1945, were passed by a resolution of the Nungarin Road Board (a local authority under the provisions of such Act) at a meeting held at Nungarin on 12th November, 1946.

Brigade and application accompanied by a copy of these by-laws shall be made to the Minister for Lands for its registration accordingly.

A bush fire brigade may be established for the whole of the road district or for any specified area thereof. Provided that, unless the resolution of the Board establishing a bush fire brigade specifies therein only a part of the district as the area for which such brigade is established, the brigade shall be deemed to be established for the whole of the said road district.

## Appointment of Officers.

2. The Board shall appoint a captain, a first lieutenant, a second lieutenant and such additional lieutenants as it shall deem necessary to act as officers of the Brigade, and who, in the Board's opinion, have the necessary qualification and knowledge of the district required in such capacities.

3. The secretary of the Board or such other person as the Board may appoint, shall be the secretary of the Brigade.

4. The Board may appoint an equipment officer who shall be responsible for the custody and maintenance in good order and condition of all equipment and appliances acquired by the Board for the purposes of the Brigade. Such officer may station such equipment at a depot approved by the captain where, if possible, motor trucks can easily be called upon. If there are more than one such depots in the area, the equipment officer shall appoint at each depot a person to look after the equipment and have it ready for immediate use when required.

5. The Board shall appoint bush fire control officers in accordance with the requirements of the district and may prescribe the area over which each such officer shall have jurisdiction. The employment, dismissal and payment for services of persons (other than officers) employed for duties under this Act, shall be vested in the chairman and secretary of the Board conjointly.

## Duties of Officers.

6. The duties of all officers appointed under these by-laws shall be as laid down in the provisions of the Bush Fires Act, 1937-1945, and each officer so appointed shall be supplied with a copy of the Act and Regulations. The captain shall have full control over the members of the Brigade whilst engaged in fire fighting and shall issue instructions as to the methods to be adopted by the firemen. In the absence of the captain, the first lieutenant; and in the absence of the first, the second lieutenant or senior officer of the Brigade present at the fire shall exercise all the power and duties of the captain. The captain shall when so directed by the Board instruct all land owners or occupiers to plough a break or breaks on all cleared land or land under pasture.

## Membership of Brigade.

7. (1) The membership of a bush fire brigade may consist of the following:—(a) subscribing members; (b) fire fighting members; and (c) associate members.

(2) Subscribing members shall be those persons, who, being interested in forwarding the objects of the Brigade, pay an annual subscription to the funds of the Brigade at the following rates:—

(3) Fire fighting members shall be those persons, being able-bodied men over 18 years of age who are willing to render service at any bush fire when called upon, and who sign an undertaking in the form contained in the First Schedule to these by-laws.

(4) Associate members shall be those persons who are willing to supply free motor transport for fire fighters or equipment, or are prepared to render other approved assistance, and who sign an undertaking in the form contained in the Second Schedule to these by-laws.

(5) No fees or subscriptions shall be payable either by fire fighting members or associate members, and the enrolment of persons as such members shall in every case be subject to the approval of the Board.

(6) A subscribing member shall be eligible for enrolment as a fire fighting member.

#### Finance.

8. The expenditure incurred by the Board in the purchase of equipment, etc., payment for services and generally for the purposes of this Act, shall be a charge on the ordinary revenue of the Board, but the secretary shall keep a separate record of the expenditure incurred under this Act.

#### 9. Meetings of Brigade—As considered necessary.

These by-laws under the Bush Fires Act, 1937-1945, were passed by a resolution of the Mount Marshall Road Board (a local authority under the provisions of such Act) at a meeting held at Bencubbin on 9th November, 1946.

- (a) by deleting the word "six" in paragraph (ii) of clause (f) and inserting the words "three" in lieu thereof;

UNIVERSITY OF WESTERN AUSTRALIA ACT,  
1911-1944.

Amendments to Statutes.

HIS Excellency the Lieutenant-Governor in Executive Council has been pleased under section 33 of the University of Western Australia Act, 1911-1944, to approve of University Statute No. 2 of 1946 (amending Statute No. 18), University Statute No. 3 of 1946 (amending Statute No. 15), and University Statute No. 4 of 1946 (amending Statute No. 22) as passed by the Senate and the convocation of the University, copies of which are shown hereunder:—

Amending Statute No. 2 of 1946.

Amendment to Statute No. 18—Conditions of awarding Hackett Bursaries and Hackett Research Studentships and Scholarships.

Section 4, subsection (1) has been amended to read:—

“Post-Graduate Research Scholarships hereinafter described as the Research Scholarships shall be open to graduates of the University of Western Australia and shall normally be tenable at that University but in exceptional circumstances and with the approval of the Professorial Board may be held at any other University or recognised institution within Australia. The Research Scholarships shall be of a value not exceeding £125 per annum if held at the University of Western Australia and of a value not exceeding £175 per annum if held at any other University or recognised institution within Australia.”

The amended section 4, subsection (1), as stated above takes the place of the present section 4, subsection (1), which reads:—

“Post-Graduate Research Scholarships hereinafter described as the Research Scholarships of a value not exceeding one hundred and twenty-five pounds per annum shall be open to graduates of the University of Western Australia and shall be tenable only at that University.”

Amending Statute No. 3 of 1946.

Amendment to Statute No. 15—Public Examinations Board.

Sections 2 (e) and (f) of Statute No. 15 have been amended by the addition of the following words at the end of each subsection, namely:—

“Provided that no representative be appointed for more than three years.”

Sections 2 (e) and (f) as amended now read:—

“(e) Three members representative of such Secondary Schools for Boys as are not under the Education Department and are recognised as Secondary Schools for this purpose by the Professorial Board. These members shall be elected annually by the Headmasters of such schools provided that no representative be appointed for more than three years.

(f) Three members representative of such Secondary Schools for Girls as are not under the Education Department and are recognised as Secondary Schools for this purpose by the Professorial Board. These members shall be elected annually by the Headmistresses of such schools provided that no representative be appointed for more than three years.”

Amending Statute No. 4 of 1946.

Amendment to Statute No. 22—Gledden Trust.

Section 6 has been amended to read:—

“(1) Each Fellow shall be required to take up his Gledden Fellowship within nine months of the date of the award thereof and to spend at least two-thirds of the period of his Fellowship outside Australia.

(2) He shall also be required before taking up his Fellowship to sign a written undertaking to return to work in Western Australia for at least one year immediately after the termination of his Fellowship if suitable work is available.

(3) He shall not during his Fellowship engage in any work other than that for which the Fellowship has been awarded except by permission of the Professorial Board.

(4) If he shall during his Fellowship accept or agree to accept any continuous and paid employment in connection with work done or to be done within the scope of his Fellowship he shall at once notify the Vice-Chancellor for the information of the Professorial Board which shall then decide on what terms

and conditions the Fellow shall continue to hold his Fellowship during such time as he remain in such continuous and paid employment.”

In the above amended section 6, the following words have been added at the end of subsection (2):—

“If suitable work is available.”

Section 7 has been amended to read:—

“(1) Applications for the Gledden Fellowships must reach the Vice-Chancellor on or before a date to be fixed by him and advertised and shall contain a full statement of the applicant's academic and professional attainments and experience and of the work which he proposes to undertake if awarded a Fellowship.

(2) Every applicant shall state the period during which he proposes to work under a Gledden Fellowship if such Fellowship be awarded to him.”

In the present section there are three subsections, but subsection (3) has now been repealed. The repealed subsection reads as follows:—

“(3) Every applicant must be employed in Western Australia at the time of his application and must have been employed for at least two years immediately before the date of his application.”

Sections 18 to 26 dealing with the Gledden Scholarships have been repealed.

The Common Seal of the University of Western Australia has been affixed in pursuance of an order of the Senate by the undersigned being legally entitled to the custody thereof as the Chancellor of the said body corporate.
