WHEREAS by the Transfer of Land Act, 1893, Amendment Act, 1896 (60 Vict., No. 22), the Governor is empowered by Proclamation in the *Government Gazette* to revest in His Majesty as of his former estate all or any lands, whereof His Majesty may become the registered proprietor; and whereas His Majesty is now the registered proprietor of (firstly) Avon Locations 3403, 3404, 5912, and 6025, (secondly) Avon Locations 3454, 6027, 6249, 6250, 6251, 13220, 13334 and portion of Avon Location 6026, and (thirdly) Avon Location 9135 as registered in the Office of Titles in Volume 1081, Folio 97: Now, therefore I, the Lieutenant-Governor, with the advice and consent of the Executive Council, do by this Proclamation revest in His Majesty, his heirs and successors, Avon Location 3403, 3404, 5912, 6025, 3454, 6027, 6249, 6250, 6251, 13220, 13334, 9135 and portion of Avon Location 6026 aforesaid as of his former estate.

The Land Act, 1933-1946.

### ORDER IN COUNCIL.

Corr. No. 5073/46.

WHEREAS by section 34 of the Land Act, 1933-1946, it is made lawful for the Governor, by Order in Council, without issuing any deed of grant, to place any

reserve under the control of any municipality, road board, or other person or persons, as a board of management, and to empower such board to make, repeal, and alter by-laws for the control and management of such reserves, and prescribe fees for depasturing thereon, and for other purposes, such by-laws to be approved by the Governor and published in the *Government Gazette*; and whereas it is deemed expedient that reserve 22617 for Sheep Dip at Westonia should be placed under the control of the Westonia Road Board as a Board of Management: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby place the beforementioned reserve under the control of the Westonia Road Board as a board of management, and doth empower such board to make, repeal, or alter by-laws for the control and management of the said reserve; for prescribing fees for depasturing thereon; for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

ORDER IN COUNCIL.

P.W. 123/47.

WHEREAS it is provided by subsection 1 (b) (iii) of section 480 of the Municipal Corporations Act, 1906-1945, that a council may with the approval of the Governor expend out of the ordinary revenue of the municipality any sum or sums not exceeding in the aggregate ten per cent. of such ordinary revenue for providing all forms of tourist propaganda both within the district and elsewhere in connection with or in relation to any tourist resort within the district of the council; And whereas the Municipality of Bunbury are desirous of expending the sum of £15 0s. 6d. from its ordinary revenue for tourist propaganda purposes: Now, therefore, His Excellency the Lieutenant-Governor, acting by and with the advice and consent of the Executive Council and in exercise of the power vested in him in the said section of the said Act, doth hereby authorise the Municipality of Bunbury to expend from its ordinary revenue the sum of £15 0s. 6d. for tourist propaganda purposes.

ORDER IN COUNCIL.

P.W. 1337/37.

WHEREAS section 74 of the Constitution Act, 1889, provides that the Governor in Council may vest in heads of departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Department of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Department) should be vested in Jack Hutchinson: Now, therefore, His Excellency the Lieutenant-Governor by and with the advice of the Executive Council hereby vests in Jack Hutchinson and any persons appointed to act temporarily in his place the appointment of foremen and all other persons employed on such works at a daily rate of wages.

Water Boards Act, 1904-1942.  
Mt. Magnet Water Area.

ORDER IN COUNCIL.

P.W.W.S. 82/47.

WHEREAS by the Water Boards Act, 1904-1942, and the Water Supply, Sewerage and Drainage Act, 1912, the Governor is empowered by Order in Council to constitute the district of a local authority or two or more local authorities or any part or parts of such district or districts a water area, under such name as may be directed; and whereas, under the provisions of the said Acts, the Governor may authorise the Minister for Water Supply, Sewerage and Drainage to exercise within a water area all the functions of a water board: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby constitute an area, having the boundaries described in the Schedule hereunder, a water

area for the purpose of the said Acts, under the name of the Mt. Magnet Water Area, and does hereby appoint the Minister for Water Supply, Sewerage and Drainage to exercise all the functions of a water board under the Acts in such area.

This Order in Council shall take effect on the 13th day of February, 1947.

FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934.

NOTICE is hereby given that the following Stay Order has been issued in accordance with section 7, subsection (1) of the Farmers' Debts Adjustment Act, 1930-34, which reads as follows:—

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for breach of covenant under any mortgage or other security for money or under an agreement for sale and purchase of lands, or other process or proceeding, shall be commenced or proceeded with or put in force against the pastoralist or any of the pastoralist's assets, whether utilised in connection with or forming portion of the assets comprised in their pastoral business or not during the operation of such Stay Order; provided that by leave of a judge any action may notwithstanding the Stay Order, be instituted and/or carried on against the pastoralist, but not beyond judgment.

BUSH FIRES ACT, 1937-1945.

By-laws of the Wickiepin Road Board relating to the establishment, maintenance and equipment of Bush Fire Brigades for the Road District of Wickiepin.

Establishment of Brigade.

1. On the resolution of the Board to establish, maintain and equip a Bush Fire Brigade under the provisions of the Bush Fires Act, 1937-45, and regulations thereunder, the Brigade shall be formed in

accordance with these by-laws; and a name shall be given to the Brigade and application accompanied by a copy of these by-laws shall be made to the Minister for Lands for its registration accordingly.

A bush fire brigade may be established for the whole of the road district or for any specified area thereof. Provided that, unless the resolution of the Board establishing a bush fire brigade specifies therein only a part of the district as the area for which such brigade is established, the brigade shall be deemed to be established for the whole of the said road district.

Appointment of Officers.

2. The Board shall appoint a captain, a first lieutenant, a second lieutenant and such additional lieutenants as it shall deem necessary to act as officers of the Brigade, and who, in the Board's opinion, have the necessary qualification and knowledge of the district required in such capacities.

3. The secretary of the Board or such other person as the Board may appoint, shall be the secretary of the Brigade.

4. The Board may appoint an equipment officer who shall be responsible for the custody and maintenance in good order and condition of all equipment and appliances acquired by the Board for the purposes of the Brigade. Such officer may station such equipment at a depot approved by the captain where, if possible, motor trucks can easily be called upon. If there are more than one such depots in the area, the equipment officer shall appoint at each depot a person to look after the equipment and have it ready for immediate use when required.

5. The Board shall appoint bush fire control officers in accordance with the requirements of the district and may prescribe the area over which each such officer shall have jurisdiction. The employment, dismissal and payment for services of persons (other than officers) employed for duties under this Act, shall be vested in the chairman and secretary of the Board conjointly.

Duties of Officers.

6. The duties of all officers appointed under these by-laws shall be as laid down in the provisions of the Bush Fires Act, 1937-1945, and each officer so appointed shall be supplied with a copy of the Act and regulations. The captain shall have full control over the members of the Brigade whilst engaged in fire fighting and shall issue instructions as to the methods to be adopted by the firemen. In the absence of the captain, the first lieutenant; and in the absence of the first, the second lieutenant or senior officer of the Brigade present at the fire shall exercise all the power and duties of the captain. The captain shall when so directed by the Board instruct all land owners or occupiers to plough a break or breaks on all cleared land or land under pasture.

Membership of Brigade.

7. (1) The membership of a bush fire brigade may consist of the following:—(a) Subscribing members, (b) fire fighting members, and (c) associate members.

(2) Subscribing members shall be those persons, who, being interested in forwarding the objects of the Brigade, pay an annual subscription to the funds of the brigade at the following rates:—

(i) owner or occupier of land within the brigade area—minimum subscription of	10 0
(ii) other persons—a minimum subscription of	5 0

(3) Fire fighting members shall be those persons, being able-bodied men over 18 years of age who are willing to render service at any bush fire when called upon, and who sign an undertaking in the form contained in the First Schedule to these by-laws.

(4) Associate members shall be those persons who are willing to supply free motor transport for fire fighters or equipment, or are prepared to render other approved assistance, and who sign an undertaking in the form contained in the Second Schedule to these by-laws.

(5) No fees or subscriptions shall be payable either by fire fighting members or associate members, and the enrolment of persons as such members shall in every case be subject to the approval of the Board.

(6) A subscribing member shall be eligible for enrolment as a fire fighting member.

## Finance.

8. The expenditure incurred by the Board in the purchase of equipment, etc., payment for services and generally for the purposes of this Act, shall be a charge on the ordinary revenue of the Board, but the secretary shall keep a separate record of the expenditure incurred under this Act.

## Meetings of Brigade.

9. To be held as required.  
These by-laws under the Bush Fires Act, 1937-1945, were passed by a resolution of the Wickiepin Road Board (a local authority under the provisions of such Act) at a meeting held at Wickiepin on 13th December, 1946.

2. Part 1 of The Metropolitan Milk Act, 1932-1935, Regulations as published in the *Government Gazette* on the 7th day of March, 1936, and the First Schedule thereto, are hereby repealed and the following inserted in lieu thereof:

##### Part I.

1. Every application for a Dairyman's License shall be in the Form No. 1 in the First Schedule.
2. Every application for a Milk Vendor's License shall be in one of the Forms Nos. 2, 3, 4 and 5 in the First Schedule.
3. Every application for a Treatment License shall be in the Form No. 6 in the First Schedule.
4. In considering the grant or refusal of any license, the Board may require the applicant to attend before it and answer such questions as it desires relative to the application, and may require an inspection and report on the premises of the applicant.
5. No license shall be granted in respect of premises which do not (or in which the plant in such premises does not) conform to these Regulations and to the Regulations or By-laws of any local authority, statutory board, body or authority.
6. A license to carry on business as a dairyman shall be in the Form No. 7 in the First Schedule.
7. A license to carry on business as a milk vendor shall be in one of the Forms Nos. 8, 9, 10 and 11 in the First Schedule.
8. A Treatment License shall be in the Form No. 12 in the First Schedule.
9. Any person desiring to transfer his license shall first apply to the Board in writing for approval of the transfer and shall give to the Board such particulars concerning the transaction as the Board may require.

10. Every license shall be issued by the Board and held by the licensee and continue in force, subject to the Act and any Regulations from time to time made thereunder.

11. Subject to the provisions of section 31 of the Act, the license fee payable for any license issued under the Act shall be the sum of two shillings and sixpence. Such fee shall accompany the application for the license, but shall be refunded to the applicant if his application is refused.

HAVING heard Mr. O. Nilsson for Mr. R. C. Cole on behalf of the applicant and Mr. G. D. Browne on behalf of the respondents, and by consent, the Court in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1941, doth hereby order that Award No. 3 of 1940 made between the abovenamed parties be and the same is hereby amended in the manner following:—

5.—Holidays.

Delete this clause and substitute in lieu thereof the following:—

“5.—Holidays.

(a) Subject to clause 4 and clause 5A, the following days, or the days observed in lieu thereof, shall be observed as holidays:—New Year's Day, Australia Day (26th January), Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Christmas Day, Boxing Day: Provided that a worker shall only be entitled to payment for such holidays at the rate of six and three-fifths (6-3/5) hours' pay or six (6) hours' pay, depending on whether the establishment is working a five (5) or a five and a half (5½) day week, for each month of continuous service and with a maximum payment for any holiday of one (1) day's pay: Provided further that where the employment of a worker is terminated he shall be paid holiday pay at the rate set out above less the amount paid to him for holidays which have already been taken.

(b) Except insofar as the worker is entitled by length of service the said days shall be observed as holidays without pay.

(c) On any public holiday not prescribed as a holiday under this Award the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done ordinary rates of pay shall apply.

(d) Service as from the first day of September, 1946, shall be taken into consideration for the purpose of this clause.”

Add a new clause as follows:—

“5A.—Annual Leave.

(a) Except as hereinafter provided a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer.

(b) Subject to subclause (f) of this clause such leave shall be granted at Christmas and notice in writing shall be given to the union by representatives of the employers not later than three (3) months before Christmas, showing the date on which the factories shall close down for the annual leave.

(c) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one (1) day being an ordinary working day for each such holiday observed as aforesaid: Provided that at the option

of the employer any of the Award holidays so falling within the period of annual leave shall be given in one of the following ways:—

(i) Added to the Easter holidays, in which case the employer may, at his option, add one (1) further day in lieu of Australia Day (26th January). Where it is the intention of the employer to adopt this method he shall, by notice posted in the factory, at the time of closing down at Christmas, notify his employees of such intention.

(ii) By agreement between the employer and the worker, but not otherwise, another day shall be given in lieu of each of such Award holidays.

(d) If after one (1) month's continuous service in any qualifying twelve (12) monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth (1/6) of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(e) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award shall not count for the purpose of determining his right to holidays.

(f) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled (subject to subclause (d) of this clause), to such holidays on full pay as are proportionate to his length of service during that period with such employer, and if such holidays are not equal to the holidays given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on holidays on full pay.

(g) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(h) Service as from the first day of September, 1946, shall be taken into consideration for the purpose of this clause.”

36.—Absence through Sickness.

Cross on behalf of the respondents, the Court in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1941, doth hereby order that Award No. 29 of 1937, as amended by Orders Nos. 499 of 1939, 73 of 1943, and 75 of 1945, made between the abovenamed parties be and the same is hereby further amended in the manner following:—

21.—Annual Holidays.

Delete this clause and substitute in lieu thereof the following:—

“21.—Annual Holidays.

(a) Except as hereinafter provided a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer: Provided that the period of leave shall, in the case of ice and/or ice-cream carters, be three and two-thirds (3-2/3rds) weeks or where such workers work a five (5) day week, three and three-fifths (3-3/5ths) weeks: Provided also that the period of leave shall, in the case of milk and/or cream carters, if required, generally speaking, to work continuously seven (7) days in the week, be three and four-sevenths (3-4/7ths) weeks.

(b) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid: Provided that this subclause shall not apply to milk carters, cream carters, ice carters and ice-cream carters.

(c) If after one (1) month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service: Provided that, in the case of ice and/or ice-cream carters, such payment shall be eleven-thirtysixths (11/36ths) of a week's pay at the ordinary rate of wage: Provided also that, in the case of milk and/or cream carters such payment shall be twentyfive-eightyfourths (25/84ths) of a week's pay at the ordinary rate of wage.

(d) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award shall not count for the purpose of determining his right to annual leave.

(e) On any public holiday not prescribed as a holiday under the Award the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done ordinary rates of pay shall apply.

(f) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (e) of this section, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(g) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(h) The provisions of this clause shall not apply to casual workers.

(i) The quantum of annual leave to be allowed to a worker shall, for service prior to 1st September, 1946, be calculated in accordance with the provisions of the Award applicable at that date, and for service subsequent to 1st September, 1946, in accordance with the provisions of this amendment."

#### 23.—General.

Delete subclause (k) of this clause and insert in lieu thereof the following:—

"(k) Subject to clause 21 (e) and 21 (f) weekly hands ready and willing to work for the whole week and not dismissed during the week for any reason set out in clause 13 of this Award shall be entitled to a full week's wages."

(f) The provisions of this clause shall not apply to casual workers.

(g) The quantum of annual leave to be allowed to a worker shall, for service prior to 1st September, 1946, be calculated in accordance with the provisions of the Award applicable at that date, and for service subsequent to 1st September, 1946, in accordance with the provisions of this amendment."

(g) The quantum of annual leave to be allowed to a worker shall, for service prior to 1st September, 1946, be calculated in accordance with the provisions of the Award applicable at that date, and for service subsequent to 1st September, 1946, in accordance with the provisions of this amendment."
