IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1947, I, the Governor of the State of Western Australia, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in any of the portions of Western Australian waters specified in the Schedule hereto from the date of the publication of this Proclamation in the *Government Gazette* for a period of three (3) years.

## Schedule.

All that portion of the Gascoyne River (near Carnarvon) lying South of a line drawn due East from the North-East extremity of Babbage Island and all that portion of Western Australian waters within a radius of one half a mile of the South entrance to the Gascoyne River.

The waters of all creeks within a distance of five miles due North of the Carnarvon jetty and the waters of all creeks South of the Carnarvon jetty to the South-easterly bank of Oyster Creek and all those portions of Western Australian waters within a radius of one quarter mile of the entrances to the aforesaid creeks.

IN pursuance of the provisions of section 11 of the Fisheries Act, 1905-1947, I, the Governor of the State of Western Australia, do hereby vary the proclamation dated 2nd December, 1948 (published in the *Government Gazette* of 10th December, 1948), prohibiting all persons from taking any fish whatsoever by means of fishing nets in any of the portions of Western Australian waters specified in the Schedule thereto, from 1st January, 1949, until 31st December, 1951, inclusive, by providing that during the currency of the said proclamation it shall be lawful to use a prawn net not exceeding 12 feet in length and having meshes of not more than one inch throughout for the capture of prawns only in the waters of that part of the Channel Entrance to Peel's Inlet described in the Schedule hereto, provided that no such net is set closer than 12 feet to any other such net set therein or closer than 25 feet to any part of the platform abutting on the Mandurah Bridge, and provided further that no such net is set in the fairway of such Channel Entrance.

## Schedule.

All that portion of Peel Inlet bounded by lines starting from the Eastern corner of location 972 Murray, and extending Westerly to the South-Eastern boundary of location 5; thence generally North-Easterly, and Northerly, along boundaries of the said location 5, and location 58, to the North-Eastern corner of the latter location; thence East-North-Easterly, along the Southern side of the Mandurah Bridge, to the common boundary of the Murray and Cockburn Sound Land Districts; thence generally Southerly, along the said boundary, to the South-Western corner of an island situate South of Channel Island and near Creery Island; thence Westerly to a point of land situate about 14 chains North-Easterly from the Eastern corner of location 972 aforesaid; and thence generally South-Westerly, along the shores of the Peel Inlet to the starting point.

WHEREAS under section 9 of the Fisheries Act, 1905-1947, it is provided that the Governor may, by Proclamation, declare, *inter alia*, that any Western Australian waters shall be closed against the taking of any prescribed species of fish by any means whatever, or against fishing generally, by any method of capture during any specified time, or for any specified period, and whereas it is desirable that the whole of the waters of St. John's Brook, together with all tributaries from the various sources thereof, to the junction of the main stream with the Blackwood River, should be declared closed for a period of three years against the taking of trout: Now, therefore, I, the said Governor, with the advice and consent of the Executive Council, do hereby declare as follows:—That the whole of the waters of St. John's Brook, together with all tributaries, from the various sources thereof, to the junction of the main stream with the Blackwood River, shall be closed against the taking of trout by any method of capture whatever for a period of three years as from date of gazettal of this Proclamation in the *Government Gazette*.

WHEREAS it is enacted by section 4 of the Vermin Act, 1918-1946, that "Vermin" means and includes any animal, bird or insect mentioned in the Third Schedule to this Act, and such other animals, birds or insects the names of which the Governor may by proclamation add to the said Schedule, and that any proclamation whereby the names of other animals, birds or insects are added to the Third Schedule may be restricted in its operation to any portion of the State to be defined by the proclamation; and whereas it is deemed desirable and expedient that donkeys run wild or at large and camels run wild or at large shall be "vermin" for the purposes of the said Act within the boundaries of the Nullagine Vermin District: Now, therefore, I, the said Governor, with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, do by this proclamation add to the Third Schedule of the said Act the names "donkeys run wild or at large" and "camels run wild or at large," and declare that this proclamation shall apply and have effect only in that portion of the State which is comprised within the boundaries of the Nullagine Vermin District as constituted under the said Act.

WHEREAS it is enacted by section 5 of the Road Districts Act, 1919-1947, that for the purposes of the said Act the word "Town" or "Townsite" means and includes *inter alia* any land (including privately owned subdivided land) which the Governor may see fit, as he is thereby empowered, to declare by Proclamation, to be a Town or Townsite for the purposes of the said Act; and whereas all that land, situate within the Moora Road District, more particularly described, defined and delineated in the Schedule hereunder, is land which the Governor may by virtue of section 5 of the said Act declare by Proclamation to be a Town or Townsite for the purposes of the said Act: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council, and in exercise of the power conferred upon me by the said Act, and of all other powers in this behalf enabling me, do hereby declare that all that land situate within Moora Road District, more particularly described, defined and delineated in the Schedule hereto, shall be a Townsite, to be known as "Miling," within the meaning and for the purposes of the Road Districts Act, 1919-1947.

All that portion of land bounded by lines starting from the intersection of the South-Eastern side of Miling Station Yard with the Northern side of Seymour Street, and extending Easterly along the latter to a point opposite the intersection of the Southern side of that street with the South-Eastern side of Hardwicke Street; thence Southerly to that point; thence South-Westerly 9 chains 7  $\frac{4}{10}$  links, along that South-Eastern side, to the Northern corner of the land the subject of Land Titles Office Diagram 14172; thence South-Easterly 2 chains 50 links, South-Westerly 1 chain and North-Westerly 2 chains 50 links (as shown on that diagram) to rejoin the South-Eastern side of Hardwicke Street; thence

Bayswater Road Board—Building By-law.

P.W. 197/44.

WHEREAS by the Road Districts Act, 1919-1947, section 208 and paragraph 37 of the Second Schedule Building Regulations, the Road Board of any district is empowered to make, alter or repeal any by-laws for all or any purposes in the said Building Regulations, the Bayswater Road Board in pursuance of the powers vested in the said Board, under and by virtue of the said Act and the said Building Regulations, and of every other authority enabling it in that behalf, doth hereby repeal and make the following by-laws.

## Building By-laws (Garages) Repealed.

Building By-law number 43 published in the *Government Gazette* on 22nd February, 1929, and amended Building By-law published in the *Government Gazette* on 18th September, 1931, relating to motor garages are hereby completely repealed and the following by-law made in their stead.

## New Building By-laws.

## (Motor Garages.)

Definition.—The expression “garage” means any building used for housing a motor vehicle and excludes a service station or any garage carried on as a business undertaking.

1. Any motor garage shall be of a minimum height of 8 feet and shall be constructed of non-inflammable material (galvanised corrugated iron must not be used), but in the Board’s gazetted brick area garages shall be built of brick, concrete, or other like substance, except where hereinafter provided:—

(a) Garages Attached to Houses.—Garages may be built attached to existing or new houses with the front of the garages no further forward than the same line as the front of the house, but shall conform to existing by-laws for buildings and be constructed of the same materials as the existing or new house.

(b) If a garage attached to a house is under the same roof as the house, such garage shall have a fire-proof ceiling according to the existing by-laws but if not under the same roof need not be ceiled.

(c) Garages to jarrah weatherboard and asbestos houses shall have the party wall fire-proofed.

2. Garages Not Attached to Houses.—Garages not attached to houses shall conform to the following:—

(a) Any garage not built in brick, stone, concrete, or like substance shall be built 30 feet distant from the frontage of any road or street.

(b) When on account of the contour, shape, or dimensions of, or want of access to the rear portion of an allotment, the location of a garage or outbuilding as set out in clause (a) is impracticable, the Board may permit the erection of such garage or outbuilding in another position subject to such restrictions as to design and materials of construction as may be necessary to preserve the amenity of the district.

(c) Clause (a) shall not apply to garages to be built of brick, stone, concrete, or other like substance which may be built 5ft. distant from the frontage of any road, or street, except where it is possible to build same on the same line as the front of the house.

3. Garages—Distances from Boundaries of Properties.—Any garage built in brick, stone, concrete, or other like substance shall be 3ft. from the building line or may abut on the building line providing a parapet wall is erected in accordance with existing building by-law paragraph 5, but if built in j.w.b., asbestos, or other like non-inflammable material shall be 4ft. from such building line.

4. Doors to Garages.—Doors to garages shall not be built of galvanised corrugated iron, except half inch ripple corrugated iron, but may be built of any other non-inflammable material approved by the Board, and shall not open on to any footpath, right-of-way, or in any way outside the owner’s block boundaries.

5. Fronts to Garages (appearance).—The front of any garage shall present a neat and artistic appearance in keeping with garages in the immediate vicinity and to the approval of the Board and shall be painted when directed by the Board.

6. Garages on Street Alignments.—In exceptional cases the Board may approve of a garage being erected with its front on the street alignment providing sliding doors or doors opening inward are fitted.

## Bayswater Road District.

## By-law Relating to Employees’ Long Service Leave.

P.W. 197/44.

THE Bayswater Road Board, under and by virtue of the powers conferred upon it by the Road Districts Act, 1919-1947, and all other powers thereunto it enabling, doth hereby make and publish the following by-law:—

1. In this by-law the following expressions shall, unless the contrary intention appears, have the meanings hereby respectively assigned to them, namely:—

“The Board” means the Bayswater Road Board.

“Employee” means and includes all persons employed in any capacity by the Board and who are in the regular and full time employ of the Board.

2. Subject as hereinafter provided every employee who has continued in the service of the Board for at least ten years shall be granted long service leave for three months in respect of each completed period of ten years of such service: Provided that such service shall not be computed in respect of a period prior to the first day of January, 1947, notwithstanding that the employee may have commenced such service prior to that date.

3. No employee shall be deemed to commence to qualify for long service leave until he or she attains the age of 18 years.

4. Notwithstanding the definition of “employee” in this by-law a person in the employ of the Board whose service is broken owing to the exigencies of his particular work for a period not exceeding three consecutive months at any one time shall also be deemed to be an employee within the meaning of this by-law and such employee shall be entitled to count all service for the purpose of computing long service leave but there shall be excluded in such computation all periods during which such service is so broken.

5. Long service leave shall be taken at such time as the Board shall nominate within one year after such leave has accrued due and if the employee elects to postpone the taking of such leave the period between the date nominated by the Board for its commencement and the date such leave is completed shall not be taken into account to qualify the employee for further long service leave.

6. The period while any employee is away on long service leave shall not be taken into account for further long service leave.

7. An employee who is eligible for three months long service leave by having completed ten years’ service and who resigns, retires or is dismissed from the service of the Board before having taken such leave shall be paid the amount to which he or she would have been entitled during long service leave in accordance with the provisions of this by-law had he or she continued in the service of the Board and taken such long service leave.

8. An employee who is dismissed shall not in any case be entitled to any pro rata long service leave or payment in lieu thereof in respect of any period of service for less than ten years nor shall an employee who resigns or retires be entitled to any leave or payment in lieu thereof for any such period of service except as herein expressly provided: Provided that:—

(a) An employee who retires at or over the age of sixty years or who irrespective of age is retired by reason of incapacity due to infirmity, illness, accident or other physical or mental defects and who has served in the Board’s employ continuously for at least one year immediately prior to such retirement shall be entitled to payment in respect of long service leave accrued due pro rata to the date of such retirement.

(b) Subject to proviso (a) of this clause an employee who is retrenched or retired by the Board for any reason other than misconduct or unsatisfactory service and who has been in the service of the Board for at least three years immediately preceding such retirement or retrenchment shall be paid for long service leave pro rata at the date of such retirement or retrenchment.

9. Payment to an employee during long service leave shall be computed on the basis of such employee’s salary or wages (excluding overtime) for

the pay period next before such leave is taken and payment in lieu of long service leave shall be computed on the basis of such employee's salary or wages (excluding overtime) for the pay period next before the date he became entitled to payment in lieu of long service leave.

10. Payment during long service leave or in lieu of long service leave may at the option of the Board be payable in a lump sum or by such instalments as the Board thinks fit: Provided that payment in full shall in any event be completed within three months after the employee first became entitled to payment during long service leave or in lieu thereof as the case may be.

11. Save as herein expressly provided no employee shall be entitled to long service leave or payment in lieu thereof in respect of any uncompleted period of ten years' service.

Bayswater Road District.

By-law Relating to Bees.

P.W. 197/44.

THE Bayswater Road Board, under and by virtue of the powers conferred upon it by the Road Districts Act, 1919-1947, and all other powers thereunto them enabling, doth hereby make and publish the following by-law:—

1. The keeping of bees on land within the limits of those portions of the Bayswater Road District which are set out and described in the Schedule hereto is hereby prohibited.

2. Any person who after the commencement of this by-law—(a) being the owner or occupier of land within the limits of those portions of the Bayswater Road District which are set out and described in the schedule hereto keeps bees or suffers bees to be kept thereon; (b) is in charge of bees which are kept on any such land, shall be guilty of a contravention of this by-law.

3. If any person shall either by act or omission contravene this by-law he shall be guilty of an offence under this by-law and on conviction for such offence shall be liable to a penalty not exceeding twenty pounds, and also if such offence is in its nature a continuing offence to a daily penalty not exceeding two pounds during the continuance of the offence.

#### The Schedule.

(a) All lands within an area bounded by a line commencing at the most Westerly corner of lot 406, Plan 6083, on Walter Road and proceeding North-Easterly along Walter Road to the corner of Coode Street, thence South-Easterly along Coode Street to the most Westerly corner of lot 16, Plan 1702, thence North-Easterly along the Northern boundary of lot 16 prolonged to Drake Street, across Drake Street to the most Westerly corner of lot 980, Plan 3402, thence generally North-Easterly along Greenford Road to its intersection with Collier Road, thence along Collier Road South-Easterly and Easterly to Sanderson Street, thence South-Easterly along Sanderson Street to the most Easterly corner of lot 285, Plan 3391, thence South-Westerly along the boundary of lot 285 prolonged to the corner of Drynan Street and lot 915, Plan 3402, thence South-Easterly along Drynan Street

and Clavering Road to the intersection with Bassendeau Road, thence along Bassendeau Road North-Easterly to its intersection with River Road, thence along River Road South-Easterly to the centre of the Perth-Midland Junction railway line, thence Westerly along the railway line to Belmont railway line, thence along the Belmont railway line Southerly to the Swan River North bank, thence Westerly along the Northern bank of the Swan River to its intersection with the Bayswater Road Board district Western boundary, thence North-Westerly along the district boundary to the starting point.

(b) All lands within an area bounded by a line commencing at the corner of Colwyn Road and River Road proceeding North-Easterly to the Eastern district boundary, thence South-Easterly and Southerly along the District boundary to the Northern bank of the Swan River, thence Southerly along the Swan River to River Road, thence North-Westerly along River Road to the starting point.
