I, THE said Governor, acting with the advice and consent of the Executive Council, do hereby appoint you G. J. Rodger, Esq., to be a Royal Commission to enquire into and report upon, in relation to forests and timber within the State of Western Australia—

- (1) forest resources and potential, including softwood development;
- (2) demands on such resources from within and without the State, and the extent to which, and the manner in which, such demands should be met;
- (3) forest valuation and finance;
- (4) forest regulation and administration.
- (5) forest utilisation and harvesting of timber crops, including dead timber;
- (6) sawmilling and fire prevention and protection;
- (7) forest policy, including the granting and conditions of existing and future permits;
- (8) forest legislation and regulations;
- (9) remedial action in relation to the foregoing.

And I declare that you shall by virtue of this Commission be a Royal Commission within the Royal Commissioners' Powers Act, 1902, as reprinted in the Appendix to the Sessional Volume of the Statutes for the year 1928 and that you shall have the powers of a Royal Commission and of the Chairman thereof under that Act.

And I hereby request you as soon as reasonably may be to report to me in writing the result of this your Commission.

Land Act, 1933-1950.

ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1950, it is *inter alia*, made lawful for Governor to direct that any land reserved pursuant to the provisions of the Act shall be leased for the purpose

for which the land is reserved as aforesaid, by Instrument of Lease, to any person (as defined in the said section); and whereas it is deemed expedient as follows:—

Corres. No. 6937/13, Vol. 2—That reserve No. 19625 (Victoria Locations 6854 and 8956) shall be leased for a term of 21 years to the Geraldton Golf Club to be held in trust for the purpose of Recreation (Golf Links).

The Land Act, 1933-1950.

ORDER IN COUNCIL.

Corr. No. 2325/84.

WHEREAS by section 34 of the Land Act, 1933-1950, it is made lawful for the Governor, by Order in Council, without issuing any deed of grant, to place any reserve under the control of any municipality, road board, or other person or persons, as a board of management, and to empower such board to make, repeal, and alter by-laws for the control and management of such reserves, and prescribe fees for depasturing thereon or other use thereof, and for other purposes, such by-laws to be approved by the Governor and published in the *Government Gazette*; and whereas it is deemed expedient that reserve 23169 for a Cemetery near Broomehill should be placed under the control of the Broomehill Road Board as a board of management: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby place the beforementioned reserve under the control of the Broomehill Road Board as a board of management, and doth empower such board to make, repeal, or alter by-laws for the control and management of the said reserve; for prescribing fees for depasturing thereon or other use thereof; for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

Goomalling Road Board.

ORDER IN COUNCIL

Toodyay Road Board.

ORDER IN COUNCIL.

- (3) paragraph (xiv) of subsection (1) of section 47 of the said Act, imposing a penalty not exceeding twenty pounds or imprisonment not exceeding one month with or without hard labour for the breach of any by-laws.

"4AA (a) The owner of every house shall cause such house to be provided with water piping with all necessary bends, tees, taps, and fittings of sufficient size to deliver to the kitchen, bathroom, laundry and lavatory of such house, an adequate and continuous supply and pressure of potable water.

(b) He shall cause all such pipes to be connected to the water reticulation mains of the Metropolitan Water Supply, Sewerage and Drainage Department.

(c) He shall maintain all such pipes, bends, tees, taps, and fittings in good and efficient repair and action."

(a) Illuminated signs under verandahs and balconies—

- (i) shall be rigidly supported from the framework of the verandah or balcony by vertical suspension rods or straps;
- (ii) shall be fixed at right angles to the building line and so that the centre of the sign coincides with the centre line of the verandah or balcony;
- (iii) shall be so fixed that the minimum distance between any two signs is six feet and so that no sign shall be within three feet of the side wall of the building in front of which it is erected;
- (iv) shall not exceed fourteen inches in depth nor eight inches in width nor eight feet in length nor fifteen pounds in weight per lineal foot;
- (v) shall be so fixed as to leave a clear headway from the lowest part of the sign to the footway of ten feet where practicable and in no case of less than nine feet.
