PROCLAMATION

WHEREAS it is enacted by section 1, subsection (2) of the Coal Mining Industry Long Service Leave Act, 1950, that the said Act shall come into operation on a day to be fixed by Proclamation: Now, therefore I, the said Administrator, acting with the advice and consent of the Executive Council, do hereby declare and proclaim that the Coal Mining Industry Long Service Leave Act, 1950, shall come into operation as on the 1st day of August, 1951.

AT a meeting of the Executive Council held in the Executive Council Chamber at Perth on the 25th day of July, 1951, the following Order in Council was authorised to be issued:—

Inspection of Machinery Act, 1921-1950.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 82 of the Inspection of Machinery Act, 1921-1950, that the Administrator may from time to time, by Order in Council, make regulations for any of the matters specified in the said section; and whereas the Administrator in Council, by Order in Council published in the *Government Gazette* of the 1st day of July, 1922, made regulations under the said Act which have subsequently from time to time been

amended; and whereas it is now deemed desirable and expedient further to amend the said regulations: Now, therefore, His Excellency the Administrator, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, hereby further amends the regulations made under and for the purposes of the said Act and published in the *Government Gazette* of the 1st day of July, 1922, and amended from time to time thereafter by notices published in the *Government Gazette* in the manner mentioned in the Schedule hereunder.

Schedule.

The abovementioned regulations are amended as follows:—

1. The scale of regulation charges made pursuant to section 36 of the said Act is amended by deleting the words "one-twentieth of the heating surface shall be deemed to be equal to one horsepower for 'Presha' water tube boilers" appearing in the second paragraph under the heading "Boilers" (*Government Gazette*, 6th May, 1949), and inserting in lieu thereof the following words:—

"Flash type boilers with no definite firegrate area fees to be charged on evaporative capacity."

2. Insert after item "Over 15 horsepower—£3 15s. 0d." in the scale of fees under the heading "Boilers" (*Government Gazette*, 29th October, 1948), the following:—

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1950, this 23rd day of June, 1951, between the Kalgoorlie Brewing Company, Limited (hereinafter called the "employers") of the one part, and the Eastern Goldfields Federated Engine Drivers' and Firemen's Union of Workers of Western Australia (hereinafter called the "Union"), of the other part, whereby it is mutually agreed by and between the parties hereto that the several stipulations, conditions and provisions set out herein, shall in all cases be binding upon and shall be faithfully and promptly carried out, observed, performed and complied with, according to the true intent and meaning thereof, by the parties hereto.

1.—Definitions.

For the purpose of this Agreement—

- (a) "engine driver" shall mean and include a worker who operates or drives any engine or engines the motive power of which is either steam, gas, air, oil, water, compressed air or electricity;
- (b) "firemen" shall mean a worker employed in a stokehold attending a steam boiler or suction gas generator over 6 h.p.

2.—Wages Schedule.

(a) The parties to this Agreement mutually agree that the minimum rate of wages that shall be paid by the employers respectively to the persons employed by such employers in the capacities undermentioned shall be as follows:—

(b) Rostered shift workers shall be paid an allowance of eight (8) shillings per week in addition to their ordinary rate of pay. This allowance shall be taken into consideration for the purpose of calculating overtime rates for overtime worked on Mondays to Saturdays, but not for the purpose of calculating any other penalty rates under this Agreement.

3.—Hours.

(a) Forty (40) hours shall constitute a week's work to be worked in shifts of eight (8) hours each, Mondays to Fridays, inclusive, or in shifts of seven (7) hours twelve (12) minutes each, Mondays to Fridays, inclusive, and four (4) hours on Saturday.

4.—Overtime.

(a) All time worked beyond the hours of duty on any day shall be deemed overtime, and shall be paid at the rate of time and one-half. Each day shall stand by itself.

5.—Record.

Each employer shall keep a record of the name of each worker, the time he starts and finishes each day, total number of hours worked, overtime worked, and wages paid to each worker, and such record shall be open to the inspection of the Secretary of, or any other person appointed by the Union during working hours.

Each worker shall sign the record kept for all money received by him.

6.—Sundays.

(a) All work performed on Sunday shall be paid for at the rate of double time.

(b) If an engine driver is called in to work on a Sunday he shall be paid a minimum of eight (8) hours at Sunday rates.

(c) If a fireman is called in to work on a Sunday, he shall be paid a minimum of four (4) hours at Sunday rates.

7.—Holidays.

(a) The following days shall be observed as holidays:—Christmas Day, Boxing Day, New Year's Day, Foundation Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Kalgoorlie Cup Day, Boulder Cup Day, King's Birthday and Brewery Employees' Picnic Day: Providing that in the case of any of the above holidays (except Labour Day and Easter Monday) falling on a Saturday, Sunday, Monday, another day as near to the following Wednesday as possible, shall be observed in lieu thereof.

(b) If no work be done, ordinary rates shall be paid for holidays. If work is performed on a holiday, time and a half rates shall be paid in addition.

(c) If an engine-driver is called in to work on a holiday he shall be paid a minimum of eight (8) hours at holiday rates.

(d) If a fireman is called in to work on a holiday he shall be paid a minimum of four (4) hours at holiday rates.

8.—Annual Bonus.

The employer shall pay each employee receiving wages under this Award a week's pay by way of bonus in the last week of December in each year. Any employee leaving the employer's service for reasons other than misconduct, dishonesty or neglect of duty before the payment of such bonus in any year shall, when leaving, be paid a *pro rata* payment in lieu thereof, any employee who shall not have been in the employ of the employer for a year in the first week in December shall receive a part of his week's pay bearing the same proportion to a week's pay as the period of his service bears to a year.

9.—Annual Leave.

(a) Each employee on completion of twelve (12) months' service shall be granted three (3) weeks' annual leave, two weeks on double pay and one week on single pay, such leave to be taken at times to be mutually agreed upon between the workers and the employers, between the 1st March and the 31st October in each year. The annual leave shall be in addition to the holidays mentioned in clause 7 hereof.

(b) On termination of service (other than by dismissal for misconduct) of a worker who has been continuously employed for more than three (3) months, he shall receive a *pro rata* payment in lieu of leave on the basis of one day's double pay for each completed month of service.

(c) On termination of service (other than by dismissal for misconduct) of a worker who has been continuously employed for more than one month, but less than three (3) months, he shall receive a *pro rata* payment in lieu of leave on the basis of one day's pay for each completed month of service.

(d) Relieving enginedrivers and firemen shall be paid for annual holidays *pro rata* to the length of time they have been employed on the higher rates.

10.—Engagement.

(a) The engagement between the employer and employee shall be weekly, a week's notice from either side to terminate same, except in the case of the employee absenting himself without leave, not obeying lawful commands, or being guilty of misconduct, or of the works of the employer being stopped through fire, tempest, or other act of God, when such Agreement may be terminated immediately.

(b) Suitable washing and changing facilities shall be provided.

11.—Absence Through Sickness.

(a) A worker who is unable through sickness or accident to attend his duties, shall notify the employer not later than 10 a.m. of the day he first absents himself from duty.

(b) A worker shall be entitled to sick pay in respect of any period of absence on account of sickness after the first day of January, 1948, on the basis of one-half day's pay for each completed month of service with the employer between the said first day of January, 1948, and the date of commencement of such absence, providing that in calculating the amount due to a worker in respect of any particular period of absence through sickness, there shall be deducted therefrom any sum or sums previously paid to him hereunder.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof of his sickness satisfactory to the employer. This proof shall be in the form of a medical certificate if the absence is for three days or more. The employer shall have the right at any time to have the worker examined by a doctor on behalf of the employer.

(d) Except as aforesaid, a worker shall not be entitled to payment for time lost through sickness or accident. This clause shall not apply where the worker is entitled to compensation under the Worker's Compensation Act.

12.—General.

(a) No enginedriver or fireman shall be called upon to do other work which will preclude him from maintaining effective supervision or control of his engines or boilers.

(b) Where the employment or work involves functions of a mixed character, the minimum wage to be paid to the employee shall be calculated as if he performed such only of the above functions as involves the highest rate of wages under this Agreement.

13.—Full Payment for Shifts.

After beginning a shift, workers shall not be paid less than a full shift's wages, unless they leave of their own accord, or are dismissed for wilful misconduct.

14.—Area.

This Agreement shall be limited in effect to the works and undertakings of the employer situated on the Eastern Goldfields.

15.—Long Service Leave.

(a) All workers who from time to time shall complete 25 years of continuous service with an employer shall be given long service leave. Such long service leave shall be taken at the conclusion of 25 years of continual service and shall comprise 13 weeks' leave of absence for recreational purposes.

(b) Should a worker who has completed fifteen (15) years of continuous service be retired compulsorily on medical ground on the advice of a medical officer appointed by the employer, or by reason of being over the employer's retiring age, or die before completing 25 years' continuous service, there shall be paid by the employer to such worker or to his dependants, as the case may require, a sum of money bearing the same relation to 13 weeks' pay at his rate as his service with the employer bears to 25 years. "Dependant" shall mean the widow and/or children under the age of 16 years, or any child in fact dependent, of any worker, and, in the case of a single worker, shall mean such dependant (if any) as such single worker may in writing notify to the company during his life time, accompanied by proper proof of actual dependency.

(c) Continuous service shall include any interval spent on service with His Majesty's armed forces during the duration of any war on which His Majesty may be engaged, and shall also include any interval spent during the duration of any war on which His Majesty may be engaged with any national service into which a worker is compulsorily drafted for defence purposes.

(d) Unless otherwise agreed in individual cases, long service leave shall be taken at such period as shall be mutually agreed upon within two (2)

years of it becoming due. In default of agreement it shall be taken at such time within such period of two (2) years as the employer shall determine.

(e) Except in the case of a worker who, at the time he becomes eligible for long service leave, is of an age exceeding 60, all long service leave shall be taken by way of actual holiday and not by way of payment in lieu thereof on retirement. A worker who at the time he becomes eligible for long service leave is beyond 60 years of age shall have the option of taking actual holiday under this scheme or of receiving payment in lieu thereof on retirement. Such option shall be exercised by a notice in writing addressed to the employer at the time of becoming eligible for long service leave.

(f) Workers on long service leave shall, while on such leave, continue to be paid at the actual rate (exclusive of overtime or other allowance) enjoyed by them at the commencement of such leave. Except in special circumstances payment shall be at the same times as during normal employment but may be made by cheque by mutual arrangement.

(g) It shall be a condition of every worker's taking long service leave that he (or she):—

- (i) shall not under any circumstances be engaged in any gainful employment while on such leave;
- (ii) shall return to the active service of the employer forthwith at the expiration of leave; and
- (iii) shall not draw any sick or accident pay simultaneously with long service leave pay.

A breach of condition (i) above will result in immediate discharge from the employer's service accompanied by forfeiture of all rights (if any) to retiring allowance or other similar payments or benefits. A breach of condition (ii) above (except as on the grounds of illness necessitating retirement or additional leave on the advice of a medical officer appointed by the employer) will result in forfeiture of all rights (if any) to retiring allowance or other similar benefits or payments.

(h) In order to avoid manning difficulties, the long service leave of workers who become entitled to the same in the first year of operation of the scheme shall be taken during such periods during the first two (2) years of the scheme as shall be mutually agreed upon, and, in default of agreement at such times as the employer may decide.

(i) For the purpose of computation and allotment of long service leave all long service leave shall be deemed to become due on the first January next, following the completion of the periods of fifteen (15) and twenty-five (25) years' continuous service.

(j) The employer shall have the right in cases of emergency to recall any worker from long service leave, in which case the unexpired leave shall be made up on some mutually convenient date.

(k) In order to avoid confusion and embarrassment workers while on long service leave shall not, without the prior permissions of the officer in charge of the particular establishment, visit any of the premises of the employer except for the purpose of collecting pay or transacting genuine business with the employer's officers. Social visits shall not be indulged in. "Establishment" means any brewery, cooperage or workshop, but does not include hotels, or annual picnics or sports or usual weekly competitive sporting activities.

(l) The benefits of long service leave shall be in addition to all benefits at present or hereafter to be enjoyed by workers.

(m) In the event of any governmental or similar long service leave scheme being introduced for industry as a whole, the parties concerned shall meet to consider alterations necessary in order to adjust the scheme to such new conditions.

(n) Notwithstanding anything in this clause contained, no worker nor his legal personal representative shall be entitled to any of the benefits by this clause conferred in any of the following circumstances:—

(i) When, in the opinion of the directors of an employer a worker has committed fraud upon the employer or any defalcation in relation to the

employer, or breach of trust or similar act prejudicially affecting or likely to so affect business or interests of the employer, and is dismissed.

(ii) If the worker shall become a bankrupt or insolvent debtor within the meaning of any Act of Parliament of the Commonwealth of Australia or of the State of Western Australia, or shall assign, alienate or charge his benefits hereunder, or any part thereof, or attempt to do so, or if through his own act or default or any operation or process of law the same shall become vested in or payable to some other persons, firm or company.

This Agreement to commence from 29th November, 1950, and to remain in force for a period of one (1) year from this date.

2. Clause 14—Absence Through Sickness.

Delete this clause and insert in lieu thereof the following:—

14. (a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health at the rate of one-twelfth (1/12th) of a week's pay for each completed month of service: Provided that, subject to subclause (g) hereof, payment for absence through such ill-health shall be limited to one (1) week's pay in each calendar year.

(b) Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(c) This clause shall not apply when the worker is entitled to compensation under the Workers' Compensation Act.

(d) A worker shall not be entitled to receive any wages from his employer for any time lost through any accident not arising out of or in the course of his employment or for any accident wherever sustained arising out of his own wilful default or for sickness arising out of his own wilful default.

(e) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(f) Notwithstanding the provisions of subclause (e) hereof, a worker who has already been allowed paid sick leave on one occasion, shall not be entitled to payment for any further absence unless he produces to the employer a medical certificate stating that he was unable to attend for duty on account of personal ill-health.

(g) Sick leave shall accumulate from year to year so that any balance of the period specified in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year: Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

(h) For the purposes of assessing a worker's entitlement to accumulated sick pay, subclause (g) hereof shall be deemed to have become operative as from the 15th April, 1951.

3. This amendment shall operate as from the beginning of the first pay period commencing after the date hereof.
