### PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 525.

New Tyres and Tubes Manufactured in Australia. IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

#### Citation.

1. This Order may be cited as Prices Control Order No. 525.

#### Revocation.

2. Prices Control Order No. 418 is hereby revoked.

#### Application.

3. This Order shall not apply in relation to the sale of any used tyre or tube.

#### Maximum Prices.

4. I fix and declare the maximum price at which any new tyre or tube manufactured in Australia, of a type and size specified in the Schedule to this Order may be sold by retail, to be the price specified therein.

#### Price Differences to be Observed.

5. Notwithstanding anything contained in the foregoing provisions of this Order, where any seller by retail of new tyres and tubes has customarily allowed any difference in price—

- to any person or to any person included in any class of persons;
- in respect of sales or supplies of certain quantities of such goods; or
- in respect of sales or supplies of such goods under certain conditions of sale or upon certain conditions of payment,

the maximum price fixed by or under this Order in respect of those goods shall, in the case of sales to any such person or persons, or of such quantities, or under such conditions, or upon such terms of payment, be reduced by the allowance of that difference.

### Variation of Maximum Prices by Notice.

6. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any new tyre or tube specified in a notice in pursuance of this paragraph may be sold by retail by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 526.

Cooked Meats and Smallgoods.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantine Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 526.

Revocation.

2. Prices Control Order No. 298, as amended by Prices Control Orders Nos. 339 and 420, are hereby revoked.

Definitions and Interpretations.

3. (a) In this Order and the Schedule hereto, unless the contrary intention appears—

"Perth Metropolitan Area" means all that area comprised within a radius of 12 miles from the General Post Office, Perth;

"South-West Land Division" means the South-West Land Division as defined in the Land Act, 1933-1938, but not including the Perth Metropolitan Area, as defined in this paragraph;

"Carnarvon area" means all that area of Western Australia comprised within a radius of 3 miles from the principal post office at Carnarvon;

"Derby area" means all that area of Western Australia comprised within a radius of 6 miles from the principal post office at Derby;

"Onslow area" means all that area of Western Australia comprised within a radius of 3 miles from the principal post office at Onslow;

"Port Hedland area" means all that area of Western Australia comprised within a radius of 3 miles from the principal post office at Port Hedland;

"Roebourne area" means all that area of Western Australia comprised within a radius of 10 miles from the principal post office at Roebourne;

"Marble Bar area" means all that area of Western Australia comprised within a radius of 3 miles from the principal post office at Marble Bar;

(b) "beef sausages" means sausages manufactured from chopped beef, mutton, lamb, or veal, or any other mixture thereof.

Sales by Wholesale.

4. I fix and declare the maximum price at which the cooked meats or smallgoods specified in the first column of the Schedule to this Order may be sold by wholesale, delivered to retail seller's premises or free on rail or free on board, to be the prices specified in the second column of such Schedule.

## Sales by Retail.

5. I fix and declare the maximum price at which the cooked meats or smallgoods specified in the first column of the Schedule to this Order may be sold by retail in the areas specified herein to be—

- (a) in respect of sales by any person whose place of business is situated in the Perth Metropolitan Area, the prices specified in the third column of that Schedule;
- (b) in respect of sales by any person whose place of business is situated in the South-West Land Division, the prices specified in the fourth column of that Schedule;
- (c) in respect of sales by any person whose place of business is situated in the Carnarvon area, the prices specified in the fifth column of that Schedule;
- (d) in respect of sales by any person whose place of business is situated in the Derby area, the prices specified in the eighth column of that Schedule;
- (e) in respect of sales by any person whose place of business is situated in the Marble Bar area, the prices specified in the seventh column of that Schedule;
- (f) in respect of sales by any person whose place of business is situated in the Onslow area, the prices specified in the sixth column of that Schedule;
- (g) in respect of sales by any person whose place of business is situated in the Port Hedland area, the prices specified in the sixth column of that Schedule;

(h) in respect of sales by any person whose place of business is situated in the Roebourne area, the prices specified in the sixth column of that Schedule;

(i) in respect of sales by any person whose place of business is not situated in any of the areas specified in this Order, the prices specified in the ninth column of that Schedule.

## Exhibition of Price List.

6. Every trader who sells or has for sale by retail any of the cooked meats or smallgoods specified in the Schedule to this Order, the maximum price of which is fixed by or under the provisions of this Order, shall exhibit in a prominent position in his place of business, or if he has more than one place of business, in each of his places of business, in such a manner as to be easily legible to persons contemplating making any purchase or conducting any business at his place of business, particulars of the maximum prices fixed by or under the provisions of this Order for the sale by him of those goods.

## Variation of Maximum Prices by Notice.

7. Notwithstanding anything contained in this Order, I declare the maximum price at which any cooked meats or smallgoods specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given, to be such price as is fixed by the Commissioner by notice in writing to that person.
