Workers' Compensation Act, 1912-1949. ORDER IN COUNCIL.

W.C.B. 31/49.

WHEREAS it is enacted by section 13 of the Workers' Compensation Act, 1912-1949 (as reprinted in February, 1949), that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him but that if an employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer from the operation of the said section; and whereas Midland Railway Company of Western Australia Limited, of Midland Junction, Western Australia, being an employer within the meaning of the said Act, and having duly made application in accordance with the said Act and regulations made thereunder for exemption from the operation of the said section 13 has proved to the satisfaction of the Minister that it has established a fund for insurance against the liability aforesaid and that it has deposited at the Treasury

PHYSIOTHERAPISTS ACT, 1950.

HIS Excellency the Administrator in Executive Council acting in exercise of the powers conferred by section 16 of the Physiotherapists Act, 1950, has been pleased to make the Regulations set forth in the Schedule hereto.

Schedule.

PHYSIOTHERAPISTS ACT, 1950.

Regulations.

Part I.—Citation.

1. These regulations may be cited as the Physiotherapists Regulations, 1951.

Part II.—Application for Registration.

- 2 Any person desiring to be registered as a physiotherapist shall lodge with the Board an application in the form prescribed, together with requisite fee.
 - 3. No application shall be considered unless made in the prescribed form.
- 4. The Board may require any applicant either to appear before it or produce further evidence to support the application for registration.
- 5. Every applicant shall produce proof of identity and evidence of good character.
- 6. The Board may require any applicant to submit statutory evidence as to the correctness or validity of any statement or document connected with the application for registration, and the Board may, at its discretion, accept such declaration as proof of the correctness or validity of the statement or document concerned.
- 7. Any person who makes a false statement, or submits any false or misleading documents, or endeavours to mislead the Board in connection with any matter, commits an offence and on conviction shall be liable to a penalty not exceeding $\pounds 25$.

Part III.—Qualifications Recognised by the Board.

- 8. Any person who proves to the satisfaction of the Board that he is a person of good character and has attained the age of twenty-one years and is not of unsound mind shall be entitled to be registered as a Physiotherapist if he—
 - (a) holds the Diploma of the Physiotherapists' Registration Board of Western Australia; or
 - (b) holds the Diploma of Physiotherapy of the University of Adelaide; or
 - (c) holds the Diploma of Physiotherapy of the University of Queensland; or
 - (d) has completed the course and passed the examinations prescribed by the Australian Physiotherapy Association of New South Wales Branch: or
 - (e) has completed the course and passed the examinations prescribed by the Masseurs' Registration Board of Victoria; or
 - (f) is a member of the Chartered Society of Physiotherapy of the United Kingdom; or
 - (g) establishes to the satisfaction of the Board that he was bona fide engaged and is competent in the practice of physiotherapy in the State for at least twenty-four months during the period of three years immediately preceding the commencement of the Act.

Part IV.—License to Practice.

- 9. After the commencement of the regulations, no person shall practice physiotherapy unless he holds a license so to do issued to him by the Board.
- 10. Every Physiotherapist whose name appears in the Register of Physiotherapists shall be entitled to a license to practice, but whether such physiotherapist applies to the Board for such license or not, he shall, whilst his name continues to appear in the said Register, be liable to pay, and shall pay, the prescribed annual license fee.
- 11. Licenses issued shall be in the prescribed form and shall be signed by the Registrar.
 - 12. Licenses shall expire on 31st December next following the date of issue.
- 13. Every physiotherapist whose name appears on the Register of Physiotherapists, shall apply to the Board during the month of January of each year, for a license to practise.
- 14. Every license fee paid shall be deemed to have been paid on the first day of the month of January of the year in which the payment is made.

Part V.-Withdrawal of Name from Register.

- 15. Any physiotherapist whose name appears on the Register of Physiotherapists, and who has ceased to practise or has left the State of Western Australia, may apply to the Board for withdrawal of his name from the Register. The Board may grant any application for withdrawal of a name from the Register of Physiotherpists.
- 16. Any person whose name has been voluntarily withdrawn from the Register of Physiotherapists may apply to the Board for restoration of his name to the said Register. The Board may direct that the name be restored on payment of the prescribed fees.
- 17. No person shall be liable for payment of license fees for any year in which his name has, for the whole of the year, been withdrawn from the Register.
- 18. Any application for withdrawal of name from the Register of Physiotherapists, or for the restoration of a name voluntarily withdrawn from the Register, shall be made on the prescribed form.
- 19. It shall be lawful for the Registrar to post notice to any Physiotherapist, addressed to him according to his address on the Register, inquiring whether he has changed his address or residence, and if no answer shall be returned to such notice within a period of six months from the posting thereof, the Board may direct that the name of such Physiotherapist be removed from the Register. The Board may restore any name so removed without fee if the person whose name was erased notifies his address before the expiry of the registration year in which his name was removed, and submits an explanation of his failure to reply to a notice despatched pursuant to this rule, which the Board in its discretion, may accept as satisfactory.
- 20. The name of any Physiotherapist registered in the Register of Physiotherapists shall be struck off the Register if the Board is satisfied after inquiry, which the Board may initiate of its own motion, that—
 - (a) before or after registration by the Board he was or has been convicted in any part of His Majesty's Dominions or elsewhere of any offence which in the opinion of the Board renders such Physiotherapist unfit to practise as a physiotherapist; or
 - (b) he is guilty of habitual drunkenness, or drunkenness frequently or at short intervals of time, or of addiction to any deleterious drug; or
 - (c) after registration by the Board he has been guilty of misconduct in a professional respect, or has been convicted for the third time of an offence against this Act or the rules or regulations, or has been disqualified in any part of His Majesty's Dominions or elsewhere from practising as a physiotherapist.

Provided that the expression "misconduct in a professional respect" shall not include any misconduct which, either from its trivial nature or from the surrounding circumstances does not in the public interest require that the physotherapist should be struck off the Register.

21. Any physiotherapist who, after due inquiry by the Board in accordance with the rules, is adjudged by the Board to be guilty of improper practices or misconduct (but not "misconduct in a professional respect") shall be liable to reprimand or suspension of license for a period not exceeding six months, as the Board may decide.

Part VI.—Advertisement Plate, Notice Board or Other Certificate.

- 22. A Physiotherapist shall not insert any advertisement or be a party to any such advertisement relating to his profession or the practice thereof beyond an announcement of change of address, commencement or resumption of practice.
- 23. Every such advertisement shall be "run on" without spacing or display and shall be in the type not larger than that used for the leading articles of the newspaper in which the advertisement is inserted. No more space shall be given to the advertisement than that required for its printing and no additions indicating qualifications, qualifying body, university or college shall be made.
- 24. The number of insertions of any such advertisement shall not exceed the following:—
 - (a) Commencement of practice—twelve consecutive daily insertions over two weeks.
 - (b) Change of address—six consecutive daily insertions over one week.
 - (c) Resumption of practice—after an absence therefrom of not less than four weeks—one insertion; after absence of not less than six months—six daily insertions for one week.
- 25. Where practices are situated in districts where only weekly papers are circulated then in case of change of address or resumption of practice an advertisement shall not exceed one insertion and in the case of commencement of practice an advertisement shall not exceed two consecutive weekly insertions.
- 26. Advertisements shall not be inserted except in papers published at the place of practice.
- 27. Where a physiotherapist changes his address from one place to another in the same town no more than one such change of address in any one year shall be advertised except with permission of the Board.
 - 28. Advertisements shall take the following form:—
 - Mr. A.B. has commenced practice as a Physiotherapist at -
 - Mr. A.B., Physiotherapist, has changed his address from——to——
 - Mr. A.B., Physiotherapist, resumed practice at ————.
 - The words "in partnership with ———" or "as assistant to ———" may be added where appropriate.
- 29. Notwithstanding anything contained in this Part, the Board shall have full authority to advertise in the Public Press as often as it considers advisable for the protection of physiotherapists accepted for military service.
- 30. A physiotherapist shall be entitled to exhibit at the place at which he carries on his profession either plates or notice boards or fixed lights, as the Board may approve, bearing only his name, his qualifications as recognised by the Board, the word Physiotherapist, his hours of attendance and telephone number. Where the sign is exhibited on the ground floor of any premises the letters and figures shall not exceed four inches in size, and when situated upon floors above the ground level shall not exceed 6 inches in size.
- 31. A physiotherapist's name and address shall appear in ordinary type only, in the telephone directory.
- 32. Except as provided in the preceding regulations of this Part a physiotherapist shall not be a party to any other form of advertisement or display relating to his profession as a physiotherapist.

Part VII.—Members of the Board—Tenure of Office.

- 33. The term of appointment of the members of the Board shall be as follows:—
 - (a) The Commissioner of Public Health shall remain a member of the Board by virtue of his office;
 - (b) the medical practitioner member shall hold office for a period of three years from the date upon which he is appointed;
 - (c) of the two physiotherapists-
 - (i) One shall be appointed for one year in the first instance, and thereafter each three years.
 - (ii) One shall be appointed for a term of three years.
 - (d) The member appointed on the nomination of the Senate of the University of Western Australia shall be appointed for a term of three years.

In the event of any vacancy occurring, the person appointed to fill the vacancy shall be appointed only for the unexpired portion of the term, excepting when a vacancy occurs within three months of the date upon which the term would be due to expire, in which case the appointee may be appointed for the unexpired portion of the term plus a further full term. Retiring members shall be eligible for re-appointment.

Fees and Travelling Allowances.

- 34. (a) For attendance at each ordinary meeting but not exceeding twelve meetings per year—
 - (1) The chairman shall be paid £3 3s. 0d.
 - (2) Members other than the chairman shall be paid £2 2s. 0d.
- (b) For attendance at an inquiry conducted by the Board in accordance with the rules— $\,$
 - (1) The chairman shall be paid £4 4s. 0d. for every day on which the Board sits to conduct the inquiry.

- (2) Members who are in attendance other than the chairman shall be paid £3 3s. 0d. for every day on which the Board sits to conduct the inquiry.
- (c) When any member of the Board is required to use his own vehicle when engaged on the business of the Board he shall be paid mileage at the ruling rate for the State Public Service.
- (d) When any member of the Board is required to travel to any place beyond a fifteen mile radius of the G.P.O., Perth, he shall be paid a travelling allowance at the higher scale prescribed for the State Public Service.

Part VIII.—Students—Minimum Age.

35. No student shall be accepted for admission to the course of training unless he has attained or will attain the age of 17 years on 31st December prior to the first year of training.

Part IX.—Miscellaneous.

36. The appendix to these regulations and the forms and notes therein contained shall be deemed to be part of and read as one with these regulations.

 (2) and inserting in lieu thereof the figures "3½";
 - (v) by inserting before "Grade 2" in paragraph (2) the following:—
 "'Grade 1A medium' shall mean potatoes suitable for export and which shall comply with the standard of Grade 1 in all respects other than weight; they shall weigh not less than 3½ ounces nor more than 6 ounces each."
- 2. Regulation 23A (Government Gazette 5/4/1940) is amended-
 - (i) by inserting after the word "State" in line 2 of paragraph (1) the words "or territory";
 - (ii) by adding after "(d) Picklers" in line 4 of paragraph (1) the following:—"(e)" Export Grade; (f) Spring Onions; (g) Bunched Onions."
 - (iii) by inserting after the definition of "Picklers" in paragraph (2) the following definition:—

"Export Grade" shall mean sound onions of similar varietal characteristics weighing from 2 ounces to 6 ounces each.

They shall be-

- (a) firm, dry, well cured, well shaped and topped;
- (b) free from wet or soft rot and other diseases;
- (c) reasonably free from injury, doubles, pipers, peelers, bottle necks, scallions, root growth, sprouting and seed stems.
- (d) reasonably free from adhering soil and other foreign matter.

For the purposes of the preceding subparagraphs—

"doubles" means onions which have more than one distinct bulb visible externally;

"pipers" means onions which have a weak or hollow centre;

"peelers" means onions which have part of the papery skin missing exposing edible flesh; "bottlenecks" means onions which have abnormally thick necks;

"scallions" means onions which have thick necks or poorly developed bulbs;

"spring onions" shall mean onion plants with foliage adhering. They shall be free from dirt or other foreign matter and blemishes caused by disease, insect injury, or sunburn. The maximum diameter of the onion bulbs shall be 1 inch.

"bunched onions" shall mean onions with foliage adhering and which are of the fiat varieties and are bunched for sale. The onions shall be free from dirt or other foreign matter and blemishes caused by disease, insect injury or sunburn. The minimum diameter of the onion bulbs shall exceed 1 inch.

- 3. Regulation 23B (Government Gazette 5/4/1940) is amended by inserting after the word "Onions" in line 1 the words "except 'Spring Onions' and 'Bunched Onions."
- 4. Delete regulation 24 (Government Gazette 21/1/38) and insert in lieu thereof a new regulation 24 as follows:—

24. (a) Whenever under section 4 of the Act an inspector finds any lot or package of products which is not in conformity with the Act or the regulations he shall issue to the owner or agent a certificate in the Form 1 in the Appendix. The inspector may permit the owner or his agent to put such lot or package of products in conformity with the Act or regulation, but the owner or agent shall not sell the lot or package of products unless and until he has obtained a certificate from the inspector in the Form 2 in the Appendix.

(b) Nothing in the preceding provision shall effect the liability of the owner or agent to prosecution under section 3 of the Act.
