PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 533.

Whole Wheat.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 533.

Revocation.

2. Prices Control Order No. 275, as amended by Prices Control Orders Nos. 324, 337 and 422, is hereby revoked.

Definitions.

3. In this Order, unless the contrary intention appears—

“bushel” means 60 lb.;

“ton” means 2,240 lb.;

“by retail” means, in relation to any sale of whole wheat, that such sale is a sale by retail of not more than one ton;

“by wholesale” means, in relation to any sale of whole wheat, that such sale is not a sale by retail as defined herein;

“nearest railway station or siding” means the railway station or siding nearest the wholesale seller’s store;

“Perth Metropolitan Area” means all that area of Western Australia comprised within a radius of 12 miles from the General Post Office at Perth;

“retail seller’s cost-into-store” means the sum of—

- (a) the price paid or payable for that wheat;
- (b) cost of transport from the point of delivery to the retail seller to the retail seller’s store, and
- (c) where the wheat is purchased by the retail seller in bulk, 3d. per bushel for bagging, plus the maximum price fixed for the bag in which the whole wheat is packed.

Sales by Wholesale.

4. I fix and declare the maximum price at which whole wheat may be sold by wholesale to be—

- (a) in respect of sales within the Perth Metropolitan Area, the price specified in the First Schedule to this Order;
- (b) in respect of sales outside the Perth Metropolitan Area, the sum of—
 - (i) the price paid or payable for the whole wheat ex rail truck at the nearest railway station or siding;
 - (ii) the cost of cartage from rail to the wholesale seller’s store;
 - (iii) where whole wheat is purchased in bulk, the maximum price fixed for the bag in which it is packed; and
 - (iv) a margin at the rate of—
 - (i) 9 pence per bushel for sales ex store;
 - (ii) 12 pence per bushel delivered free on rail, free on wharf or to purchaser’s premises;
 - (iii) 15 pence per bushel delivered free on board.

Sales by Retail.

5. I fix and declare the maximum price at which whole wheat may be sold by retail to be the retail seller's cost-into-store plus the margin as set out in the Second Schedule to this Order, according to the quantity sold and the point of delivery.

Variation of Maximum Prices by Notice.

6. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which whole wheat specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 534.

Meat Meal and Bone Meal.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 534.

Revocation.

2. Prices Control Order No. 423 is hereby revoked.

Definitions.

3. In this Order and the Schedule thereto, unless the contrary intention appears—

“meat meal” includes whale meat meal;

“bone meal” includes whale bone meal;

“prevailing price” means, in relation to the sale of any meat meal or bone meal by any person other than a retail seller, the price at which that person sold meat meal or bone meal of that class or kind on the 18th day of July, 1951, upon substantially

the same terms and conditions, or if no such sale was made by that person on that date upon substantially the same terms and conditions, then the last preceding date upon which such a sale was made by that person upon substantially the same terms and conditions;

“cost per ton into store of the retail seller” means the price paid or payable for the meat meal or bone meal, plus the cost of transport actually incurred and properly attributable to conveying the meal from the point of delivery to the retail seller to that retail seller's store.

Maximum Wholesale Price.

4. I fix and declare the maximum price at which meat meal or bone meal may be sold by any person by wholesale to be the prevailing price.

Maximum Retail Price.

5. I fix and declare the maximum price at which meat meal or bone meal may be sold by any person by retail to be the sum of—

- (a) the purchase price paid or payable by the retail seller;
- (b) the cost of transporting the meat meal or bone meal from the point of delivery to the retail seller, to that retail seller's store;
- (c) (i) where sold ex store, the margin specified in the Schedule to this Order, according to the cost into store of the retail seller and the quantity sold; or (ii) where delivered free on rail, free on wharf or to the purchaser's premises, the margin specified in the Schedule to this Order, according to the cost into store of the retail seller and the quantity sold, plus 12s. 6d. per ton; or (iii) where delivered free on board a vessel, the margin specified in the Schedule to this Order, according to the cost into store of the retail seller and the quantity sold, plus 12s. 6d. per ton and the actual transport charges from wharf to vessel.

Variation of Maximum Prices by Notice.

6. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any meat meal or bone meal specified in a notice given in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 535.

Ales, Lagers and Stouts—Northampton Areas.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 535.

Revocation.

2. Prices Control Order No. 395, as amended by Prices Control Order No. 476, is hereby revoked.

Definitions.

3. In this Order and the Schedule thereto, unless the contrary intention appears—

- (a) "goods specified" means any of the goods specified in the Schedule to this Order;
- (b) "Northampton areas" means all those areas of Western Australia comprised within a radius of 3 miles from the principal post office of each of the following towns:—Northampton, Nabawa, and Yuna;
- (c) "oz." means a fluid ounce or ounces, as the case may be;
- (d) (i) "small 5 oz. glass" means, any glass or similar container containing less than 5 oz.;
- (ii) "5 oz. glass" means any glass or similar container containing 5 oz. or more, but less than 7 oz.;
- (iii) "7 oz. glass" means any glass or similar container containing 7 oz. or more, but less than 8 oz.;
- (iv) "8 oz. glass" means any glass or similar container containing 8 oz. or more, but less than 10 oz.;
- (v) "10 oz. pot or glass" means any glass or similar container containing not less than 10 oz.;
- (vi) "bottle" means a reputed quart (26 oz.).

Maximum Prices—Quantities Specified in Schedule.

4. I fix and declare the maximum price at which any variety or quantity of the goods specified in the Schedule to this Order may be sold by any person by retail in the Northampton areas to be the price specified in that Schedule.

Quantities Not Specified.

5. I fix and declare the maximum price at which any of the goods specified in the Schedule to this Order may be sold by any person in quantities other than those specified in that Schedule, to be the maximum price fixed by the foregoing provisions of this Order for the next smaller quantity of such goods specified in that Schedule, or if there is no small quantity specified, then such price (calculated to the nearest downward half-penny) as bears the same ratio to the maximum price fixed for the next higher measure or quantity as the quantity actually sold bears to the next higher quantity.

Sales in Dining-room or Lounge.

6. Notwithstanding the foregoing provisions of this Order, I fix and declare the maximum prices at which any quantity of the goods specified in the Schedule to this Order may be sold by any person in any hotel dining-room or lounge in the Northampton areas to be the prices specified in the said Schedule, plus an amount equal to the difference between the hotel dining-room or lounge prices respectively charged by that person on 17th day of September, 1948, for any such goods, and the public bar prices charged by that person for such goods on such date: Provided that if in the case of any sale, by reason of the absence of records such difference between the hotel dining-room or lounge prices and the public bar prices on the 17th day of September, 1948, cannot be ascertained, the provisions of this paragraph shall not apply, and such sale shall be deemed to have been made in the public bar.

Exhibition of Maximum Prices.

7. Every person who sells or has for sale by retail in the Northampton areas any goods, the maximum price for the sale of which is fixed by or under the provisions of this Order, shall exhibit in a prominent position in his place of business, or if he has more than one place of business, in

each of his places of business and in each of his bars, lounges, dining-rooms or other places, at such place or places of business where such goods are sold or had for sale, particulars of the maximum prices fixed by or under the provisions of this Order for the sale by him of such goods.

Variation of Maximum Prices by Notice.

8. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any goods, a maximum price for the sale of which is fixed by the foregoing provisions of this Order and which are specified in a notice given in pursuance of this paragraph, may be sold in the Northampton areas by any person to whom such notice is given, to be such price as is fixed by the Commissioner by notice in writing to such person.

Ales, Lagers and Stouts—Geraldton Area.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 536.

Revocation.

2. Prices Control Order No. 394, as amended by Prices Control Order No. 475, is hereby revoked.

Definitions.

3. In this Order and the Schedule thereto, unless the contrary intention appears—

- (a) "goods specified" means any of the goods specified in the Schedule to this Order;
- (b) "Geraldton area" means all that area of Western Australia comprised within a radius of 3 miles from the principal post office at Geraldton;

- (c) "oz." means a fluid ounce or ounces, as the case may be;
- (d) (i) "small 5 oz. glass" means any glass or similar container containing less than 5 oz.;
- (ii) "5 oz. glass" means any glass or similar container containing 5 oz. or more, but less than 8 oz.;
- (iii) "8 oz. glass" means any glass or similar container containing 8 oz. or more, but less than 12 oz.;
- (iv) "12 oz. pot or glass" means any glass or similar container containing not less than 12 oz.;
- (v) "bottle" means a reputed quart (26 oz.).

Maximum Prices—Quantities Specified in Schedule.

4. I fix and declare the maximum price at which any variety or quantity of the goods specified in the Schedule to this Order may be sold by any person by retail in the Geraldton area, to be the price specified in that Schedule.

Quantities Not Specified.

5. I fix and declare the maximum price at which any of the goods specified in the Schedule to this Order may be sold by any person in quantities other than those specified in that Schedule, to be the maximum price fixed by the foregoing provisions of this Order for the next smaller quantity of such goods specified in that Schedule, or if there is no smaller quantity specified, then such price (calculated to the nearest downward halfpenny) as bears the same ratio to the maximum price fixed for the next higher measure or quantity as the quantity actually sold bears to the next higher quantity.

Sales in Dining-room or Lounge.

6. Notwithstanding the foregoing provisions of this Order, I fix and declare the maximum prices at which any quantity of the goods specified in the Schedule to this Order may be sold by any person in any hotel dining-room or lounge in the Geraldton area to be the prices specified in the said Schedule, plus an amount equal to the difference between the hotel dining-room or lounge prices respectively charged by that person on 17th day of September, 1948, for any such goods, and the public bar prices charged by that person for such goods on such date: Provided that if in the case of any sale, by reason of the absence of records such difference between the hotel dining-room or lounge prices and the public bar prices on the 17th day of September, 1948, cannot be ascertained, the provisions of this paragraph shall not apply, and such sale shall be deemed to have been made in the public bar.

Exhibition of Maximum Prices.

7. Every person who sells or has for sale by retail in the Geraldton area, any goods, the maximum price for the sale of which is fixed by or under the provisions of this Order, shall exhibit in a prominent position in his place of business or, if he has more than one place of business, in each of his places of business, and in each of his bars, lounges, dining-rooms or other places, at such place or places of business where such goods are sold or had for sale, particulars of the maximum prices fixed by or under the provisions of this Order for the sale by him of such goods.

Variation of Maximum Prices by Notice.

8. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any goods, a maximum price for the sale of which is fixed by the foregoing provisions of this Order and which are specified in a notice given in pursuance of this paragraph, may be sold in the Geraldton area by any person to whom such notice is given, to be such price as is fixed by the Commissioner by notice in writing to such person.
