#### NURSES REGISTRATION ACT, 1921-1948.

1. Regulation 29 paragraph (1) of Part V—Training and Examination of Nurses is amended by adding after the word "months" in line 4 the words "and in the case of a trainee as a mothercraft nurse, in which case the period shall be four months."

2 Part V, Division 1-Examinations is amended by-

(a) Deleting regulation 31 and inserting in lieu thereof a new regulation 31 as follows:

31. The Board shall hold an examination for registration on completion of training in the subjects prescribed in the course of study for the particular branch of nursing for which she desires registration, and a First Professional Examination at the end of the first year of training in the subjects prescribed in the course of study for the first year of training.

Provided that, when a course of study approved by the Board is taken prior to the commencement of training, the Board may permit the candidate to present herself for Part I (Anatomy and Physiology and Hygiene) of the First Profes-sional Examination before commencing training, or grant credit for passing an approved examination of equal standard after such a course of study, and may grant exemption from the lectures in the subjects of Part I during training, and from any written examination in these subjects.

#### (b) inserting after regulation 31 a new regulation 31A as follows:-

31A. (1) In the event of a candidate failing to satisfy the examiners at the First Professional Examination taken by her, such candidate may be permitted to sit for one but not more than one deferred examination in the subjects in which she failed to satisfy the examiners as aforesaid. A candidate who is permitted to sit at a deferred examination and who qualifies at such deferred examination in all subjects in which she failed to satisfy the examiners as aforesaid, shall be deemed to have passed the First Professional Examination, but such candidate shall not be eligible to sit for the examination for registration until at least twenty (20) months have elapsed after she has passed the First Professional Examination.

(2) Any trainee who fails to comply with the preceding provisions of this regulation shall discontinue training provided always that the Board may in its absolute discretion and subject to such times and conditions as it thinks fit permit any such trainee to re-commence one of the prescribed courses of training.;

(c) deleting regulation 34 and inserting in lieu thereof a new regulation 34 as follows:—

34. (1) Candidates for admission to the First Professional Examination shall make application to the secretary of the Board in accordance with Form No. 14A in Appendix I to these regulations, not later than one month before the date of such examination.

(2) The application shall be accompanied by the prescribed examination fee and a statement signed by the matron showing—

(a) the date on which training commenced;

- (b) that the applicant has attended the prescribed course
- of lectures and passed the necessary examination; and

(c) that the applicant has had the practical experience prescribed by these regulations;

(d) deleting regulation 42 and inserting in lieu thereof a new regulation 42 as follows:—

42. In the event of a candidate failing to satisfy the examiners at the first examination for registration taken by her, such candidate may be permitted to sit for a subsequent examination or examinations for registration, upon payment on each occasion of a further entrance fee as prescribed in Appendix II to these regulations.

3. Regulation 43 of Part V, Division 2—Attendances at Lectures, etc. is amended by inserting after paragraph (1) a new paragraph (1A) as follows:—

(1A) Instruction in invalid cookery may be given at the training hospital by a qualified dietitian approved by the Board, or, in lieu thereof, may be given by a qualified cookery teacher approved by the Board.

4. Regulation 7 of Part VI—Mothercraft Nurses Training Schools (Government Gazette, 23/9/49) is amended by deleting the figures and symbols in brackets, "(10s.)" in line 3.

#### Schedule.

1. (1) These by-laws may be cited as the Murray Trout Acclimatisation Society By-laws.

(2) In these by-laws "Council" means the Council of the Society, and "Society" means the Murray Trout Acclimatisation Society.

2. It shall not be lawful for any person to fish for trout with any net or fixed engine in any part of any river, creek or stream upwards from its mouth to its source.

3. The open season for trout shall be the period commencing on the 1st day of November in each year and ceasing on the Monday after Easter Monday, in the year next following, and the fishing for trout at any time other than during such open season is hereby prohibited.

4. No person shall at any time fish for trout in the waters of any part of the Banksiadale Dam other than by means of a rod and line, and artificial lure. 5. (1) A person holding a general licence from the Society issued in the form in the Appendix hereto may, subject to the conditions prescribed by by-laws 4 and 6, fish for trout in any waters.

(2) Every such general licence shall endure from the date on which it is issued to the date on which the then current open season shall cease.

A special fishing licence may be issued to persons non-resident in the Society's area for a period of one week for 10s. (ten shillings).

(3) Any person who is not the holder of a licence issued under these by-laws shall not fish for trout.

(4) The fee for every such general licence shall be as provided in Rule 8 of the Society.

6. Every licence under by-law 5 hereof shall be issued, subject to the following conditions:— (a) That the holder shall not fish for trout in

- (a) that the noider shall not fish for trout in any waters—
  - (i) during any period other than the period determined by by-law 3 as the open season for trout;
  - (ii) in which it is declared by any by-law that no person shall fish for trout;
  - (iii) on any day later than one hour after sunset or earlier than one hour after sunrise;
  - (iv) on any day on which he has already taken six trout;
  - (v) tackle shall consist of a single rod and line held in the hand. Lures shall consist of any artificial bait or any whole natural bait, which is the natural food of trout. Fishing in other than the mainstreams of the Murray and Dandalup Rivers with worms is prohibited.

(b) That the holder shall not take any trout of a less length than twelve inches measured from the tip of the snout to the end of the tail, and that any trout of a less length than twelve inches shall forthwith be returned unharmed to the water from which it was taken.

(c) That the holder shall within one week of taking any trout report to the secretary of the Society the length, the weight, and the nature of the contents of the stomach of every such trout.

7. (1) For the purpose of preventing offences under these by-laws the Council may appoint wardens who shall within the area in which the Society is registered have the powers conferred upon an inspector by the Fisheries Act, 1905-1949.

(2) Any complaint for an offence under these by-laws may be laid by the president or secretary of the Society.

(3) All engines, lines, nets and other articles, but not any boat, used by or in the possession of any person, in breach of any of these by-laws, shall be forfeited to the use of His Majesty.

(4) Where the commission of any offence against these by-laws involves the forfeiture of any article. the conviction of any person for such offence shall operate as a condemnation of such article, without the necessity of any complaint being laid for such condemnation.

8. Any person guilty of a breach of any of these by-laws or of any of the conditions endorsed on his licence shall be liable to a penalty of  $\pounds 5$  on conviction.

#### LAND ACT, 1933-1950.

By-laws—Houtmans Abrolhos Islands.

Department of Lands and Surveys, Perth, 20th February, 1951.

Corres. 3756/29.

HIS Excellency the Administrator in Executive Council, acting pursuant to section 34 of the Land Act, 1933-1950, has been pleased to revoke the bylaws relating to the control and management of the Houtmans Abrolhos Islands under the said Act, and published in the *Government Gazette* on the 23rd day of September, 1932, and substitute in lieu thereof the by-laws set forth in the Schedule hereunder.

#### Schedule.

1.—Injuring or Destroying Trees, etc. No person shall injure, cut, break, deface, pull up, remove or destroy any tree, shrub, plant, or flower growing on the said Islands, or cut or remove any dead wood or timber therefrom.

## 2.—Injuring the Soil or Surface, etc.

No person shall break or interfere with the soil or surface of any part of the said Islands, or with any improvements or works thereon, and, subject as hereinafter provided, no person shall interfere with or destroy any birds or animals thereon.

#### 3.—Persons Misconducting Themselves.

No person shall commit any riotous or indecent act, or make use of any indecent or improper language, or commit any nuisance on the said Islands.

### 4.—Posting Bills.

No person shall write or affix, or be concerned in writing or affixing on the Islands, or to anything thereon, anything written or printed or any picture, placard or advertisement, unless the consent in writing of the trustees of Houtmans Abrolhos Islands, or of an officer of the Trustees authorised in that behalf shall have been pre-viously obtained.

#### 5.—Shooting, etc., on the Islands.

No person shall have in his possession any fire-arm on any portion of the Islands, unless the consent in writing of the trustees of Houtmans Abrolhos Islands or of an officer of the trustees, authorised in that behalf shall have been previously obtained.

#### -Selling Goods on the Islands

No person or persons shall sell or expose for sale anything on any portion of the said Islands, unless the consent in writing of the trustees of Houtmans Abrolhos Islands, or an officer of the trustees authorised in that behalf shall have been previously obtained.

## 7.---Waste Litter to be Removed.

Every person who shall at any time be on the said Islands, shall collect or remove, or cause to be collected and removed, all waste matter, broken glass, or rubbish of any kind which was brought on the ground by him, or in the bringing of which, on the ground, he was in any way concerned.

# 8.—Dogs or other Animals not to be Allowed on Islands.

No person shall cause or suffer dogs or other animals to be upon the Islands without special approval in writing of the trustees of Houtmans Abrolhos Islands, or an officer of the trustees authorised in that behalf.

## 9.—Permits to Land.

No person (not being a person exempted under No person (not being a person exempted under by-law 13 hereof) shall land and/or remain on the said Islands without having first obtained a permit hereunder. A permit shall authorise the person to whom it is granted to land and/or remain on the said Islands, for a period not exceeding the period stated therein from the date of the granting of the normality. of the permit.

#### 10.--Remaining on the said Islands.

No person shall remain on the said Islands for a longer period than his permit authorises.

#### 11.—From whom Permits Obtainable.

Permits may be granted by any captain of any boat authorised in writing by the trustees to carry passengers, and holding the special license of the Board to do so, or by any member or officer of the trustees authorised in that behalf, on the pay-ment of the prescribed fee of 15s. to the secretary of the Trustees.

#### 12.—Form of Permit.

Every permit shall state the name of the person to whom it is issued, the date of issue, and the time when the permit expires, and no permit shall be transferrable.

## 13.-Exemptions-Landing Permit.

The following persons are exempted from the provisions of by-law 9:—Children under 14 years of age, officials and workmen of the trustees, mem-

bers of the trustees, officers of a Government department, lessees from/or persons exempted by the trustees and any person who is the holder of a fisherman's license where the holder of such license does not camp, or reside, or store goods, gear, or effects of any kind from the Islands or any of them.

### 14.—Landing Fees.

The prescribed fees per person for a permit will be:—(1) Tourist Landing Permit, 15s. Permit to be for each continuous period of 21 days or part thereof. No landing fees shall be chargeable against any of the classes of persons who come within by-law No. 13.

#### 15.—Trespassers.

Any person not being a person exempted under by law 13 hereof landing at the said Islands with-out first having obtained a permit, or who having obtained a permit remains on the said Islands after the period for which his permit is issued, shall be deemed a trespasser, and shall be guilty of a breach of these by-laws.

## 16.-Plying for Hire.

No boat, aircraft, vehicle or other craft shall ply for hire within the trustees' jurisdiction what-soever, unless licensed by the trustees in writing and under such terms and conditions as may be imposed.

## 17.-Removal Without Permission.

No person or persons shall remove anything whatsoever from the said land or water under the trustees' jurisdiction, without special permis-sion in writing and under such terms and condi-tions as the trustees prescribe: Provided that nothing herein contained shall prohibit any licensed fisherman under the Fisheries Act 1905-1921 from fisherman under the Fisheries Act, 1905-1921, from lawfully obtaining fish (including crayfish) also taking game, pursuant to the terms of their respective license or any person holding a license to re-move fertiliser deposits from the reserve issued under the provisions of the Land Act, 1933-1950.

## 18.-Erection of Buildings, Jetties, etc.

No person shall erect, or cause to be erected, any building, jetty or other structure on the Islands, unless by special permission in writing and under such terms and conditions as the trustees may prescribe.

## 19.—Permits, Orders, Licenses, etc.

All orders, licenses, permits, etc., shall bear the signature of the president and secretary of the . trustees, or their deputies for the time being.

## 20.—Fishermen's Occupational Charges.

A charge of £2 per annum is payable to the trustees by occupiers of the tents erected on the Islands, within the control of the trustees. This charge is payable in respect of each tent or hut, but, does not authorise the trustees to levy a charge against more than one person in occupation in any one year. The charge is payable on the 1st day of April in each year from which date the 1st day of April in each year from which date the year for the purpose of calculation of charge shall commence. "Occupier" includes a person having the charge, management or control of the hut or tent during any part of the year.

## 21.—Penalty.

Any person who is guilty of any contravention (by act or omission) of any of the foregoing by-laws shall be liable on summary conviction to a penalty not exceeding £20 0s. 9d. And upon such conviction the trustees may cancel his permit to land and thereafter refuse to issue a further per-mit to him. mit to him.

WHEREAS under the provisions of the Road Districts Act, 1919-1948, the Governor may make uniform general by-laws for all or any of the purposes for which by-laws may be made under the said Act; and whereas under the said provisions such by-laws shall have the force of law in any districts which the Governor may from time to time prescribe: Now, therefore, His Excellency the Administrator, acting under the said provisions and with the advice and consent of the Executive Council, doth hereby make the following uniform general by-law for the prevention of damage to roads, and doth further prescribe that the said by-law shall come into operation and have the force of law within the road districts set out in the Schedule hereto.

#### Uniform General By-law.

#### Prevention of Damage to Roads.

1. This by-law may be cited as the "Prevention of Damage to Roads By-law, 1951."

2. The Board may, for the prevention of damage or injury to any road vested in or under its control, by order at any time and for such periods as the Board considers necessary, close to vehicular traffic such road or any portion thereof, if, in the opinion of the Board, the passing of vehicles over such road or portion thereof is likely to cause damage or injury to such road.

Provided that no road shall be closed to traffic for a longer period than 28 days, or for periods aggregating more than 28 days in any period of 12 months, without the previous permission of the Minister.

3. Whenever an order is made by a Board in pursuance of the provisions of paragraph 2 hereof with respect to any road or portion thereof, the Board shall—

- (i) bring to the notice of the public such order—
  - (a) by causing a copy thereof to be affixed to the ordinary notice board of the Board;
  - (b) by broadcasting the text of such order from such broadcasting stations within the State as the Board considers necessary or expedient for the purpose; and
  - (c) by placing or erecting, where practicable, in conspicuous places in or near to such road or portion thereof such notices and signs as the Board considers necessary;
- (ii) whenever possible and practicable, cause such fences and barriers to be placed on or across such road or portion thereof as the Board may deem proper;
- (iii) during the time such fences and barriers shall remain so placed, cause to be affixed thereon such lights, during the night, as shall be sufficient to prevent injury or damage to vehicles and passengers; and
- (iv) provide, where necessary and practicable, suitable and passable alternative or side tracks alongside or in the vicinity of such road or portion thereof.

4. Every order made in pursuance of the provisions of paragraph 2 hereof shall cease to have effect on the date of expiry of such order if stated therein, or, if no such date is stated, on the expiration of 28 days from the making thereof, and, where permission of the Minister is obtained to extend the operation of an order for a longer period than 28 days, then on the expiration of such extended period for which such permission has been obtained. 5. Every person who drives or impels or causes to be driven or impelled any vehicle on a road or portion thereof which has, pursuant to the provisions of paragraph 2 hereof, been closed to vehicular traffic, shall be guilty of an offence.

THIS Agreement, made in pursuance of the Indus-trial Arbitration Act, 1912-1950, this first day of July, one thousand nine hundred and fifty-one, between the Westralia Cooperage Pty. Limited (hereinafter called "the Employer") of the one part, and the Federated Coopers of Australia, W.A. Branch, Industrial Union of Workers, of Perth, Western Australia (hereinafter called "the Union") of the other part, witnesseth that for the consideraof the other part, witnesseth that for the considera-tions hereinafter appearing, the parties hereto mutually covenant and agree the one with the other, as follows:----

#### 1.—Title.

This Agreement shall be known as the Coopers' Agreement, 1951, and replaces Agreement No. 30 of 1948.

#### 3 — Area

This Agreement shall operate over the area comprised within a radius of fifty (50) miles from the G.P.O., Perth, and within a radius of five (5) miles from the Post Office, Albany.

#### -Term.

The term of this Agreement shall be for a period of one (1) year from the date hereof.

## 5.—Scope.

This Agreement shall apply to the employment of coopers and machinists.

#### 6.—Weekly Hiring.

Except as provided in subclause 10 (c) hereof, the engagement of workers under this Agreement shall be a weekly one terminable by one week's notice on either side. Provided that the employer may at any time dismiss a worker for misconduct.

#### 7.—Hours.

Forty (40) hours shall constitute a week's work to be worked between the hours of 7.30 a.m. and 5.30 p.m. Monday to Friday inclusive.

#### 8.-Overtime.

(a) All work performed in excess of eight (8) hours per day or outside the hours prescribed in clause 7 hereof shall be paid for at the rate of time and a half.

(b) When overtime is worked a meal break of not less than thirty (30) minutes shall be allowed at a time mutually agreed upon between the employer and the worker.

(c) All time worked on Sundays shall be paid for at the rate of double time.

(d) All time worked on the holidays prescribed in clause 11 (a) hereof shall be paid for at the rate of time and a half in addition to the day's pay which the worker would ordinarily receive in respect of such holiday.

(e) Notwithstanding anything contained in this Agreement-

(i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.

(ii) No organisation party to this Agreement or worker or workers covered by this Agreement shall in any way, whether directly or indirectly be a party to or con-cerned in any ban, limitation, or restric-tion upon the working of overtime in accordance with the requirements of this subclause.

#### 9.—Tea Money,

When a worker without being notified on the previous day is required to continue work after the usual finishing time for more than one (1) hour, he shall be provided with any meal required or shall be paid the sum of two shillings and six-pence (2s. 6d.) in lieu thereof.

#### 10.-Wages.

The minimum rates of wages payable to workers covered by this agreement shall be as follows:-Per Week.

(b) Coopers and for machinists ....

(c) Casual Workers-

A casual worker shall mean a worker who is employed for less than two (2) weeks and shall be paid at the rate of ten per cent. (10%) in addition to the ordinary rate of wage prescribed above.

#### 11.—Annual Leave and Public Holidays.

(a) Subject to clause 8 (d) of this agreement the following days or the days observed in lieu thereof shall be observed as holidays without de-duction of pay, namely, New Year's Day, Australia Day, Labour Day, Good Friday, Easter Monday, Anzac Day, Foundation Day, Brewery Employees' Picnic Day, King's Birthday, Show Day, Christmas Day and Boxing Day.

(b) On any public holiday not prescribed as a holiday under this agreement, the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done ordinary rates of pay shall apply.

(c) Except as hereinafter provided a period of two (2) consecutive weeks leave with payment of double wages as prescribed and two (2) days with allowed annually to a worker by his employer after a period of twelve months continuous service with such employer.

(d) If any award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(e) If after three (3) months continuous service in any qualifying twelve (12) monthly period a worker lawfully leaves his employer or his employ-ment is terminated by the employer through no fault of the worker, the worker shall be paid onethird (½) of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(f) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this agreement, shall not count for the purpose of determining his right to annual leave.

(g) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (e) of this section, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(h) A worker who is dismissed for misconduct or who illegally severs his contract of service, shall not be entitled to the benefit of the provisions of this clause.

(i) The provisions of this clause shall not apply to casual workers.

#### 12.—Apprentices.

(a) The Arbitration Court's Standard Apprenticeship Regulations, 1941, shall form part of and be embodied in this agreement.

12 (a).—Proportion of Apprentices.

The proportion of apprentices shall be one (1) for every three (3) or fraction of three (3) journeymen employed.

#### 13.—Absence Through Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week for each completed month of service: Provided that payment for absence through such ill-health shall be limited to one week in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment or for any accident, wherever sustained, arising out of his own wilful default or for sickness arising out of his own wilful default.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(d) No worker shall be entitled to the benefits of this clause unless he notifies or causes his employer to be notified not later than 10 a.m. on the day he first absents himself from duty that he is unable to attend for duty.

#### 14.—Breakdowns, etc.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the union or unions affiliated with it, or by any other association or union, or through the breakdown of the employer's machinery or any stoppage of work by any cause which the employer cannot reasonably prevent.
