WHEREAS it is enacted by section 11 of the Native Administration Act, 1905-1947 (Reprinted) that the Governor may by Proclamation declare any Crown lands to be Reserves for Natives and abolish

any reserve so declared; and whereas by Proclamation issued under the Native Administration Act, 1905-1941 and published in *Government Gazette* on the 17th day of October, 1947, the Governor declared an area at Onslow more particularly described as reserve 22675 (Onslow Lot 379) to be a Reserve for Natives; and whereas it is now deemed desirable and expedient to abolish the said reserve: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council and in exercise of the power in that behalf conferred by section 11 of Native Administration Act, 1905-1947 (Reprinted), do hereby abolish the reserve for natives as declared and described and defined in the hereinbefore mentioned Proclamation published in the *Government Gazette* on the 17th day of October, 1947.

WHEREAS by section 33 of the Land Act, 1933-1950, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order, and with power of sub-leasing; and whereas it is deemed expedient that reserve No. 23553 (Carnarvon Lot 647) should vest in and be held by the Carnarvon Municipal Council in trust for Recreation (Golf Links): Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Carnarvon Municipal Council in trust for Recreation (Golf Links), with power to the said Carnarvon Municipal Council, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding twenty-one (21) years from the date of the lease.

LAND AND INCOME TAX ASSESSMENT
ACT, 1907-1948.

Land Tax—Notice to Make Returns.

NOTICE is hereby given that every person who was at noon on the 30th day of June, 1952, the owner, within the meaning of the said Act, of any land whatsoever in Western Australia and who is liable to land tax, is hereby required to make and furnish to me at the office of the Commissioner of Taxation, Perth, on or before the 31st day of August, 1952, a land tax return in the prescribed form.

A return form A should be lodged by all persons owning land who have not previously rendered a land tax return. A return form GA in lieu of return form A should be lodged by a land owner (not liable for Federal land tax) who has bought or sold land or who has effected or varied improvements on land since 30th June, 1951. Where there have been no such changes, a further return will not be required.

Penalty for not furnishing a return—not less than £2 nor more than £100. Penalty for making a false return—not less than £2 nor more than £100 and treble tax.

Taxpayers may obtain return forms at the Taxation Department, Perth, or at any Post Office in Western Australia.

Schedule.

By-laws for the Regulation of the Wubin Memorial Park, pursuant to the Parks and Reserves Act, 1895-1947.

WHEREAS the Wubin Memorial Park, Wubin, is an "A" Class reserve gazetted under the provisions of the Permanent Reserves Act, 1899, and is vested in the Wubin Memorial Park Board, hereinafter called "the Board," under and by virtue of the provisions of the Parks and Reserves Act, 1895-1947.

And whereas the undersigned are the members of such Board under the provisions of the said Statute.

Now, therefore, the members of the Board, in pursuance of the powers vested in them by the Parks and Reserves Act, 1895-1947, hereby make

the following by-laws for the regulation of the park, and hereby impose the following penalties, that is to say:—

1. In the constructions of these by-laws, the expression "the park" means the Wubin Memorial Park, and includes any part thereof. The expression "unauthorised person" means any person other than a person for the time being being duly authorised in writing by an officer of the Board.

2. No unauthorised person shall do any of the following acts on the Park, that is to say:—

(i) Cut, pluck, injure, or destroy any tree, bush or flower growing thereon.

(ii) Dig, cut, or remove any sod, turf, loam, sand, gravel, or other substance thereon or therefrom.

(iii) Light any fire, or wilfully, carelessly, or negligently do any act which may cause, or be likely to cause, damage by fire to anything growing or being thereon.

(iv) Wilfully, carelessly, or negligently deposit or leave thereon, or on any part thereof, any rubbish, bricks, manure, timber or other substance or material whatsoever.

(v) Catch or trap any bird, or lay or place any trap for the taking of birds, or take any bird's egg or nest, or shoot or chase or disturb any game or other animal.

(vi) Cause or suffer any horse, pony, mule, ass, bull, ox, cow, calf, heifer, steer, sheep, lamb, goat, hog, or sow, belonging to him, or in his charge, to enter or go thereupon.

(vii) Encamp thereon, or erect or place thereon, any booth, tent, shed, stand, screen, post, rail, fence, swing chair or seat (other than a camp-stool, or other portable chair or seat), or other erection or obstruction of any kind whatsoever, or make any enclosure of any part thereof.

(viii) Carelessly, negligently or wilfully injure, deface or remove any seat, notice, or notice board, post, chair, railing fence, barrier or other thing which may be from time to time erected or placed thereon by or by the authority of the Board.

(ix) Post or paint any bill, placard, or notice thereon, or on any fence, erection, or tree thereon.

(x) Paint, write, cut, carve, or in any manner inscribe letter, figures, or marks upon, or otherwise disfigure, any rock or tree, or any wall or fence, or other structure or erection on the park.

(xi) Drive any vehicle, save along any stoned, metalled, gravelled or otherwise defined road.

(xii) Ride any horse, pony, donkey, or other animal, or drive any vehicle on the park, except in places prescribed in writing by the Board.

(xiii) Brawl, fight, use indecent language, or act in an indecent, disorderly, or offensive manner, or sell, distribute, or exhibit any indecent, or infamous book, picture, or representation to the obstruction, annoyance, or danger of persons resorting to the park.

(xiv) Fire or discharge any firearm, or throw or discharge any missile.

(xv) Climb any tree thereon.

(xvi) Sell or let for hire any article, or distribute any bill or like thing, or place any chair or seat for hire without the consent in writing of the Board under the hand of some official.

(xvii) Play any game or athletic sport upon the park, except in such areas and at such times and subject to such conditions and after payment of such fees and charges as may from time to time be prescribed in writing by the Board.

(xviii) Deliver or read any public speech, lecture, prayer, sermon, or address of any kind, or sing any sacred or secular song, or enter into any public discussion, or hold or cause or take part in any public assemblage, except between morning and sunset, and on the site or sites (if any) approved by the Board and defined by notice-boards.

(ixx) Play or make sounds on any musical instrument without the consent of the Board in writing under the hand of some official.

(xx) Bathe or wash or wash clothes or other articles in any water on the park, except under such conditions, in such places, at such times, and in such manner as the Board may from time to time in writing prescribe, and not to carry away or otherwise remove or use any water therein, whether natural water or otherwise.

(xxi) Cause or allow any dog to enter any portion of the park, except under control on a leash.

(xxii) Wilfully interfere with or obstruct the authorised user of the park, or wilfully obstruct any officer of the Board in the execution of his duty or in the proper execution of any work in connection with the laying out, planting, improvement or maintenance of the park.

(xxiii) Do, aid in, or abet any act or thing which may not in these by-laws be specifically mentioned and which may tend to the injury or disfigurement of the park, or to interfere with the use thereof for the public for the purposes of exercise and recreation.

3. Where by a notice or notices which shall be conspicuously exhibited on the park, the Board shall from time to time set apart any portion of the park for any game or athletic sport, or generally for the assemblage of persons for any purpose, no person shall on any portion of the park so set apart as aforesaid—

(a) drive, ride, or pass over the ground with any vehicle or upon horseback;

(b) drive or ride among or to the danger or annoyance of persons assembled for any of the purposes aforesaid;

(c) take part in any such game or assemblage aforesaid, except at such time and under such regulations as the Board may from time to time prescribe;

(d) obstruct, interfere with, or annoy, any person who is taking part or has made preparation to take part in, or is lawfully present at any gathering for any of the purposes aforesaid;

(e) place any chair, seat, band-stand or other moveable erection on such portion of the park without the consent of the Board under the hand of some official.

4. Every person who shall infringe any by-laws for the regulation of the park may be removed therefrom by any officer of the Board or by any constable, in any one of the several cases hereinafter specified, that is to say:—

(a) Where the infraction of the by-law is committed within the view of such officer or constable, and the name and residence of the person infringing the by-law is unknown and cannot be readily ascertained by such officer or constable.

(b) Where the infraction of the by-law is committed within the view of such officer or constable, and from the nature of such infraction or from any other fact of which such officer or constable may have knowledge, or of which he may be credibly informed, there may be reasonable ground for belief that the continuance on the park of the person infringing the by-law may result in another infraction of a by-law, or that the removal of such person from the park is otherwise necessary as a security for the proper use and regulation thereof.

5. Every person who shall offend against any provisions of these by-laws shall be liable to a fine not exceeding twenty pounds (£20).

6. Nothing in these by-laws shall interfere with the powers of the police or any authority legally existing for preventing or punishing offences.

7. Nothing in or done under any of the provisions of the foregoing by-laws shall in any respect prejudice or injuriously affect the rights of any person acting legally by virtue of some estate, right or interest in or over or affecting the park or any

part thereof, or be deemed to confer on the Board any greater estate, right, or power than they possess under the abovementioned Statute.

HIS Excellency the Governor in Executive Council, acting pursuant to the powers conferred by section 39 of the Marketing of Eggs Act, 1945-1951, has been pleased to amend in the manner mentioned in the Schedule hereunder the regulations made under and for the purposes of the said Act and published in the *Government Gazette* on the 14th day of June, 1946, and amended by notices published in the *Government Gazette* on the 31st day of December, 1947; 5th day of August, 1949; 3rd day of March, 1950 and the 7th day of July, 1950.

1. Regulation 48 is amended—
 - (i) by inserting in paragraph (a) after the word "produced", in line two the word "held,"; and
 - (ii) by inserting in paragraph (b) after the word "produced," in line three the word "held,".
2. Regulation 49 is amended by substituting for the word "business" in line two the words "any business whatsoever".
3. Regulation 50 is amended—
 - (i) by substituting for the word "business" in line one the words "any business whatsoever"; and
 - (ii) by adding after the word "premises" in line one the words "on which eggs are produced, held, stored, graded, packed, dried, pulped, or otherwise treated".

INDUSTRIAL AGREEMENT No. 5 of 1952.

(Registered 26th May, 1952.)

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1950, this 23rd day of April, one thousand nine hundred and fifty-two, between the Swan Brewery Company Limited; the Emu Brewery Limited; the Stirling Brewery Limited; and the West Australian Glass Manufacturers Limited; and Union Maltings Proprietary Limited, all of Perth and Fremantle (hereinafter in these presents called "the employers") of the one part, and the Breweries and Bottle Yards Employees' Industrial Union of Workers, of Western Australia, of Perth, being an industrial union of workers registered under the provisions of the Industrial Arbitration Act, 1912-1950 (hereinafter in these presents called "the Union") of the other part, whereby it is mutually agreed by and between the parties hereto that the several stipulations, con-

ditions and provisions set out herein shall, in all cases, be binding upon and shall be faithfully and promptly carried out, observed, performed and complied with, according to the true intent and meaning thereof by the parties hereto, and it is also hereby mutually agreed by and between the parties hereto that this Agreement shall apply to the whole of the employees embraced in the Schedule herein contained.

1.—Interpretation.

For the purpose of this Agreement:—

- (a) "Casual hand" shall mean any person who is not employed continually for more than forty ordinary working hours, 7.30 a.m. to 5.30 p.m.
- (b) "Cylinder man," whenever used in this Agreement, shall mean a worker who is generally employed at a majority of the undermentioned occupations, namely, filling, preparing, carbonating, and racking beer from a chilling cylinder, but

shall not mean any employee who is casually employed in any one of the lastmentioned processes.

(c) "Bottle-washer" shall mean any person employed washing bottles by hand or machinery.

(d) "Fireman" shall mean a person employed in a stokehold attending a steam boiler or gas-producing plant.

(e) "Nightcellarmen" and "nightmalsters" shall apply only to cellarmen and malsters who are employed on night duties.

(f) "Leading hands" are employees who are in charge of and responsible for the work of others.

2.—Wages Schedule.

The parties to this Agreement mutually agree that the minimum rate of wages that shall be paid by the employers respectively to the persons employed by such employers in the capacities undermentioned is as follows:—

(a) Basic wage—within a radius of 15 miles from the G.P.O., Perth—£10 14s. 1d.

Workers in cold rooms or cellars with a temperature of less than 45 deg. Fah. shall be paid 5s. per week in addition to the minimum rate.

Maltsters working on permanent night duties at the Swan Malt House shall be paid an allowance of sixteen shillings (16s.) per week in addition to the ordinary rate of pay.

Boiler cleaning, which shall include scraping, cleaning and painting cylinders.—For all time which they may be employed at this class of work, workers shall be entitled to be paid at the rate of one shilling (1s.) per hour in addition to the rates prescribed herein for their ordinary classification.

Ammonia Coils.—For all time which they may be employed chipping, cleaning, scraping, or painting ammonia coils, workers shall be entitled to be paid at the rate of one shilling (1s.) per hour in addition to the rates prescribed herein for their ordinary classifications, and whilst so engaged shall be supplied free with goggles, pullovers and respirators and allowed reasonable time before the end of each shift to cleanse themselves.

Coal Handling.—Workers employed on breaking, crushing, and handling coal in bunkers or bins shall, for all time whilst so engaged, be entitled to be paid at the rate of 6d. per hour in addition to the rates prescribed herein for their ordinary classifications.

Boots.—The employers agree to supply boots to those workers employed at bottle washing on the tanks at the tubs at the filters, at the cask-washing shed, and at the bottlers, to be worn during working hours, same to be supplied free of cost by the employers.

Oilers and Aprons.—The employers agree to provide oilskin coats and leather aprons for carters, to be used whilst the employer's work is being done only.

3.—Hours.

Forty hours shall constitute an ordinary week's work for all workers. Such hours shall (except as to shift workers) be worked on the following basis:—

(a) All workers other than those mentioned in subclauses (b) and (c) hereunder.—Five-day week, Mondays to Fridays, inclusive, eight hours per day, to be worked within a spread of hours of 7.30 a.m. to 5.30 p.m., with one hour for lunch.

(b) Stablemen and Firemen.—Five-day week, Mondays to Fridays, inclusive, eight hours per day, starting time not before 5 a.m. on any day. The employer may require any stableman or fireman to start work at any time after 5 a.m.

(c) Night Cellarmen and Night Maltsters.—Five-day week, Mondays to Fridays, inclusive, eight hours per day, starting time not before 4.30 p.m. nor after 2 a.m. on any ordinary working day.

4.—Shift Work.

(a) Workers may be employed—

(i) on "regular shift work," that is, in regular rotation from week to week on two or three shifts spread over 16 or 24 hours, respectively, day shift to be worked from 7.30 a.m. to not later than 3.30 p.m., afternoon shift from 3.30 p.m. to not later than 11.30 p.m., and night shift from 11.30 p.m. to not later than 7.30 a.m.;

(ii) on "casual shift work," that is on one weekly shift only worked in any department, casual, day, afternoon and night shifts to start and finish at the times respectively referred to in the preceding paragraph.

(b) In the case of both regular and casual shift work the first shift of the week will begin on Sunday at 11.30 p.m. and the last shift of the week shall finish at 11.30 p.m. on Friday. Duty rosters shall be posted on Friday in each week and shall show the starting and finishing times of each worker during each week. Particulars relating to starting and finishing times shall be rigidly adhered to.

(c) The provisions contained in the previous sub-clauses of this clause may be varied by mutual agreement between any employer and the Union.

(d) All workers employed on regular shift work shall be paid an allowance equal to 5 per cent. of their ordinary weekly rate of pay for any week during which they work afternoon shift and an allowance equal to 10 per cent. of their ordinary weekly rate of pay for any week during which they work night shift.

(e) All workers employed on casual shift work shall be paid an allowance equal to 7½ per cent. of their ordinary weekly wage for any week during which they work afternoon shift and 12½ per cent. of their ordinary weekly wage for any week during which they work night shift.

(f) A crib time of 30 minutes shall be allowed to the permanent night maltsters employed at the Swan Malt House and to all workers, whether on regular or casual shift. Crib time shall be included in the working time.

(g) The additional allowances mentioned in sub-clauses (d) and (e) hereof shall be taken into consideration in calculating overtime rate for any overtime for work done beyond eight hours per day on Mondays to Fridays, inclusive. Except as aforesaid, the above allowances shall not be included for purpose of calculating any other penalty rates under this Agreement.

5.—Overtime.

(a) The following overtime shall be paid for at the rate of time and a half:—

All time up to four hours worked—

(i) over eight hours per day on Mondays to Fridays, inclusive;

(ii) outside the starting and finishing times mentioned in clause 3 (a) and before the starting times of 5 a.m. and 4.30 p.m. mentioned in clauses 3 (b) and (c), respectively;

(iii) in the case of shift workers outside rostered starting and finishing times;

(iv) on Saturday.

(b) All overtime in excess of four hours worked during the periods referred to in subclause (a) shall be paid for at the rate of double time.

(c) Subject to any alteration by mutual arrangement, all workers on day work engaged in or about a brewery or bottling works shall, if required to work more than one hour's overtime after the usual finishing time, be entitled to knock off for one hour after the usual finishing time for refreshments, in which event, and if notice of overtime has not been given at least twenty-four hours previously, tea money shall be paid at the rate of four shillings (4s.), provided that where food is provided by the employer, tea money shall be reduced to the rate of three shillings (3s.).

6.—Lunch Intervals.

The lunch intervals of 60 minutes shall be taken between 12 o'clock noon and 1 p.m., or between 1 p.m. and 2 p.m.

7.—Smoke-o.

Ten minutes shall be allowed at 10 o'clock a.m. and again at 3 o'clock p.m. This concession, however, does not apply to men working on shifts.

8.—Casual Hands.

Casual hands shall be paid by the hour at the rate of ordinary pay plus two shillings (2s.) per day.

9.—Record.

Each employer shall keep a record of the name of each worker except stablemen, the time he starts and finishes each day, total number of hours worked, overtime worked, and wages paid to each worker, and such record shall be open to the inspection of the secretary of or any other person appointed by the Union, during working hours. Each worker shall sign the record kept for all moneys received by him.

10.—Sundays.

All work performed by workers in any department on Sunday and Easter Saturday shall be paid for at the rate of double time. All workers required to work on Sundays shall be allowed one Sunday off per fortnight: Provided that the employer may, in an emergency, require such workers to work on consecutive Sundays.

11.—Holidays.

All work performed by workers in any department on the undermentioned holidays shall be paid for on an hourly basis at a rate equal to one and one-half ($1\frac{1}{2}$) times the ordinary rate of pay per hour, with a minimum of four (4) hours' pay, and in addition such workers shall be paid one (1) day's pay for the holiday. All holiday shifts shall rotate. One ordinary day's pay shall be paid for the undermentioned holidays to workers who do not work that day.

The days to be observed as holidays according to the provisions of this Agreement are Christmas Day, Boxing Day, New Year's Day, Anniversary Day (in January), Annual Picnic Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day (in June), Show Day, and Sovereign's Birthday. In case any of the above holidays falls on a Saturday or a Sunday, the following Monday shall be observed in lieu thereof.

12.—Annual Leave.

Each employee, on completion of 12 months' service, shall be granted three (3) weeks' annual leave, two (2) weeks on double pay and one (1) week on single pay, such leave to be taken at times to be mutually agreed upon between the workers and the employers. The annual leave shall be in addition to the holidays mentioned in clause 12 hereof.

On termination of service of a worker who has been continuously employed for more than three months, he shall receive a pro rata payment in lieu of leave on the basis of two and one-twelfth ($2\frac{1}{12}$) days' pay for each completed month of service. On termination of service of a worker who has been continuously employed for more than one month, but less than three months, he shall receive a pro rata payment in lieu of leave on the basis of one and one-quarter ($1\frac{1}{4}$) days' pay for each completed month of service.

13.—Annual Bonus.

The employer shall pay such employee receiving wages under this Award, a week's pay by way of bonus in the last week in December in each year. Any employee leaving the employer's service for reasons other than misconduct, dishonesty, or neglect of duty before the payment of such bonus in any year shall, when leaving, be paid a pro rata payment in lieu thereof; any employee who shall not have been in the employ of the employer for a year in the first week in December shall receive a part of his week's pay bearing the same proportion to a week's pay as the period of his service bears to a year.

14.—Long Service Leave.

(a) All workers who from time to time shall complete 25 years of continuous service with an employer shall be given long service leave. Such long service leave shall be taken at the conclusion of 25 years of continuous service and shall comprise 13 weeks' leave of absence for recreational purposes.

(b) Should a worker who has completed 15 years of continuous service be retired compulsorily on medical grounds on the advice of a medical officer appointed by the employer, or by reason of being over the employer's retiring age, or die before completing 25 years' continuous service, there shall be paid by the employer to such worker or to his dependants, as the case may require, a sum of money bearing the same relation to 13 weeks' pay at his rate as his service with the employer bears to 25 years. "Dependant" shall mean the widow and/or children under the age of 16 years, or any child in fact dependent on any worker and, in the case of a single worker, shall mean such dependant (if any) as such single worker may in writing notify to the employer during his lifetime, accompanied by proper proof of actual dependency.

(c) Continuous service shall include any interval spent on service with Her Majesty's Armed Forces during the duration of any war on which Her Majesty may be engaged, and shall also include any interval spent during the duration of any war on which Her Majesty may be engaged with any national service into which a worker is compulsorily drafted for defence purposes.

(d) Unless otherwise agreed in individual cases, long service leave shall be taken at such period as shall be mutually agreed upon within two years of it becoming due. In default of agreement, it shall be taken at such time within such period of two years as the employer shall determine.

(e) Except in the cases of a worker who, at the time he becomes eligible for long service leave, is of an age exceeding sixty, all long service leave shall be taken by way of actual holiday and not by way of payment in lieu thereof on retirement. A worker who at the time he becomes eligible for long service leave is beyond sixty years of age shall have the option of taking actual holiday under this scheme or of receiving payment in lieu thereof on retirement. Such option shall be exercised by a notice in writing addressed to the employer at the time of becoming eligible for long service leave.

(f) Workers on long service leave shall, while on such leave, continue to be paid at the actual rate (exclusive of overtime or other allowance) enjoyed by them at the commencement of such leave. Except in special circumstances, payment shall be at the same times as during normal employment, but may be made by cheque by mutual arrangement.

(g) It shall be a condition of every worker's taking long service leave that he (or she)—

- (i) shall not under any circumstances be engaged in any gainful employment while on such leave;
- (ii) shall return to the active service of the employer forthwith at the expiration of the leave; and
- (iii) shall not draw any sick or accident pay simultaneously with long service leave pay.

A breach of condition (i) above will result in immediate discharge from the employer's service, accompanied by forfeiture of all rights (if any) to retiring allowance, or other similar payment or benefits. A breach of condition (ii) above (except as on the grounds of illness necessitating retirement or additional leave on the advice of a medical officer appointed by the employer) will result in forfeiture of all rights (if any) to retiring allowance or other similar benefits or payments.

(h) In order to avoid manning difficulties, the long service leave of workers who become entitled to the same in the first year of operation of the scheme shall be taken during such periods during the first two years of the scheme as shall be mutually agreed upon, and in default of agreement, at such times as the employer may decide.

(i) For the purpose of computation and allotment of long service leave, all long service leave shall be deemed to become due on the 1st October next following the completion of the periods of 15 and 25 years' continuous service.

(j) The employer shall have the right, in cases of emergency, to recall any worker from long service leave, in which case the unexpired leave shall be made up on some mutually convenient date.

(k) In order to avoid confusion and embarrassment, workers, whilst on long service leave, shall not, without the prior permission of the officer in charge of the particular establishment, visit any of the premises of the employer except for the purpose of collecting pay or transacting genuine business with the employer's officers. Social visits shall not be indulged in. "Establishment" means any brewery, coo-perage, or workshop, but does not include hotels or annual picnics or sports, or usual weekly competitive sporting activities.

(l) The benefits of long service leave shall be in addition to all benefits at present or hereafter to be enjoyed by workers.

(m) In the event of any governmental or similar long service leave scheme being introduced for industry as a whole, the parties concerned shall meet to consider alterations necessary in order to adjust the scheme to such new conditions.

(n) Notwithstanding anything in this clause contained, no worker, nor his legal personal representative shall be entitled to any of the benefits by this clause conferred in any of the following circumstances:—

- (i) When, in the opinion of the directors of an employer, a worker has committed fraud upon the employer, or any defalcation in relation to the employer, or breach of trust or similar act prejudicially affecting or likely to so affect business or interests of the employer, and is dismissed.
- (ii) If the worker shall become a bankrupt or insolvent debtor within the meaning of any Act of the Parliament of the Commonwealth of Australia or of the State of Western Australia, or shall assign, alienate or charge his benefits hereunder, or any part thereof, or attempt to do so or, if through his own act or default, or by operation or process of law the same shall become vested in or payable to some other person, firm or company.

15.—Under-rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage, may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.

(b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for or be employed at the proposed lesser rate.

(d) The provisions of regulation 92 of the regulations made under the Industrial Arbitration Act, 1912-1950, shall be deemed to apply to any Board of Reference appointed hereunder.

16.—Engagement.

The engagement between employer and worker, except casual hands, shall be weekly, and may be terminated by a week's notice from either party, except in the case of the worker absenting himself without leave, not obeying lawful commands, or being guilty of other misconduct, or of the works of the employer being stopped, through fire or tempest, when such engagement may be terminated immediately.

17.—Absence Through Sickness.

(a) A worker who is unable through sickness or accident to attend his duties shall notify the employer not later than 10 a.m. on the day he first absents himself from duty.

(b) A worker shall be entitled to sick pay in respect of any period of absence on account of sickness after the 1st day of January, 1948, on the basis of one-half day's pay for each completed month served with the employer between the said

1st day of January, 1948, and the date of the commencement of such absence, provided that in calculating the amount due to a worker in respect of any particular period of absence through sickness there shall be deducted therefrom any sum or sums previously paid to him hereunder.

(c) The term "sickness" shall not include any case where the worker is entitled to compensation under the Workers' Compensation Act.

(d) No worker shall be entitled to the benefits of this clause unless he produces proof of his sickness satisfactory to the employer. This proof shall be in the form of a medical certificate if the absence is for three days or more. The employer shall have the right at any time to have the worker examined by a doctor on behalf of the employer.

(e) Except as aforesaid, a worker shall not be entitled to payment for time lost through sickness or accident.

18.—Contractors.

All work of any employee in the capacity as mentioned in this Agreement in or about a brewery or bottling works or in connection with the business of brewing or bottling beer shall be carried out departmentally by bona fide brewery employees engaged and paid direct by the brewery proprietors and not by agents or contractors. This clause shall not apply to contractors erecting, repairing or making alterations to buildings or machinery, or to carriers being engaged for the delivery of goods other than beer, as has been the practice or custom prior to this date. But when contractors are employed delivering beer, the brewery company shall undertake to see that whilst employed on such work the contractors pay to both the drivers and offsiders the same wages and work under the same conditions as is provided in this Agreement.

19.—Area.

This Agreement shall apply to the area comprised within a radius of fifteen (15) miles from the General Post Office, Perth.

20.—Term.

This Agreement shall be for a term of twelve (12) months from the 29th day of November, 1951.
