WHEREAS by section 3 of the Perth Gas Company's Act, 1886-1937, it is enacted that the limits of the said Act shall extend to and include the City of Perth and every place being within a circle of five miles from the General Post Office in the City of Perth and every other place outside the circle of five miles to which the Governor may from time to time by proclamation declare that the Act shall extend: Provided that the Governor shall not make or issue any proclamation under this section to extend the limits of the Act to any place situated within the district of any municipal council or of any road board outside the said circle of five miles unless and until the municipal council or the road board concerned (as the case may be) has by resolution consented thereto; and whereas it is desirable to extend the limits of the Act to that portion of the Municipality of Claremont described in the schedule hereunder; and whereas the said Municipality of Claremont has by resolution passed on the 12th day of October, 1936, consented thereto: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid and of every other power in this behalf me enabling, do hereby proclaim and declare that the limits of the Act shall extend to and include that portion of the Municipality of Claremont described in the schedule hereunder which is outside the circle of five miles from the General Post office in the City of Perth.

## The Schedule.

That area bounded on the West side by Queenslea Drive and its continuation South to the river, but including College Avenue; on the South side by Shenton Road; on the West side by Servetus Street; and on the North side by the Municipal boundary; both sides of the streets and roads forming the above boundaries to be included in the area of supply.

specified in such order, and with power of sub-leasing; and whereas it is deemed expedient that Class A Reserve No. 9323 (portion of Swan Location 2039) should vest in and be held by the Perth Road Board in trust for the purpose of Recreation: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Perth Road Board in trust for Recreation, with power to the said Perth Road Board, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding twenty-one (21) years from the date of the lease.

## INQUIRY AGENTS LICENSING ACT, 1954.

## INQUIRY AGENTS LICENSING ACT, 1954.

## Regulations.

## Citation.

1. These regulations may be cited as the Inquiry Agents Licensing Act Regulations.

## Interpretation.

2. In these regulations unless the context requires otherwise—

“Act” means the Inquiry Agents Licensing Act, 1954;

“appendix” means the appendix to these regulations;

expressions used in these regulations have the same respective meanings as in the Act.

Application for License in the First Instance  
and for Renewal of License.

3. (1) An applicant for a license in the first instance or for the renewal of a license shall complete and lodge four copies of an application, in or substantially in Form No. 1 in the appendix and, where his application is for a license in the first instance, he shall lodge the originals and one copy of testimonials signed by not less than three reputable persons, as to the good character of the applicant, with the Clerk of the Court of Petty Sessions in the district in which the applicant lives.

(2) The holder of a license who desires a renewal of the license, shall lodge application for the renewal with the Clerk of Petty Sessions, not later than the 15th day of May next preceding the 30th day of June on which the license expires if not renewed.

4. The Clerk of the Court of Petty Sessions shall appoint a time, being not less than thirty-five days after the date of the lodging of the application, whether for a license in the first instance or a renewal, for the hearing of the application, and shall endorse the four copies of the form of application accordingly, and return two of the copies to the applicant.

5. Not less than twenty-eight days before the day appointed for the hearing of the application—

(a) the applicant shall, in the case of an application for a license in the first instance, cause one copy of the form as completed and endorsed to be published, once in the *Government Gazette* and once in a newspaper circulating in the district appointed for the hearing of the application, but publication of an application for renewal of a license is not required; and

(b) the Clerk of the Court of Petty Sessions, in case of either application, shall cause a copy of the form as so completed and endorsed, and in the case of an application for a license in the first instance, the original of each of the testimonials, to be served on the Commissioner of Police.

Objections to Granting of Applications for Licenses in the First  
Instance and Renewals of Licenses.

6. The Commissioner of Police or a person authorised for the time being by him or any other person may show cause against the granting of the application, whether for a license in the first instance, or for a renewal, at the hearing, if, not less than seven days before the date appointed for the hearing, he serves upon the applicant and the Clerk of the Court of Petty Sessions appointed for the hearing a notice in Form No. 2 in the appendix of his intention to object to the granting of the application stating the grounds of objection shortly but sufficiently to show their substance.

## Grounds of Objection.

7. An objection is competent only if and to the extent that the grounds of the objection affect the good character of the applicant or go to prove that he is not in all other respects a fit and proper person to be the holder of a license.

## Application for Cancellation of License.

8. (1) An application for cancellation of a license may be made—

(a) by the Commissioner of Police or a person for the time being authorised by him to make the application; or

(b) any other person.

(2) An applicant for cancellation of a license shall lodge two completed copies of Form No. 3 in the appendix with the Clerk of the Court of Petty Sessions by which the license was issued showing in the form the grounds of the application shortly but sufficiently to show their substance.

(3) The Clerk of the Court of Petty Sessions shall appoint a time being not less than twenty-one days from the date of the lodging of the application for the hearing of the application and shall endorse the two copies of the form of application accordingly and hand one of the copies to the applicant.

(4) Not less than fourteen days before the day appointed for the hearing of the application the applicant shall serve the copy so completed and endorsed upon the licensee.

Form of License.

9. The form of a license or renewal of a license is Form No. 4 in the appendix.

Form of Bond.

10. The form of bond mentioned in section six of the Act is Form No. 5 in the appendix.

## REGISTRATION OF BIRTHS, DEATHS AND MARRIAGES ACT, 1894-1948.

HIS Excellency the Governor in Executive Council, under the provisions of the Registration of Births, Deaths and Marriages Act, 1894-1948, has been pleased to make the regulations hereunder.

1. These regulations shall take effect and have the force of law as from the 1st day of January, 1955.
2. The regulation published in the *Government Gazette* on the 31st day of August, 1917, page 1381, is revoked.
3. The following provisions apply to any person, not being a salaried officer under the Public Service Act, 1904-1953, who acts in the capacity of a district registrar or an assistant district registrar.

## When Acting as District Registrar.

(1) All fees received by a district registrar from the public in accordance with the Second Schedule to the Registration of Births, Deaths and Marriages Act, 1894-1948, except as hereinafter provided, shall be paid to the Consolidated Revenue Fund of the State.

(2) (a) A district registrar shall be paid by the Registrar General the sum of four shillings (4s.) for each registration of a birth, death or a marriage he effects.

(b) Irrespective of the number of registrations effected by a district registrar during any quarter, the minimum quarterly amount payable to him by the Registrar General under this Regulation shall be two pounds (£2).

(c) Where the Registrar General directs that any fee be waived, and that fee would otherwise have been paid by the public and retained by a district registrar in accordance with paragraph (3) of this regulation, the Registrar General shall pay to the district registrar the amount of the fee so waived.

(3) A district registrar is permitted to retain for his own use all fees received by him from the public in respect to a service rendered by him as specified in Part III and Part IV of the Second Schedule to the Act with the exception of fees in connection with (a) the registration of a marriage after 14 days from the date of the marriage; (b) a special marriage license; (c) correction of an entry in a register; (d) a document incorporating the result of a search; or (e) the entry of a change of name on a registration.

## When Acting as Assistant District Registrar.

(1) All fees received by an assistant district registrar from the public in accordance with the Second Schedule to the Act shall be transmitted to the relevant district registrar together with the documents concerned.

(2) For each information paper received by an assistant district registrar for the registration of a birth or a death occurring within the registry district for which he is appointed assistant district registrar he shall be paid by the Registrar General the sum of two shillings (2s.).
