IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1951, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in any of the portions of Western Australian waters specified in the Schedule hereto from 1st April, 1955, to 31st March, 1960, inclusive.

WHEREAS by section 161 of the Health Act, 1911-1954, it is enacted, *inter alia*, that the provisions contained in Division 3 of Part V of the Act shall operate and have effect in the health district of any local authority, within the meaning of the Act, in which the Governor may from time to time declare by Order in Council that such provisions shall operate and have effect: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, hereby declares that the provisions contained in Division 3 of Part V of the Health Act, 1911-1954, shall operate and have effect in the health district of the Nedlands Road Board, a health district within the meaning of the Act.
