TRAFFIC ACT, 1919-1954.

Municipality of Geraldton.

Traffic By-laws and Amendments.

L.G. 605/52.

A By-law of the Municipality of Geraldton, pursuant to an Order in Council made under the Authority of Section 49 of the Traffic Act, 1919-1954.

IN pursuance of the powers conferred by the said Order in Council, the Municipality of Geraldton, by this by-law, orders as follows:—

Traffic by-law No. 1, passed by the Municipality of Geraldton on the 22nd day of August, 1951, and published in the *Government Gazette* on the 19th day of October, 1951, as amended by by-laws passed by the said Municipality on the 13th day of February, 1952, the 13th day of August, 1952, and the 27th day of October, 1954, and published in the *Government Gazette* on the 4th day of April, 1952, the 31st day of October, 1952, and the 3rd day of December, 1954, respectively, is hereby repealed and the following new by-law is passed in substitution therefor:—

Traffic By-law No. 1.

(1) The Municipality of Geraldton hereby appoints the following places in streets within its municipal district to be used as stands for licensed motor cars plying for hire:—

(a) Marine Terrace, on the Northerly side, commencing at a point 30 feet North-Easterly of the North-Eastern corner of Marine Terrace and Cathedral Avenue, and extending North-Easterly for a distance of 60 feet (four vehicles).

(b) Cathedral Avenue, on the Easterly side, commencing at a point 30 feet North-Westerly of the North-Eastern corner of Marine Terrace and Cathedral Avenue, and extending North-Westerly for a distance of 78 feet (four vehicles).

(c) Durlacher Street, on the Easterly side, commencing at the North-Eastern corner of Durlacher Street and Marine Terrace, and extending North-Westerly for a distance of 36 feet, and having a width at right angles to Durlacher Street of 17 feet (four vehicles).

(d) Adjoining Durlacher Street, on the land adjoining on the Easterly side, the place described on the last preceding subparagraph (c) and commencing at the commencement of that place and extending North-Westerly for a distance of 36 feet and having a width at right angles to and Easterly of Durlacher Street of 17 feet (four vehicles).

(e) Marine Terrace, on the Southerly side, commencing at a point 141 feet South-Westerly of the South-Western corner of Marine Terrace and Forrest Street, and extending South-Westerly for a distance of 35 feet (two vehicles).

(f) Marine Terrace, on the Northerly side, commencing at a point 30 feet from the North-Western corner of Marine Terrace and Fitzgerald Street and extending South-Westerly for a distance of 80 feet (four vehicles).

(g) Marine Terrace, on the Northerly side, commencing at a point 40 feet from the North-Eastern corner of Marine Terrace and Fitzgerald Street and extending North-Easterly for a distance of 40 feet (two vehicles).

(2) The said Municipality hereby appoints the following places in streets within the said district to be used as stands for licensed omnibuses plying for hire:—

(a) Cathedral Avenue, on the Easterly side, commencing at a point 30 feet from the South-Eastern corner of Marine Terrace and Cathedral Avenue and extending in a South-Easterly direction for a distance of 60 feet (two vehicles).

(b) Eleanor Street, on the Easterly side, commencing at a point 30 feet from the South-Eastern corner of Cathedral Avenue and Eleanor Street and extending North-Easterly for a distance of 90 feet (three vehicles).

(c) Cathedral Avenue, on the Westerly side, commencing at a point 40 feet from the South-Western corner of Lester Avenue and Cathedral Avenue and extending in a South-Easterly direction for a distance of 170 feet, including the approach (four vehicles).

(3) The number of vehicles to be allowed at any one time to ply for hire on each respective stand appointed by paragraph (1) and paragraph (2) of this by-law shall be the number set out against the description of each respective stand in those paragraphs.

(4) No person in charge of any vehicle shall, at any time, leave such vehicle or cause or permit such vehicle to be stationary on the Southerly side of Marine Terrace, Geraldton, between Post Office Lane and the South-Westerly boundary of the Geraldton Post Office land, unless he does so in the course of a duty or engagement as an employee of or contractor with the Postmaster General's Department.

(5) (a) No person in charge of any vehicle shall, at any time, leave such vehicle or cause or permit such vehicle to be stationary on either side of Eleanor Street, Geraldton, or on either side of North-West Coastal Highway, Geraldton, between Durlacher Street and Forrest Street, except in accordance with subparagraph (b) or subparagraph (c) of this paragraph.

(b) Subparagraph (a) of this paragraph shall not apply in respect of any cycle, motor cycle, or motor car or any motor waggon of the type known as a utility left, caused or permitted to be stationary on the Northerly side of Eleanor Street or North-West Coastal Highway.

(c) Subparagraph (b) of this paragraph shall not apply in respect of any vehicle left, caused or permitted to be stationary on the Southerly side of Eleanor Street or North-West Coastal Highway in such a position that the whole of the vehicle is within the area formed by the Southerly kerb and the nearest white line marked on the roadway parallel thereto.

(6) No person in charge of a vehicle shall, at any time, leave such vehicle or cause or permit such vehicle to be stationary—

(a) on the Easterly side of Durlacher Street, Geraldton, between Marine Terrace and Eleanor Street;

(b) on the Westerly side of Cathedral Avenue, Geraldton, between Marine Terrace and Lester Avenue;

(c) on the Westerly side of Fitzgerald Street, Geraldton, between Marine Terrace and a point in line with the Southerly boundary of Lester Avenue.

(7) No person in charge of any vehicle shall leave such vehicle or cause or permit such vehicle to be stationary on any portion of Marine Terrace, Geraldton, other than on portion of a stand duly appointed for that type of vehicle, for a longer period than 30 minutes between the hours of 9 a.m. and 5 p.m. on any day other than Saturday or Sunday, or for a longer period than 30 minutes between the hours of 9 a.m. and 12 noon on any Saturday.

(8) No person in charge of any vehicle shall, at any time, leave such vehicle or cause or permit such vehicle to be stationary in any street within the said district, whether on a duly appointed stand or not, in such a position as to obstruct the entrance to any lane or right-of-way, or to obstruct the passage of vehicles to or from any premises by way of an entrance way provided for that purpose.

(9) (a) In this paragraph, "park" means to permit any vehicle to stand, whether occupied or not, upon a street or way otherwise than temporarily for the purpose of and while actually engaged in loading or unloading passengers or goods or in obedience of traffic regulations or traffic signs or signals, and "vehicle" means any motor vehicle the tare of which is two tons or more.

(b) No person shall park any vehicle as defined in this paragraph upon that portion of Marine Terrace, Geraldton, which lies between its junction with Forrest Street and its intersection with Fitzgerald Street, or upon that portion of Durlacher Street, Geraldton, which lies between its intersection with Eleanor Street and its junction with George Road.

(10) If any person shall commit any breach of any provision of this by-law he shall be liable to a penalty not exceeding twenty pounds.

Amendments to General By-laws.

L.G. 1831/52.

PURSUANT to the powers conferred by the Road Districts Act, 1919-1954, the Mosman Park Road Board doth hereby amend the by-laws published in the *Government Gazette* on the 13th day of February, 1948, as follows:—

By inserting a new by-law 145 (a):—

Car Ports or Car Shelters.

145. (a) Car ports or car shelters of the pergola type, comprising flat roof or top supported by posts of timber, steel, brick work, concrete or masonry, but without walls, may be erected, provided, in the case of timber posts, the timber used shall be dressed and of a minimum size of 4in. x 4in., and in the case of steel posts, the posts shall be galvanised, and of a minimum diameter of 2in.

Provided that the space between posts shall not be less than 6ft., and shall not be filled or held in with any material.

The roof shall be constructed with a slight approved fall for drainage, and shall be either of corrugated galvanised iron, corrugated or flat asbestos, tempered hardboard, or timber sheeted with bituminous roofing felt or other approved roofing materials. Provided also, that water from the roof shall not be permitted to discharge on to adjoining land not in the same possession.

Eighth Avenue.—Portion of Swan Location Y, and being all lots between Whatley Crescent and Guildford Road.

Boundary Street.—Portion of Swan Location Y, and being lots 1, 2 and 3 on Diagram 5448.

East Street.—Portion of Swan Location Y, and being lot 1 on Diagram 2150 and lots 1, 2 and 3 on Diagram 5869.

Guildford Road.—(i) All lots on Plan 2164 and Diagram 14173, between Seventh and Ninth Avenues.

(ii) Lots 68, 94 and 95 on Plan 1885, and lots 1, 2, 3 and 4 on Diagram 2316.

(iii) Lot 2 (to a depth of 150 feet) on Diagram 4605 and lots 25 and 26 on Plan 1632.

(iv) Lots 16, 17, 18 on Plan 2540.

(v) Lots 132 and 133 on Plan 1469.

(vi) All lots between Seventh and Eighth Avenue on Plan 1885 and Diagram 10239.

(vii) Lots 124, 125 and 128 on Plan 1885.

(viii) All lots between Falkirk and Caledonian Avenue on Plan 1885.

(ix) Lot 564 on Plan 1885.

(x) Lots 1, 2 and 3 on Diagram 4751.

Caledonian Avenue.—Portion of Swan Location 2039, being lots 273-277 (inclusive) on Plan 2610.

6. The Fourth Schedule to the said by-laws is altered by the addition at the end thereof of the following:—

South Crescent.—(i) Portion of Swan Location X, section 4A, and being lots 151-160 inclusive on Plan 1469.

(ii) Lot 1 on Diagram 8941.

(iii) Portion of Swan Location X, section 3A, and being lots 41-49 inclusive on Plan 1588.

(iv) All land on Diagrams 4868 and 4954.

HIS Excellency the Governor in Executive Council has been pleased to approve of the amendments made by the Minister, in the manner mentioned in the Schedule hereunder, of the by-laws made under the provisions of the Country Areas Water Supply Act, 1947-1954, published in the *Government Gazette* on the 12th August, 1949, and amended by notices published in the *Government Gazette* on the 25th November, 1949; 24th November, 1950; 17th August, 1951, and the 14th March, 1952.

The abovementioned by-laws are amended as follows:—

1. By-law 43 is deleted and a new by-law 43 is substituted as follows:—
43. No person unless he has been duly admitted by the Minister as a licensed water supply plumber shall fix, alter or repair meters, pipes or fittings connected with the works of the Minister.
2. By-law 44 is deleted and a new by-law 44 is substituted as follows:—
44. (a) The Minister may grant a Water Supply plumber's license operative in the areas to which these by-laws apply, excluding areas open for sewerage connections within a sewerage area or district constituted under the Country Towns Sewerage Act, 1948-1954, to a plumber who satisfies the Minister that he is a competent water supply plumber and is a fit and proper person to hold the license.
(b) An applicant who applies to the Minister for a water supply plumber's license may be required by the Minister to submit to an examination in the theory and practice of plumbing work.
3. By-law 54, paragraph (20), is amended by substituting for the word "and" in line four the word "which."
4. By-law 84, paragraph (e), subparagraph (i) (G.G. 24/11/50) is amended by inserting after the word "Darlington" in line three the word "Kalamunda."
5. Schedule I is amended by adding after paragraph (o) a new paragraph (p) as follows:—
