WHEREAS under the provisions of subsection (2) of section 17 of the Charitable Collections Act, 1946-1949, it is provided that moneys, securities or goods vested in the Minister by a proclamation made under section 17 of the Act shall be held upon the trusts upon which they were held prior to being vested in the Minister and that the Governor may by proclamation vary the trusts and may by the same or any subsequent proclamation vest the said moneys, securities or goods or any part thereof in such persons and for such charitable purposes as the Governor shall specify; and whereas by a proclamation dated the 21st day of July, 1955, all moneys and securities for moneys held by any person for the Kulin Hospital Scheme were vested in the Minister: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred on me by section 17 of the Act, hereby vary the trusts and vest the said moneys and securities for moneys in the persons, and for the charitable purposes, specified in the schedule to this proclamation.

## Schedule.

1. The sum of one hundred and twenty-five pounds (£125) is vested in the Kulin Infant Health Clinic Committee for the purpose of carrying out its objects.
2. The sum of one hundred and sixty-six pounds fourteen shillings and eight pence (£166 14s. 8d.) is vested in the Kondinin Ambulance Committee for the purpose of carrying out its objects.

3. The sum of one hundred and sixty-six pounds fourteen shillings and seven pence (£166 14s. 7d.) is vested in the Kondinin District Hospital Committee for the purpose of carrying on the hospital.

WHEREAS by sections 223 and 225 of the Municipal Corporations Act, 1906-1954 (6 Edward, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the *Government Gazette*, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge, or thoroughfare, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a public highway within the meaning of any law now or hereafter in force; and whereas the Municipality of Geraldton has requested that certain lands named and described in the Schedule hereunder which have been used for streets or ways within the Municipality of Geraldton, be declared public highways: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said lands to be public highways, and such lands shall, from the date of this Proclamation, be absolutely dedicated to the public as highways within the meaning of any law now or hereafter in force.

## ORDER IN COUNCIL.

P.W. 1149/48A.

WHEREAS section 74 of the Constitution Act, 1889, provides that the Governor in Council may vest in heads of departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Departments of Public Works and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Department) should be vested in Charles Groves, and that the power vested in Archibald Glen Kirkwood should be revoked: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, hereby vests in Charles Groves and any persons appointed to act temporarily in their place, the appointment of foremen and all other persons employed on such works at a daily rate of wages; and doth hereby revoke the power vested in Archibald Glen Kirkwood.

## Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

## ORDER IN COUNCIL.

M.W.S. 1290/55.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works and stormwater drainage works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.

Fremantle District.

Fremantle Main Sewer, Relaying Part of  
First Section.

A thirty (30) inch diameter reinforced concrete pipe sewer with manholes and other apparatus connected therewith, between Ocean Road and Treatment Works and near the Old Mandurah Road, as shown on Plan M.W.S.S. & D.D., W.A., No. 7969.

This Order in Council shall take effect from the 21st day of October, 1955.

WESTERN AUSTRALIA.

No. 294 of 1955.

In the matter of the Industrial Arbitration Act, 1912-1952, and in the matter of an industrial dispute between the Australian Workers' Union, Westralian Branch, Industrial Union of Workers and the Minister for the North-West as Minister controlling the Harbour and Lights Department and the State Shipping Service of Western Australia.

WHEREAS an industrial dispute between the above-named parties was on the 30th day of August, 1955, referred to the Conciliation Commissioner in pursuance of a delegation by the Hon. President of the Court of Arbitration: Now, the said Conciliation Commissioner, having heard the parties and having made investigations, and by agreement between the parties as to procedure, doth hereby order and declare that Award No. 11 of 1955 be and the same is hereby amended in the manner following:—

Add to clause 7 the following:—

Liberty is reserved to either party to apply to amend the hourly rate.

Delete clause 11 and insert in lieu thereof the following:—

## 11.—Meal Hours.

1. (a) Subject to subclause 2 (d) hereof, the hours for meals shall be—

Breakfast—7 a.m. to 8 a.m.

Dinner—Noon to 1 p.m.

Tea—5 p.m. to 6 p.m.

(b) Supper.—If work commences before 11 p.m. a supper hour may be taken between the hours of 11 p.m. and 1 a.m., but if work commences at 11 p.m. or later, no supper hour shall be allowed.

2. For the purposes of the following, the supper period shall be regarded as a meal hour.

## (a) Monday to Friday, both Inclusive.

All employees, including shed hands, shall be paid five shillings and sixpence (5s. 6d.) for each meal other than the first; provided that such entitlement shall only be in respect of such meals where work resumes after the end of such meal period; and provided further that where a break of eight hours has not been taken between one ship and the next, that all meal periods in respect of such second or subsequent ship, shall be paid for at the rate of five shillings and sixpence (5s. 6d.) per meal period.

## (b) Saturdays and Sundays.

All employees including shed hands, shall be paid five shillings and sixpence (5s. 6d.) for each meal period; provided that such entitlement shall only be in respect of such meals where work resumes after the end of such meal period.

Where employees work through a dinner or tea break on Saturdays and Sundays and such work continues into the hour following such meal break, one payment of five shillings and sixpence (5s. 6d.) in respect of each meal period so worked shall be made in addition to the penalty rate prescribed in clause 12.

## (c) Holidays.

Meal payments shall be in accordance with the payments usually made for the particular day on which the holiday falls.

## (d) Extended Meal Hour.

At Carnarvon all meal periods other than the first and supper period, may be extended for jetty gangs and ship gangs to one and a half (1½) hours.

## (e) Mooring Gangs.

Notwithstanding anything else contained in the foregoing, mooring gangs shall be compensated for meals strictly in accordance with the allowances actually made to jetty and ship gangs on each particular ship.

Scott on behalf of the respondents, and in pursuance of a remission to me by the Court of Arbitration, and in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1952, I hereby order and declare that Award No. 71 of 1948, be and the same is hereby amended in the manner following:—

Clause 23.—Conditions and Extra Rates.

1. Delete this clause and insert in lieu thereof the following:—

23.—Conditions and Extra Rates.

(a) One shilling (1s.) per day or portion thereof in addition to the prescribed rate shall be paid to—

- (i) any worker working on wet ground;
- (ii) workers required to throw up metal or other material with a shovel more than six (6) feet above the level from which they are working.
- (iii) workers engaged in drying or screening metal.

(b) Two shillings and sixpence (2s. 6d.) per day or portion thereof in addition to the prescribed rate shall be paid to casual workers.

(c) Workers engaged on fire-fighting shall be paid at the rate of two shillings (2s.) per hour in addition to their prescribed rate, for the time so employed.

(d) (i) Leading hands placed in charge of not less than three (3) or more than ten (10) other workers shall be paid one pound three shillings and sixpence (£1 3s. 6d.) per week above the rate of wage of the workers whose work they direct.

(ii) Leading hands placed in charge of more than ten (10) other workers shall be paid one pound eleven shillings and sixpence (£1 11s. 6d.) per week above the rate of wage of the workers whose work they direct.

(e) The wage of any worker temporarily taking over the duties of another worker shall not be reduced whilst he is so employed.

(f) Drivers who in addition to the hours of which the week is comprised are required to feed horses shall be paid as under in addition to their ordinary wage:—

A horse driver who is required to harness or groom a horse or horses outside his ordinary hours shall be paid for such work at overtime rates.

(g) Any worker who is called upon to clean out a septic tank and who is required to enter a septic tank to perform such work shall receive a margin at the rate of two pounds eight shillings and sixpence (£2 8s. 6d.) per week, plus two shillings and sixpence (2s. 6d.) per hour whilst so engaged. Provided that if such work is performed by mechanical means such worker shall be paid a margin at the rate of two pounds eight shillings and sixpence (£2 8s. 6d.) per week. Gum boots, masks and overalls shall be supplied by the employer to workers engaged on such work.
