THE KALGOORLIE-BOULDER RACING CLUB.

Notice of Adoption of By-laws.

NOTICE is hereby given that at a meeting of the Committee of The Kalgoorlie-Boulder Racing Club held on the 1st day of February, 1953, a resolution was passed by an absolute majority of the Committee adopting as the By-laws of the Club the By-laws set out hereunder.

Notice is hereby further given that a copy of such By-laws was sent to the Chief Secretary on the 1st day of September, 1955, and that the same have not been disallowed and will come into operation upon the publication thereof.

The By-laws Hereinbefore referred to:

By-laws of the Kalgoorlie-Boulder Racing Club.

Part I.

Constitution.

1. The Club shall be called "The Kalgoorlie-Boulder Racing Club." Title of Club.
2. The Club shall consist of all persons who shall be members (but not including honorary members) of The Kalgoorlie Racing Club and The Boulder Racing Club on the 28th day of February, 1953 and also of all persons who shall thereafter be duly elected members of the Club and who continue to be members pursuant to these By-laws. Of whom it consists.

Members and Their Admission.

3. No person shall be eligible for admission as a member of the Club unless he shall have resided in Western Australia for a period of at least six (6) calendar months immediately prior to his nomination. Provided that such residential qualification shall not be necessary in the case of a member of any Club which is a principal Club in any State. Residential qualification of Candidates for election as Members.
4. (a) Candidates for admission as members of the Club shall be proposed in writing by one member and seconded by another and shall be elected by the Committee by ballot. Unless at least two one-thirds of the members of the Committee present at the meeting at which the election takes place shall vote in favour of the candidate he shall be deemed not elected. Candidates Proposal and Election of.
- (b) The Widow of a deceased member may within a year, or such other period as the Committee may determine, of such members' death apply for admission as a non-effective member and the provisions of paragraph (a) preceding insofar as the election is concerned shall apply. A non-effective member shall not be entitled to be present or vote at any meeting of the Club. Non-effective members.

- Notice of Ballot for election.
5. No ballot shall be held unless at least two days' written notice thereof shall have been previously sent to each member of the Committee, containing the names and occupations of the candidates and the names of their respective proposers and seconders.
- When Candidate becomes a Member.
6. A candidate shall become a member so soon as he has been elected and paid his entrance fee and subscription for the current year.
- Honorary Life Members.
7. Any person who has rendered valuable services to the Club, or who shall give a plate, purse or trophy, of the value of one hundred pounds to be run for at the races under the management of the Club, may be admitted an honorary life member of the Club. Honorary life members shall be entitled to the same rights and privileges and be subject to the like obligations as other members but shall not be liable to the payment of any entrance fee or annual subscription.
- Ex Officio Honorary Members.
8. The Governor of Western Australia and his Staff for the time being shall be honorary members of the Club.
- Visitors may be admitted Honorary Members at any Meeting.
9. Visitors to the State may be admitted by the Committee as honorary members at any race meeting without payment of any subscription.
- Members not to vote or enjoy privileges of membership unless subscription paid.
10. No member shall be qualified to vote on any occasion whatever, or enjoy any of the privileges of a member, unless he has paid his subscription for the current year.
- Addresses of Members.
11. All members shall communicate their addresses from time to time to the Secretary of the Club, who shall register the same, and all letters delivered at or sent by post to such addresses shall be considered to have been delivered to the respective members personally. If no addresses be given, all letters and notices posted and addressed to the last known place of abode of the members shall be considered to have been delivered to the respective members personally.
- Persons ceasing to be Members to forfeit all rights.
12. All persons ceasing to be members of the Club, whether by retirement, expulsion, death, neglecting to pay the annual subscription, or otherwise, shall forfeit ipso facto all rights to or claim upon the Club or its property.

Entrance Fee and Subscription.

13. (a) The entrance fee for members (other than country and non-effective members) shall be such sum not exceeding £3 3s. as the Committee may from time to time determine in the case of members ordinarily residing within fifty miles of the Town Hall Kalgoorlie and £1 11s. 6d. in the case of members ordinarily residing outside of fifty miles from the Town Hall, Kalgoorlie. Non-effective members shall not be required to pay any entrance fee.
- (b) The annual subscription to the Club (except in the case of non-effective members) shall be £5 5s. for members ordinarily residing within fifty miles of the Town Hall Kalgoorlie and £2 12s. 6d. for members residing outside of that radius.
- (c) The annual subscription for non-effective members shall be £1 1s.
- (d) Upon payment of his subscription each member (other than non-effective members) shall be entitled to receive a ticket (which shall not be transferable) for his own use and two ladies' tickets.

- (e) Upon payment of her subscription a non-effective member shall be entitled to receive a ticket (which shall not be transferable) for her own use and one ladies' ticket.
- (f) All annual subscriptions shall be inclusive of any amusement tax payable thereon.

14. Every candidate shall, within one month after his election, pay his entrance fee, and subscription for the current year, otherwise his election shall be void unless he shall justify the delay to the satisfaction of the Committee.

Entrance fee when payable.

15. The fiscal year of the Club shall commence on the first day of March in each year and annual subscriptions shall be payable in advance on that date.

Subscription when payable.

16. Any member who has paid his subscription for the current year, and who intends to be absent from the State during at least six months of the succeeding year, may make written application to the Committee to place his name on the "Absent Members' List."

Absent members may apply to be placed on Absent Members' List.

17. The Committee may grant such application, and if such member continues absent from the State for more than one year, may keep the name of such member on the "Absent List" during his absence.

Committee may grant such applications.

18. Any member whose name is on the "Absent List" shall not be entitled to any of the privileges of a member and shall not be required to pay his annual subscription for the first year his name is on such list but thereafter so long as his name shall be included therein he shall in lieu of the annual subscription for the time being payable under By-law 14 pay an annual subscription of £1 ls. PROVIDED ALWAYS that any such member may at any time on his return to the State pay his annual subscription for the current year as provided by By-law No. 14 or the balance thereof as the case may be and become an effective member.

Absent member not required to pay subscription.

19. (a) If any member shall:—

Effect of non-payment of subscription.

- (i) Resign from the Club or
- (ii) Neglect to pay his subscription before the 1st day of July next following the same becoming payable he shall cease to be a member of the Club and his name shall be erased from the list of members.
- (b) Upon the application at any time of any former member who may have resigned from the Club or whose name may have been erased from the list of members as aforesaid the Committee may in its absolute discretion readmit such member to membership of the Club either with or without payment in whole or in part of any unpaid subscription or of any further entrance fee as the Committee may in the circumstances of the case think fit.

The Committee.

20. The affairs and general business of the Club shall be managed by a Committee. The first Committee of the Club shall consist of the members of the Committees of the Kalgoorlie Racing Club and The Boulder Racing Club in office on the 28th day of February, 1953 and such Committee shall hold office until the conclusion of the General Meeting to be held in the year 1954. Thereafter the committee shall consist of twelve members of whom six to be determined by lot shall retire at the conclusion of the General Meeting to be held in the year 1955 and thereafter the six longest in office shall retire annually but shall be eligible for re-election and in the event of any dispute between two or more retiring members as to whom shall have been longest in office the same shall be determined by lot.

Committee number of and election.

- Members eligible for election.
21. No person shall be eligible to become a member of the Committee unless he shall have been a member of the Club (or of the Kalgoorlie or Boulder Racing Clubs) for at least eighteen months prior to the General Meeting at which the election is to take place, and no person shall be eligible to become a member of the Committee, or to hold office as a Committeeman, if he be a Steward or Committeeman of any Proprietary Race Club, Trotting Club or Betting Club, or if he be under any contract with the Club; provided that anything in this By-law contained shall not render ineligible from holding office as a Committeeman any member of the Committee who may act as a Steward at any race meeting held on any Racecourse of the Club by any other Racing Club or any Betting Club.
- Method of election.
22. The names of all members proposed or submitting themselves for election to the Committee shall be in the hands of the Secretary of the Club (hereinafter referred to as "the Secretary") at least fourteen clear days before the Annual General Meeting in each year.
- If number of candidates exceed vacancies.
23. If there shall be more candidates nominated than there shall be vacancies to be filled the Secretary shall cause an alphabetical list of the candidates to be published in a daily newspaper circulating in Kalgoorlie at least seven days before the date of the Annual General Meeting.
- If number candidates equal to or less than number vacancies.
24. If the number of candidates nominated for election as members of the Committee is equal to or less than the number of vacancies the Chairman of the General Meeting shall declare all the candidates who have been nominated elected and the General Meeting may thereupon proceed to fill up the remaining vacancies (if any) by show of hands subject to a poll being demanded.
25. If the number of candidates nominated for election as members of committee is greater than the number of vacancies a ballot shall be taken on the day of the annual general meeting. The ballot shall commence at 3.30 p.m. and close at 8.30 p.m. Each ballot paper shall contain the names of all candidates duly nominated, printed in alphabetical order, according to their surnames. Every member voting shall strike through the names of all persons named in such ballot paper for whom he does not desire to vote, and shall then deposit such ballot paper in the ballot box. Every member voting shall vote for the full number of candidates to be elected and any paper containing a greater or less number of names than there are vacancies to be filled shall be rejected as informal. The ballot boxes shall be opened in the presence of three scrutineers chosen by the general meeting from the members present. The majority of such scrutineers shall, at the close of the ballot, certify to the secretary the names of the successful candidates, and in case of there being an equal number of votes recorded for two or more candidates, the majority of the scrutineers shall then decide who shall be elected. The names contained in such certificate of the scrutineers, or a majority of them, shall be the members of the committee in place of those that retire, or whose term of office shall have expired. The committee shall from time to time make such provision as they may think necessary for taking such ballot. No member shall be entitled to vote at an election of committee until his subscription shall have been paid.
- Procedure in event of Death of Candidate.
- Should any duly qualified candidate for election to the Committee die during the period commencing on the date of closing of the nominations and ending on the day of the Annual General Meeting at the hour at which the Annual General Meeting is called or become ineligible for election within the same period then and in any such case the name of such candidate shall be erased from the ballot paper.
- Voting by Absent Members.
26. A member unable to attend on the day of election to record his vote, may at any time after the names of the intending candidates have been duly advertised, obtain from the secretary a ballot paper endorsed by the secretary, and after duly notifying

thereon the members for whom he proposes to vote, shall put such paper in an envelope endorsed "Ballot Paper," addressed to the secretary, and the secretary shall retain such ballot paper and envelope until the day of election, when, in the presence of the scrutineers, it shall be opened and the ballot paper taken therefrom and deposited in the ballot box. A member absent from Kalgoorlie or Boulder may record his vote by letter or telegram addressed to the Secretary. Provided that such member shall vote for no more nor less than the number of candidates to be elected, and such letter or telegram shall be delivered to the scrutineers on the day of election.

27. In the event of any vacancy or vacancies occurring in the Committee after the annual election, the Committee shall have the power of filling the same up until the next General Meeting, when a member or members shall be elected to fill such vacancy or vacancies.

Casual
vacancy.

28. If the Committee do not fill up such vacancy or vacancies within 28 days of the occurrence thereof the Committee shall convene a Special General Meeting of the members of the Club to elect a member or members to fill such vacancy or vacancies, and By-laws 22, 23, 24, 25 and 26 shall apply to such election in the same manner as they apply to the election of members of the Committee at the General Meeting, provided always that wherever the words "General Meeting" appear in such By-laws the words "Special General Meeting" shall be read in lieu thereof provided further that if the number of members nominated for election to fill any such vacancy or vacancies shall not exceed the number of vacancies, the member or members who has or who have nominated shall, upon the closing of the nominations, be deemed to have been elected.

Procedure
to fill
up same.

29. The member or each member (if more than one) so elected shall hold office until the expiration of the term for which the member in whose place he shall have been elected could have held it in accordance with the By-laws.

Term of

Powers of the Committee.

30. The Committee shall have the power of from time to time appointing and at their pleasure dismissing all such officers (except the Auditor) and servants as they may think necessary for the purposes of carrying out the objects of the Club, and without derogating from the general powers hereby given the Committee may from time to time appoint and at their pleasure dismiss (1) a secretary, (2) a handicapper or handicappers, (3) a steward or stewards.

Power to
appoint and
dismiss
officers.

31. The Committee may pay or allow such salaries, allowances and recompenses to any officers or servants appointed by them during their services or employments as the Committee shall from time to time see fit.

Power to
pay officers
and servants.

32. The Committee shall have power to enter into such contracts on behalf of the Club as they shall think advisable and shall at all times dispose of the funds of the Club as they may deem best for carrying out the objects of the Club.

Power to
make
contracts.

33. Any member who has been found guilty of a corrupt practice under the Rules of Racing by the Committee or Stewards, or by the Committee or Stewards of the Western Australian Turf Club, or by the Committee or Stewards of any Club whose decision has been adopted by the Western Australian Turf Club shall, ipso facto be expelled from the Club.

Expulsion
of
members.

The Committee may expel any Member who:—

- (a) Has been found guilty by the Committee or Stewards of any Racing Club of a malpractice or who has been disqualified under the Rules of Racing by the Committee or Stewards of any Racing Club.

- (b) Has been guilty of grossly improper conduct or riotous behaviour at any Race Meeting.
- (c) Is a defaulter in stakes or bets in reference to any race.
- (d) Becomes a jockey, trainer of horses, or bookmaker.
- (e) Declines or neglects to pay any fine imposed on him by the Stewards or Committee.

(f) Is guilty of any Act which in the opinion of the Committee renders it undesirable that he should continue to be a Member.

Provided always that no Member, except a Member ipso facto expelled in accordance with the first part of this rule shall be expelled by the Committee until after he shall have been given an opportunity to show cause to the Committee why he should not be expelled.

Power to issue programmes at race meetings.

34. Subject to the Rules of Racing of the Western Australian Turf Club, the Committee shall have power to fix the dates and prepare and issue the programmes of the Race Meetings of the Club to be held during the year, and to prepare the conditions of, and advertise to be run in succeeding years, such races as they in their judgment may deem expedient to make public during their term of office.

Can reject decline to receive Nominations or Entries.

35. All nominations or entries for any race to be run at any race meeting of the Club shall be subject to the approval of the Committee, who may decline to receive and at any time after having received reject, any such nomination or entry without giving a reason for so doing. If any nomination or entry shall be rejected the fees paid in respect thereof shall be refunded.

Power to postpone races.

36. The Committee may, in case of urgent necessity, put off from time to time the races of any Race Meeting of the Club.

Sub-Committees.

37. The Committee may delegate any of their powers to Sub-Committees consisting of such member or members of their body as they may think fit. Any Sub-Committee so formed shall in the exercise of the powers so delegated conform to any resolutions that may be imposed on them by the Committee. The proceedings of all Sub-Committees so appointed shall be regulated by the Rules heretofore contained relating to the proceedings of the Committee.

Proceedings of Committee.

Meetings of a Committee Quorum.

38. The Committee shall meet as often as they deem necessary; five shall form a quorum and minutes of the proceedings shall be entered in a book and be read and confirmed at the next meeting.

Meeting shall be convened by Chairman or Secretary.

39. A Committee meeting may be convened by the Chairman or Secretary and shall be convened by either upon receipt of a requisition requesting either to do so, signed by three members of the Committee.

Chairman and Vice-Chairman.

40. The Committee shall at their first meeting after the General Meeting, elect a Chairman and Vice-Chairman, who shall hold office until the next General Meeting. Any vacancy occurring in the interim shall be filled up by the Committee.

Presiding at Meetings.

41. The Chairman, or in his absence, the Vice-Chairman shall preside at all meetings of the Committee, and if neither be present some other member of the Committee to be elected by the meeting shall preside. The Chairman at any meeting shall have a deliberative as well as a casting vote.

Non-attendance at Meetings.

42. Any member of the Committee having been absent from four consecutive Committee Meetings, extending over three months, shall cease to be a member thereof unless he shall have obtained leave of absence from the Committee, but may be reinstated by a resolution carried by two-thirds of the members of the Committee.

Powers of majority of Committee.

43. A majority of the Committee at any meeting of the Committee shall have all the powers hereby given to the Committee.

Stewards.

44. If and so long as there shall be no Stipendiary Stewards of the Club, or no quorum of Stipendiary Stewards of the Club able to perform the duties of Stewards, the Committee shall be and be deemed to be the Stewards of the Club. Committee as Stewards.
45. The stewards of the Club shall act as sole Stewards at all race meetings held on the racecourse of the Club, whether by a Club race committee, company or person or body of persons. Stewards as sole Stewards.
46. The Stewards shall have such powers, privileges and duties as are from time to time fixed and determined by the By-laws and Rules of Racing. Powers of Stewards.
47. The Committee and Stewards and every one of them shall be indemnified from the funds of the Club against all damages and costs that may be recovered against them or any one of them in any legal proceedings that may be instituted against them or any of them in consequence of the performance of their duties and also against all costs that may be incurred by them or any of them in defending any such proceedings. Indemnification.

The Secretary.

48. It shall be the duty of the Secretary to keep full and accurate accounts of all sums of money received or expended on account of the Club; to make full and accurate minutes in the books of the proceedings of all General, Special and Committee Meetings; to give all notices of all General and Special Meetings, and also propositions to be brought before them, as also notices of Committee Meetings; and subject to the directions of the Committee to make all necessary disbursements from the funds of the Club by cheques drawn upon the relative account at the Club's Bankers which cheques shall be signed in such manner as the Committee shall from time to time determine and to obtain receipts or discharges for the same; and to carry out the instructions of the Committee and Stewards. The Secretary shall give such security for the faithful discharge of his duties as the Committee may deem necessary. Duties of Secretary.

The Auditor.

49. There shall be one auditor of the Club who shall retire annually at the General Meeting of the Club but shall be eligible for re-election. The Auditor shall be nominated and elected in accordance with the By-laws relating to the nomination and election of Members of the Committee. It shall be his duty to carefully audit the books of the Club, and the accounts prepared by the Secretary for submission at the General Meetings, and to certify to the correctness thereof. Should any vacancy occur after any General Meeting the Committee shall have power to fill up such vacancy until the next General Meeting. The remuneration of the Auditor shall be fixed by the Members at the General Meeting. Duties of the Auditor and how elected.

General and Special Meetings.

50. There shall be a General Meeting of the Club in April in each year on a date to be determined by the Committee, for the purpose of electing members of the Committee, discussing the general business of the Club, receiving recommendations from members for consideration by the Committee, and receiving from the Committee an abstract of the state of the account of the receipts and payments, with a report of the general concerns of the Club. At such meeting the accounts shall exhibit a true statement of the total receipts and payments of the Club during the year immediately preceding the first of March with a statement of the balance of such account. Annual General Meeting.
51. A printed copy of such report, balance sheet and statement of receipts and payments shall be posted or sent to each member of the Club seven days previously to the General Meeting. Report and Balance Sheet to be forwarded to Members.

- Notice of propositions by Members. 52. Should any member desire to bring forward any proposition or motion at any General Meeting of the Club, he shall give written notice thereof to the Secretary at least fourteen clear days prior to the General Meeting at which he may wish his proposition considered; and the Secretary shall embody such proposition in the notice convening the meeting.
- Business to be transacted. 53. No business of a special description shall be transacted at any such meeting, unless special notice of such business shall have been given in the circular letter convening the meeting.
- Extraordinary or Special General Meeting. 54. The Committee may, whenever they think fit, and they shall upon a requisition in writing under the hands of not fewer than twelve members convene a Special General Meeting.
- Requisition for Special Meeting. 55. Any requisition so made by members shall clearly and fully express the objects of the meeting required to be called, and shall be left at the office of the Club.
- Meeting, when held. 56. Upon such requisition being so left, the Committee shall forthwith proceed to convene a Special General Meeting, to be held at such time and place as they shall think fit, not being less than fourteen nor more than twenty-eight days after the leaving of such requisition.
- Business to be transacted. 57. No business shall be entered upon by any Special General Meeting except such as shall be set forth in the notice convening the same.
- Quorum. 58. At the General or any Special General Meeting ten members must be present before proceeding to business. If within half an hour from the time appointed for the meeting a quorum is not present the meeting if convened upon the requisition of members shall be dissolved. In any other case it shall stand adjourned to such a date (not being more than 14 days thereafter) and at such time and place as the Chairman (and in his absence the Vice-Chairman) shall as soon as possible thereafter determine and of which adjourned meeting notice shall be given by advertisement in a daily newspaper circulating in Kalgoorlie; and if at such adjourned meeting a quorum is not present, it shall be adjourned sine die.
- Chairman. 59. The Chairman and in his absence the Vice-Chairman and in the absence of both the Chairman and the Vice-Chairman then some member of the Committee to be elected by the meeting shall preside at the General and at all Special General Meetings. The Chairman of all such Meetings shall have a casting vote only.
- Voting. 60. All propositions, questions and matters (except the election of Committeemen nominated as before mentioned) submitted in accordance with these Rules to any meeting shall be decided by a majority of those present, to be determined in the first instance by a show of hands.
- Poll. 61. Any five members may demand a poll, and if a poll is so demanded, the proposition, question or matter shall be finally decided by a division, to be held and conducted in such manner as shall be determined by the Chairman.
- Miscellaneous.
- Insulting Officials. 62. If any person shall be proved to the satisfaction of the Committee to have insulted, abused or imputed improper motives to any member of the Committee, Steward Handicapper, or official of the Club, in connection with the performance of any matter or thing done by him, them or any of them in the exercise or performance of his or their duty, such person shall be punished by the Committee in such manner, either by being fined a sum not exceeding Ten Pounds, being warned off or otherwise as the nature of the case may require.

Part II.

Management of Racecourses.

63. The divisions into which the land vested in the Chairman for the time being of the Club, with the buildings, erections, and fences thereon, is parcelled out and known, are as follows:— Division of Club's premises.

1. The Grand Stand, the Lawn and Approaches.
2. The Weighing Yard, the Committee Room, the Committee Stand, the Stewards' Room, the Stewards' Stand, the Judge's Box and approaches.
3. The Saddling Paddock.
4. The outer Carriage Paddock and Approaches.
5. The Leger Stand and Enclosure.
6. The Course Proper.
7. The Training Ground and Approaches.
8. The Members Stand and Enclosures, and the Members' Carriage Paddock and Approaches.
9. The Totalisator Buildings.
10. The Jockeys' and Trainers' Stand.
11. That part of the land not included in the previous ten divisions.

64. The following is the maximum scale of Tolls and charges which shall be levied and taken for admission to the several divisions of the said land and the buildings thereon respectively:— Tolls and Charges.

For the admission of each male person to the first division	s. d. 15 0
For admission of each lady, and each person under the age of 14 years to the first division	6 9
For the admission of each person to the third division (Saddling Paddock) not exceeding	2 6
For the admission of each person to the fifth division (Leger Reserve)	3 0
For admission to the seventh division for training or exercising every horse for each six months	10 0

Provided that all Members, shall upon production of their tickets, and all ladies producing Ladies' Cards issued to Members, be admitted to any part of the said land with the exception of the second, sixth, seventh, ninth and tenth divisions, and shall be admitted to the Members' Car Park with their motor vehicles without payment of any of the above tolls and charges for admission. Provided further that no vehicle licensed for hire shall be allowed to remain in the Members' Car Park.

65. Subject to the provisions of the By-laws, and to the Rules of Racing, all persons who shall have duly paid the fees for the use of the sixth of the said divisions for the purpose of training or exercising horses shall upon production to the Clubs' officials of their training track tickets for the term then current, be admitted thereto with their horses for the period for which such tickets are issued, subject however, to the conditions thereof, and to such orders as the Committee or the Stewards may from time to time give, as in their opinion occasion may require with reference to such division. Any person trespassing on such division with a horse or horses without having first paid the necessary fees shall be disqualified or otherwise dealt with as the Committee may in their discretion determine. Admission for training horses.

66. No vehicle shall at any time (without the consent of the Committee) be driven or taken across or on to the sixth and seventh of the said divisions. Vehicles not to be driven on certain divisions of Club's premises.

- Penalty for taking Strangers to Members' Grand Stand. 67. No person except members of the Club shall be admitted to the eighth of the said divisions; and any member who shall without the consent of a Committeeman being first obtained, take any other person (not being a fellow member or an honorary member) into the said eighth division, may for the first offence be fined a sum not exceeding £5, for the second offence a fine not exceeding £10, and for the third offence shall be expelled from the Club. Provided that any Member may take in his Company into the Members' Carriage Paddock any person or persons holding a ticket entitling such person or persons to admission to the first division.
- Judge's Box. 68. No person except the Judge and the Timekeeper or any person the Judge may call to his assistance, shall enter the Judge's Box from the time of the lowering of the starting barrier until after the conclusion of the race.
- Weighing Yard and Enclosure. 69. No person shall enter the Weighing Yard, or the approaches thereto, except the Committee, the Stewards, the officers of the Club, the jockeys requiring to be weighed, and the owners and trainers of horses desirous of seeing their jockeys weighed.
- Stewards and Committee's Stand and Room. 70. No person shall enter the Stewards' Stand, the Stewards' Room, the Committee Stand, the Committee Room or the several approaches thereto, except the officers of the Club and such persons as the Committee or the Stewards may invite to do so.
- Course proper. 71. No person shall be allowed on the Course Proper at any time except the Officers of the Club and the jockeys of horses actually engaged in a race about to be run, without the written authority of the Stewards during the time a Race Meeting is under their jurisdiction or without the consent of the Committee at any other time.
- Admission of general public. 72. No person shall enter the said first, third, fourth or fifth divisions of the said Course without a ticket duly authorising him in that behalf or in cases where turnstiles are used without paying the appropriate admission charges. Such ticket shall be issued and such permission of entry given on the express understanding that it is revocable by the Committee or Stewards or any one of them at any time.
- Totalisator buildings. 73. No person shall enter the ninth of the said divisions except the Chairman of the Committee, any Committeeman or Stewards specially appointed by the Committee to supervise the working of the Totalisator, the Officers of the Club engaged in the working of the said machine, or on the invitation of the Chairman of the Committee.
- Persons disqualified for admission to any part of Racecourse. 74. The following person shall not be admitted into any of the said divisions:—
- (a) Any person under sentence of disqualification by the Committee or the Stewards, or by any Stewards whose decision shall be final and not subject to appeal under the Rules of Racing, or by the Committee or Stewards of any Racing Club or Race Meeting, whose decision has been adopted by the Committee under the Rules of Racing.
 - (b) Any person who has been warned off any racecourse.
 - (c) Any person not admitted to any of the said divisions in pursuance of these By-laws.
 - (d) Any person whose name is on the forfeit list.
 - (e) Any person who is a defaulter in bets.

(f) Any person who has been at any time declared guilty of corrupt practice by the Committee or Stewards, or by any Stewards whose decision shall be final and not subject to appeal under the Rules of Racing, or by the Committee or Stewards of any Racing Club whose decision has been adopted by the Committee under the Rules of Racing.

(g) Any person who, having been a member, has been expelled from the Club.

75. The Committee or Stewards, or any one of them may, without giving reason, refuse admission to all or any of the said divisions to anyone not a member; and may, with or without giving reason, expel any person not a member who has gained admission to any of the said divisions, without refunding such person the money he has paid to obtain entrance.

Committee or Stewards may refuse admission.

76. Every member of the Club, and any person paying for admission to any of the said divisions, shall upon demand, produce and (if required) surrender his ticket to all gatekeepers and other persons having authority from the Club to demand the production or surrender of the same.

Tickets to be produced.

77. Persons renting or hiring for any Race Meeting any Stands, or any portions thereof, or any Booth upon the said racecourse, shall abide by any order given by the Committee, Stewards, or any one of them or Secretary, in the reference to the said racecourse and the buildings and other erections thereon.

Tenants hiring course.

78. No person, without permission, shall remain on any racecourse belonging to the Club or any part thereof for a longer period than half-an-hour after the last race of the day shall have been run.

Remaining on land after races.

79. No person shall, without the consent of the Committee, allow any cattle, horses, camels, donkeys, pigs or sheep, of which he is the owner, or which are under his control or in his custody, to trespass into or upon the said land, or any part or division thereof; and no person shall, without the consent of the Committee, admit, take, or drive any cattle, horses, camels, donkeys, pigs or sheep into or upon the said land or any division or part thereof. Any person offending against this By-law shall on conviction thereof before a Justice forfeit and pay for every such offence over and above the amount of the injury done any sum not exceeding Ten Pounds.

Cattle, etc. trespassing.

80. No person shall admit, take, or drive any dogs, goats or poultry into or on the said land or any division or part thereof, or into any building thereon, and any dogs, goats or poultry found upon the said land may be destroyed by any officer or servant of the Club. Any person offending against this By-law shall on conviction thereof before a Justice forfeit and pay for every such offence over and above the amount of the injury done any sum not exceeding Ten Pounds.

Dogs, goats, and poultry to be destroyed.

81. Any officer or servant or employee of the Club and any other person, finding any lost property or document upon any land in the use or occupation of the Club, or upon any land belonging to the Club, or in any building or premises erected on any such land shall immediately deliver the same to the office appointed by the Committee for the reception of lost property, to the person in charge of such office; but should such office be closed, shall deliver such property at the office of the Club in Kalgoorlie, to the person for the time being in charge of such office. Any person committing a breach of this By-law will be liable to a penalty not exceeding Five Pounds.

Lost property.

82. No person, unless duly authorised in writing by the Secretary, shall distribute or post or stick bills or placards or assist in distributing or posting or sticking same within or upon any fence, wall, building, property or premises of the Club. Any person committing a breach of this By-law will be liable to a penalty not exceeding Five Pounds.

Bills and placards.

Removal
and
punishment
of offenders.

83. Any person committing on the said land or any division or part thereof, or in any of the buildings or erections for the time being thereon, any of the following offences, may be removed from such land notwithstanding such person may be a Member of the Club, or may have purchased, and is or may be in possession of a ticket of admission, and in addition such person shall on conviction of any such offences before the Justice forfeit and pay for every such offence a penalty not exceeding Ten Pounds:—

1. Assaulting any person.
2. Being drunk.
3. Riding, crossing or trespassing upon the Course, or any part of it, unless authorised during a Race Meeting, or when the horses are preparing or prepared to start, or are running for any race.
4. Using profane, indecent, or obscene language.
5. Using any threatening, abusive, or insulting words.
6. Behaving improperly, riotously, or in a disorderly manner or fighting.
7. Being found in the first, third, fourth or fifth divisions and not producing upon demand or (if required) not surrendering to any gatekeeper, servant, or other person having authority from the Committee to demand production of the same, a ticket duly authorising admission to such division, unless the person so found shall forthwith satisfy the Stewards or one of them, that the proper charge for admission has been paid by him, and that his ticket has been lost.
8. Obtaining admission to the said land or any division or part thereof when disentitled to such admission under these By-laws.
9. Remaining on the said land or any division or part thereof, after having been warned off any part of the said land or on behalf of the Committee or Stewards.
10. Betting or wagering or offering to bet or wager unless duly authorised so to do by the Committee under these By-laws.
11. Selling or offering to sell tips or information in connection with races run or to be run on the Club's Course.
12. Throwing, passing, conveying, or receiving any money, purse, book, letter or other documents, or other article or thing, over, through, or under any fence, building or partition erected or being at any time between the First and Fifth divisions.
13. Signalling or communicating information by any means whatsoever from the First to the Fifth, or from the Fifth to the First division.

A Defaulter
definition of.

84. A person shall be, and be considered a defaulter in bets:—

If being a member—

- (a) The Committee after investigation, shall have decided that such a member is a defaulter—

If not being a member—

- (a) The Committee after investigation, shall have decided that such a person is a defaulter or—
- (b) The Committee having been credibly informed that such person is a defaulter, and having called upon such a person to make a written statement concerning the alleged default, such person does not make any such statement, or such statement when made is not satisfactory to the Committee,

Part III.

Bookmakers and Betting.

85. Any person the holder of the requisite bookmakers license issued by The Western Australian Turf Club may apply to the Club for a permit to carry on the business of a bookmaker at any race meeting or race meetings conducted by the Club.

Registration
of and issue
of licenses to.

86. Permits may be granted to cover the first, fourth, fifth and eleventh divisions or any one or more of such divisions.

87. The Committee may from time to time fix the fee to be paid to the Club in respect of such permits and such fee may be either for a single race meeting or for a year or any lesser period.

Committee
may fix fee
for licenses.

88. A bookmaker shall carry on his business upon the place set aside by the Committee for that purpose and upon no other place.

Committee
may set apart
places for
betting
purposes.

89. The Committee may at any time revoke any permit without giving any reason therefor and shall not be called upon to refund any portion of the fee paid by the bookmaker for such permit.

Committee
may revoke
licenses.

90. No person shall carry on the business of a bookmaker upon any racecourse belonging to the Club unless he is the holder of a permit as aforesaid and any person offending against this By-law may be removed from the racecourse by any official of the Club and shall for every offence forfeit a sum not exceeding Ten Pounds.

No person to
act as
bookmaker
without
license.

91. Any person convicted of an offence against these By-laws shall be liable to a penalty where not otherwise provided by these By-laws of a sum not exceeding Ten Pounds.
