# ORDER IN COUNCIL.

Forests File 970/21, Lands File 720/29, Vol. 2. WHEREAS by the Forests Act, 1918, it is provided that the Governor may, by Order in Council, dedicate any Crown lands as State Forests within the meaning and for the purpose of that Act: Now, therefore, His Excellency the Governor, with the advice and consent of Executive Council, doth hereby dedicate Nelson Locations 12389, 12390 and 12391 as an addition to State Forest No. 37 within the meaning and for the purposes of the Forests Act, 1918. (Plan 438D/40, A3.)

Traffic Act, 1919-1954. Ashburton Road Board. ORDER IN COUNCIL.

# L.G. 1038/52.

HIS Excellency the Governor, acting by and with the advice and consent of the Executive Council, hereby makes the following order under section 49 of the Traffic Act, 1919-1954, namely, that the Ashburton Road Board is hereby empowered to make by-laws in pursuance of—

- (1) Clause (a) of paragraph (i) of subsection (1) of section 47 of the said Act, prescribing the rules to be observed in respect of any vehicle being driven or used on roads.
- (2) Clause (u) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting the use of any specified road by any vehicle or by any person riding, driving, or in charge of any animal.
- (3) Clause (v) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting the use of any specified road by any vehicle or by any person riding, driving or in charge of any animal, except when proceeding in a prescribed direction.

- (4) Clause (w) of paragraph (i) of subsection (1) of section 47 of the said Act, prescribing the routes to be followed by all classes of traffic, or any particular class of traffic or vehicle, from one specified point to another, either generally or between any specified times.
- (5) Clause (y) of paragraph (i) of subsection (1) of section 47 of the said Act, providing for the placing, erection or installation on roads or footpaths of traffic signs and directions, and for the marking on roads or footpaths of signs for the direction of traffic, both vehicular and pedestrian.
- (6) Clause (zd) of paragraph (i) of subsection (1) of section 47 of the said Act, appointing stands and parking places for different classes of vehicles and regulate the use thereof.
- (7) Clauses (zl) and (zm) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting or restricting the parking of vehicles or vehicles of a specified class or classes in all roads, or in specified roads or specified parts of roads, at all times or at specified times, and prescribing a penalty for any breach thereof.

Subject to the condition that no such by-law shall be valid and effectual unless it has prior to notification of its making being published in the Government Gazette, been submitted to and approved by the Governor.
