At the Court of Buckingham Palace.

The 25th day of January, 1956.

Present, The Queen's Most Excellent Majesty.

WHEREAS the Governor of Western Australia (being one of the States constituting the Commonwealth of Australia) reserved on the ninth day of December in the year One thousand nine hundred and fifty-five a certain Bill passed by the Legislature of the said State, intituled "A Bill for an Act to amend the Constitution Acts Amendment Act, 1899-1954" for the signification of Her Majesty's Pleasure thereon.

And whereas the said Bill, so reserved as aforesaid, has been laid before Her Majesty in Council, and it is expedient that it should be assented to by Her Majesty.

Now, therefore, Her Majesty doth by this present Order, by and with the advice of Her Privy Council, declare Her Assent to the said Bill.

IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1951, I, the Governor of the State of Western Australia, by and with the advice and consent of Executive Council, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in all that portion of Western Australian waters specified in the Schedule hereto, from 1st June, 1956, to 31st May, 1961, inclusive.

Schedule.

All that portion of Cockburn Sound and Careening Bay, Garden Island, bounded by lines starting at the Easternmost extremity of Colpoys Point, on that island, and extending East for 20 chains; thence South-South-Westerly to a point situate 20 chains East of the Easternmost extremity of Collie Head; thence West to that point and thence generally North-North-Easterly along the high water mark of Cockburn Sound and Careening Bay aforesaid to the starting point.

WHEREAS by section 3 of the Perth Gas Company's Act, 1886-1937, it is enacted that the limits of the said Act shall extend to and include the City of Perth and every place being within a circle of five miles from the General Post Office in the City of Perth and every other place outside the circle of five miles to which the Governor may from time to time by proclamation declare that the Act shall extend: Provided that the Governor shall not make or issue any proclamation under this section to extend the limits of the Act to any place situated within the district of any Municipal Council or of any Road Board outside the said circle of five miles unless and until the Municipal Council or the Road Board concerned (as the case may be) has by resolution consented thereto; and whereas it is desirable to extend the limits of the Act to that portion of the Perth Road Board described in The Schedule hereunder; and whereas the said Perth Road Board has by resolution passed on the 6th day of March, 1956, consented thereto: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid and of every other power in this behalf me enabling, do hereby proclaim and declare that the limits of the Act shall extend to and include that portion of the Perth Road Board described in The Schedule hereunder which is outside the circle of five miles from the General Post Office in the City of Perth.

All that portion of land bounded by lines starting at a point on the low water mark of the Indian Ocean situate in prolongation Westerly of the Northern side of Beach Road (road No. 246) and extending generally Easterly to and along that side and the Southern boundary of Swan Location H to its intersection with a line joining the South-Eastern corner of Perthshire Location 104 and the intersection of the North-Eastern boundary of Swan Location T and the South-Eastern side of Walter Road (road No. 250); thence South-Easterly along that line to the Southern side of Truganina Road; thence Easterly along that side; thence Southerly along the Western side of Malaga Road (road No. 5805); thence Westerly along the Northern side of Widgee Road (road No. 8145) to a point situate in prolongation Northerly of the Western side of Bunya Street (road No. 7354); thence Southerly to and along that side to a point situate in prolongation North-Westerly of the North-Eastern side of Wellington Road; thence South-Easterly to and along that side to the present gas area boundary, an arc of a circle having a radius of five miles from the General Post Office (as defined in the Perth Gas Company's Act, 1886); thence generally Westerly and generally South-Westerly along that arc to the North-Eastern boundary of that portion of land being portion of Perthshire Location An and Swan Location 1251 as shown coloured green on Land Titles Office Diagram 16637; thence 314 degrees 43 minutes to a Western boundary of location 1251 aforesaid; thence Northerly along that boundary to the Southern side of Border Road; thence Westerly along that side to a point situate in prolongation Southerly of the Eastern side of Brompton Road; thence Northerly to and along that side and the Western boundary of location 3176 to the South-Eastern corner of location 1097; thence Westerly along the Southern boundary of that location and onwards to the low water mark of the Indian Ocean aforesaid; and thence generally Northerly along that low water mark to the starting point.

ORDER IN COUNCIL.

L.G. 842/52.

WHEREAS it is provided by subsection 1 (b) (iii) of section 480 of the Municipal Corporations Act, 1906-1954, that a Council may with the approval of the Governor expend out of the ordinary revenue of the Municipality any sum or sums not exceeding in the aggregate 10 per cent. of such ordinary revenue for providing all forms of tourist propaganda both within the district and elsewhere in connection with or in relation to any tourist resort within the district of the council; and whereas the Municipality of Bunbury is desirous of expending the sum of £265 from its ordinary revenue for tourist propaganda purposes: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of the Executive Council and in exercise of the power vested in him in the said section of the said Act, doth hereby authorise the Municipality of Bunbury to expend from its ordinary revenue the sum of £265 for tourist propaganda purposes.

ORDER IN COUNCIL.

L.G. 125/56.

HIS Excellency the Governor acting by and with the advice and consent of the Executive Council hereby makes the following order under section 49 of the Traffic Act, 1919-1954, namely, that the Wagin Municipal Council is hereby empowered to make by-laws in pursuance of—

(1) Clause (a) of paragraph (i) of subsection (1) of section 47 of the said Act, prescribing the rules to be observed in respect of any vehicle being driven or used on roads.

(2) Clause (y) of paragraph (i) of subsection (1) of section 47 of the said Act, providing for the placing, erection or installation on roads, or footpaths of traffic signs and directions, and for the marking on roads or footpaths of signs for the direction of traffic, both vehicular and pedestrian.

(3) Clause (zd) of paragraph (i) of subsection (1) of section 47 of the said Act, appointing stands and parking places for different classes of vehicles and regulate the use thereof.

(4) Clauses (zl) and (zm) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting or restricting the parking of vehicles or vehicles of a specified class or classes in all roads or in specified roads, or specified parts of roads, at all times or at specified times, and prescribing a penalty for any breach thereof.

Subject to the condition that no such by-law shall be valid and effectual unless it has prior to notification of its making being published in the *Government Gazette*, been submitted to and approved by the Governor.
