IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1951, I, the Lieutenant Governor and Administrator of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in that portion of Western Australian waters specified in the Schedule hereto from November 1 in each of the years 1956, 1957, 1958, 1959 and 1960 to April 30 of each succeeding year respectively.

### Schedule.

All that portion of Oyster Harbour bounded by lines starting at a point on the Western shore of Oyster Harbour aforesaid situate in prolongation Easterly of the Northern boundary of lot 57 of Plantagenet Location 7 and extending Easterly to a point known as "Kalgan Stake;" thence Southerly to the Easternmost extremity of Green Island; thence South-South-Easterly passing through a point known as the "Wreck" and onwards to the Northern boundary of reserve 22698 and thence generally Westerly and generally Northerly along the shores of the said Oyster Harbour to the starting point.

WHEREAS by a Proclamation dated the 27th day of February, 1951, that portion of the land comprised in Pastoral Lease 394/1034, described in the First Schedule hereto was, in exercise of the power conferred by section 109 of the Land Act, 1933-1954, resumed for the purpose of a "Common"; and whereas it is desirable that the portion of land comprised in the said lease described in the Second Schedule hereto should be resumed for the said purpose in lieu of the land described in the First Schedule: Now therefore, I, Sir Charles Gairdner, Governor as aforesaid, with the advice and consent of the Executive Council, do hereby revoke the recited Proclamation of the 27th day of February, 1951, and do by this my Proclamation, resume that portion of the said Pastoral Lease 394/1034, which is described in the Second Schedule hereto for the purpose aforesaid.

#### The First Schedule.

All that portion of Pastoral Lease 394/1034 bounded by lines starting from a point on a Southern boundary of that lease situate 377 chains 37 links East from its Westernmost South-Western corner, and extending 1 degree 30 minutes 658 chains; thence 91 degrees 30 minutes 267 chains 50 links; 1 degree 30 minutes 63 chains; 91 degrees 30 minutes 63 chains; 181 degrees 30 minutes 573 chains; 95 degrees 160 chains; 180 degrees 295 chains 35 links, to a Southern boundary of the aforesaid lease; and thence West, North and again

West along its present boundaries to the starting point excluding the area required for use as an Aerial Landing Ground and the area previously resumed for Wittenoom Gorge Townsite.

Health Act, 1911-1955.

ORDER IN COUNCIL.

P.H.D. 286/54.

WHEREAS in accordance with section 60 of the Health Act, 1911-1955, His Excellency the Governor has received details of a plan for the general installation of apparatus for the bacteriolytic treatment of sewage in the townsite of Kalgoorlie by the Kalgoorlie Road Board, and is satisfied that the scheme is formulated in accordance with the provisions of the Health Act, 1911-1955, and that the cost and provisions for repayment justify the undertaking, and that the works if carried out in the manner designed will be of benefit to that portion of the district of the local authority which the works are designed to serve: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, do hereby order that the Kalgoorlie Road Board, being the local health authority for the Kalgoorlie Health District, is hereby empowered to undertake the construction of the said works.

ORDER IN COUNCIL.

WHEREAS it is provided in section 251 of the Health Act, 1911-1955, that the Commissioner of Public Health may, if authorised by the Minister, from time to time and for such time as the Minister

thinks fit, *inter alia*, exercise the special powers set out in paragraphs (1) to (17a) of that section within or with respect to any district, or any part thereof, for the purpose of more effectually checking or preventing the spread of any dangerous infectious disease; and whereas it is further provided in paragraph (18) of that section that the Commissioner may exercise any other power conferred upon him by the Governor: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, doth hereby confer on the Commissioner the power to provide for the immunisation against any dangerous infectious disease for which, in the opinion of the Commissioner, an efficient immunising agent exists, of any person who consents to being so immunised against that disease.

ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1954, it is, *inter alia* made lawful for the Governor by Order in Council to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the conditions that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor, and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient that reserve No. 24503 (Canning Location 1355) should, subject as aforesaid, be granted in fee simple to the Alexandra Home for Women and Babies and Mothercraft Training School Incorporated to be held in trust for the purpose of a site for Alexandra Home: Now therefore, His Excellency the Governor by and with the advice and consent of the Executive Council doth hereby direct that the before-mentioned reserve shall be granted in fee simple to the Trustees aforesaid to be held in trust for the purpose of a site for Alexandra Home, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

## Workers' Compensation Act, 1912-1954.

## ORDER IN COUNCIL.

WHEREAS it is enacted by section 13 of the Workers' Compensation Act, 1912-1954, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability the Governor may, by Order in Council, exempt such employer from the operation of the said section; and whereas the Australia and New Zealand Bank Limited, of St. George's Terrace, Perth, is an employer within the meaning of the said Act and as such is subject to section 13, and having in accordance with the Act and the regulations made thereunder made application for exemption from the operation of the section has satisfied the Minister that it has established a fund for insurance against its said liability and has deposited at the Treasury securities to wit a bond for five thousand pounds charged with all payments to become due under such liability: Now therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the power conferred by the Act doth hereby exempt the Australia and New Zealand Bank Limited, St. George's Terrace, Perth, from the operation of section 13 of the Workers' Compensation Act, 1912-1954, until the 20th day of June, 1958.
