IT is hereby notified, for general information, that the Hon. Minister for Lands, acting pursuant to the powers conferred by section 17, subsection (3) of the Bush Fires Act, 1954, has approved of the suspension of all declarations of prohibited burning times made under section 17, subsection (1), of the said Act so far as such declarations extend to any land used for railway purposes by the Midland Railway Company of Western Australia Limited in the road districts for the periods stated in the schedule hereunder. Any burning undertaken on railway land under the provisions of this suspension shall be subject to the following conditions:—

PUBLIC SERVICE SALARIES AGREEMENT
 AMENDMENT, 1956.

(P.S.C. No. 2 of 1956.)

THIS Agreement to be known as the Public Service Salaries Agreement Amendment, 1956 (P.S.C. No. 2 of 1956) made pursuant to the provisions of Part X of the Industrial Arbitration Act, 1912-1952, this 21st day of September, 1956, between the Civil Service Association of Western Australia (Incorporated) (hereinafter referred to as the "Association") of the one part and the Public Service Commissioner of Western Australia (hereinafter referred to as the "Commissioner") of the other part, witnesseth as follows:—

Whereas the parties hereto being the parties to an Agreement (P.S.C. No. 1 of 1954), dated the 12th day of May, 1954, and published in the *Government Gazette* (No. 25), dated the 21st day of May, 1954 (hereinafter referred to as the "principal Agreement") which was subsequently amended by an Agreement (P.S.C. No. 2 of 1955) dated the 25th day of February, 1955, and published in the *Government Gazette* (No. 21) dated the 18th day of March, 1955, have mutually agreed that the principal Agreement as amended by the said Agreement P.S.C. No. 2 of 1955 shall be and the same is hereby further varied in the manner following, that is to say—

1.—Clause 2—Arrangement.

(a) Add the words "and Examiners" after the word "Draftsmen" in line 10.

(b) Substitute the words "Laboratory Technologists and Assayers: Males" for the words "Laboratory Technicians: Ex-Cadets" in line 15.

(c) Insert the figures, symbol and words "13a. Laboratory Assistants: Males" between lines 15 and 16.

(d) Insert the figures, symbol and words "15a. Laboratory Technologists: Females" between lines 18 and 19.

(a) The normal commencing, incremental and terminal annual salary rates, expressed as margins over the basic rate, for male laboratory technologists and assayers appointed to the base grade career range (classification G-II-1/5) shall be—

£325 - £355 - £430 - £475 - £520 - £610 - £655, provided that a laboratory technologist or assayer who possesses the degree of Bachelor of Science of the University of Western Australia or an equivalent qualification approved by the Commissioner, shall commence at a margin of £355 per annum.

(b) A laboratory technologist or assayer not in possession of the degree of Bachelor of Science on appointment but who subsequently secures that qualification shall be paid the margin in the range prescribed by subclause (a) which the Commissioner deems appropriate to the officer's year of service as a laboratory technician or assayer in the career range.

(c) A laboratory technologist or assayer shall progress annually through the marginal range prescribed in subclause (a) provided that—

(i) advancement beyond a margin of £355 per annum shall not be approved unless a certificate is furnished by the permanent head to the Commissioner stating that the officer has—

made satisfactory progress in the practice of his technical duties; and reached the standard of efficiency expected of him and is wholly or mainly carrying out technical duties of such quality and importance as to warrant the payment of a salary margin in excess of £355 per annum; and

(ii) advancement beyond a margin of £520 per annum shall not be approved unless a certificate is furnished by the permanent head to the Commissioner stating that the officer has—

continued to make satisfactory progress in the practice of his technical duties; and maintained his efficiency and developed his capacity to carry out and is in fact wholly or mainly carrying out technical duties of such higher quality and importance as to warrant the payment of a salary margin in excess of £520 per annum.

(a) The rates of pay for male laboratory assistants shall be—

An allowance paid under this subclause shall be converted to salary on promotion to a higher position and shall cease should an officer in receipt of the allowance refuse to accept promotion.

 and who is in receipt of a salary margin which is expressed in column (a) of Schedule B to this Agreement, shall be paid qualifications allowance at the rate expressed in column (b) of that Schedule immediately adjacent to the officer's salary margin: Provided that payment of the allowance shall vary in the manner indicated in the Schedule according to variations in the officer's salary margin and shall cease either as a result of the officer becoming entitled to a salary margin for which no qualifications allowance is provided or by the effluxion of a period of 10 years from the date on which the officer first became entitled to payment of the allowance, whichever occurs first.

(ii) Graduates:

A male adult clerk who holds—

a degree in Arts, Science, Economics or Law of the University of Western Australia; or

who holds or passes—

a qualification or examination which, in the opinion of the Commissioner, is equivalent to any of the aforesaid,

and who is in receipt of a salary margin which is expressed in column (a) of Schedule B to this agreement, shall be paid qualifications allowance at the rate expressed in column (c) of that Schedule

immediately adjacent to the officer's salary margin: Provided that payment of the allowance shall vary in the manner indicated in the Schedule according to variations in the officer's salary margin and shall cease either as a result of the officer becoming entitled to a salary margin for which no qualifications allowance is provided or by the effluxion of a period of 10 years from the date on which the officer first became entitled to payment of the allowance either under this or the previous paragraph, whichever occurs first.

18.—Clause 20—Temporary Officers.

Delete the existing clause and substitute the following new clause:—

20.—Temporary Officers.

A person employed in a temporary capacity under the provisions of section 31 of the Public Service Act, 1904-1955, shall be paid at a daily or weekly rate of pay equivalent to the annual rate that would be payable under the provisions of this Agreement to a permanent officer engaged on duties of a similar nature and of equal responsibility, except that—

(a) a male employed in a temporary capacity as a clerk or as a laboratory assistant shall be paid in accordance with the following scale of rates:—
