AT a meeting of the Executive Council held in the Executive Council Chamber, at Perth, on the 19th day of October, 1956, the following Order in Council was authorised to be issued:—

Country Towns Sewerage Act, 1948-1954.

Northam Sewerage Area and Sewerage Districts.

### ORDER IN COUNCIL.

WHEREAS by section 4 (a) of the Country Towns Sewerage Act, 1948-1954, the Governor may, by Order in Council, constitute any part or parts of the State outside the boundaries of the Metropolitan Water, Sewerage and Drainage Area as constituted and defined by the Act. No. 43 of 1909, as a sewerage area under such name as may be directed by the Order in Council; and whereas by section 4 (b) of the Country Towns Sewerage Act, 1948-1954, the Governor may, by Order in

Council, constitute sewerage districts by dividing any sewerage area into sewerage districts, under such names as may be directed: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, by and with the advice and consent of the Executive Council, doth hereby constitute that part of the State defined in the First Schedule hereunder, a sewerage area, and assign the name of Northam Sewerage Area thereto, and doth also hereby divide the said Northam Sewerage Area into two sewerage districts, namely (a) Northam No. 1 Sewerage District, and (b) Northam No. 2 Sewerage District, as defined in the Second and Third Schedules respectively hereunder.

### First Schedule.

#### Northam Sewerage Area.

All that portion of land bounded by lines starting at a point on the North-Western side of road No. 108 situate in prolongation North-Westerly of the South-Western boundary of Avon Location a, and extending generally North-Easterly and Easterly along the North-Western and Northern sides of road No. 108 to a point situate in prolongation South-Westerly of the South-Eastern side of road No. 1850; thence North-Easterly to and along that side and onwards to the South-Western boundary of location Q; thence North-Westerly, North-Easterly and South-Easterly along boundaries of that location; thence North-Easterly along the North-Westernmost boundary of location P2 to the North-Eastern side of the Northam-Goomalling Railway Reserve; thence generally South-Easterly along that side and that of the Eastern Railway Reserve to the North-Western boundary of location 62; thence South-Westerly and South-Easterly along boundaries of that location to the Northern corner of location 39; thence South-Westerly along the North-Western boundary of that location to the South-Western side of the Eastern Railway Reserve aforesaid; thence generally North-Westerly along that side to a point situate in prolongation South-Easterly of the South-Western side of road No. 159; thence generally North-Westerly to and along that side to the South-Eastern boundary of location C1; thence South-Westerly and North-Westerly along boundaries of location d to a Southern

boundary of reserve 16773 (L.T.O. Plan 4151); thence generally Westerly and generally North-Easterly along boundaries of that reserve to its Northernmost corner; and thence North-Westerly to and along the South-Western boundaries of locations 1309 and aforesaid, and onwards to the starting point and as outlined in green on Plan P.W.D., W.A. 35343.

Second Schedule.

Northam No. 1 Sewerage District.

All that portion of land bounded by lines starting at the Westernmost corner of that portion of Avon Location a, as shown coloured green on L.T.O. Plan 5867 and extending generally North-Easterly and generally South-Easterly along boundaries of that portion of location a to the South-Eastern boundary of that location; thence North-Easterly along that boundary and onwards to and along that of location R, reserve 13238, location 20511, again reserve 13238 and again location R to the North-Western corner of location P2; thence South-Easterly, South-Westerly, again South-Easterly, North-Easterly and again South-Easterly along boundaries of locations P2 and P1 to the North-Western boundary of location P; thence South-Westerly along the South-Eastern side of Throssell Street; thence North-Westerly along the South-Western side of Burn Street and onwards to and along the South-Western boundary of Northam Suburban Lot P1 and again onwards to the South-Eastern boundary of location a aforesaid; thence North-Easterly along that boundary to the South-Western corner of that portion of that location as shown coloured green on L.T.O. Plan 5867 aforesaid; and thence generally North-Westerly along boundaries of that portion of location a to the starting point, and as outlined in blue on Plan P.W.D., W.A. 35343.

Third Schedule.

Northam No. 2 Sewerage District.

All that portion of land within the Northam Sewerage Area as defined in the First Schedule hereto, with the exception of the Northam No. 1 Sewerage District as defined in the Second Schedule hereto, and being the whole of the area as shown hatched yellow on Plan P.W.D., W.A. 35343.

This Order in Council shall take effect on the 1st day of November, 1956.
