## ORDER IN COUNCIL.

Corres. No. 3376/53.

WHEREAS by section 33 of the Land Act, 1933-1958, it is, *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall

be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to each other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient that reserve No. 24135 (Borden lot 67) should, subject as aforesaid, be granted in fee simple to The Bunbury Diocesan Trustees in trust for the purpose of a "Church Site (Anglican)": Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall be granted in fee simple to the aforesaid body to be held in trust for the aforesaid purpose, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

Country Areas Water Supply Act, 1947-1957.  
Central Rating Zone and Kondinin  
Rating Zone.

ORDER IN COUNCIL.

P.W.W.S. 130/58.

WHEREAS by section 10 of the Country Areas Water Supply Act, 1947-1957, it is enacted, *inter alia*, that the Governor may for the purposes of the Act, by Order in Council, alter or extend the boundaries of a rating zone: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, doth hereby, for the purposes of the Act, alter the boundaries of the Central Rating Zone by including in that rating zone the portions of land described in paragraphs (a), (b), (c) and (d) of the First Schedule hereunder and by excising from that rating zone the portion of land described in the Second Schedule hereto; and doth also hereby alter the boundaries of the Kondinin Rating Zone by including in that rating zone the portions of land described in paragraphs (a) and (b) of the Third Schedule hereunder.

First Schedule.

Central Rating Zone.

(a) All the land bounded by lines commencing at the intersection of the southern boundary of the Goldfields and Agricultural Country Water Area with the southern prolongation of the eastern boundary of Avon Location 17229 and proceeding southerly to a point situate on the southern boundary of location 17236; thence westerly to a point on the western side of the Merredin-Narrogin Railway Reserve; thence generally southerly, along the said side to a point opposite the south-eastern corner of location 23444; thence easterly to the north-eastern corner of location 23690; thence southerly, westerly and again southerly to the south-eastern corner of location 23392; thence westerly and southerly to the south-western corner of location 25744; thence easterly and southerly to the south-eastern corner of location 21935; thence generally westerly to the south-eastern corner of location 16620; thence southerly, following part of the boundaries of the Kondinin Water Area as published in the *Government Gazette*, dated 22nd April, 1927 (reference file P.W.W.S. 361/27), to the eastern boundary of the Merredin-Narrogin Railway Reserve; thence across the reserve to and south-westerly along its western boundary to its intersection with the western boundary of location 13663; thence north-north-westerly, about 19 miles, to the north-eastern corner of location 16867; thence westerly along a public road, to the north-eastern corner of location 18798; thence generally northerly along a public road to the aforesaid southern boundary of the Goldfields and Agricultural Country Water Area; thence in a general north-easterly direction along the said southern boundary to the point of commencement, and being all that land as shown bordered green on Plan P.W.D., W.A., 34671, Drawing No. 4.

(b) All that portion of land bounded by lines starting from the intersection of the present southern boundary of the Goldfields and Agricultural Country Water Area and the western boundary of Avon Location 23909 and extending southerly along that boundary and onwards to the northern boundary of location 23939; thence westerly, southerly and again westerly along boundaries of that location to the north-eastern corner of location 23497; thence westerly and southerly along boundaries of that location to a point situate in prolongation easterly of the northern boundary of location 23998; thence westerly and southerly to and along boundaries of that location to the north-western corner of location 19871; thence southerly along the western boundary of that location and onwards to the northern boundary of location 19872; thence generally westerly and southerly along boundaries of that location to the south-eastern corner of location 17236; thence westerly along the southern boundary of that location to the present southern boundary of the Goldfields and Agricultural Country Water Area aforesaid; and thence generally northerly and generally north-easterly along that boundary to the starting point.

Being the land delineated and shown bordered blue and marked "D" on sheet 5 of Department of Lands and Surveys Miscellaneous Plan 247, and on Plan P.W.D., W.A., 36886.

Ltd.
