IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1956, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby proclaim and declare that all those portions of Western Australian waters defined in the schedule hereto shall be closed against the use

of fishing nets other than hand scoop nets for a period of five years as from date of publication of this Proclamation in the *Government Gazette*.

Schedule.

- (1) The waters of the Swan River and of its affluents and tributaries from the Perth Causeway upwards to the Railway Bridge at Guildford.
- (2) The waters of the Swan River and of its affluents and tributaries from the Middle Swan Bridge connecting the Middle Swan Road upwards to its source.
- (3) The waters of the Swan River and of its affluents and tributaries from a line drawn from the south-western extremity of Point Resolution to the south-western extremity of the Point Walter Jetty (situated at Point Walter), downwards to a line drawn from the western extremity of the South Mole to the western extremity of the North Mole at Fremantle.
- (4) The waters of the Canning River and of its affluents and tributaries upwards to its source, from a line drawn from a point on the right bank and situate eight chains north-westerly from Salter Point, and extending 242 deg. 21 min. 22 chains $3 \frac{6}{10}$ th links across the said river, the extremities of such line being marked on the ground with steel rails.
- (5) All that area of Western Australian waters from the southerly extremity of Mudurup Rocks (south of Cottesloe Jetty) and extending in a northerly direction to the south-western extremity of North Street, Cottesloe, with a width of a quarter of a mile from the foreshore.
- (6) All that area of Western Australian waters from the south-western extremity of North Street, Cottesloe, and extending in a northerly direction to a point one-half mile south of the drain at Swanbourne with a width of a quarter of a mile from the foreshore.

WHEREAS under the provision of section fourteen of the Fauna Protection Act, 1950-1954, the Governor in Executive Council may declare, *inter alia*, an open season in respect of any of the fauna in any part or parts of the State and for such period as he thinks fit, and place such restrictions on the taking or disposal of the fauna as he considers advisable; and whereas the Governor may vary the provisions of a Proclamation promulgated pursuant to the power so conferred upon him: Now, therefore I, the said Governor, acting by and with the advice and consent of the Executive Council, do hereby declare that the Proclamation dated the 17th day of June, 1960 (F.D. 70/53, Ex. Co. No. 2111) is varied as follows:—

WHEREAS by section 3 of the Perth Gas Company's Act, 1886-1937, it is enacted that the limits of that Act shall extend to and include the City of Perth, and every place being within a circle of five miles from the General Post Office in the City of Perth and every other place outside the circle of five miles to which the Governor may from time to time by Proclamation declare that the Act shall extend; and whereas it is also provided by that section that the Governor shall not make or issue any Proclamation under that section to extend the limits of that Act to any place situated within the district of any municipal council or of any road board outside the said circle of five miles unless and until the municipal council or the road board concerned (as the case may be) has by resolution consented thereto; and whereas the Bayswater Road Board has by resolution passed on the 8th day of June, 1960, consented to the extension of the limits of the Act to those portions of the Bayswater Road District described in the schedule hereunder: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid and of every other power in this behalf enabling, do hereby proclaim and declare that the limits of the Act shall extend to and include those portions of the Bayswater Road District described in the schedule hereunder which are outside the circle of five miles from the General Post Office in the City of Perth.

IN pursuance of the provisions of section 10 of Fisheries Act, 1905-1956, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby prohibit all persons from taking any fish whatsoever by means of sunk nets, being nets the ground or lead line of which is moved along the bottom and the cork line of which is submerged during the process of hauling, in the whole of the waters of the Swan and Canning Rivers and all their affluents and tributaries, for a period of five years from date of publication of this Proclamation in the *Government Gazette*, excepting during the months of May, June, July, August and September in each year in that portion of the waters of the Swan River defined in the Locality Schedule hereto.

Locality Schedule.

The whole of the waters of the Swan River known as Melville Water, together with all its affluents and tributaries except the waters of the Canning River and its affluents and tributaries flowing between straight lines drawn from Point Lewis to Point Belches and from Point Resolution to Point Walter, respectively.

lot 63; thence south-easterly along south-western boundaries of that lot and lot 90 and onwards to the northern corner of lot 102; thence south-westerly and south-easterly along boundaries of that lot and the south-western boundary of lot 131 and onwards to the northern corner of lot 141; thence south-westerly and south-easterly along boundaries of that lot and the south-western boundary of lot 172 to its southern corner; thence southerly to the northern corner of lot 598 of location S as shown on Land Titles Office Deposited Plan 3471; thence south-easterly along the north-eastern boundaries of that lot and lot 599 to the eastern corner of the lastmentioned lot; thence south-westerly along the south-eastern boundary of that lot to its southern corner; thence south-easterly along south-western boundaries of lots 600 to 612 inclusive to the north-western side of Hardy Road; thence south-westerly along that side to the south-western side of Moojebing Street (road number 9400); thence south-easterly along that side and onwards to the right bank of the Swan River; thence generally southerly downwards along that bank to its intersection with an arc of a circle having a radius of five miles from the General Post Office (as defined in the Perth Gas Company's Act, 1886); thence generally north-westerly along that arc to its intersection with the north-eastern side of Wellington Road; thence north-westerly along that side to the southern side of Wonga Road as shown on Land Titles Office Deposited Plan 440; thence north-westerly to the intersection of the northern side of Wonga Road and the western side of Bunya Street aforesaid, and thence northerly along the western side of Bunya Street and onwards to the starting point.
