Plant Diseases Act, 1914-1958.

PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency The Honourable Sir John

WHEREAS by section 5 of the Plant Diseases Act, 1914-1958, it is provided (*inter alia*) that the Governor may, by Proclamation, prohibit either absolutely or except in accordance with regulations the bringing into any specified portion of the State from the rest of the State generally or from any specified portion thereof any specified kind of plant, fruit, or other thing which would in his opinion be likely to introduce any disease into the State or into any specified portion thereof, as the case may be and all or any coverings or goods in or with which any plant, fruit or other thing of the kind specified has been contained or packed or come in contact; and whereas I, the Lieutenant-Governor, am of opinion that the bringing of bananas into the Carnarvon District from the rest of the State generally would be likely to introduce into that portion of the State disease of a fungal or virus nature: Now, therefore I, the Lieutenant-Governor, acting with the advice and consent of the Executive Council, hereby prohibit the bringing by any person into the area bounded by a circle having a radius of twenty-five miles from the Carnarvon Post Office of the fruit known as banana and any covering in which bananas have been contained or packed and any goods with which bananas have come into contact, from the rest of the State, generally.

Forests Act, 1918-1954.

ORDER IN COUNCIL.

Lands Corres. 2533/60.

WHEREAS by the Forests Act, 1918-1954, it is provided that the Governor may, by Order in Council, reserve from sale any Crown land as a Timber Reserve within the meaning and for the purpose of that Act; Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council doth hereby declare the Crown land described in the schedule hereto as Timber Reserve No. 140/25 within the meaning and for the purposes of the said Act.

Schedule.

All that portion of land containing about 11,800 acres, bounded by lines starting from the south-western corner of Nelson Location 3085 and extending easterly along the southern boundary of that location to the north-western corner of location 8546; thence southerly, easterly and northerly along boundaries of that location to the southern boundary of location 3085 aforesaid; thence easterly along that boundary and southern boundaries of locations 965 and 1521 to a western boundary of location 8553; thence southerly and easterly along boundaries of that location to the western side of a one chain road passing along western boundaries of locations 7342, 7345 and 11558; thence southerly along that side to the northern corner of location 7352; thence south-westerly along a north-western boundary of that location and onwards to the south-western side of a one chain road passing along south-western boundaries of locations 7352 and 7351; thence generally south-easterly along that side to the northern corner of location 7350; thence south-westerly along north-western boundaries of that location and location 9487 to the western corner of the lastmentioned location; thence south-easterly along the south-western boundary of that location to the north-western side of a protected

road between the southern corner of that location and the north-western corner of location 9836; thence generally south-westerly along that side to the eastern boundary of location 9835; thence northerly and westerly along boundaries of that location to an eastern boundary of location 5858; thence northerly, westerly, again northerly and again westerly along boundaries of that location to its north-western corner, and thence northerly to the starting point. Forests Act, 1918-1954.

ORDER IN COUNCIL.

Lands Corres. 2531/60.

WHEREAS by the Forests Act, 1918-1954, it is provided that the Governor may, by Order in Council, reserve from sale any Crown land as a Timber Reserve within the meaning and for the purpose of that Act: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council, doth hereby declare the Crown land described in the schedule hereto as Timber Reserve No. 141/25 within the meaning and for the purpose of the said Act.

Country Towns Sewerage Act, 1948-1954.
Narrogin Sewerage Area.

ORDER IN COUNCIL.

WHEREAS by section 4 of the Country Towns Sewerage Act, 1948-1954, the Governor may, by Order in Council, constitute any part or parts of the State outside the boundaries of the Metropolitan Water, Sewerage and Drainage Area as constituted and defined by the Act (No. 43 of 1909) as a Sewerage Area; and whereas by section 4 (b) of the Country Towns Sewerage Act, 1948-1954, the Governor may, by Order in Council, constitute sewerage districts by dividing any sewerage area into sewerage districts under such names as may be directed: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council doth hereby constitute that part of the State defined in Schedule "A" hereunder a sewerage area and assign the name of "Narrogin Sewerage Area" thereto and also doth hereby divide the Narrogin Sewerage Area into two sewerage districts, namely—

(a) No. 1 Narrogin Sewerage District,

(b) No. 2 Narrogin Sewerage District,
defined in Schedule "B" hereunder.

Schedule "A."

Narrogin Sewerage Area.

All that portion of land contained within a circle having a radius of five miles with its centre situate within Narrogin Townsite at the south-eastern corner of Town Lot 56, as shown on Plan P.W.D. 38425.

Schedule "B."

Narrogin Sewerage Districts.

Narrogin No. 1 Sewerage District.

All that portion of land contained within the boundaries of Narrogin Townsite, as shown on Plan P.W.D. 38425.

Narrogin No. 2 Sewerage District.

All that portion of land contained within the Narrogin Sewerage Area excluding the land contained within the boundaries of Narrogin Townsite, as shown on Plan P.W.D. 38425.
