WHEREAS by section 9 of the Fisheries Act, 1905-1960, it is provided that the Governor may, by Proclamation, prohibit all persons from taking fish of any specified species, by any specified means of capture, in any specified portion of Western Australian waters, during a specified portion of any year: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, prohibit all persons from taking the fish known as Australian salmon in every portion of Western Australian waters by means of a net which when set in the water prevents and is intended to prevent the free passage through such water of fish, and which is commonly known as a "set block net", from the date of publication hereof to December 30, 1961, and from 1st January to 30th December in each of the years 1962, 1963, 1964 and 1965.

The Proclamation dated 17th December, 1959 (published in *Government Gazette* No. 100 of 24th December, 1959) relating to the prohibition of "set block nets" is hereby revoked.

WHEREAS it is enacted by section 27 of the Rights in Water and Irrigation Act, 1914-1954, that the Governor, without constituting any irrigation district under Part IV of the said Act, may, on the recommendation of the Minister and acting with the advice of the Commissioners, at any time and from time to time by proclamation declare that Part 111 of the said Act shall apply to and have effect in relation to any river, stream, watercourse, lagoon, lake, swamp or marsh specified in the proclamation to which immediately prior to the issue of the proclamation the said Part 111 does not apply but that no such declaration shall be made until after the expiration of thirty days after notice of intention to make such declaration has been given to the local authority or authorities in or through whose district or districts such river, stream, watercourse, lagoon, lake, swamp or marsh runs or is situate to the intent that before the making of such declaration any objection by such local authority or local authorities may be considered; and whereas the Minister has recommended and the Commissioners have advised the Governor by proclamation to declare that Part 111 of the said Act shall apply to and have effect in relation to the Wungong and Southern River system to which immediately prior to the issue of the proclamation the said Part 111 does not apply; and whereas after due notice given the local authority or local authorities concerned have not made any objection to the proposed declaration: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council and on the recommendation of the Minister and with the advice of the Commissioners and in exercise of the powers conferred by the said Act, do hereby declare that Part 111 of the Rights in Water and Irrigation Act, 1914-1954, shall apply to and have effect in relation to the Wungong and Southern River system as defined in the schedule hereto.

Wungong and Southern River System Under the Rights in Water and Irrigation Act.

(a) All that portion of the Southern River between its confluences with the Canning River and the Wungong River.

(b) All that portion of the Wungong River between its confluences with the Southern River and Wungong Brook.

(c) All that portion of Wungong Brook between its confluence with the Wungong River and that part of the Wungong Brook Catchment Area boundary adjacent to the north-western corner of Canning Location 387.

(d) All that portion of Wungong Brook South Branch between its confluence with Wungong Brook and the western boundary of Canning Location 637.

All as shown delineated red on Plan P.W.D., W.A. 38653.

ORDER IN COUNCIL.

Onslow Country Water Area.

ORDER IN COUNCIL.

P.W.W.S. 244/27.

WHEREAS it is enacted by Section 8 of the Country Areas Water Supply Act, 1947-1960 that the Governor may by Order in Council extend the boundaries of a Country Water Area now therefore His Excellency the Governor by and with the consent of the Executive Council doth hereby extend the boundaries of the Onslow Country Water Area by adding thereto the area as defined in the schedule hereunder.

Extension of Onslow Country Water Area.

(a) All that portion of land bounded by lines starting from a point on the western boundary of Reserve 1054 situate 26 chains 45 links from its north-western corner and extending 57 degrees 54 minutes 76 chains 23 links; thence 147 degrees 54 minutes 400 chains; thence 237 degrees 54 minutes 160 chains; thence 327 degrees 54 minutes 400 chains; and thence 57 degrees 54 minutes 83 chains 77 links to the starting point.

(b) All that portion of land, being a strip of land 300 feet wide on each side of the surveyed line of the pipeline, commencing at its intersection with the south-eastern boundary of the area described in paragraph (a) situate about 102 chains from its north-western corner and extending 269 degrees 22 minutes about 422 chains to peg No. 11; thence 273 degrees 45 minutes 282 chains 10 and two-tenths links to peg No. 10; thence 267 degrees 15 minutes 252 chains 1 and five-tenths links; thence 281 degrees 11 minutes 9 chains 62 and one-tenth links; thence 254 degrees 19 minutes 7 chains 27 and three-tenths links; thence 274 degrees 6 minutes 196 chains 16 and six-tenths links to peg No. 7A; thence 317 degrees 55 minutes 27 chains 41 and three-tenths links to peg No. 6A; thence 328 degrees 36 minutes 11 chains 62 and two-tenths links to peg No. 5; thence 346 degrees 50 minutes 44 chains 14 and two-tenths links to peg No. 4; thence 358 degrees 14 minutes 57 chains 40 and three-tenths links to peg No. 3; thence 351 degrees 18 minutes 34 chains 80 and two-tenths links to peg No. 2; and thence 350 degrees 23 minutes about 25 chains to its intersection with the southern boundary of Onslow Townsite.

(c) All that portion of the Indian Ocean bounded on the west, the north, and the east by lines situate 300 feet from and parallel to the western, the northern and the eastern sides of the Onslow Jetty, and bounded on the south by the seashore.

Increase in Membership.

Workers' Compensation Act, 1912-1960.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 13 of the Workers' Compensation Act, 1912-1960, *inter alia* that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under the Act to all workers employed by him,

but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer from the operation of such section; and whereas Australian Iron & Steel Pty. HAVING heard Mr. J. Anderson on behalf of the Applicant and Mr. G. Martin on behalf of the Respondents, and by consent, the Court in pursuance of the powers contained in Section 92 of the Industrial Arbitration Act, 1912-1952, doth hereby order and declare that the "Gate and Fence and Ornamental Wrought Iron Making Award" No. 53 of 1955, as amended, be and the same is hereby further amended in the terms of the attached Schedule.

1. Clause 6—Hours: Add to subclause (c) of this clause the following proviso:—

Provided that other starting and finishing times may be fixed in particular cases by agreement between the employer and the Union concerned.

2. Clause 7—Overtime: Delete this clause and insert in lieu thereof the following:—

7.—Overtime.

- (a) For all work done beyond the hours of duty on any week day other than a holiday, payment shall be at the rate of time and a half, for the first four (4) hours and double time thereafter.
- (b) Notwithstanding anything contained in this Award—
 - (i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirements.
 - (ii) No organisation, party to this Award or worker or workers covered by this Award shall in any way, whether directly or indirectly be a party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.
- (c) Work done on Sundays or the holidays prescribed in Clause 13 (a) shall be paid for at double time rates, except in connection with repairs to the employer's machinery which has broken down and has caused a stoppage of operations, when the rate of time and a half shall apply to the work done on such days.
- (d) When a worker is recalled to work after leaving work, he shall be paid at least three hours at overtime rates.
- (e) When a worker is required to hold himself in readiness for a call to work after ordinary hours, he shall be paid at ordinary rates for the time he so holds himself in readiness.
- (f) A worker required to work overtime for more than two (2) hours, without being notified on the previous day or earlier that

he will be so required to work, shall be supplied with a meal by the employer or paid five shillings (5s.) for a meal.

If the amount of overtime required to be worked necessitates a second or subsequent meal, the employer shall, unless he has notified the workers concerned on the previous day or earlier that such second or subsequent meal will also be required, provide such meals or pay an amount of three shillings and fourpence (3s. 4d.) for each such second or subsequent meal.

No such payments need be made to workers living in the same locality as their workshops who can reasonably return home for such meals.

If a worker in consequence of receiving such notice has provided himself with a meal or meals and is not required to work overtime or is required to work less overtime than notified, he shall be paid the amounts above prescribed in respect of the meals not then required.

- (g) When a worker is required for duty during any meal time whereby his meal time is postponed for more than one hour, he shall be paid at overtime rates until he gets his meal.
 - (h) (i) Rest period after overtime. When overtime work is necessary it shall, wherever reasonably practicable be so arranged that workers have at least eight (8) consecutive hours off duty between the work of successive days.
 - (ii) A worker (other than a casual worker) who works so much overtime between the termination of his ordinary work on any one day and the commencement of his ordinary work on the next day that he has not at least eight (8) consecutive hours off duty between those times shall, subject to this subclause, be released after completion of such overtime until he has had eight (8) consecutive hours off duty without loss of pay for ordinary working time occurring during such absence.
 - (iii) If, on the instructions of his employer, such a worker resumes or continues work without having such eight (8) consecutive hours off duty, he shall be paid at double rates until he is released from duty for such period and he shall then be entitled to be absent until he has had eight (8) consecutive hours off duty without loss of pay for ordinary working time occurring during such absence.
 - (i) Overtime on Shift Work shall be based on the rate payable for Shift Work.
3. Insert a New Clause as follows:—
- 7A.—Shift Work.
- (a) An employer may, if he so desires, work his establishment on shifts, but before doing so shall give notice of his intention to the Union or Unions concerned, and of the intended starting and finishing times of ordinary working hours of the respective shifts.
 - (b) Work other than day shift shall not be recognised as afternoon or night shift unless in either case five (5) consecutive afternoons or nights are worked, but shall be deemed to be overtime. On completion of the fifth (5th) consecutive afternoon's or night's work the worker shall be deemed to have been employed on afternoon or night shift, as the case may be, during the preceding four (4) afternoons or nights and thereafter during any subsequent consecutive afternoons or nights he is so employed.
 - (c) The loading on the ordinary rates of pay for shift work shall be five per cent. (5%) for afternoon shift and 10 per cent. (10%) for night shift.

- (d) The sequence of shift work shall not be deemed to be broken under the preceding paragraph (b) by reason of the fact that the works are closed on a Saturday or Sunday or on any public holiday.
- (e) Where a shift commences on or after 11 p.m., then the whole shift shall be paid for at the rate which applies to the major portion of the shift.

4. Clause 10—Contract of Service: Delete Sub-clause (a) of this clause and insert in lieu thereof the following:—

- (a) The contract of service shall be by the week and shall be terminable by one (1) week's notice on either side given on any day, or (if the employer terminate it) by payment of one (1) week's pay, except—

(i) in the case of a casual worker when one (1) hour's notice shall suffice, and

(ii) for the first month of employment, when the hiring shall be from day to day and during this period a day's notice or a day's pay shall be sufficient.

5. Clause 15—Special Rates and Provisions.—Add to this clause the following new subclauses:—

- (d) Dirt Money.—Threepence (3d.) per hour extra shall be paid to workers engaged on work of an unusually dirty nature, where clothes are necessarily unduly soiled or injured or boots are unduly injured by the nature of the work done.

(e) Protective Equipment:

(i) The employer shall have available, a sufficient supply of protective equipment (as for example) hand screens, goggles, glasses, gloves, aprons, leggings and gum boots for use by his workers when engaged on work for which some protective equipment is reasonably necessary. It shall be a defence to an employer charged with a breach of this subclause if he proves that he was unable to obtain either the item of equipment the subject of the charge or a suitable substitute.

(ii) Every worker shall sign an acknowledgement on receipt of any article of protective equipment and shall return same to the employer when he has finished using it or on leaving his employment.

(iii) No worker shall lend another worker any such article of protective equipment issued to such first mentioned worker, and if the same are lent, both the lender and the borrower shall be deemed guilty of wilful misconduct.

(iv) Before goggles, glasses, or gloves or any such substitutes which have been used by a worker are re-issued by the employer to another worker, they shall be effectively sterilised.

(v) During the time any article of protective equipment is on issue to the worker, he shall be responsible for any loss or damage thereto, fair wear and tear attributable to ordinary use excepted.

6. Insert a New Clause as follows:—

24.—Piecework.

(a) Subject to the minimum wages rates and other conditions herein prescribed, an employer may remunerate any of his workers under any system of payment by results.

(b) The Union may during the currency of this Award apply to the Court for the correction or regulation of any piecework rates, time bonus rate, task rate, or any other system of payment by results.

7. These alterations will take effect as from the beginning of the first pay period commencing after the date hereof.
