TOTALISATOR AGENCY BOARD BETTING ACT, 1960.

HIS Excellency the Governor in Executive Council has been pleased to approve of the regulations set forth in the schedule hereunder, made by the Totalisator Agency Board pursuant to the provisions of section 57 of the Totalisator Agency Board Betting Act, 1960.

Schedule. Regulations.

- Principal regulations. 1. In these regulations the Totalisator Agency Board Betting Regulations, 1961, published in the *Government Gazette* on the 8th February, 1961, are referred to as the principal regulations.
- Reg. 34 amended. 2. Regulation 34 of the principal regulations is amended by adding after paragraph (b) of subregulation (6) the following paragraph:—
(c) Notwithstanding the provisions of paragraph (a) of this subregulation, the dividend declared for a bet of five shillings (5s.) shall not in any case be of a lesser amount than five shillings (5s.).
- Reg. 36 amended. 3. Regulation 36 of the principal regulations is amended by adding after subregulation (1) the following subregulation:—
(1a) Notwithstanding the provisions of subregulation (1) of this regulation, the totalisator pool dividend for a bet of five shillings (5s.) declared by the Board pursuant to that subregulation shall not in any case be of a lesser amount than five shillings (5s.).


By-law No. 66—Building Line.


