streets meeting the same, to the point of its intersection with the south-western boundary of Newcastle Street; thence along that boundary, in a south-easterly direction, across Fitzgerald Street, to the starting point; and

- (b) the area bounded by lines, starting in West Perth from the point where an imaginary line in prolongation in a southerly direction of the eastern boundary of Charles Street meets the southern boundary of Roe Street and extending thence, in a north-westerly direction, across Charles Street, along the south-western boundary of Railway Street, across all streets meeting the same, to the point of its intersection with an imaginary line in prolongation in a north-easterly direction of the south-eastern boundary of Thomas Street; thence along that imaginary line, in a south-westerly direction, across the railway line and along the said south-eastern boundary in a south-westerly direction, across all streets meeting the same, to the point of its intersection with the north-eastern boundary of King's Park Road; thence along that boundary in a south-easterly direction, across all streets meeting the same, to a point where an imaginary line being a prolongation of that boundary in a south-easterly direction meets the point of intersection of the south-eastern boundary of Malcolm Street with the north-eastern boundary of Bellevue Terrace; thence along that north-eastern boundary in a south-easterly direction, across Mount Street and along the north-eastern boundary of Cliff Street, to a point where an imaginary line in prolongation of that boundary in a south-easterly direction meets the north-western boundary of Mounts Bay Road; thence along that north-western boundary, in a north-eastern and easterly direction, and across Spring Street, to the point of its intersection with the north-eastern boundary of Spring Street; thence along that north-eastern boundary, in a north-westerly direction, to the point of its intersection with the south-eastern boundary of Mount Street; thence along that south-eastern boundary, in a north-easterly direction, to the point of its intersection with the south-western boundary of Saint George's Terrace; thence along that south-western boundary, in a north-westerly direction, to the point of its intersection with the south-eastern boundary of Malcolm Street; thence across Saint George's Terrace to the point of the intersection of its northern boundary with the north-eastern boundary of Saint George's Place and along that north-eastern boundary, in a north-westerly direction to the point of its intersection with the south-western boundary of Hay Street; thence across Hay Street to the point of intersection of its north-eastern boundary with the eastern boundary of George Street and along that eastern boundary, in a northerly direction, across Murray Street, to the point of the intersection of that boundary with the south-western boundary of Wellington Street; thence, across Wellington Street, to the point of the intersection of its north-eastern boundary with the eastern boundary of Marquis Street; thence along that eastern boundary, in a northerly direction, to the railway line; thence along an imaginary line in a northerly direction to the starting point.

INDUSTRIAL AGREEMENT.

No. 5 of 1961.

(Registered 22nd March, 1961.)

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1952, this 22nd day of March, 1961, between McPhee Industries (hereinafter called "the employer") of the one part and the Federated Miscellaneous Workers' Union of Australia, West Australian Branch, Union of Workers, a duly registered industrial union (hereinafter called "the union") of the other part, witnesseth that it is agreed by and between the employer and the union that the rates of pay and the conditions of employment for the classifications of workers mentioned herein being members of the union in the employ of the said employer shall be as set out hereunder:—

1.—Title.

This Agreement shall be known as the "Drum Reclaiming Agreement."

2.—Arrangement.

3.—Scope.

This Agreement shall apply to all workers who are employed by McPhee Industries in the Reclamation of Drums. Provided that it shall not apply to workers who are at present provided for in any award of the Court of Arbitration of Western Australia or in any Industrial Agreement registered in accordance with the Industrial Arbitration Act, 1912-1952.

4.—Term.

The term of this Agreement shall be for a period of one (1) year from the beginning of the first pay period commencing after the date hereof.

5.—Hours.

(a) Forty (40) hours shall constitute a week's work, to be worked in five (5) days, Monday to Friday inclusive.

(b) Except in the case of shift workers, the ordinary day's work shall be performed between the hours of 7 a.m. and 6 p.m.

(c) No working day shall exceed eight (8) hours, which shall be worked in a continuous shift.

6.—Overtime.

(a) All time worked before the usual starting time or after the usual finishing time, Monday to Friday inclusive, and all time worked on Saturday shall be paid at the rate of time and one half for the first four (4) hours and double time thereafter.

(b) All time worked on a Sunday or the holidays prescribed in clause (7) hereof shall be paid for at the rate of double time.

(c) Notwithstanding anything contained in this Agreement:—

(1) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement;

(2) no organisation party to this Agreement, or worker, or workers covered by this Agreement shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation, or restriction upon the working of overtime in accordance with the requirements of this subclause.

(d) In the calculation of overtime rates, each day's work shall stand alone.

(e) Overtime on shift work shall be based on the rate payable for shift work.

(f) These overtime rates shall not apply to excess time due to private arrangements between the workers themselves or for the purpose of effecting the customary rotation of shifts, or which is owing to a relieving man not coming on at the appointed time. The time for which any worker may be paid at ordinary rates instead of overtime due to a relieving man not coming on at the proper time, shall not exceed two (2) hours, after the expiration of which overtime rates shall apply for the whole shift.

(g) Where a worker is required to work overtime on a Saturday or Sunday, or a holiday, the minimum payment shall be as for, four (4) hours at overtime rates.

7.—Holidays.

(a) The following days, or the days observed in lieu, shall, subject to clause 7 (b) hereof, be allowed as holidays without deduction of pay, namely: New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Christmas Day, and Boxing Day.

(b) On any public holiday not prescribed as a holiday under this Agreement the employer's establishment or place of business may be closed in which case a worker need not present himself for duty and payment may be deducted, but if work be done, ordinary rates of pay shall apply.

(c) Except as hereinafter provided, a period of two (2) consecutive weeks leave with payment of ordinary wages as prescribed shall be allowed annually to worker by his employer after a period of twelve (12) months' continuous service with such employer.

(d) If any Agreement holiday fall within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(e) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one sixth (1/6th) of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(f) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Agreement shall not count for the purpose of determining his right to annual leave.

(g) In the event of a worker being employed by an employer for portion of only a year, he shall only be entitled subject to subclause (e) of this clause to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(h) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(i) The provisions of this clause shall not apply to casual workers.

8.—Absence through Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one twelfth (1/12th) of a week for each completed month of service: Provided that payment for absence through such ill-health shall be limited to one week in each calendar year. Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment or for any accident wherever sustained arising out of his own wilful default, or for sickness arising out of his own wilful default.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(d) Sick leave shall accumulate from year to year so that any balance for the period specified in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker, and, subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year, without diminution of the sick leave prescribed in respect of that year. Provided that the sick leave which accumulated pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

(e) Notwithstanding the provision of subclause (c) hereof, a worker who has already been allowed paid sick leave on one occasion shall not be entitled to payment for any further absence in the same year unless during the ordinary working hours that the worker is absent the employer requests in writing the employee to produce on his return to work a medical certificate stating that he was unable to attend for duty on account of personal ill-health.

9.—Time and Wages Record.

The employer shall keep or cause to be kept a record wherein shall be entered:—

- (a) the name of each worker;
- (b) the nature of his employment;
- (c) the total hours worked each day;
- (d) the wages and overtime (if any) received therefor;
- (e) the age of each junior worker.

The employer shall be responsible for the proper posting of the record each week, which shall be signed weekly only if correct, by the worker. Such record shall be open for inspection at the factory office by a duly accredited representative of the Union during working hours.

10.—Contract of Service.

(a) All employees shall be engaged either as weekly or casual employees; provided that an employer may engage a new employee as a casual and may alter the engagement to a weekly one at any time up to the pay day immediately following the day of engagement. If an employer so alters the engagement he shall only be liable to pay the employee concerned the proportion of the weekly rate calculated on the basis of the time worked.

(b) A week's notice shall be given on either side or in lieu of notice, by the payment or forfeiture, as the case may be, of a week's wages to terminate the employment of a weekly hand.

(c) Provided this shall not affect the right of an employer to dismiss an employee without notice for misconduct.

(d) Provided further that during the first week of the employment, an employer may dismiss a worker or a worker may leave the employment by either giving the other not less than one (1) hour's notice.

11.—Meal Money.

A worker required to work overtime for more than two (2) hours, without being notified on the previous day or earlier, that he will be so required to work, shall be supplied with a meal by the employer or paid five shillings (5s.) for a meal.

If the amount of overtime required to be worked necessitates a second or subsequent meal, the employer shall, unless he has notified the workers concerned on the previous day or earlier, that such a second or subsequent meal will also be required, provide such meals or pay an amount of three shillings and fourpence (3s. 4d.) for each second or subsequent meal.

No such payments need be made to workers living in the same locality as their workshops who can reasonably return home for such meals. If a worker in consequence of receiving such notice has provided himself with a meal or meals and is not required to work overtime, or is required to work less overtime than notified, he shall be paid the amount above prescribed in respect of the meals not then required.

12.—Right of Entry.

(a) Accredited representatives of the Union shall be permitted to interview the workers on the business premises of the employer during non-working times or meal breaks.

(b) In the case of a dispute between the Union and an employer which is likely to lead to a cessation of work or to an application to the Court and which involves the inspection of workers or of machines in the process of production, such Union representatives shall have the right of entry into the factory at any time during which the workers or machines concerned are working, but this permission shall not be exercised without the consent of the employer more than once in any one week.

(c) Provided that the duly accredited representative shall notify the employer beforehand of his intention to exercise his rights under this clause.

13.—Board of Reference.

(a) The Court may appoint for the purpose of this Agreement a board or boards of reference. Each board shall consist of a chairman and two (2) other representatives, one to be nominated by each of the

parties. There are assigned to each such board in the event of no agreement being arrived at between the parties of the Agreement, the functions of:—

- (1) Adjusting any matters of difference which may arise between the parties from time to time except such as involve interpretations of the provisions of the Agreement or any of them.
- (2) Deciding any other matters that the Court may refer to such board from time to time.

(b) An appeal shall lie from any decision of such board in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1912-1952 which for this purpose are embodied in the Agreement.

14.—Under Rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage, may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.

(b) In the event of no agreement being arrived at the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the board and pending the board's decision, the worker shall be entitled to work for and be paid the proposed lesser rate.

15.—Junior Workers.

(a) Junior workers, upon being engaged shall furnish the employer with a certificate containing the following particulars:—

- (1) Name in full.
- (2) Age, and date of birth.

No worker shall have any claim upon an employer for additional pay in the event of the age of the worker being wrongly stated either on the certificate or, if no such certificate is furnished, verbally to the employer. If any junior shall wilfully misstate his age either verbally to the employer or in the certificate, he alone shall be guilty of breach of this Agreement, and in the event of a worker having received a higher rate than that to which he was entitled, he shall make restitution to the employer.

16.—Proportion of Juniors.

The proportion of male juniors shall be:—

One junior to every four adult male workers in receipt of adult male rates of pay.

17.—Limitation of Juniors.

Junior workers shall not be employed in any of the following classifications:—

- (1) Chiming and reshaping of drums.
- (2) Painting of drums.
- (3) Lacquering of drums.
- (4) Rumbling plant operators.

18.—Mixed Functions.

A worker engaged for more than half ($\frac{1}{2}$) of one (1) day or shift on duties carrying a higher rate than his ordinary classifications shall be paid the higher rate for such day or shift. If employed for less than half ($\frac{1}{2}$) of one (1) day or shift he shall be paid the higher rate for the time so worked.

19.—Shiftwork.

(a) An employer may, if he so desires, work his establishment on shifts, but before doing so, shall give notice of his intention to the Union and of the intended starting and finishing times of ordinary working hours of the respective shifts.

(b) (i) Where any particular process is carried out on shifts other than day shift, and less than five (5) consecutive afternoon or five (5) consecutive night shifts are worked on that process, then the workers employed on such afternoon or night shifts shall be paid at overtime rates.

(ii) The sequence of work shall not be deemed to be broken under the preceding paragraph by reason of the fact that work on the process is not carried out on a Saturday or Sunday or on any public holiday.

(c) The loading on the ordinary rates of pay for shift work shall be five per cent (5%) for afternoon shift and ten per cent. (10%) for night shift.

(d) Where a shift commences at or after 11 p.m., then the whole shift shall be paid for at the rate which applies to the major portion of the shift.

(e) Where an ordinary shift or a shift worker finishes by 8 a.m. on Saturday such hours on the Saturday shall be regarded as ordinary hours of employment and shall not be subject to penalty rates.

20.—Breakdowns.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed, because of any strike by the Union or Unions affiliated with it or by any other association of unions or through the breakdown of the employer's machinery or any stoppage of work by any cause which the employer cannot reasonably prevent.

21.—Casual Workers.

Any worker dismissed through no fault of his own before the expiration of one (1) week of his employment shall be considered casual and shall receive ten per cent. (10%) above the rate specified for the work performed.

22.—Protective Clothing.

(a) When a worker is required to wear goggles, masks, aprons or gloves for the protection of either his person or his clothing, the employer shall provide same free for use by the worker. Such protective clothing shall remain the property of the employer and shall be returned when required, in good order and condition, fair wear and tear excepted.

(b) Should any dispute arise under subclause (a) of this clause, the matter shall be determined by a board of reference.

23.—Posting of Agreement and Union Notices.

Every employer shall allow union notices, except those which on reasonable grounds he considers objectionable, and a copy of this Agreement to be posted up by the Union in a place accessible to the workers and approved by the employer.

24.—Rest Periods.

A rest period of ten (10) minutes between 10 a.m. and 10.10 a.m. and between 3 p.m. and 3.10 p.m. each day shall be given to all workers without deduction of pay.

25.—Preference.

Preference of Employment.

(a) In this clause the term "Unionist" means a worker who is a financial member of the industrial union of workers party to this Agreement.

(b) In engaging or dismissing labour preference of employment shall be given to unionists, provided that such unionists are adequately experienced in the class of work to be performed and are otherwise competent to perform the work: Provided further that it shall be a defence on the part of an employer charged with engaging a worker other than "Unionist" when a "Unionist" was available for such engagement, that the employer having made enquiries from the appropriate union did not know that any "Unionist" competent to perform the class of work involved was available.

(c) Any worker whose application for membership of the union had been refused shall have the right of appeal to the Industrial Registrar whose decision on such matter shall be final. Such worker who has exercised his right of appeal shall pending the decision of the Industrial Registrar have the same rights under this clause as a "Unionist."

(d) Subject to subclause (e) hereof workers who are not "Unionists" shall within seven days of being supplied with the necessary application form for membership and a copy of this clause by an accredited representative of the applicant union, apply in the prescribed manner for membership and if accepted as a member maintain financial membership whilst employed by the employer.

(e) Exemptions:—

(1) Any worker may apply in writing to the Industrial Registrar, Court of Arbitration, Perth (whose decision shall be final), for exemption from this clause.

(2) An applicant for exemption shall detail in the application to the Industrial Registrar his reasons for desiring exemption; and such application shall only be valid and considered by the Industrial Registrar if it is forwarded by registered post within seven days of the applicant's receipt of the application for membership as prescribed in subclause (d).

(3) The Industrial Registrar in the exercise of his discretion may grant exemption with such conditions as he deems desirable:—

(a) If the applicant is a financial member of any other registered industrial union;

(b) if the employee objects on the grounds of conscientious religious belief to becoming a member of any industrial union; and

(c) for any other reason which the Industrial Registrar deems sufficient.

(4) A worker refused exemption by the Industrial Registrar shall within seven days of the decision make application for membership of the applicant union and if accepted as a member maintain financial membership whilst employed by the employer.

(f) No employer shall, while to his knowledge adequately experienced unionists competent to perform the class of work required are available, retain in his employment any worker for a period of more than seven days after being advised by the union concerned that such worker has not complied with either subclause (d) or paragraph 4 of subclause (e) of this clause or for a period of more than seven days after a conviction for a breach of this clause in reference to the employment of such worker.

26.—Long Service Leave.

A worker shall be entitled to leave with pay in respect of long service in accordance with the Long Service Leave Order No. 55 of 1958.
