Totalisator Agency Board Betting Act, 1960. PROCLAMATION

WESTERN AUSTRALIA, By His Excellency The Honourable Sir John TO WIT, JOHN PATRICK DWYER, Lieutenant-Governor and Administrator. IL.S.3 By His Excellency The Honourable Sir John Patrick Dwyer, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor and Administrator in and over the State of Western Australia and its dependencies in the Commonwealth

WHEREAS it is enacted by subsection (2) of section 4 of the Totalisator Agency Board Betting Act. 1960, that the Governor may on the recommendation of the Minister and the Board, from time to time, and at any time, by Proclamation declare any portion or portions of the State to be a totalisator agency region for the purposes of that Act; and whereas the Minister and the Board have recommended that the land described in the Schedules hereunder be declared totalisator agency regions for those purposes: Now, therefore I, the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council, do hereby declare that the land described in the schedules hereunder shall be totalisator agency regions for the purposes of the Totalisator Agency Board Bet-ting Act, 1960, in the case of the land described in the First Schedule, as from and including the 29th day of May, 1961; in the case of the land described in the Second Schedule, as from and including the 6th day of June, 1961; and, in the case of the land described in the Third Schedule, as from and including the 12th day of June, 1961.

First Schedule.

All that portion of land comprising the area bounded by lines starting, in the City of Fremantle, at the point of the intersection of an imaginary line in prolongation north-north-westerly of the north-eastern boundary of Pakenham Street and the south-eastern boundary of the railway reserve at Fremantle and extending along that south-eastern boundary in a south-westerly direction, across Cliff Street and thence southerly to the point of the intersection of that railway reserve boundary with the north-western boundary of Marine Terrace;

thence along that north-western boundary in a general north-easterly, easterly and south-easterly direction, across all streets meeting the same, to the point of its intersection with the north-western boundary of Collie Street; thence along that north-western boundary in a north-easterly direction, across Pakenham Street, to the point of the intersection of that boundary with the north-eastern boundary of Pakenham Street; thence along that north-eastern boundary in a north-north-westerly direction, across all streets meeting the westerly direction, across all streets meeting the same, to the point of its intersection with the southeastern boundary of Phillimore Street; and extending thence along an imaginary line, in prolongation of the north-eastern boundary of Pakenham Street, across Phillimore Street, to the starting point.

Second Schedule.

All that portion of land comprising the area bounded by lines starting at the intersection of the western boundary of Charles Street with the northern boundary of Haynes Street, North Perth, and extending in an easterly direction across Charles Street to the point of the intersection of the western boundary of Charles Street with the northern boundary of Mabel Street; thence along that northern boundary, across all streets meeting the same, to the point of its intersection with the western boundary of Fitzgerald Street; thence along that western boundary in a north-easterly direction to the point of its intersection with the south-western boundary of Walcott Street; thence along that south-western boundary in a south-easterly direction across Fitzgerald Street and all streets meeting that boundary to the point of its intersection with the north-western boundary of Lord Street; thence north-easterly across Walcott Street and along the north-western boundary of Guildford Road to the point of its intersection with the south-western boundary of Park Street; thence along an imaginary line at right angles to, and across, Guild-ford Road and across West Parade to the point where it meets the western boundary of the rail-way reserve of the railway between Perth and

Mount Lawley; thence along that western boundary in a general southerly and south-westerly direction, across all streets meeting the same, to the point of its intersection with an imaginary line being a line in prolongation, in a south-easterly direction, of the south-western boundary of Newcastle Street; thence in a north-westerly direction along that imaginary line, across Lord Street and along the south-western boundary of Newcastle Street, across all streets meeting the same, to the point of its intersection with the north-western boundary of Palmerston Street; thence along that north-western boundary in a north-easterly direction, across Newcastle Street and all other streets meeting that boundary to the point of its intersection with the north-eastern with the north-eastern boundary of Clarectic Street thence along ern boundary of Glendower Street; thence along that north-eastern boundary in a north-westerly direction to the point of its intersection with the south-eastern boundary of Throssell Street; thence along that south-eastern boundary in a northalong that south-eastern boundary in a north-easterly direction to the point of its intersection with the southern boundary of Vincent Street; thence along that southern boundary in a westerly direction, across Throssell Street and all streets meeting that boundary, to the point of its intersection with the eastern boundary of Charles Street; thence in a northerly direction along that eastern boundary across Vincent Street and all streets meeting that boundary to the point of its streets meeting that boundary to the point of its intersection with the north-eastern boundary of Angove Street; thence north-westerly across Charles Street to the point of intersection of its western boundary with the north-eastern boundary of Scarborough Beach Road and extending thence in a north-north-westerly direction along that western boundary, across Haynes Street, to the starting point.

Third Schedule.

All that portion of land comprising the area bounded by lines starting in the Municipal District of the City of Perth, at a point where an imaginary line in prolongation in a south-easterly direction of the north-eastern boundary of Cliff Street meets the north-western boundary of Mounts Bay Road; extending thence along that north-western boundary in a general southerly, south-westerly and westerly direction, across all streets meeting the same, to the point of its intersection with the eastern boundary of Winthrop Avenue; thence westerly across Winthrop Avenue to the point of intersection of the western boundary of that avenue with the northern boundary of Stirling Highway; thence along that northern boundary in a general western. along that northern boundary, in a general west-erly direction, across all streets meeting the same, to the point of its intersection with the eastern boundary of Smyth Road; thence along that eastern boundary in a northerly direction, across all streets meeting the same to the point of its inter-section with the southern boundary of Onslow Road; thence along that southern boundary in a westerly direction, across Smyth Road to the point of its intersection with the south-eastern boundary of Railway Road; extending thence in a westerly direction along an imaginary line in prolongation of the southern boundary of Onslow Road, across Railway Road and the railway to the point where that imaginary line meets the north-western boundary of the railway reserve of the railway between Perth and Fremantle; thence along that northwestern boundary in a general north-easterly, easterly and south-easterly direction, across all streets meeting the same, to the point of its intersection with an imaginary line in prolongation in a north-easterly direction of the south-eastern boundary of Thomas Street; thence along that imaginary line in a south-westerly direction, across the railway line and Arthur Street, and continuing thence in the same direction along the south-eastern boundary of Thomas Street, across all streets meeting the same, to the point of its intersection with the north-eastern boundary of King's Park Road; thence along that north-eastern boundary in a south-easterly direction, across all streets meeting the same, and extending along an imaginary line drawn from the termination of that boundary in

a south-easterly direction to the point of the intersection of the south-eastern boundary of Malcolm Street with the north-eastern boundary of Bellevue Terrace; thence along that north-eastern boundary in a south-easterly direction to and across Mount Street and along the north-eastern boundary of Cliff Street in the same direction; and thence, in the same direction, along the imaginary line first in this Schedule mentioned to the start-
