WHEREAS it is enacted by subsection (2) of section 4 of the Totalisator Agency Board Betting Act, 1960, that the Governor may on the recommendation of the Minister and the Board, from time to time, and at any time, by Proclamation declare any portion or portions of the State to be a totalisator agency region for the purposes of that Act; and whereas the Minister and the Board have recommended that the land described in the schedules hereunder be declared totalisator agency regions for those purposes: Now, therefore I, the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council, do hereby declare that the land described in the schedules hereunder shall be totalisator agency regions for the purposes of the Totalisator Agency

Board Betting Act, 1960, in the case of the land described in the First Schedule, as from and including the 10th day of July, 1961; and, in the case of the land described in the Second Schedule, as from and including the 17th day of July, 1961.

First Schedule.

All that portion of land comprising the area bounded by lines starting in Mount Lawley at the point where an imaginary line extending, from the point of intersection of the south-western boundary of Park Street with the north-western boundary of Guildford Road, across Guildford Road at right angles thereto and across West Parade meets the western boundary of the railway reserve of the railway between Perth and Mount Lawley and extending thence along that western boundary in a general northerly and north-easterly direction to the point where it meets an imaginary line in prolongation south-easterly of the south-western boundary of Fourth Avenue West; thence along that imaginary line in a north-westerly direction across Railway Parade and along the south-western boundary of Fourth Avenue West across all streets meeting same to the point of its intersection with the south-eastern boundary of Hamer Parade; thence at right angles across Fourth Avenue West and in a north-easterly direction along that south-eastern boundary to the point of its intersection with the south-western boundary of Central Avenue; thence along that boundary in a north-westerly direction across Hamer Street and all other streets meeting the same to the point of the intersection of an imaginary line of its prolongation with the north-western boundary of Learoyd Street; thence along that north-western boundary in a north-easterly direction across all streets meeting the same, to the point of its intersection with the south-western boundary of Harold Street; thence along that south-western boundary in a north-westerly direction to the point of its intersection with the north-western boundary of Perth Street; thence along that boundary in a north-easterly direction across Harold Street and all other streets meeting the same to the point of its intersection with the north-eastern boundary of Grand Promenade; thence along that north-eastern boundary in a north-westerly direction across all streets meeting the same to the point of its intersection with the north-western boundary of Surrey Street; thence along that north-western boundary in a north-easterly direction across all streets meeting the same to the point of its intersection with the south-western boundary of Lennard Street; thence continuing in a north-easterly direction along an imaginary line drawn from the intersection last-mentioned in prolongation of that north-western boundary across all streets meeting the same to the point where it meets the north-eastern boundary of Wellington Road; thence along that north-eastern boundary in a north-westerly direction to the point of its intersection with the eastern boundary of Camboon Street; thence along that eastern boundary in a northerly direction across all streets meeting the same to the point of its intersection with the southern boundary of Gordon Road; thence continuing in the same direction across Gordon Road to the point of its merger with the eastern boundary of Camboon Road and thence continuing along that eastern boundary across all streets meeting the same to the point of its intersection with the northern boundary of Victoria Road; thence along that northern boundary in a westerly direction across Camboon Road and Uganda Street to the point of its intersection with the eastern boundary of Redcliffe Road; thence along that eastern boundary in a northerly direction to the point of its intersection with the southern boundary of Sydney Street; thence along that southern boundary in a westerly direction across all streets meeting the same to the south-western boundary of Wanneroo Road; thence along that south-western boundary in a south-easterly direction across all streets meeting the same to the point of its merger with the south-western boundary of Charles Street; thence in the same direction along that south-western boundary across all streets meeting the same to the point of its intersection with the northern boundary of Haynes Street, North

Perth; thence in an easterly direction across Charles Street to the point of the intersection of the western boundary of Charles Street with the northern boundary of Mabel Street; thence along that northern boundary in the same direction across all streets meeting the same to the point of its intersection with the western boundary of Fitzgerald Street; thence along that western boundary in a north-easterly direction to the point of its intersection with the south-western boundary of Walcott Street; thence along that south-western boundary in a south-easterly direction across Fitzgerald Street and all streets meeting that boundary to the point of its intersection with the north-western boundary of Lord Street and thence north-easterly across Walcott Street and along the north-western boundary of Guildford Road to the point of its intersection with the south-western boundary of Park Street and thence along the imaginary line first in this schedule mentioned to the starting point.

Second Schedule.

All that portion of land comprising the area bounded by lines starting in Fremantle at the intersection of the northern boundary of Stephen Street with the western boundary of Carrington Street; thence along that western boundary in a southerly direction across Stephen Street and all other streets meeting the same to the point of its intersection with the southern boundary of South Street; thence along that southern boundary in an easterly direction across Carrington Street and all other streets meeting the same to the point of its intersection with the western boundary of North Lake Road; thence along that western boundary in a general northerly direction across South Street and all other streets meeting the same to the point of its intersection with the northern boundary of High Road; thence along that northern boundary in an easterly direction across North Lake Road and all other streets meeting the same to the point of its intersection with the eastern boundary of Pulo Road; thence along that eastern boundary in a north and north-easterly direction across Brentwood Avenue to the point where an imaginary line in prolongation of that eastern boundary meets the high water mark of the left bank of Bull Creek; thence along that high water mark and the high water mark of the left bank of the Canning River in a general northerly direction to the point of the intersection of the latter high water mark. With an imaginary line drawn in prolongation in an easterly direction of the southern boundary of Heim Street; thence along that imaginary line in a westerly direction and along the southern boundary of Helm Street across all streets meeting the same to the point of its intersection with the western boundary of Ogilvie Road; thence along that western boundary in a northerly direction across all streets meeting the same and along an imaginary line in prolongation of that western boundary to the point where it meets the high water mark of the left bank of the Canning River; thence along that high water mark in a general northerly and north-westerly direction to the point where it merges with the high water mark of the left bank of the Swan River; thence along the high water mark lastmentioned in a general westerly direction to the point where it meets an imaginary line in prolongation of the northern boundary of Bolton Street, East Fremantle; thence along that imaginary line in an easterly direction across Riverside Road and along the said northern boundary in the same direction to the point of its intersection with the western boundary of Preston Point Road; thence along that western boundary in a southerly direction across all streets meeting the same to the point of its intersection with the northern boundary of Canning Highway; thence across Canning Highway in a southerly direction to the point of the intersection of its southern boundary with the western boundary of Silas Street; thence along that western boundary in a southerly direction to the point of its intersection with the northern boundary of Marmion Street; thence along that northern boundary in an easterly direction across Silas Street and all other streets meeting the same to the point of its intersection with the western boundary of Carrington Street and thence along

that western boundary in a southerly direction across all streets meeting the same to the starting point.

Health Act, 1911-1960.

(Section 235A.)

ORDER IN COUNCIL.

Ex. Co. No. 1178.

WHEREAS it is enacted by section 235A of the Health Act, 1911-1960, that the Governor, having received a certificate given by the Commissioner of Public Health that any quantity of food is in the opinion of the Commissioner injurious or dangerous to health, and being satisfied that there are reasonable grounds for the Commissioner's opinion, may declare that the quantity of food is dangerous; and whereas the Commissioner has given to the Lieutenant-Governor and Administrator a certificate that the quantity of food described in the schedule hereto is, in his opinion, dangerous to health: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, acting by and with the advice and consent of the Executive Council, do hereby declare that the quantity of food described in the schedule hereto is dangerous.

Loan Poll Provisions.

ORDER IN COUNCIL.

L.G. 823/60.

WHEREAS it is enacted by section 689 of the Local Government Act, 1960 (hereinafter referred to as "the said Act") that where because of the relation in time of the day fixed for the coming into operation of the said Act to the time at which, or period during which, anything is required or directed to be done by or under the said Act, whether it is (*inter alia*) the preparation of an electoral roll, the holding of an election, or any other thing, the Governor is of opinion that for the purposes of giving effect to the transition from the operation of a repealed Act to the operation of the said Act, and to the intention and purposes of the said Act, an order is necessary or desirable for (*inter alia*) altering or adjusting the manner or form in which the thing is so required or

directed to be done, or otherwise, the Governor may make orders accordingly; and whereas it is also enacted by subsection (4) of section 611 of the said Act that for the purpose of taking a poll of ratepayers in connection with a loan proposed to be raised by the council of a municipality the returning officer shall use the roll of the district of that municipality as last settled prior to the taking of the poll; and whereas it may be necessary after the commencement of the said Act to take a poll so referred to before the roll of the district has been settled in accordance with the requirements of the said Act; and whereas the said Act repeals the Municipal Corporations Act, 1906-1959, and the Road Districts Act, 1919-1959, under which the municipalities of municipal districts and the road boards of road districts were respectively required in relation to loan polls to prepare special rolls in accordance with those respective Acts and by-laws made under those respective Acts; and whereas in order to enable a loan poll to be taken in a district the roll of which has not been settled as required by the said Act, the Governor is of opinion that an order is necessary or desirable authorising the preparation of a special roll in accordance with the terms of this Order in Council hereinafter contained for use by a returning officer for the purpose mentioned, and in certain districts conferring on owners of rateable land therein the voting rights set forth in section 82 of the said Act: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, acting by and with the advice and consent of the Executive Council, and in exercise of the powers conferred by section 689 of the said Act, do hereby order that, whereafter the commencement of the said Act it is necessary in any municipal district the roll of which has not been settled in accordance with the requirements of the said Act to take a poll of ratepayers in respect to a loan proposed to be raised by the council of that municipal district,—

- (a) the roll to be used by the returning officer where the municipality is a former municipal district shall be a special roll of owners of rateable land prepared in accordance with the provisions of the Municipal Corporations Act, 1906-1959, and the by-laws made by the council of the former municipal district under that Act, and where the municipality is a former road district shall be a special roll prepared in accordance with the provisions of the Road Districts Act, 1919-1959, and the uniform by-laws made under that Act but including therein all owners of rateable land within the district, whether resident owners or not; and
- (b) in voting at such poll, when taken in the district of a municipality which is a former road district, each owner of rateable land within that district may cast such number of votes as he would be entitled to cast pursuant to the scale set forth in section 82 of the said Act if the poll were an election mentioned in that section.

Suspension of Part XV.

ORDER IN COUNCIL.

L.G.D. 817/60.

WHEREAS it is enacted by subsection (2) of section 373 of the Local Government Act, 1960, that at the request of a council the Governor may by order from time to time suspend the operation of all or any of the provisions of Part XV of the Act in its district or any portion thereof to which they apply for such period as he thinks fit; and whereas by Order in Council issued on the 7th June, 1961, and published in the *Government Gazette* on the 16th June, 1961, His Excellency the Lieutenant-Governor and Administrator did suspend the operation of all the provisions of Part XV of the Local Government Act, 1960, in the respective districts of portions thereof specified in the second column of the schedule to the Order of the municipalities specified in the

first column of that schedule for the period, in respect of each district or portion of a district, from and including the 1st day of July, 1961, until such time as an Order is made under paragraph (b) of subsection (1) of that section applying all or any of the provisions of that Part to that district or portion of a district; and whereas it is deemed advisable and expedient to substitute for a particular portion of a municipal district specified in the said order the portion of that municipal district hereinafter mentioned: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council and in exercise of the power conferred by the Local Government Act, 1960, doth hereby substitute for the portion of the district of the municipality of Mukinbudin specified in the second column of the schedule to the Order in Council issued on the 7th June, 1961, and published in the *Government Gazette* on the 16th June, 1961, the following portion of that district:—

The whole of the district with the exception of the townsites of Mukinbudin, Lake Brown, Bonnie Rock and special areas defined by Order in Council published in the *Government Gazette* on the 25th May, 1934, and the 20th July, 1934.

ORDER IN COUNCIL.

HIS Excellency the Lieutenant-Governor and Administrator, acting by and with the advice and consent of the Executive Council, pursuant to the powers conferred by section 12 of the Local Government Act, 1960, doth hereby alter and adjust the district boundaries as between the Shires of Geraldton-Greenough, Irwin, Mingenew and Mullewa in the manner described in Schedules A, B, C, D, E and F, hereto.

Schedule A.

1.—Transfer of Territory from the Shire of Geraldton-Greenough to the Shire of Mullewa.

(a) All that portion of land bounded by lines starting from the intersection of the southern boundary of late Pastoral Lease 2080/93 with the western boundary of Victoria Location 9992, a point on the present Shire of Geraldton-Greenough District boundary, and extending northerly and easterly along boundaries of that location to the south-eastern corner of location 10065; thence northerly along the eastern boundary of that location to the south-eastern corner of location 9841; thence northerly and westerly along boundaries of that location to the eastern boundary of location 4060; thence northerly and westerly along boundaries of that location to the eastern boundary of location 6724; thence northerly about 13 chains along that boundary to a northern boundary of late Pastoral Lease 2080/93 aforesaid, a point on the present Shire of Geraldton-Greenough District boundary aforesaid; and thence easterly, southerly and westerly along that boundary to the starting point. Area of land involved 960 acres.

(b) All that portion of land bounded by lines starting from the intersection of the eastern boundary of late Pastoral Lease 509/93 with the southern boundary of Victoria Location 7249, a point on the present Shire of Geraldton-Greenough District boundary, and extending westerly, northerly and easterly along boundaries of that location to the westernmost south-western corner of location 10277; thence northerly along a western boundary of that location and onwards to the southern boundary of location 8019; thence westerly, northerly and easterly along boundaries of that location to the intersection with the eastern boundary of late Pastoral Lease 2395/93, a point on the present Shire of Geraldton-Greenough District boundary aforesaid; and thence generally southerly along that boundary to the starting point. Area of land involved 2,880 acres. (Public Plans 157C/40 and 126B/40.)

Schedule B.

2.—Transfer of Territory from the Shire of Mullewa to the Shire of Geraldton-Greenough.

(a) All that portion of land bounded by lines starting from the intersection of the southern boundary of late Pastoral Lease 2080/93 with the western boundary of Victoria Location 9992, a point on the present Shire of Mullewa District boundary, and extending southerly along the western boundary of that location and onwards to the north-eastern corner of location 7912; thence generally southerly along eastern boundaries of that location, location 8090 and location 7930 to the south-eastern corner of the lastmentioned location; thence westerly along the southern boundary of that location to its intersection with the eastern boundary of late Pastoral Lease 2395/93, a point on the present Shire of Mullewa District boundary aforesaid; and thence northerly and easterly along that boundary to the starting point. Area of land involved 173 acres.

(b) All that portion of land bounded by lines starting from the intersection of the eastern boundary of late Pastoral Lease 509/93 with the southern boundary of Victoria Location 7249, a point on the present Shire of Mullewa District boundary, and extending easterly along the southern boundary of that location to the northernmost north-western corner of location 10279; thence easterly, southerly, again easterly, again southerly and westerly along boundaries of that location to the north-eastern corner of location 10280; thence southerly along the eastern boundary of that location to the north-eastern corner of location 10019; thence southerly and westerly along boundaries of that location to the intersection with the eastern boundary of late Pastoral Lease 1864/93, a point on the present Shire of Mullewa District boundary aforesaid; and thence northerly, westerly and again northerly along that boundary to the starting point. Area of land involved 11,177 acres. (Public Plans 126B/40 and 126C/40.)

Schedule C.

- 3.—Transfer of Territory from the Shire of Geraldton-Greenough to the Shire of Irwin.

All that portion of land bounded by lines starting from the north-eastern corner of Victoria Location 2009, a point on the present Shire of Geraldton-Greenough District boundary and extending northerly along the eastern boundary of location 10286 and onwards to the southern boundary of location 10019; thence easterly along that boundary to its intersection with the eastern boundary of late Pastoral Lease 1864/93, a point on the present Shire of Geraldton-Greenough District boundary aforesaid; and thence southerly and westerly along that boundary to the starting point. Area of land involved 90 acres. (Public Plan 126C/40.)

Schedule D.

- 4.—Transfer of Territory from the Shire of Mullewa to the Shire of Irwin.

All that portion of land bounded by lines starting from the intersection of the eastern boundary of late Pastoral Lease 1864/93 with the southern boundary of Victoria Location 10019, a point on the present Shire of Mullewa District boundary, and extending easterly and northerly along boundaries of that location to the north-western corner of location 9991; thence easterly along northern boundaries of that location and location 9770 and onwards to the north-western corner of location 10161; thence north-easterly, and southerly along boundaries of that location to the north-western corner of location 10184; thence easterly and southerly along boundaries of that location to the intersection with the prolongation easterly of the northern boundary of location 2009, a point on the present Shire of Mullewa District boundary aforesaid; and thence westerly and northerly along that boundary to the starting point. Area of land involved 6,547 acres. (Public Plans 1267/40 and 127/80.)

Schedule E.

- 5.—Transfer of Territory from the Shire of Mullewa to the Shire of Mingenew.

All that portion of land bounded by lines starting from the intersection of the prolongation easterly of the northern boundary of Victoria Location 2009 with the eastern boundary of location 10184, a point on the present Shire of Mullewa District boundary, and extending northerly along the eastern boundaries of locations 10184 and 10115 to a point situate in prolongation westerly of the northern boundary of location 10186; thence easterly to and along that boundary and the northern boundary of location 10344 and onwards to the western boundary of location 2013, a point on the present Shire of Mullewa District boundary aforesaid; and thence southerly and westerly along that boundary to the starting point. Area of land involved 3,955 acres. (Public Plan 127/80.)

Schedule F.

- 6.—Transfer of Territory from the Shire of Irwin to the Shire of Mingenew.

All that portion of land bounded by lines starting from the north-western corner of Victoria Location 9574, a point on the present Shire of Irwin District boundary, and extending northerly to and along eastern boundaries of locations 10155, 10185 and 10184 to the intersection with the prolongation easterly of the northern boundary of location 2009, a point on the present Shire of Irwin District boundary aforesaid; and thence easterly, southerly and westerly along that boundary to the starting point. Area of land involved 5,786 acres. (Public Plan 127/80.)

Generally, owners of land in the scheme area will be encouraged to develop and subdivide their land according to the design shown on the Scheme Plan, which forms a basis for subdivision, but which is not intended to be rigidly adhered to, provided that any amendments suggested by owners would not impede the subdivision and development of the area as a whole.

1. Clause 6—Hours.—Delete subclause (a) of this Clause and insert in lieu thereof the following:

(a) The ordinary hours of work shall be as follows:—

- (i) In an ordinary week forty (40) hours;
- (ii) In a week in which one Award holiday occurs on an ordinary working day thirty three (33) hours and twenty (20) minutes where the worker works a five and a half (5½) day week or thirty two (32) hours where the worker works a five (5) day week.

(iii) In a week in which two Award holidays occur on ordinary working days twenty six (26) hours and forty (40) minutes where the worker works a five and a half (5½) day week or twenty four (24) hours where the worker works a five (5) day week.
