Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1960.

Metropolitan Main Drainage District No. 1.  
Brook Street, Bassendean, Extension.

ORDER IN COUNCIL.

M.W.S. 1335/57.

WHEREAS by section 7 (a) of the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1960, it is provided that the Governor may, by Order in Council, alter or extend the boundaries of the Metropolitan Water, Sewerage and Drainage Area, or any District, or Metropolitan Main Drainage District, and whereas it is desirable that the boundaries of the Metropolitan Main Drainage District No. 1 as at present defined should be altered: Now, therefore I, the Lieutenant-Governor and

Administrator, acting by and with the advice and consent of the Executive Council, do hereby extend the boundaries of the Metropolitan Main Drainage District No. 1 and declare that the said boundaries as shown on Plan M.W.S.S. & D.D., W.A. No. 7087, and as described in Order in Council of 2nd July, 1948, and subsequent amendments, shall be extended in the following manner by adding the area described in the schedule hereunder and including it in Metropolitan Main Drainage District No. 1.

Schedule.

All that portion of land bounded by lines commencing at the centre of the intersection of Kenny and Palmerston Streets, Bassendean, and proceeding in a westerly direction along the centre of Palmerston Street to a point on the prolongation of the centre-line of the right-of-way lying between Kenny and Kathleen Streets; thence in a northerly direction along the said prolongation and the centre of the said right-of-way to a point on the prolongation of the north-eastern boundary of lot 15, Guildford Road; thence along the said boundary to and across Guildford Road to the eastern boundary of the Railway Reserve; thence in a general north-easterly direction along the said boundary to a point on the prolongation of the said boundary in the centre of North Street; thence in a south-easterly direction along the centre of the said street to a point in the centre of the intersection of North Street and Guildford Road; thence in a southerly direction along the centre of North Street to a point on the prolongation of the northern boundary of lot 5, North Street; thence in an easterly direction along the said boundary to the western bank of the Swan River; thence in a south-easterly direction along the said bank to the southern boundary of lot 9, North Street; thence in a westerly direction along the said boundary to a point in the centre of North Street; thence in a southerly direction to the centre of the junction of North Street and Brook Street; thence in a south-easterly and southerly direction along the centre of North Street to a point on the prolongation of the southern boundary of lot 8, North Street; thence in a westerly direction along the said boundary and along the southern boundaries of lots 5, 4, 3, Brook Street, to the south-western corner of the said lot 3; thence in a northerly direction along the western boundary of the said lot 3 and the prolongation thereof to a point in the centre of Brook Street; thence in a westerly direction along the centre of Brook Street to a point in the centre of West Road; thence in a southerly direction along the centre of West Road to a point on the prolongation of the centre-line of Extension Road; thence in a westerly direction along the centre of Extension Road to a point on the prolongation of the eastern boundary of lot 94, Whitfield Road; thence in a southerly direction along the said boundary and along the eastern boundaries of lots 96 and 98, Whitfield Road, to the south-eastern corner of the said lot 98; thence in a westerly direction along the southern boundary of the said lot to a point on the prolongation thereof in the centre of Whitfield Street; thence in a southerly direction along the centre of Whitfield Street to a point on the prolongation of the southern boundary of lot 68, Whitfield Street; thence in a westerly direction along the said boundary to the north-eastern corner of lot 69, Hamilton Street; thence in a southerly and westerly direction along the eastern and southern boundaries respectively of the said lot to a point in the centre of Hamilton Street; thence in a southerly direction along the centre of Hamilton Street to a point on the prolongation of the southern boundary of lot 39, Hamilton Street; thence in a westerly direction along the said boundary to the north-eastern corner of lot 40, James Street; thence in a southerly direction along the eastern boundaries of lots 40, 42, 44, James Street to the south-eastern corner of the said lot 44, James Street; thence in a westerly direction along the southern boundary of the said lot to and across James Street and along the southern boundary of lot 19, James Street, to the eastern boundary of lot 18, Guildford Road; thence in a southerly direction along the said boundary and the prolongation thereof to a point in the centre of Guildford Road; thence in a westerly direction along the centre of

Guildford Road to the centre of the junction of Guildford Road and Wilson Street; thence in a southerly direction along the centre of Wilson Street to a point on the prolongation of the southern boundary of lot 8, Wilson Street; thence in a westerly direction along the said boundary and the southern boundary of lot 92, Parker Street, to a point in the centre of Parker Street; thence in a southerly direction along the centre of Parker Street to a point on the prolongation of the northern boundary of lot 104, Parker Street to the north-western corner of the said lot; thence in a southerly direction along the western boundaries of lots 104, 105, 106, 107, Parker Street, to the south-eastern corner of lot 177, Kenny Street; thence in a westerly direction along the southern boundary of the said lot to a point in the centre of Kenny Street; thence in a southerly direction along the centre of Kenny Street to the point of commencement, as shown in colour on Plan M.W.S.S. & D.D., W.A. No. 7087.
