WHEREAS it is enacted by sections 2 and 3 of the Ports and Harbours Act, 1917, that it shall be lawful for the Governor, by Proclamation, to declare that any place bounded as set out in the Proclamation shall be a port or harbour for the purpose of the Shipping and Pilotage Act, 1855-1954, and may in like manner define for the purposes of that Act the limits of any port or harbour therein mentioned; and whereas it is also enacted by section 4 of the Ports and Harbours Act, 1917, that the Governor may, by Proclamation, revoke or vary any Proclamation issued under that Act; and whereas, by a Proclamation issued under the lastmentioned Act on the 30th day of July, 1924, and published in the *Government Gazette* on the 8th day of August, 1924, the Lieutenant-Governor and Administrator did proclaim and declare the area set out in the schedule to that

Proclamation to be a Harbour for the purposes therein mentioned and that the Harbour mentioned in that schedule be bounded and limited as therein appeared; and whereas it is deemed desirable and expedient to vary that Proclamation in manner hereinafter set forth: Now, therefore I, the Lieutenant-Governor and Administrator, acting by and with the advice and consent of the Executive Council and in exercise of the powers conferred by section 4 of the Ports and Harbours Act, 1917, do hereby vary the Proclamation so issued on the 30th day of July, 1924, by substituting for the schedule to that Proclamation the following schedule:—

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposal dated the 16th day of October, 1957, for the revocation in part of the dedication of Crown lands as State Forest; and whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, with the advice and consent of the Executive Council, doth hereby revoke in part the dedication of Crown lands as State Forest No. 37 by excising those portions of such State Forest as are described in the schedule hereto.

Proposed Loan of £14,000.

## ORDER IN COUNCIL.

WHEREAS by the Water Boards Act, 1904-1954, a Water Board may, with the approval of the Governor, borrow money for the construction of works for the storage, distribution and supply of water: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, with the advice and consent of the Executive Council, hereby approves, under the provisions of section 113 of the Water Boards Act, 1904-1954, of the Bunbury Water Board borrowing the sum of fourteen thousand pounds (£14,000) from the Commonwealth Savings Bank and repayable with interest by thirty (30) equal half-yearly instalments over a period of fifteen (15) years with interest at the rate of five pounds seventeen shillings and sixpence (£5 17s. 6d.) per annum for the purpose of financing the works referred to on Bunbury Water Board Plan No. 133 and approved by Order in Council dated the 2nd August, 1961, and published in the *Government Gazette* on the 11th August, 1961, subject to the said works being commenced not later than the 1st day of February, 1962.

conferred by the Local Government Act, 1960, do hereby declare that the uniform general by-laws made pursuant to the provisions of paragraph (a) of subsection (1) of section 433A of the Local Government Act, 1960, on the 21st day of June, 1961 and published in the *Government Gazette* on the 23rd day of June, 1961, shall apply to the districts and portions of a district specified in the First Schedule hereto to the extent specified in the Second Schedule hereto.
