WHEREAS it is enacted by section 115 of the Factories and Shops Act, 1920-1959, that the expression "Public Holiday" shall mean certain days therein specified, and any other day declared by Proclamation to be a public holiday for the purposes of the said Act: Now, therefore I, the said Governor, acting by and with the advice and consent of the Executive Council, do hereby proclaim and declare that Monday, the 13th day of November, 1961, shall be a public holiday throughout the State for the purpose of section 115 of the Factories and Shops Act, 1920-1959, and all shops, including hairdressers' establishments (with the exception of shops mentioned in the Fourth

Schedule and those in respect of which the Sovereign's Birthday holiday is not prescribed as a holiday under the relevant Award or Industrial Agreement registered under the provisions of the Industrial Arbitration Act, 1912-1952) and warehouses, shall be closed.

Local Government Act, 1960.

Union of the Municipalities of the City of Fremantle and the Town of North Fremantle.

ORDER IN COUNCIL.

L.G. 793/61.

WHEREAS the municipality of the City of Fremantle and the municipality of the Town of North Fremantle are municipalities constituted under the Local Government Act, 1960; and whereas the districts of the City of Fremantle and the Town of North Fremantle are adjoining; and whereas it is provided in the said Act by paragraph (d) of subsection (2) of section 12 that the Governor by order made after effective presentation to him of a petition bearing the common seal of each municipality which will be directly affected by the order, may unite two or more municipalities whose districts are adjoining and their districts, so as to form one municipality and one district; and whereas the municipalities of the City of Fremantle and the Town of North Fremantle respectively have submitted a petition to His Excellency the Governor in accordance with the provisions of the said Act, praying that the municipality of the City of Fremantle and the municipality of the Town of North Fremantle and their districts should be united so as to form one municipality and one district to be known as the City of Fremantle; and whereas it is considered expedient that the prayer of the petition should be granted: Now, therefore, His Excellency the Governor, pursuant to the provisions of the said Act, acting by and with the advice and consent of the Executive Council, doth hereby unite the municipality of the City of Fremantle and the municipality of the Town of North Fremantle and their districts to form one municipality and one district to be known as the City of Fremantle and doth hereby direct that such Order shall take effect as and from the 1st day of November, 1961.

ORDER IN COUNCIL.

L.G. 2391/52.

WHEREAS it is enacted, *inter alia*, by subsection (1) of section 433A of the Local Government Act, 1960, that the Governor may make and publish in the *Gazette* uniform general by-laws for all or any of the purposes for which by-laws may be made by a Council under Part XV of the Act and may by order declare that all or any such uniform general by-laws as are specified in the order shall apply to the whole or any portion of a district so specified; and whereas by an Order in Council so made on the 21st day of June, 1961, and published in the *Government Gazette* on the 23rd June, 1961, the Lieutenant-Governor and Administrator did there by make the uniform general by-laws set out in the First Schedule thereto and declare that those by-laws should have the force of law on and after the 1st day of July, 1961, in each municipal district specified in the Second Schedule to the Order in Council; and whereas it is desired that the said by-laws should apply to the municipal district of the Shire of Swan-Guildford: Now, therefore, His Excellency the Governor,

acting with the advice and consent of the Executive Council, and in exercise of the power conferred by the Local Government Act, 1960, doth hereby declare that the uniform general by-laws made pursuant to the provisions of paragraph (a) of subsection (1) of section 433A of the Local Government Act, 1960, on the 21st day of June, 1961, and published in the *Government Gazette* on the 23rd day of June, 1961, shall apply to the respective portions of the district of the Shire of Swan-Guildford specified in the schedule hereto to the extent therein specified.

IT is hereby notified for public information that the Hon. Minister for Mines has approved of the undermentioned General Rules relating to scholarships, to come into operation as from the 20th October, 1961, for the year 1962 and subsequent years.

Entrance Scholarship.

One Entrance Scholarship will be offered annually to candidates who are under 17 years of age on 31st December of the year in which application is made, and who are able to comply with the scholarship rules.

The scholarship is tenable for one year and is valued at £80, with remission of school fees, except laboratory deposits.

Applicants for this scholarship should be candidates for the University Junior Certificate examinations, School of Mines of W.A. Preparatory or Qualifying examinations, or be enrolled in a fourth year high school course.

A scholar will be required to enrol as a full-time student at the School of Mines in Kalgoorlie in the Qualifying subjects (Leaving Certificate standard) as a prerequisite to commencing a diploma course.

Senior Scholarships.

Two Senior Scholarships will be offered annually to candidates who are under 19 years of age on 31st December of the year in which application is made, and who are able to comply with the scholarship rules.

Each scholarship is tenable for two years and is valued at £150 per annum, with the remission of school fees, except laboratory deposits.

Applicants for these scholarships should be candidates for the University Leaving examinations, or School of Mines of W.A. Qualifying examinations.

A scholar will be required to enrol as a full-time student at the School of Mines of W.A. at Kalgoorlie in a diploma course.

General Rules.

1. Scholarships will be awarded by a Scholarship Committee consisting of the Director and not less than two other members who shall be members of the Advisory Committee or heads of Departments of the School.

2. Applications from candidates, together with proof of age must reach the Registrar, School of Mines of W.A., Kalgoorlie, on or before the second Monday in October of each year.

3. No scholarships shall be awarded to a candidate whom the Committee decides has not a good prospect of coping with the course in which he would be required to enrol.

4. No person shall be allowed to hold two of these scholarships concurrently.

5. Candidates must have been resident in Western Australia for the six months preceding the date at which applications close.

6. The Committee reserves the right of refusing any application.

7. The Committee reserves the right of cancelling any scholarship, at any time during the tenure of that scholarship, should the holder be reported for irregular attendance, idleness, or bad conduct.

8. As a condition of holding a School of Mines Scholarship, successful candidates must regularly attend the classes at the School of Mines, and pass the annual examinations in the subjects specified for each scholarship.

9. Scholarship holders must pass the subjects for which they are enrolled each year. The subjects for which they are enrolled shall not generally require more than 24 hours of class work per week.

10. Scholarships will only be granted to students who are willing to attend the School as normal full-time students. The normal hours of the School are from 10 a.m. to 1 p.m., and from 7 p.m. to 10 p.m., from Monday to Friday, but classes may be held at other times. Scholarship holders are expected to devote the whole of their time to the work of the School.

11. Scholarship students are required to make at least 90 per cent. attendance at all lectures and practical classes.

12. (i) Notwithstanding anything contained in these rules the scholarship may not be awarded to a student who is awarded any other scholarship which is approximately equivalent in value and which enables the student to study full-time.

(ii) An applicant shall furnish in his application details of any scholarship which he holds or for which he has applied at the date of the lodging of his application with the Registrar.

13. The interpretation of these rules, together with the decision of all matters not specifically provided for, shall rest with the Committee.
