WHEREAS by section 11 of the Native Welfare Act, 1905-1960, it is provided that the Governor is empowered by Proclamation to declare any Crown lands to be a Reserve for Natives; and whereas it is deemed desirable that a Reserve for Natives should be declared at Norseman: Now, therefore I, the said Governor, with the advice of Executive Council, do hereby declare all that portion of land containing approximately 55 acres, known as Dundas Location 200, to be a Reserve for Natives (Reserve No. 26233).

WHEREAS it is enacted by section 11 of the Native Welfare Act, 1905-1960, that the Governor may, by Proclamation, declare any Crown lands

to be Reserves for Natives and abolish any reserve so declared; and whereas by Proclamation issued under the Native Welfare Act, 1905-1960, and published in the *Government Gazette* on the 22nd February, 1952, the Governor declared an area at Norseman more particularly described as Reserve No. 22914 and defined in the schedule to such Proclamation to be a Reserve for Natives; and whereas it is now deemed desirable and expedient to abolish the said reserve: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council and in exercise of the powers in that behalf conferred by section 11 of the Native Welfare Act, 1905-1960, do hereby abolish the Reserve for Natives as declared and described and defined in the hereinbeforementioned Proclamation published in the *Government Gazette* on the 22nd February, 1952, as aforesaid.

Australian waters specified in the schedule hereto during the months of January, April, May, June, August, September, October, November and December in every year.

IN pursuance of the provisions of section 19 of the Fisheries Act, 1905-1961, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby declare as follows:—

- (a) That with respect to nets known as or called "set nets," nets of not more than 500 yards in length having meshes throughout of not less than two inches and not less than 45 meshes in depth shall, when used or intended to be used in those waters of Peel Inlet and Harvey Estuary which have a depth of not less than five feet, be lawful nets.
- (b) That with respect to nets known as or called "set nets," nets of not more than 500 yards in length having meshes

throughout of not less than two and a half inches shall, when used or intended to be used in those waters of Peel Inlet and Harvey Estuary, which have a depth of not more than five feet, be lawful nets.

- (c) That with respect to nets known as or called "hauling nets," when used or intended to be used for the catching of mullet and yellow-eye mullet, nets of not more than 800 yards in length having meshes throughout of not less than two inches shall when used or intended to be used in the waters of Peel's Inlet and Harvey Estuary, be lawful nets.
- (d) That with respect to nets known as or called "whiting set nets" for catching whiting, nets of not more than 300 yards in length having meshes throughout of one and three-quarter inches and of not more than 33 meshes in depth shall, when used or intended to be used in those waters of Peel Inlet and Harvey Estuary which have a depth of not less than six feet, be lawful nets.
- (e) That with respect to nets known as or called "whiting hauling nets" for catching whiting, nets of not more than 120 yards in length, having meshes throughout of one and three-quarter inches shall, when used or intended to be used in the waters of Peel's Inlet and Harvey Estuary, be lawful nets. It shall be lawful for nets known as or called "whiting hauling nets" to be used in conjunction with nets known as or called "mullet and yellow-eye mullet nets."
- (f) That with respect to nets known as or called "garfish nets" for the catching of garfish, nets of not more than 60 yards in length having meshes throughout of not less than one and one-eighth inches shall, when used or intended to be used in the waters of Peel's Inlet and Harvey Estuary, be lawful nets. It shall be lawful for nets known as or called "garfish nets" to be used in conjunction with nets known as or called "mullet and yellow-eye mullet hauling nets."

The Proclamation dated 22nd August, 1956, and published in *Government Gazette* (No. 73) of 31st August, 1956, is hereby revoked.

IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1961, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby declare that all those portions of Western Australian waters described in the schedule hereto shall be closed against the use of fishing nets for a period of five years from the date of publication hereof.

Schedule.

All those portions of Warnbro Sound, the Indian Ocean and Shoalwater Bay bounded by lines starting from a point on the high water mark of Warnbro Sound situate in prolongation southerly of the eastern side of June Road, and extending southerly along that prolongation to a line parallel

to and half a mile from the high water mark of Warnbro Sound aforesaid; thence generally westerly along that line to its intersection with a line parallel to and one mile from the high water mark of Penguin Island; thence generally southerly, generally westerly, generally northerly and generally easterly along that line to a point situate south from Cape Peron; thence north to that cape, and thence generally south-easterly along the high water mark of Shoalwater Bay and Warnbro Sound aforesaid to the starting point. (Public Plan 341D/40.)

The Proclamation dated 7th September, 1960, and published in *Government Gazette* (No. 78) of 16th September, 1960, is hereby revoked.

WHEREAS pursuant to the provisions of section 19 of the Child Welfare Act, 1947-1959, His Excellency the Lieutenant-Governor and Administrator, by an Order in Council published in the *Government Gazette* on the 20th December, 1957, did (*inter alia*) establish a special court to be called a Children's Court at Gascoyne Junction and did also determine the Gascoyne Magisterial District to be the area in and for which that special court should exercise jurisdiction; and whereas by the said section it is enacted (*inter alia*) that the Governor may, by Order in Council, revoke or annul any establishment of a Children's Court, and amend, vary or revoke any appointment or determination made under the said section: Now, therefore, His Excellency the Governor, in exercise of the powers conferred by the said section and with the advice and consent of the Executive Council, doth hereby revoke—

- (a) the establishment of the Children's Court at Gascoyne Junction effected by the Order in Council published in the *Government Gazette* on the 20th December, 1957; and
- (b) the determination of the Gascoyne Magisterial District as the area in and for which the Children's Court established at Gascoyne Junction shall exercise jurisdiction as effected by that Order in Council.

Local Government Act, 1960.
Shires of Coorow, Carnamah, Perenjori
and Dalwallinu.
Creation of New Shire of Coorow and
Adjustments to Other Shires.

ORDER IN COUNCIL.

L.G. 219/60 "A."

WHEREAS it was provided in section 8 of the Road Districts Act, 1919, that the Governor may constitute a road district in accordance with that section and may divide the district into Wards; and whereas the Road Districts Act was repealed by the Local Government Act, 1960; and whereas by sections 15 and 16 of the Interpretation Act, 1918, authority is given for the continuance under the repealing Act of any action commenced under the repealed Act; and whereas it is provided by section 12 of the Local Government Act, 1960, that the Governor may constitute a Shire, may divide the district into Wards, determine the number of offices of councillor assigned to the municipality; and whereas it is further provided by subsection (6) of the said section 12 that the Minister may refer to the Local Government Boundaries Commission appointed under that subsection any question concerning the constitution of a municipality; and whereas before the repeal of the Road Districts Act certain residents of those portions of the road district of Carnamah, known as the Coorow and South Wards respectively, petitioned the Minister requesting that a new road district should be constituted comprising a portion of the then existing Carnamah Road District and portions of the Perenjori and Dalwallinu Road Districts, and

petitioned also that the new district should be divided into five wards with five members, being one for each ward; and whereas on the coming into operation of the Local Government Act, 1960, the Minister referred to the consideration of the Local Government Boundaries Commission the petition submitted to him under the repealed Act by the people of the district already mentioned; and whereas the Local Government Boundaries Commission recommended to the Minister that a new Shire, to be known as the Shire of Coorow, should be constituted having five wards and five members: Now, therefore, His Excellency the Governor, acting by and with the consent of the Executive Council, pursuant to the provisions of the Local Government Act, 1960, doth hereby—

- (1) sever from the district of the municipality of the Shire of Carnamah, the land specified in Schedule A hereto;
- (2) sever from the district of the Shire of Perenjori, the land shown in Schedule B hereto;
- (3) sever from the district of the Shire of Dalwallinu, the land shown in Schedule C hereto;
- (4) sever from the district of the Shire of Carnamah and annex to the district of the shire of Dalwallinu, to form part of the Central Ward thereof, the land shown in Schedule D hereto;
- (5) constitute as a new municipality, to be known as the Shire of Coorow, the area shown in Schedule E hereto and divide that district into five wards comprising the areas and bearing the descriptions set forth in Schedule F hereto;
- (6) describe the boundaries of the Shire of Carnamah as amended by the severance aforesaid, as set forth in Schedule G hereto;
- (7) describe the boundaries of the Winchester Ward of the Shire of Carnamah, after the severance abovementioned, as set forth in Schedule H hereto;
- (8) alter the number of offices of Councillor assigned to the municipality of the Shire of Carnamah to five;
- (9) abolish the Coorow and South Wards of the district of the Shire of Carnamah;
- (10) determine that the number of offices of Councillor assigned to the municipality of the Shire of Coorow shall be five, comprising one Councillor for each ward;
- (11) direct that the members at present holding office as representatives of the Coorow and South Wards of the Shire of Carnamah shall go out of office on the 30th day of June, 1962;
- (12) direct that an election shall be held to return five Councillors for the Shire of Coorow on the 18th August, 1962;
- (13) direct that this order shall take effect as and from the 1st day of July, 1962.

Schedule A.

Transfer of Territory from the District of the Shire of Carnamah to the District of the Shire of Coorow.

All that portion of land bounded by lines starting from the shore of the Indian Ocean at the northernmost north-western corner of Leeman Townsite, a point on present boundary of the Shire of Carnamah, and extending easterly along the northern boundary of that townsite to its north-eastern corner; thence easterly to the north-western corner of Victoria Location 2699; thence generally north-easterly, easterly and generally south-south-westerly along boundaries of location 8346 to the north-western corner of location 10251; thence easterly along the northern boundaries of that location, locations 10250 and 10249 and southerly along the eastern boundary of the last-mentioned location to a point situate in prolongation westerly of the northern boundary of location 10253; thence easterly to and along that

boundary to the north-eastern corner of that location; thence east-north-easterly to the north-western corner of location 10043; thence easterly along the northern boundaries of that location, locations 10044 and 10045 and south-south-easterly along the eastern boundary of the lastmentioned location to a point situate in prolongation westerly of the southern boundary of location 10097; thence easterly and northerly to and along boundaries of that location to its north-eastern corner; thence northerly and easterly along boundaries of location 4999 (Reserve 24618) to the western boundary of location 8047; thence northerly and easterly along boundaries of that location and onwards to the eastern side of the Midland Railway; thence generally northerly along that side to a point situate in prolongation south-westerly of the south-eastern boundary of lot M.910 of location 2023; thence north-easterly to and along that boundary and onwards to the westernmost corner of lot M.1438; thence generally south-easterly along south-western boundaries of that lot to the westernmost north-western corner of lot M.1377; thence north-easterly and easterly along boundaries of that lot to the south-eastern corner of lot M.1636; thence generally northerly along eastern boundaries of that lot and lot M.1792 to the easternmost north-eastern corner of the lastmentioned lot; thence easterly to and along the northern boundaries of lots M.1669, M.1311, M.1312 and M.1528, and southerly along the eastern boundary of the lastmentioned lot to the south-western corner of lot M.1649; thence easterly, northerly and again easterly along boundaries of that lot and onwards to the southernmost south-western corner of location 9971; thence easterly, northerly, again easterly and again northerly along boundaries of that location to the southern boundary of location 9969; thence easterly along that boundary and onwards to the western boundary of the eastern severance of location 9972; thence northerly along that boundary to the north-western corner of that severance, a point on the present boundary of the Shire of Carnamah aforesaid; and thence generally south-easterly, generally westerly and generally northerly along that boundary to the starting point.

Transfer of Territory from the District of the Shire of Perenjori to District of the Shire of Coorow.

- (a) create a new Ward in the district of the municipality of the Shire of Armadale-Kelmscott as set forth in the schedule hereto and to be known as the Roleystone Ward;
- (b) describe the portion of the former Kelmscott Ward affected by the creation of the new Ward and to continue to be known as the Kelmscott Ward as set forth in the schedule hereto;
- (c) alter the number of offices of councillor assigned to the municipality from seven to eight and to allocate the additional councillor to the Roleystone Ward;

- (d) direct that members at present holding office as councillors for the Kelmscott Ward shall go out of office on the 26th May, 1962;
- (e) direct that an election shall be held on the 26th day of May, 1962, to return a councillor for the Roleystone Ward and two councillors for the Kelmscott Ward.

No. 5 of 1962.

(Registered 26th March, 1962.)

THIS Agreement made in pursuance of the Indus-
trial Arbitration Act, 1912-1952, this 14th day of
March, 1962, between the Australian Workers'
Union, Westralian Branch, Industrial Union of
Workers (hereinafter referred to as "the Union")
of the one part and Cheynes Beach Whaling Co.
Ltd. (hereinafter referred to as "the Company")of the other part, witnesseth that, for the con-
siderations hereinafter appearing, the parties hereto
mutually covenant and agree the one with the
other as follows:—

This Agreement shall be known as "The Cheynes
Beach Whale Chaser Crews Agreement, 1962."

3.—Definitions.

"Whaling season" shall mean the period from
the day the Company commence whaling opera-
tions, continuing until at least forty-eight (48)
hours after the last whale, to be nominated by
the Company, has been taken."Port day" shall mean any day on which a
vessel is in harbour for the purpose of maintenance
or repair, or is prevented from whaling by rough
weather or any other cause."Port rate" shall mean the rate payable on a
port day."Whaling day" shall mean any day on which a
vessel proceeds to sea on whaling operations."Whaling rate" shall mean the rate payable on
a whaling day.

4.—Area.

This Agreement shall operate over that area in
which the Company is carrying out whaling opera-
tions off the coast of Albany, Western Australia.

5.—Scope.

This Agreement shall apply to all crew members
below the rank of ship's officer who are employed
by the company on whaling operations.

6.—Term.

The term of this Agreement shall be from 15th
March, 1962, until the completion of the 1962
whaling season.

7.—Hours.

(1) Port Days.—(a) Eight (8) hours shall con-
stitute a day's work to be worked between the
hours of 8 a.m. to 5 p.m. on any day Monday
to Friday inclusive.(b) All work performed in excess of eight (8)
hours per day or outside the daily spread of hours
prescribed in subclause (a) hereof shall be paid
for at the rate of time and one-half for the first
four (4) hours and double time thereafter.(c) All work performed on a Sunday or on a
holiday prescribed in clause 10 hereof shall be
paid for at the rate of double time.(d) In the calculation of overtime rates, each
day shall stand alone, provided that when a worker
continues working beyond midnight on any day,
the hours worked after midnight shall be counted
as part of the previous day's work for the purpose
of calculating the rates to be paid.(e) For the purpose of this clause, forty (40)
hours shall comprise a week's work.(f) Crew members who are required to attend
a call-out outside the daily spread of hours pre-
scribed in subclause (a) hereof and are not put to
work shall be paid for each such call-out as
follows:—Saturdays, Sundays and holidays prescribed
in clause 10 hereof—two (2) hours at the
appropriate rate.(2) Whaling Time.—(a) The working week
whilst whaling operations are being carried out
shall consist of seven (7) days, Monday to Sunday

inclusive, and on such days crew members shall work such hours as are necessary for the successful execution of whaling operations, provided that on any day on which a vessel commences whaling operations and returns to port through weather conditions, or any other reasons, prior to the elapse of ten (10) hours from standby, crew members may be employed, at the discretion of the Company, until such ten (10) hours have elapsed.

(b) The Master of each vessel shall determine each day's whaling time and no overtime shall be payable, provided that on returning to port after the completion of a whaling day all work performed in excess of one (1) hour after berthing shall be paid for at port overtime rates.

(c) Crew members shall be granted one (1) day off in each two weekly period, payment for such day to be made at port rate.

(3) Station Bunkering.—(a) When a chaser is required to deliver fuel oil to the station or to standby a vessel receiving whale oil for overseas shipment, that day shall be counted as a whaling day and in addition crew members of such chaser shall be credited, in respect to both "head bonus" and "end of season bonus" with the number of whales caught by the whaling vessel during such bunkering period.

(b) Whilst on bunkering duties, all work performed, in excess of one (1) hour after the berthing of the whaling vessel as set out in clause 7 (2) (b) hereof, shall be paid for at port overtime rates.

8.—Wages.

(a) The rate of wage for seamen and firemen shall be:—

(i) Port rate—£17 10s. per week.

(ii) Whaling rate—£32 11s. per week.

(b) The rate of wage for a cook shall be £31 10s. per week.

Provided that when messing is discontinued in accordance with the provisions of clause 14 (a) hereof the cook's rate of wage shall be £17 10s. per week.

(c) The above rates are inclusive of the South-West Land Division basic wage of £14 17s. 3d.

9.—Bonus Rates.

(a) Head Bonus.—The Company shall pay to each seaman, fireman and cook a "head bonus" of thirteen shillings and sixpence (13s. 6d.) for each legal whale of either baleen or sperm variety credited to the catcher upon which he is employed.

For a whale to be credited to a catcher, it must be delivered to the station whale buoy by either catcher.

The "head bonus" referred to shall be paid weekly.

(b) End of Season Bonus.—The Company shall pay to each seaman, fireman and cook an "end of season bonus" of six shillings and sixpence (6s. 6d.) for each legal whale of either baleen or sperm variety credited to the catcher during his period of employment on such catcher, provided that—

(i) the Company takes in excess of three hundred (300) legal length whales, all types included. On the three-hundredth (300th) whale being taken, the additional bonus will accrue for all whales credited to the chaser upon which and for that period during which a crew member is employed and will continue to accrue for all additional whales taken until the end of the season.

(ii) The crew member is in the employ of the Company at the end of the season and has been in the employ of the Company for not less than twelve (12) calendar weeks prior to that date.

(iii) A crew member who terminates his employment prior to the end of the season for reasons not acceptable to the Company shall forfeit his "end of season bonus." Should any dispute arise regarding this clause, the Union shall have the right to refer the matter to a Board of Reference.

10.—Holidays.

(a) The following days or the days observed in lieu, shall, subject to subclause (b) hereof, be allowed as holidays without deduction of pay, namely, New Year's Day, Australia Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Sovereign's Birthday, Christmas Day and Boxing Day.

(b) A crew member required to work on any of the foregoing days shall be paid an additional day's pay at port rates.

11.—Holiday Pay.

(a) A crew member shall be entitled to holiday pay at the rate of one-sixth (1/6th) of a week's pay at port rate in respect of each month of continuous service.

(b) Any time in respect of which a crew member is absent from work, except time for which he is entitled to claim sick pay, or time spent on holidays, annual leave or long service leave, as prescribed, shall not count for the purpose of determining his right to annual leave.

(c) A crew member who is justifiably dismissed for misconduct shall not be entitled to the benefits of the provisions of this clause.

(d) If any prescribed holiday falls within a worker's period of annual leave, there shall be added to that period one day, being an ordinary working day, for each such holiday observed.

12.—Contract of Service.

(a) The contract of service shall be by the week and shall be terminable by one (1) week's notice given on either side on any day. If the Company or the crew member fails to give the required notice, one (1) week's wages shall be paid or forfeited.

(b) The preceding clause does not apply when the last whale of the season has been nominated by the Company, in which case two (2) days' notice of termination of engagement shall apply.

(c) This clause does not affect the right to dismiss for misconduct.

13.—Absence Through Sickness.

(a) A crew member shall be entitled to payment for non-attendance on the grounds of personal ill-health for one-twelfth (1/12th) of a week's pay for each completed month of service. Payment hereunder may be adjusted at the end of the season or at any time the crew member leaves the service of the Company.

(b) This clause shall not apply when the crew member is entitled to compensation under the Workers' Compensation Act.

(c) All sick leave unclaimed shall be paid to the crew member on termination of employment or at the end of the season.

14.—Messing and Accommodation.

(a) Messing and accommodation, including bedding, shall be provided by the Company whilst whaling, provided that for any non-whaling period in excess of five (5) continuous days, messing shall be discontinued.

(b) All bedding and linen shall be signed for by each crew member. Failure to return same at termination of service may be treated by the Company as lost and the cost thereof be paid by the crew member concerned.

15.—Preference.

(a) In this clause, the term "unionist" means a worker who is a financial member of the Australian Workers' Union, Westralian Branch, Industrial Union of Workers.

(b) In engaging or dismissing labour, preference of employment shall be given to unionists, provided that such unionists are adequately experienced in the class of work to be performed and are otherwise competent to perform the work: Provided further that it shall be a defence on the part of the Company charged with engaging a worker other than a "unionist," when a "unionist" was available for such engagement, that the Company, having made enquiries from the Union, did not know that any "unionist" competent to perform the class of work involved was available.

(c) Any worker whose application for membership of the Union has been refused shall be so advised by the Union in writing and shall have the right of appeal within seven days of being so advised to the Industrial Registrar, whose decision on such matter shall be final. Such worker who has exercised his right of appeal shall, pending the decision of the Industrial Registrar, have the same rights under this clause as a "unionist."

(d) Subject to subclause (e) hereof, workers who are not "unionists" shall within seven (7) days of being supplied with the necessary application form for membership and a copy of this clause, by an accredited representative of the Union, apply in the prescribed manner for membership and, if accepted as a member, maintain financial membership whilst employed by the Company.

(e) Exemptions.—(i) Any worker may apply in writing to the Industrial Registrar, Court of Arbitration, Perth (whose decision shall be final) for exemption from this clause.

(ii) An applicant for exemption shall detail in the application to the Industrial Registrar his reasons for desiring exemption, and such application shall only be valid and considered by the Industrial Registrar if it is forwarded by registered post within seven (7) days of the applicant's receipt of the application for membership as prescribed in subclause (d).

(iii) The Industrial Registrar in the exercise of his discretion may grant exemption with such conditions as he deems desirable—

- (a) if the applicant is a financial member of any other registered industrial union;
- (b) if the worker objects on the grounds of conscientious religious belief to becoming a member of any industrial union;
- (c) for any other reason which the Industrial Registrar deems sufficient.

(iv) A worker refused exemption by the Industrial Registrar shall, within seven (7) days of the decision, make application for membership of the Union and, if accepted as a member, maintain financial membership whilst employed by the Company.

(f) The Company shall not, while to its knowledge adequately experienced unionists competent to perform the class of work are available, retain in its employment any worker for a period of more than seven (7) days after being advised by the Union that such worker has not complied with either subclause (d) or paragraph (iv) of subclause (e) of this clause, or for a period of more than seven (7) days after a conviction for a breach of this clause in reference to the employment of such worker, or for a period of more than seven (7) days after the Company has been advised by the Union that the worker has not exercised his right of appeal under subclause (c) hereof following the rejection of his application for membership or having exercised such appeal has had such appeal rejected by the Industrial Registrar.

16.—Long Service Leave.

The provisions of Order No. 55 of 1958, as amended, shall apply.

5.—Contract of Service.

(a) Except in the case of casual workers, the contract of service shall be by the week and shall be terminable by one week's notice given on either side on any day. If the Company or a worker fails to give the required notice one week's wages shall be paid or forfeited.

(b) This clause does not affect the right to dismiss for misconduct.

6.—Wages.

The minimum rates of wages payable under the provisions of this Agreement shall be as follows:—

7.—Hours.

(a) The ordinary working hours shall be worked between Monday and Friday inclusive and shall not exceed forty (40) in any one week or eight (8) hours in any one day.

(b) The meal interval shall not exceed one (1) hour.

(c) When a night shift is worked, the ordinary hours of such shift shall be inclusive of a twenty minute crib time which shall be taken in relays at such times as not to cause a stoppage of work.

8.—Overtime.

(a) For all work done beyond the hours of duty payment shall be made at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) All work performed on Sundays or on the holidays prescribed in subclause 11 (a) hereof shall be paid for at the rate of double time.

(c) Overtime on shift work shall be based on the rate payable for shift work.

(d) A worker required to work overtime for more than two (2) hours, without being notified on the previous day or earlier that he will be so required to work, shall be supplied with a meal by the Company.

(e) (i) The Company may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.

(ii) No organisation party to this Agreement, or worker or workers covered by this Agreement, shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.

(f) In the calculation of overtime rates, each day shall stand alone. Provided that, when a worker continues working beyond midnight on any day, the hours worked after midnight shall be counted as part of the previous day's work for the purpose of calculating the rates to be paid.

(g) When a worker is recalled to work after the completion of his shift he shall be paid at least two (2) hours at overtime rates.

(h) When a worker is required to hold himself in readiness for a call to work after ordinary hours, he shall be paid at ordinary rates for the time he so holds himself in readiness.

9.—Rest Period After Overtime.

(a) When overtime work is necessary it shall, wherever reasonably practicable, be so arranged that workers have at least eight (8) consecutive hours off duty between the work of successive days.

(b) A worker who works so much overtime between the termination of his ordinary work on one day and the commencement of his ordinary work on the next day that he has not at least eight (8) consecutive hours off duty between those times shall, subject to this subclause, be released after completion of such overtime until he has had eight (8) consecutive hours off duty without loss of pay for ordinary working time occurring during such absence.

(c) If, on the instructions of the Company, such a worker resumes or continues work without having had such eight (8) consecutive hours off duty, he shall be paid at double rates until he is released from duty for such period and he shall then be entitled to be absent until he has had eight (8) consecutive hours off duty without loss of pay for ordinary working time occurring during such absence.

10.—Shift Work.

When the work is performed on shifts, the loading on the ordinary rate of pay for night shift shall be ten per cent. (10%).

11.—Holidays.

(a) The following days, or the days observed in lieu, shall, subject to subclause (b) of clause 8 hereof, be allowed as holidays without deduction of pay, namely: New Year's Day, Australia Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Sovereign's Birthday, Christmas Day and Boxing Day. Provided that another day may be taken as a holiday by arrangement between the parties, in lieu of any of the days named in the subclause.

(b) Where Christmas Day, Boxing Day or New Year's Day fall on a Sunday and where Christmas Day or New Year's Day fall on a Saturday, such holiday or holidays shall be observed on the next succeeding working day or days which shall be deemed a holiday or holidays without deduction of pay in lieu of the days named.

12.—Annual Leave.

(a) Except as hereinafter provided, a period of two (2) consecutive week's leave with payment of ordinary wages as prescribed shall be allowed annually to a worker after a period of twelve (12) months' continuous service.

(3)—57601

(b) If any prescribed holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday as aforesaid.

(c) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the Company through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(d) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Agreement shall not count for the purpose of determining his right to annual leave.

(e) In the event of a worker being employed by the Company for portion only of a year, he shall only be entitled, subject to subclause (c) of this clause, to such leave on full pay as is proportionate to his length of service during that period with the Company, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of the Company are on leave on full pay.

(f) A worker who is justifiably dismissed for misconduct shall not be entitled to the benefit of the provisions of this clause.

13.—Sick Leave.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week for each completed month of service: Provided that payment for absence through such ill-health shall be limited to one (1) week in each calendar year. Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the Company in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) A worker shall not be entitled to receive any wages from the Company for any time lost through the result of an accident not arising out of or in the course of his employment, or for any accident, wherever sustained, arising out of his own wilful default, or for sickness arising out of his own wilful default.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to the Company of sickness, but the Company shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(d) Sick leave shall accumulate from year to year, so that any balance of the period specified in subclause (a) of this clause which has in any year not been allowed to any worker by the Company as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed shall be allowed by the Company in any subsequent year without diminution of the sick leave prescribed in respect of that year. Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

14.—First Aid.

The Company shall provide a first aid chest in conformity with the scale prescribed by the Factories and Shops Act.

15.—Time and Wages Record.

(a) The Company shall keep a record containing—

- (i) the names of all workers employed to whom this agreement applies;
- (ii) the class of work performed;
- (iii) the hours worked (including overtime) by each worker; and

(iv) the wages paid (including overtime) to each such worker.

(b) Such record may be inspected at any time during ordinary working hours by a duly accredited representative of the Union, and he shall be allowed to take extracts therefrom.

16.—Preference.

(a) In this clause, the term, "Unionist" means a worker who is a financial member of the Australian Workers' Union, Westralian Branch, Industrial Union of Workers.

(b) In engaging or dismissing labour, preference of employment shall be given to Unionists, provided that such unionists are adequately experienced in the class of work to be performed and are otherwise competent to perform the work: Provided further that it shall be a defence on the part of the Company charged with engaging a worker other than a "unionist" when a "unionist" was available for such engagement, that the Company, having made enquiries from the Union, did not know that any "unionist" competent to perform the class of work involved was available.

(c) Any worker whose application for membership of the Union has been refused shall be so advised by the Union in writing and shall have the right of appeal within seven days of being so advised to the Industrial Registrar whose decision on such matter shall be final. Such worker who has exercised his right of appeal shall, pending the decision of the Industrial Registrar, have the same rights under this clause as a "unionist."

(d) Subject to subclause (e) hereof, workers who are not "unionists" shall within seven (7) days of being supplied with the necessary application form for membership and a copy of this clause, by an accredited representative of the Union, apply in the prescribed manner for membership and, if accepted as a member, maintain financial membership whilst employed by the Company.

(e) Exemptions.—(i) Any worker may apply in writing to the Industrial Registrar, Court of Arbitration, Perth (whose decision shall be final) for exemption from this clause.

(ii) An applicant for exemption shall detail in the application to the Industrial Registrar his reasons for desiring exemption, and such application shall only be valid and considered by the Industrial Registrar if it is forwarded by registered post within seven (7) days of the applicant's receipt of the application for membership as prescribed in subclause (d).

(iii) The Industrial Registrar in the exercise of his discretion may grant exemption with such conditions as he deems desirable—

- (a) if the applicant is a financial member of any other registered industrial union;
- (b) if the worker objects on the grounds of conscientious religious belief to becoming a member of any industrial union;
- (c) for any other reason which the Industrial Registrar deems sufficient.

(iv) A worker refused exemption by the Industrial Registrar shall, within seven (7) days of the decision, make application for membership of the Union and, if accepted as a member, maintain financial membership whilst employed by the Company.

(f) The Company shall not, while to its knowledge adequately experienced unionists competent to perform the class of work are available, retain in its employment any worker for a period of more than seven (7) days after being advised by the Union that such worker has not complied with either subclause (d) or paragraph (iv) of subclause (e) of this clause, or for a period of more than seven (7) days after a conviction for a breach of this clause in reference to the employment of such worker, or for a period of more than seven days after the Company has been advised by the Union that the worker has not exercised his right of appeal under subclause (c) hereof following the rejection of his application for membership, or having exercised such appeal has had such appeal rejected by the Industrial Registrar.

17.—Long Service Leave.

The provisions of Order No. 55 of 1958, as amended, shall apply.
