Inspection of Machinery Act, 1921-1958.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 82 of the Inspection of Machinery Act, 1921-1958, that the Governor may from time to time, by Order in Council, make regulations for any of the matters specified in that section: Now, therefore, His Excellency the Governor in Executive Council, acting pursuant to the powers conferred by the Act, hereby makes the regulations set out in the schedule hereunder.

Schedule.

Regulations.

The regulations made under the provisions of the Inspection of Machinery Act, 1921-1958, as reprinted pursuant to the Reprinting of Regulations Act, 1954, and published as so reprinted in the *Government Gazette* on the 20th March, 1957 (such reprinted regulations including all amendments to and including those appearing in the *Government Gazette* on the 18th May, 1956) are amended in the manner following:—

1. By substituting for the words, "Holman Hoists" in line one of the introductory paragraph under the heading, "Regulations Relating to Winding Engines" the words, "hoists driven by electric motors not exceeding twenty horse-power or by rotary air motors."

2. By substituting for the passage, "two hundred (200) feet" in line four of the introductory paragraph hereinbeforementioned the passage, "two hundred and fifty (250) feet."

3. By inserting after the word, "engine" in line four of paragraph (5) of regulation 17 under the heading, "Regulations Relating to the Conduct of Examinations, Qualifications of Applicants, and the Granting of Certificates to Engine Drivers, Crane and Hoist Drivers, and Boiler Attendants" the words, "of any horse-power."

4. By substituting for the passage commencing with the word, "less" in line four of subparagraph (c) of paragraph (5) of regulation 17 hereinbeforementioned down to and including the word, "months" being the last word in that subparagraph the words, "less than nine months."

5. By deleting the passage, "or 12 months, as the case may be," in lines two and three of subparagraph (d) of paragraph (5) of regulation 17 hereinbeforementioned.

6. By adding immediately after paragraph (5) of regulation 17 hereinbeforementioned the following paragraph:—

(5a) An applicant for a restricted winding engine driver's certificate, not available for steam winding engines, but which shall entitle the holder to drive and have charge of an electric winding engine not exceeding one hundred (100) horse-power on any mine operated by his employer within the boundary of the defined locality where he is employed at the time of making his application, shall—

- (a) comply with the provisions of paragraph (1) of this regulation; and
- (b) produce satisfactory evidence that during a period of six months he has been actually assisting to drive for not less than twelve (12) hours in each week, under the supervision of a certificated winding engine driver, or the holder of a certificate equivalent thereto issued in this State, an electric winding engine which was driven by an electric motor of not less than forty (40) horse-power, and that he has a satisfactory knowledge of the operation of electric winding engines.
