WHEREAS by section 166 of the Factories and Shops Act, 1920-1959, it is enacted that the Governor may, by Proclamation, temporarily suspend the operations of the said Act, in so far as it applies to the closing time fixed or appointed for any shop or shops, either generally or in any specified locality or district: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, do by this Proclamation temporarily suspend the operations of the Factories and Shops Act, 1920-1959, for the period the 8th day of April to the 11th day of April, 1963, inclusive, in so far as the said Act applies to the closing time of shops situated in those districts throughout the State which would normally observe the weekly half holiday during that period between the usual hour of closing of such shops and 6 p.m. on the said days.

Constitution Act, 1889.

ORDER IN COUNCIL.

P.W. 1060/58.

WHEREAS section 74 of the Constitution Act, 1889, provides that the Governor in Council may vest in Heads of Departments, or other officers or persons within the State, power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Department of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and

Drainage Department) should be vested in Donald Barry Collett, John Gordon Lewis, Lionel Douglas Clarke, Francis Kersley Fowler and Jack Hulme: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, hereby vests in Donald Barry Collett, John Gordon Lewis, Lionel Douglas Clarke, Francis Kersley Fowler and Jack Hulme the appointment of foremen and all other persons employed on such works at a daily rate of wage.

Companies Act, 1961-1962.

ORDER IN COUNCIL.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1962.

ORDER IN COUNCIL.

M.W.S. 694514/63.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1962, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.

South of Swan River Sewerage.

Hordern Street to Woodman Point Pressure Main.

Second Section of the Hordern Street, Victoria Park to Woodman Point Pressure Main comprising—

(a) a sewage pumping station; and

(b) an 18-inch diameter pipe rising main;

together with, in each case, all things necessary for the undertaking.

This Order in Council shall take effect from the 29th day of March, 1963.

Bunbury Water Board.

ORDER IN COUNCIL.

Waroona Country Water Area.

ORDER IN COUNCIL.

P.W.W.S. 495/46.

WHEREAS it is enacted by section 8 of the Country Areas Water Supply Act, 1947-1960, that the Governor may, by Order in Council, alter or extend the boundaries of a Country Water Area: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby extend the boundaries of the Waroona Country Water Area to include the area described in schedule hereunder.

Schedule.

Waroona Country Water Area—Alteration of Boundaries.

All that portion of land bounded by lines starting from the north-western corner of Waroona Suburban Lot 26 and extending easterly along the

northern boundaries of that lot, lots 33 and 36 to the north-eastern corner of the lastmentioned lot, a point on the northern boundary of Waroona Townsite; thence generally easterly along that boundary to the western boundary of Murray Location 180; thence southerly along that boundary to the northern side of road number 2596; thence east-south-easterly along that side to the southern boundary of location 180 aforesaid; thence westerly and southerly to and along boundaries of location 254 to its south-western corner and onwards to the southern side of road number 613; thence generally east-south-easterly along that side to the western boundary of the Waroona Irrigation Waterworks; thence generally south-easterly and generally north-easterly along boundaries of that irrigation waterworks to the southern side of road number 613 aforesaid; thence generally easterly along that side to the western boundary of location 27; thence southerly and easterly along boundaries of that location to the north-eastern corner of location 1365; thence southerly along the eastern boundary of that location to the north-eastern corner of location 1377; thence southerly, generally westerly and northerly along boundaries of that location to the southern boundary of location 10; thence westerly and generally northerly along boundaries of that location to a point situate in prolongation easterly of the southern side of Cornucopia Street; thence westerly to and along that side to the eastern side of the South-Western Railway Reserve; thence northerly along that side to a point situate in prolongation easterly of the southern side of Roberts Road; thence westerly to and along that side to the south-eastern side of McFarlane Road; thence north-easterly along that side to a point situate in prolongation easterly of the northern boundary of Hamel Agricultural Area Lot 26; thence westerly to and along that boundary and the northern boundaries of lots 27 to 34 inclusive to the north-western corner of the lastmentioned lot; thence north-easterly to and along the south-eastern side of McCabe Road and onwards to the southern boundary of location 26; thence easterly along that boundary to the western side of South-Western Highway (road number 41); thence generally northerly along that side to the southern side of McLarty Street, a point on the southern boundary of Waroona Townsite; thence westerly and generally northerly along that boundary to the southern side of Drake Road; thence westerly along that side to a point situate in prolongation southerly of the western boundary of Waroona Suburban Lot 26 aforesaid; thence northerly to and along that boundary to the starting point, all as shown bordered red on Plan P.W.D., W.A. 39989, Sheets 1 and 2.

Central Rating Zone and Ballidu Rating Zone.

ORDER IN COUNCIL.

P.W.W.S. 1059/61, "B."

WHEREAS it is enacted by section 10 of the Country Areas Water Supply Act, 1947-1960, that the Governor may, by Order in Council, alter the boundaries of a Rating Zone in a Country Water Area; and whereas, by section 10 of the said Act, it is further provided that the Governor may, by Order in Council, constitute a Rating Zone in a Country Water Area: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby alter the boundaries of the Central Rating Zone by excising therefrom the area defined in Schedule "A" hereunder, and doth also hereby constitute the whole of the area defined in Schedule "B" hereunder to be a rating zone and to assign the name "Ballidu Rating Zone" thereto.

Schedule "A."

Constitution of Ballidu Rating Zone.

All that portion of land bounded by lines starting from the western corner of Ballidu Town Lot 64 and extending north-easterly and south-easterly along boundaries of that lot and south-easterly along the north-eastern boundary of lot 65 to the north-western side of McNeill Street; thence north-easterly along that side to a point situate in prolongation north-westerly of the north-eastern boundary of lot 515; thence south-easterly to and along that boundary to the north-western side of Baroota Street; thence north-easterly along that side to a point situate in prolongation north-westerly of the north-eastern boundary of lot 63; thence south-easterly to and along that boundary and onwards to the western boundary of lot 72 (Reserve 19676); thence southerly along that boundary to the south-western corner of that lot, a point on the eastern boundary of Ballidu Townsite; thence generally southerly along that boundary to the north-eastern side of Moora Road; thence north-westerly and westerly along sides of that road to the south-western side of a one-chain road, as shown coloured blue on Land Titles Office Plan 3970, passing along the south-western and north-western boundaries of Ballidu Station Yard; thence generally north-westerly along that side and north-easterly along the north-western side of that road to the north-eastern side of the Perth-Mullewa Railway Reserve; thence generally north-westerly along that side to a point situate in prolongation south-westerly of the north-western boundary of lot 64 aforesaid, and thence north-easterly to the starting point, and being the land shown bordered red on Plan P.W.D., W.A. 40003.

Schedule "B."

Area Excised from Central Rating Zone.

All that portion of land contained within the Ballidu Townsite boundary and being the land shown bordered blue on Plan P.W.D., W.A. 40003.

Three Springs Sewerage Area.

ORDER IN COUNCIL.

P.W.W.S. 1096/62.

WHEREAS by section 4 (a) of the Country Towns Sewerage Act, 1948-1956, the Governor may, by Order in Council, constitute any part of parts of the State outside the boundaries of the Metropolitan Water, Sewerage and Drainage Area as constituted and defined by the Act, No. 43 of 1909, as a sewerage area; and whereas by section 4 (b) of the Country Towns Sewerage Act, 1948-1956, the Governor may, by Order in Council, constitute sewerage districts by dividing any sewerage area into sewerage districts under such names as may be directed: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby constitute that part of the State defined in Schedule "A" hereunder a sewerage area and assign the name of "Three Springs Sewerage Area" thereto and also doth hereby divide the Three Springs Sewerage Area into two sewerage districts, namely:—

(a) No. 1 Three Springs Sewerage District;

(b) No. 2 Three Springs Sewerage District;

defined in Schedule "B" hereunder.

Schedule "A."

Three Springs Sewerage Area.

All that portion of land contained within a circle having a radius of five miles with its centre situate within Three Springs Townsite at the northern corner of town lot 94, Railway Road, as shown bordered red on Plan P.W.D., W.A. 40088, Drawing No. 1.

Schedule "B."

Three Springs No. 1 Sewerage District.

and thence west, 17 chains 5 5/10 links to the starting point, as shown bordered blue on Plan P.W.D., W.A. 40088, Drawing Nos. 1 and 2.

Three Springs No. 2 Sewerage District.

All that portion of land contained within Three Springs Sewerage Area excluding the land contained within the boundary of Three Springs No. 1 Sewerage District, as shown bordered green on Plan P.W.D., W.A. 40088, Drawing No. 1.

All that portion of land contained within a circle having a radius of five miles with its centre situate at the North Eastern corner of Avon Location 24010, as shown bordered red on Plan P.W.D., W.A. 40089, Drawing No. 1.

Schedule "B."

Wundowie No. 1 Sewerage District.

All that portion of land contained within the boundary of Wundowie Townsite as shown bordered blue on Plan P.W.D., W.A. 40089, Drawing Nos. 1 and 2.

Wundowie No. 2 Sewerage District.

All that portion of land contained within Wundowie Sewerage Area excluding the land contained within the boundary of Wundowie Townsite as shown bordered green on Plan P.W.D., W.A. 40089, Drawing No. 1.

WHEREAS an industrial dispute existed between the abovenamed parties; and whereas the said dispute was referred into Court for the purpose of hearing and determination; and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference; and whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to make the said agreement an Award of the Court: Now, therefore, the Court, pursuant to section 65 of the Industrial Arbitration Act, 1912-1961, and all other powers therein enabling it, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court:—

Two classes of labour only shall be employed in the hairdressing industry, viz. Seniors and apprentices.

(a) "Senior" means a worker who has completed his or her apprenticeship period and has passed the final examination of the Court of Arbitration, or who is registered by the Hairdressers Registration Board of Western Australia. Except that anywhere where the provisions of the Hairdressers Registration Act are not currently applicable a senior shall mean a person with at least five years of full time hairdressing experience.

(b) "Apprentice" shall mean a worker not less than 15 years or more than 25 years of age at commencement of the apprenticeship who is serving articles of apprenticeship or who is employed in the industry with a view to becoming an apprentice.

(c) "Hairdresser" shall mean any person employed in ladies hairdressing establishments performing the following work: Head shaving, hair-cutting, hair removing, hair dressing, hair trimming, hair curling or waving, hair singeing, shampooing, wig making, hair working, hair dyeing or colouring, manicuring, face, neck or head massage, or other similar stimulative treatment or process of the hair, head, face or neck, carried on, used, or employed in ladies hairdressing salons, beauty parlours, or similar establishments, whether with or without the aid of any apparatus, appliance, preparation or substance.

(d) "Registered" shall mean any worker registered by the Hairdressers Registration Board of Western Australia, for the particular class of hairdressing being performed.

(e) "Under Rate Worker". An under rate worker shall be a person as provided for in clause 25 of this Award.

6.—Hours.

The hours of work shall not exceed (except as provided by clause 7 of this Award) forty (40) hours per week and shall be worked between 8 a.m. and 6 p.m. on Monday to Friday inclusive and 8 a.m. and 12 noon on Saturdays.

A worker may, in order to complete the one operation, in relation to any one customer, on which he or she is engaged at the hour fixed for ceasing work, continue to work for a period not exceeding one (1) half hour after the hour so fixed for ceasing work for that day.

Except as provided in clause 7 a worker continuing to work as aforesaid shall start one (1) half hour or such shorter period later than the usual starting time on the following working day.

No employer shall allow any employee to be on his premises more than half an hour before the usual starting time of the employee.

Provided that in any day there shall not be any broken time other than meal times.

7.—Overtime.

Overtime shall not be worked except up to a total of half an hour per day as provided in clause 6. This extra half hour or lesser period per day may at the option of the employer be either (a) adjusted by later commencing time as provided in clause 6 or (b) paid for at a time and a half rate.

8.—Holidays and Annual Leave.

(a) The following days or the days observed in lieu thereof shall be observed as paid holidays, namely:—

New Year's Day,
Australia Day,
Good Friday,
Easter Saturday,
Easter Monday,
Anzac Day,
Labour Day,
Foundation Day,
Christmas Day,
Boxing Day,

and on these days no work shall be performed.

(b) On any public holiday not prescribed as a holiday under this Award the employer's establishment or place of business may be closed in which case a worker need not present himself for duty and payment may be deducted, but if work be done ordinary rates of pay shall apply.

(c) Except as hereinafter provided a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of 12 months continuous service with such employer.

(d) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(e) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(f) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award shall not count for the purpose of determining his right to annual leave.

(g) In the event of a worker being employed by an employer for portion only of a year, he shall be entitled, subject to subclause (e) of this clause, only to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers or such employer are on leave on full pay.

(h) A worker who is dismissed for misconduct or dereliction of duty or who illegally severs his contract of service shall not be entitled to the benefits of the provisions of this clause.

(i) This clause does not apply to part time workers.

9.—Wages.

The minimum rates of wages payable shall be as follows:—

(f) Provided that a worker, notwithstanding that the term of apprenticeship shall have expired, shall continue to receive the wages payable in the last year of apprenticeship until he or she has passed the final examination of the Court of Arbitration

10.—Apprentices.

(a) The provisions of the Statutory Apprenticeship Regulations 1953 are hereby embodied in and form part of this Award.

(b) The term of apprenticeship shall be five (5) years. A probationary period of three (3) months previous to being indentured shall be lawful; such probationary period to be deemed portion of the term of apprenticeship.

(c) Apprentices shall be instructed in their trade at their employers places of business and/or the Hairdressing Department of the Perth Technical College and in no other places.

(d) Apprentices shall be examined annually by examiners appointed by the Court of Arbitration.

11.—Time and Wages Record.

The employer shall keep and enter up or cause to be kept and entered up a book containing—

- (a) the name of each worker;
- (b) the class of work performed;
- (c) starting time and finishing time for each day;
- (d) the total number of hours worked each week;
- (e) the wages to be paid to each worker;
- (f) the ages of apprentices.

Such book shall be open for inspection by a duly authorised representative of the Union during the working hours of 10 a.m. and 4 p.m. on Monday to Thursday inclusive.

12.—Engagement.

(a) Employment shall be on a weekly basis and shall be terminated only by one (1) week's notice given by either party. Provided that any worker may be summarily dismissed by his employer for misconduct or refusal to obey lawful orders. If an employer or a worker fails to give the required notice one (1) week's wages in lieu of notice shall be paid by the employer or forfeited by the worker according to whichever is the defaulting party.

(b) Where no senior is available for full time employment, part time may be worked provided neither the Union of Employees nor the Union of Employers objects.

The procedure required, where it is wished to employ a part time worker, is that both the proposed employer and employee shall notify both the Union of Employees and the Union of Employers by registered or certified mail (this will constitute proof of notice) and, in the absence of any written objection from either body within seven (7) days, the employer and employee concerned are entitled to assume that approval has been given to part time working.

(c) Payment for the time worked under subsection (b) above shall be at the hourly rate with an amount equal to 10% added thereto.

(d) Where a worker is employed part time his employment shall be for a minimum of four (4) hours in any one day, and a minimum total of twelve (12) hours in any one week.

13.—Registration.

No worker shall be employed in the industry as a hairdresser, in any part of the State where the Hairdressers Registration Act is currently applicable, other than workers registered by the Hairdressers Registration Board of Western Australia for the particular class of hairdressing being done. This clause shall not apply to apprentices.

14.—Sick Pay.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health at the rate of 1/12th of a week's pay for each completed month of service. Provided that payment for absence through ill-health shall be limited to one week's pay in each calendar year.

(b) Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the services of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(c) This clause shall not apply when the worker is entitled to compensation under the Workers' Compensation Act.

(d) A worker shall not be entitled to receive any wages from his employer for any time lost through any accident not arising out of, or in the course of his employment or for any accident, wherever sustained, arising out of his own wilful default, or for sickness arising out of his own wilful default.

(e) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(f) Notwithstanding the provisions of subclause (e) hereof, a worker who in any calendar year has already been allowed paid sick leave on one occasion for one day only shall not be entitled to payment for any further absence of one day only unless he produces to the employer a medical certificate stating that he was unable to attend for duty on account of personal ill-health.

15.—Meal Times.

Every worker shall be entitled to one (1) hour for a meal between the hours of 11.30 a.m. and 2.30 p.m.

No worker shall work or be required to work so as to lose or be deprived of any meal time or part thereof, or work for longer than four and one half (4½) hours without such a meal time.

16.—Breakdowns.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the Union or Unions affiliated with it, or by any other association or Union, or through the breakdown of the employer's machinery, or any stoppage of work by any cause which the employer cannot reasonably prevent.

17.—Posting of Award.

A copy of this Award shall be kept in a conveniently conspicuous place in the staff room of the employer's premises.

18.—Staff Room.

The employer shall provide a suitable room or accommodation for workers in which to change and keep their clothes while on duty.

19.—Long Service Leave.

(a) Right to Leave.

A worker shall as herein provided be entitled to leave with pay in respect of long service.

(b) Long Service.

(1) The long service which shall entitle a worker to such leave shall, subject as herein provided, be continuous service with one and the same employer.

(2) Such service shall include service prior to the 1st day of April, 1958, if it continued until such time but only to the extent of the last twenty completed years of continuous service.

(3) (i) Where a business has, whether before or after the coming into operation hereof, been transmitted from an employer (herein called "the transmitter") to another employer (herein called "the transmittee") and a worker who at the time of such transmission was an employee of the transmitter in that business becomes an employee of the transmittee—the period of the continuous service which the worker has had with the transmitter (including any such service with any prior transmitter) shall be deemed to be service of the worker with the transmittee.

(ii) In this subclause "transmission" includes transfer conveyance assignment or succession whether voluntary or by agreement or by operation of law and "transmitted" has a corresponding meaning.

(4) Such service shall include—

(a) any period of absence from duty on any annual leave or long service leave;

(b) any period of absence from duty necessitated by sickness of or injury to the worker but only to the extent of fifteen working days in any year of his employment;

(c) any period following any termination of the employment by the employer if such termination has been made merely with the intention of avoiding obligations hereunder in respect of long service leave or obligations under any award in respect of annual leave;

(d) any period during which the service of the worker was or is interrupted by service—

(i) as a member of the Naval, Military or Air Forces of the Commonwealth of Australia other than as a member of the British Commonwealth Occupation Forces in Japan and other than as a member of the Permanent forces of the Commonwealth of Australia except in the circumstances referred to in Section 31 (2) of the Defence Act, 1903-1956 and except in Korea or Malaya after June 26th, 1950;

(ii) As a member of the Civil Construction Corps established under the National Security Act, 1939-1946;

(iii) in any of the Armed Forces under the National Service Act, 1951 (as amended).

Provided that the worker as soon as reasonably practicable on the completion of any such service resumed or resumes employment with the employer by whom he was employed immediately before the commencement of such service.

(5) Service shall be deemed to be continuous notwithstanding—

(a) the transmission of a business as referred to in paragraph (3) hereof;

(b) any interruption of a class referred to in paragraph (4) hereof irrespective of the duration thereof;

(c) any absence from duty authorised by the employer;

(d) any standing-down of a worker in accordance with the provisions of an award, Industrial Agreement, Order or Determination under either Commonwealth or State law;

(e) any absence from duty arising directly or indirectly from an industrial dispute if the worker returns to work in accordance with the terms of settlement of the dispute;

(f) any termination of the employment by the employer on any ground other than slackness of trade if the worker be re-employed by the same employer within a period not exceeding two months from the date of such termination;

- (g) any termination of the employment by the employer on the ground of slackness of trade if the worker is re-employed by the same employer within a period not exceeding six months from the date of such termination;
- (h) any reasonable absence of the worker on legitimate union business in respect of which he has requested and been refused leave;
- (i) any absence from duty after the coming into operation of this clause by reason of any case not specified in this clause unless the employer during the absence or within fourteen days of the termination of the absence notifies the worker in writing that such absence will be regarded as having broken the continuity of service, which notice may be given by delivery to the worker personally or by posting it by registered mail to his last recorded address, in which case it shall be deemed to have reached him in due course of post.

Provided that the period of any absence from duty or the period of any interruption referred to in placita (c) to (i) inclusive of this paragraph shall not (except as set out in paragraph (4) hereof) count as service.

(c) Period of Leave.

(1) The leave to which a worker shall be entitled or deemed to be entitled shall be as provided in this subclause.

(2) Where a worker has completed at least 20 years' service the amount of leave shall be—

- (a) in respect of 20 years' service so completed—13 weeks' leave;
- (b) in respect of each 10 years' service completed after such 20 years—six and a half weeks' leave.

(3) Where a worker has completed at least 15 years' service since its commencement and his employment is terminated—

- (a) by his death;
 - (b) in any circumstances otherwise than by the employer for serious misconduct;
- the amount of leave shall be—

- (i) if such termination takes place before the worker has become entitled to leave under placitum (a) of paragraph (2) hereof such proportion of 13 weeks' leave as the number of completed years of such service bears to 20 years;
- (ii) if such termination takes place after the worker has become entitled to leave under placitum (a) of paragraph (2) hereof the leave due under such placitum and in addition such proportion of 13 weeks' leave as the number of completed years of such service after the accrual of such entitlement bears to 20 years.

(4) Where a worker has completed at least 10 years' service but less than 15 years' service since its commencement and his employment is terminated—

- (i) by his death; or
- (ii) by the employer for any reason other than serious misconduct; or
- (iii) by the worker on account of sickness or injury to the worker or domestic or other pressing necessity where such sickness or injury or necessity is of such a nature as to justify or in the event of a dispute is, in the opinion of the Special Board of Reference, of such a nature as to justify such termination;

the amount of the leave shall be such proportion of 13 weeks' leave as the number of completed years of such service bears to 20 years.

(5) In the cases to which paragraphs (3) and (4) hereof apply the worker shall be deemed to have been entitled to and to have commenced leave immediately prior to such termination.

(d) Payment for Period of Leave.

(1) A worker shall subject to paragraph (3) hereof, be entitled to be paid for each week of leave to which he has become entitled or is deemed to have become entitled the ordinary time rate of pay applicable to him at the date he commences such leave;

(2) Such ordinary time rate of pay shall be the rate applicable to him for the standard weekly hours which are prescribed by this award, but in the case of casuals and part-time workers shall be the ordinary time rate for the number of hours usually worked up to but not exceeding the prescribed standard;

(3) Where by agreement between the employer and the worker the commencement of the leave to which the worker is entitled or any portion thereof is postponed to meet the convenience of the worker the rate of payment for such leave shall be at the ordinary time rate of pay applicable to him at the date of accrual or, if so agreed, at the ordinary time rate of pay applicable at the date he commences such leave;

(4) The ordinary time rate of pay—

(a) shall include any deductions from wages for board and/or lodging or the like which is not provided and taken during the period of leave;

(b) shall not include shift premiums, overtime, penalty-rates, commissions, bonuses, allowances or the like.

(5) In the case of workers employed on piece or bonus work or any other system of payment by results payment shall be at ordinary time rates.

(c) Taking Leave.

(1) In a case to which paragraph (2) of subclause (e) applies:—

(a) Leave shall be granted and taken as soon as reasonably practicable after the right thereto accrues due or at such time or times as may be agreed between the employer and the worker or in the absence of such agreement at such time or times as may be determined by the Special Board of Reference having regard to the needs of the employer's establishment and the worker's circumstances.

(b) Except where the time for taking leave is agreed to by the employer and the worker or determined by the Special Board of Reference the employer shall give to a worker at least one month's notice of the date from which his leave is to be taken.

(c) Leave may be granted and taken in one continuous period or if the employer and the worker so agree in not more than three separate periods in respect of the first 13 weeks' entitlement and in not more than two separate periods in respect of any subsequent period of entitlement.

(d) Any leave shall be inclusive of any public holidays specified in this award occurring during the period when the leave is taken but shall not be inclusive of any annual leave.

(e) Payment shall be made in one of the following ways:—

(i) In full before the worker goes on leave;

(ii) at the same time as his wages would have been paid to him if the worker had remained at work, in which case payment shall, if the worker in writing so requires, be made by cheque posted to an address specified by the worker; or

(iii) in any other way agreed between the employer and the worker.

(f) No worker shall, during any period when he is on leave, engage in any employment for hire or reward in substitution for the employment from which he is on leave, and if a worker breaches this provision he shall thereupon forfeit his right to leave hereunder in respect of the unexpired period of leave upon which he has entered, and the employer shall be entitled to withhold any further payment in respect of the period and to reclaim any payments already made on account of such period of leave.

(2) In a case to which paragraph (3) or paragraph (4) of sub-clause (c) applies and in any case in which the employment of the worker who has become entitled to leave hereunder is terminated before such leave is taken or fully taken the employer shall, upon termination of his employment otherwise than by death pay to the worker, and upon termination of employment by death pay to the personal representative of the worker upon request by the personal representative, a sum equivalent to the amount which would have been payable in respect of the period of leave to which he is entitled or deemed to have been entitled and which would have been taken but for such termination. Such payment shall be deemed to have satisfied the obligation of the employer in respect of leave hereunder.

(f) Granting Leave in Advance and Benefits to be Brought into Account.

(1) Any employer may by agreement with a worker allow leave to such a worker before the right thereto has accrued due, but where leave is taken in such a case the worker shall not become entitled to any further leave hereunder in respect of any period until after the expiration of the period in respect of which such leave had been taken before it accrued due.

(2) Where leave has been granted to a worker pursuant to the preceding paragraph before the right thereto has accrued due, and the employment subsequently is terminated, the employer may deduct from whatever remuneration is payable upon the termination of the employment a proportionate amount on the basis of 13 weeks for twenty years' service in respect of any period for which the worker has been granted long service leave to which he was not at the date of termination of his employment or prior thereto entitled.

(3) Any leave in the nature of long service leave or payment in lieu thereof under a State law or a long service leave scheme not under the provisions hereof granted to a worker by his employer in respect of any period of service with the employer shall be taken into account whether the same is granted before or after the coming into operation hereof and shall be deemed to have been leave taken and granted hereunder in the case of leave with pay to the extent of the period of such leave and in the case of payment in lieu thereof to the extent of a period of leave with pay equivalent to the amount of the payment and to be satisfaction to the extent thereof of the entitlement of the worker hereunder.

(g) Records to be Kept.

(1) Each employer shall during the employment and for a period of twelve months thereafter or in the case of termination by death of the worker a period of three years thereafter keep a record from which can be readily ascertained the name of each worker and his occupation, the date of the commencement of his employment and his entitlement to long service leave and any leave which may have been granted to him or in respect of which payment may have been made hereunder.

(2) Such record shall be open for inspection in the manner and circumstances prescribed by this Award with respect to the Time and Wages Record.

(h) Special Board of Reference.

(1) There shall be constituted a Special Board of Reference for the purpose hereof to which all disputes and matters arising hereunder shall be referred and the Board shall determine all such disputes and matters.

(2) There shall be assigned to such Board the functions of—

(a) the settlement of disputes on any matters arising hereunder;

(b) the determination of such matters as are specifically assigned to it hereunder.

(3) The Board of Reference shall consist of one representative or substitute therefore nominated from time to time by the Western Australian Employers' Federation (Incorporated) any one representative or substitute nominated from time to time by the West Australian Trade Unions Industrial Council (A.L.P.) together with a Chairman to be mutually agreed upon by the organisations named in this paragraph.

(i) State Law.

(1) The provisions of any State law to the extent to which they have before the coming into operation hereof conferred an accrued right on a worker to be granted a period of long service leave in respect of a completed period of 20 or more years' service or employment or an accrued right on a worker or his personal representative to payment in respect of long service leave shall not be affected hereby and shall not be deemed to be inconsistent with the provisions hereof.

(2) The entitlement of any such worker to leave in respect of a period of service with the employer completed after the period in respect of which the long service leave referred to in paragraph (1) hereof accrued due shall be in accordance herewith.

(3) Subject to paragraphs (1) and (2) hereof, the entitlement to leave hereunder shall be in substitution for and satisfaction of any long service leave to which the worker may be entitled in respect of employment of the worker by the employer.

(4) An employer who under any State Law with regard to long service leave is exempted from the provisions of that law as at the first day of April, 1958 shall in respect of the workers covered by such exemption be exempt from the provisions hereof.

(j) Exemptions.

The Special Board of Reference may subject to such conditions as it thinks fit exempt any employer from the provisions hereof in respect of its employees where there is an existing or prospective long service leave scheme which, in its opinion is, viewed as a whole, more favourable for the whole of the employees of that employer than the provisions hereof.

(k) Liberty to Apply.

Liberty is granted to any party to this Award to apply to the Court at any time for an appropriate variation of this Clause if any of the terms and conditions operating under the code of Long Service Leave being negotiated between the Australian Council of Trade Unions and Federal Employers' Organisations is varied in any way.

20.—Tools of Trade.

Seniors shall provide their own tools of trade which shall be kept in a workmanlike condition. Employers shall provide apprentices with all tools of trade. Subject to fair wear and tear, worn tools shall be replaced. Lost or wilfully damaged tools shall be made good by the apprentice.

21.—Premiums.

No person shall directly or indirectly request or permit any other person to pay or give, or shall receive from any person, any premiums, bonuses, consideration or payment for employing or teaching or purporting to employ or teach such person, or any other person, any of the callings to which this Award applies.

22.—Proportion.

(a) The maximum number of apprentices allowed to any employer in the industry shall be in the proportion of two (2) to every one fully qualified senior hairdresser employed by him.

(b) Where the employer or partner, or manager or company director, is a fully qualified hairdresser and regularly works at the trade, such persons shall be counted as senior hairdressers for the purpose of computing the number of apprentices to be allowed.

23.—Uniforms.

In the event of a worker being required to wear a special uniform or costume, such special uniform or costume shall be provided by and laundered at the employer's expense. Provided that an overall shall not be regarded as a special uniform or costume. Employers shall provide apprentices with overalls but the laundering of such overalls shall be the responsibility of the worker.

24.—Preference to Unionists.

(a) Preference of employment shall be given to competent members of the Union. Provided that any worker or applicant for employment who furnishes proof that he is a financial member of any other registered industrial union of workers shall, subject to the provisions hereinafter contained, be given equal preference.

(b) Any worker or applicant for employment who is not a member of the Union or of any other registered industrial union of workers shall within fourteen (14) days of commencing employment under this Award apply in accordance with its rules to become a member of the Union and any worker who is not a member of the Union but is a member of another registered industrial union of workers shall within fourteen (14) days from the expiration of his then current membership with such other union apply to become a member of the Union.

(c) The provisions of this clause shall not debar from employment or continuance in employment, any applicant for employment or any worker, whose application to become a member of the Union has been refused by the Union unless and until such refusal is withdrawn or the matter is determined by the Industrial Registrar of the Court of Arbitration.

(d) Any worker or applicant for employment who becomes a member of the Union shall continue his financial membership of the Union in accordance with its rules while he continues to be employed under this Award.

(e) The employer shall within fourteen (14) days of being advised in writing by the Union of the breach by a worker of the provisions of this clause determine the employment of any worker who fails to comply with the provisions of this preference clause unless such breach is remedied by the worker concerned within such fourteen (14) days. Any dispute as to whether a worker has committed a breach of this clause may be referred to the Industrial Registrar of the Court of Arbitration, by either the employer or the parties to this Award.

(f) The provisions of this clause shall not apply to any worker who objects on the grounds of conscientious religious belief to being a member of an industrial union of workers so long as such worker from time to time pays to a charitable organisation nominated by the Industrial Registrar of the Court of Arbitration an amount equivalent to the subscription and levies prescribed by the rules of the Union to be paid by its members.

(g) Should any dispute arise as to the conscientious religious beliefs of any worker or applicant for employment the same shall be referred to the Industrial Registrar of the Arbitration Court for decision.

(h) The Union shall mean the West Australian Hairdressers and Wigmakers Employees' Union of Workers.

25.—Under Rate Workers.

Any person employed on postiche work and who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.

26.—Board of Reference.

(a) For the purpose of this Award, a Board of Reference is hereby appointed, which shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. The said Board shall have assigned to it in the event of no agreement being arrived at between the parties to the dispute, the functions of—

(i) adjusting any matters of difference which may arise from time to time except such as involve interpretation of the provisions of this Award or any of them;

(ii) dealing with any other matter which the Court may refer to the Board from time to time.

(b) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1912-1961, which for this purpose are embodied in this Award.
