WHEREAS by section 31 of the Land Act, 1933-1962, the Governor may by Proclamation and subject to such conditions as may be expressed therein, classify as of Class "A" any lands of the Crown reserved to Her Majesty for any of the purposes

specified in the said section; and whereas it is deemed expedient that the addition to Class "A" Reserve No. 14792 "National Park" as described in the schedule hereto should be classified as of class "A": Now, therefore I, the Governor, with the advice and consent of the Executive Council, do by this my Proclamation classify as of Class "A" the additions to Class "A" Reserve No. 14792 as described in the schedule hereto and increase the area of the said reserve by about 8,647 acres accordingly.

WHEREAS it is enacted by subsection (1) of section 5 of the Stock Diseases Act, 1895-1960, that, in any case where he deems it necessary for the purpose of preventing the introduction or dissemination of disease into or in the State, the Governor may, from time to time, by Proclamation, prohibit or put restrictions on the introduction into the State from any other State of the Commonwealth specified in the Proclamation of any infected stock or stock suspected to be infected for such specified period as may appear to him necessary or expedient for the purpose; and whereas it is also enacted by subsection (2) of that section that the Governor may, by Proclamation, vary or revoke any Proclamation so made under that section; and whereas by a Proclamation made on the 17th day of May, 1961, and published in the *Government Gazette* on the 19th day of May, 1961, the Lieutenant-Governor and Administrator did prohibit until the 30th day of November, 1961, the introduction into this State of any swine or of any carcass of any swine or portion thereof from the State of New South Wales; and whereas by a Proclamation made on the 20th day of November, 1962, and published in the *Government Gazette* on the 30th day of November, 1962, the Governor did vary the said Proclamation by extending the period of prohibition specified therein until and including the 31st

day of May, 1963; and whereas it is deemed desirable and expedient to further extend the period of prohibition until and including the 30th day of November, 1963: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council, do hereby vary the said Proclamation made on the 17th day of May, 1961, as varied by the Proclamation made on the 20th day of November, 1962, by extending until and including the 30th day of November, 1963, the period for which the introduction into the State of any swine and of any carcass of any swine or portion thereof from the State of New South Wales is prohibited.

ORDER IN COUNCIL.

WHEREAS the enactment contained in section 74 of the Constitution Act, 1889, whereby the appointment of all public officers under the Government of the State is vested in the Governor in Council does not apply to minor appointments which by Order in Council are vested in the Heads of Departments or other officers or persons within the State; and whereas it is desirable that the appointment of foremen and all other persons employed at a daily wage on water supply, sewerage and drainage works under the control of the Metropolitan Water Supply, Sewerage and Drainage Department should be vested in various officers: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, hereby further amends schedule appended to the Order in Council gazetted on the 14th July, 1961, by the addition of the name of R. C. Vaile and of any person appointed temporarily to act in the place of such officer.

ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1962, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such Order and with power of subleasing; and whereas it is deemed expedient that Reserve No. 26784 (Jandakot Lot 443) should vest in and be held by the Shire of Gosnells in trust for the purpose of Recreation (Golf Course): Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned Reserve shall vest in and be held by the Shire of Gosnells in trust for Recreation (Golf Course) with power to the said Shire of Gosnells, subject to the approval in writing of the Minister for Lands being first obtained to lease the whole or any portion of the said reserve for any term not exceeding 21 years from the date of the lease.

ORDER IN COUNCIL.

Forests 290/62, Lands 7728/11.

WHEREAS by the Forests Act, 1918-1954, it is provided that the Governor may, by Order in Council, dedicate any Crown lands as State Forests within

the meaning and for the purposes of that Act: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby dedicate the area of Crown land in the Cockburn Sound, Avon and Murray Districts described in the schedule hereto as State Forest No. 67, within the meaning and for the purposes of the said Act.

ORDERS IN COUNCIL.
