WHEREAS it is enacted (*inter alia*) by section 89A of the Police Act, 1892-1962, that the Governor may, on the recommendation of the Commissioner of Police, by Proclamation prohibit—

- (a) the use or possession of any slot machine, or class or classes of slot machine; or
- (b) the use or possession in any place, class or classes of place of any slot machine, or class or classes of slot machine;

named in the Proclamation and that he may from time to time, by Proclamation, vary or cancel any Proclamation so made; and whereas the Deputy Commissioner of Police (being a person discharging the duties of the Commissioner of Police) has recommended to me, the Lieutenant-Governor and Administrator, that the use and possession of every such slot machine as is mentioned in the schedule hereto be prohibited; and whereas by reason of the premises it appears to me, the Lieutenant-Governor and Administrator, expedient to cancel the Proclamation hereinafter mentioned: Now, therefore I, the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council and in exercise of the powers conferred as aforesaid, do hereby cancel the Proclamation made under the said section on the 14th day of February, 1962, and published in the *Government Gazette* on the 16th day of February, 1962, and, on the recommendation of the Deputy Commissioner of Police, do hereby prohibit the use and possession of every slot machine such as is mentioned in the schedule hereto after 14 days from the day of the publication of this Proclamation in the *Government Gazette*.

Schedule.

Every slot machine that—

- (a) has any recording or accounting device (other than one device recording each player's progress score) fitted within or upon it;
- (b) returns, or purports to return, to the player, or entitles the player to, any money or money's worth (including the right to use or play the machine for an additional or longer period), on the contingency of any score recorded by it;
- (c) affords, or purports to afford, any advantage to a player for the insertion of more than one coin or token, prior to the commencement of use or play; or
- (d) is a machine of the kind generally known and described as a poker machine, fruit machine or roulette machine or is a mechanical device in the nature of, or similar to, any of them.

WHEREAS it is enacted by subsection (2) of section 4 of the Totalisator Agency Board Betting Act, 1960-1962, that the Governor may, on the recommendation of the Minister and the Board, from time to time, and at any time, by Proclamation, declare any portion or portions of the State to be a totalisator agency region for the purposes of that Act; and whereas the Minister and the Board have recommended that the land described in the Schedule hereunder be declared totalisator agency regions for those purposes: Now, therefore I, the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council, do hereby declare that as from and including the 16th day of September, 1963, the land described in the schedule hereunder shall be totalisator agency regions for the purposes of the Totalisator Agency Board Betting Act, 1960-1962.

(The Order in Council issued under Executive Council Minute No. 5921, dated the 21st December, 1912, concerning this Reserve is hereby superseded.)

Corres. 755/59.—That Class "A" Reserve No. 25307 should vest in and be held by the Shire of Northampton in trust for the purpose of Recreation and Parklands, subject to the condition that the reserve is not to be used for the purpose of Camping.

Corres. 482/63.—That Reserve No. 26964 (Gnowangerup Lots 319 and 320) should vest in and be held by the United Aborigines Mission in trust for the purpose of a Native Community Centre.

Corres. 2624/62.—That Reserve No. 26965 (Balladonia Lot 17) should vest in and be held by the Minister for Water Supply, Sewerage and Drainage in trust for the purpose of Water.

Corres. 836/52.—That Reserve No. 26966 (Mount Magnet Lot 395) should vest in and be held by the Shire of Mount Magnet in trust for the purpose of Public Utility.

Now, therefore, His Excellency the Lieutenant-Governor and Administrator, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall vest in and be held by the abovementioned bodies in trust for the purposes aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1962, it is, *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined

Now, therefore, His Excellency the Lieutenant-Governor and Administrator, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall be granted in fee simple to the abovementioned bodies to be held in trust for the aforesaid purposes, subject to the condition that the lands shall not be leased or mortgaged in whole or in part without the consent of the Governor.
