WHEREAS it is enacted by subsection (2) of section 4 of the Totalisator Agency Board Betting Act, 1960-1963, that the Governor may, on the recommendation of the Minister and the Board from time to time, and at any time, by Proclamation, declare any portion or portions of the State to be a totalisator agency region for the purposes of that Act; and whereas the Minister and the Board have recommended that the land described in the schedules hereunder be declared totalisator agency regions for those purposes: Now, therefore I, the Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby declare that the land described in the schedules hereunder shall be totalisator agency regions for the purposes of the Totalisator Agency Board Betting Act, 1960-1963, in the case of the land described in the first schedule, as from and including the 15th day of June, 1964, and, in the case of the land described in the second schedule, as from and including the 13th day of July, 1964.

First Schedule.

The whole of the land contained in the municipal district of the Shire of Plantagenet.

Second Schedule.

The whole of the land contained in the municipal district of the Shire of Mt. Magnet.
