WHEREAS it is enacted by section 8 of the Prisons Act, 1903-1963, *inter alia*, that the Governor may, by Proclamation in the *Government Gazette*, declare any building, enclosure or place to be a gaol, and that any Proclamation made under that section may be altered or revoked by the Governor; and whereas by a Proclamation made on the 22nd day of February, 1922, and published in the *Government Gazette* on the 24th day of February, 1922, the Governor did declare the lockup at Geraldton to be a police gaol; and whereas by a Proclamation made on the 8th day of March, 1922, and published on the 10th day of March, 1922, the Governor did alter that firstmentioned Proclamation; and whereas it is deemed desirable and expedient to further alter that firstmentioned Proclamation: Now, therefore I, the Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby alter the firstmentioned Proclamation published in the *Government Gazette* on the 24th day of February, 1922, as altered by Proclamation published in the *Government Gazette* on the 10th day of March, 1922, by declaring that the police gaol at Geraldton shall be a gaol as from the date of publication of this Proclamation in the *Government Gazette*.

Newdegate Country Water Area.

ORDER IN COUNCIL.

P.W.W.S. 1086/63.

WHEREAS it is enacted under section 8 of the Country Areas Water Supply Act, 1947-1960, that the Governor may, by Order in Council, constitute a Country Water Area: Now, therefore, His Excellency the Lieutenant-Governor, by and with the consent of the Executive Council, doth hereby constitute the Newdegate Country Water Area as defined in the schedule hereunder, and assign the name of "Newdegate Country Water Area" thereto.

Shire of Busselton.

ORDER IN COUNCIL.

L.G. 491/64.

WHEREAS the Council of the Shire of Busselton is desirous, under the by-law making power conferred by section 193 of the Local Government Act, 1960, of making by-laws for regulating public bathing and the costumes of bathers and the conduct of bathers and others in the sea adjoining though outside its district for a distance of two hundred (200) yards from low water mark at ordinary spring tides; and whereas it is enacted, by subparagraph (iv) of paragraph (a) of that section, that such by-laws may be made only pursuant to an order made under subsection (8) of section 190 of the Act; and whereas it is enacted by the subsection last mentioned, that where, in the opinion of the Governor, a by-law making power conferred by the Act on a Council should be extended to an area which is outside the district, the Governor may, by order, declare that for the purpose of the exercise of the power the area is to be regarded as being within the district and that the Council may exercise the power in respect of the area as if in fact it were within the district; and whereas the Lieutenant-Governor is of the opinion that the said by-law making power should be extended to the said area outside the district of the said Council: Now, therefore, His Excellency the Lieutenant-Governor, pursuant to the powers conferred by subsection (8) of section 190 of the Local Government Act, 1960, and acting by and with the advice and consent of the Executive Council, doth hereby declare that for the purpose of the exercise of the said by-law making power an area which is outside the district of the Shire of Busselton, namely the area which adjoins that district and extends for a distance of two hundred (200) yards seaward from low water mark at ordinary spring tides is to be regarded as being within the district of the Shire of Busselton, and that the Council of the Shire of

Busselton may make by-laws for regulating public bathing and the costume of bathers and the conduct of bathers and others in respect of that area as if in fact it were within the municipal district of the Shire of Busselton.

If it is impracticable to provide the firebreaks in the positions or by the date specified, then application to place the firebreaks in an alternative position or to complete same by a later date must be made in writing to the Council by 25th October, 1964.

**Townsites.**

On or before the 25th day of October, 1964, all town lots within the Shire of Dumbleyung must be cleared of all inflammable material and maintained free of such material.
