AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth, this 25th day of November, 1964, the following Orders in Council were authorised to be issued:—

Fire Brigades Act, 1942-1964.

ORDER IN COUNCIL.

WHEREAS it is enacted by subsection (1) of section 5 of the Fire Brigades Act, 1942-1964, that, subject to the provisions of subsection (2) of that section, the municipal districts and parts thereof constituted as fire districts prior to the coming into operation of the Fire Brigades Act Amendment Act, 1959, as set out in the Second Schedule to the Act, are for the purposes of the Act fire districts under the respective names as set out in that schedule; and whereas it is further enacted, *inter alia*, by subsection (2) of that section that for the purposes of the Act the Governor may from time to time, by Order in Council, adjust the boundaries of a fire district; and whereas by an Order in Council published in the *Government Gazette* on the 16th August, 1963, the Governor did adjust the boundaries of the Metropolitan Fire District by (*inter alia*) substituting that portion of the Municipal District of the Shire of Cockburn described in the First Schedule to that Order in Council; and whereas it is deemed expedient to further adjust the boundaries of the Metropolitan Fire District: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, doth hereby adjust the boundaries of the Metropolitan Fire District which district is referred to in column one of Part II of the Second Schedule to the Act by substituting for the portion of the Municipal District of the

Shire of Cockburn described in the schedule to the said Order in Council so published on the 16th August, 1963, the portion of the Municipal District of that Shire set out in the schedule to this Order in Council.

Schedule.

Cockburn Fire District.

All that portion of land situate within the Municipal District of the Shire of Cockburn, bounded by lines starting from a point on the shore of the Indian Ocean situate in prolongation westerly of the southern side of Island Street and extending easterly to and along that side to the north-western corner of part of lot 1 of Cockburn Sound Location 5 as shown on Land Titles Office Plan 2513; thence southerly along the western boundary of that part of lot 1 to the northern side of Rollinson Road; thence easterly along that side to the western side of Cockburn Road; thence northerly along that side to the northern boundary of location 5 aforesaid; thence easterly along that boundary to the western boundary of location 10; thence northerly and easterly along boundaries of that location to the centre-line of North Lake Road; thence generally southerly along that centre-line and generally south-easterly along the centre-line of Forrest Road to the northern boundary of Reserve 11479 (Spearwood-Jandakot Railway Reserve); thence generally westerly along that boundary to a point situate in prolongation northerly of the centre-line of Shallcross Street; thence southerly to and along that centre-line to the centre-line of Newton Street; thence westerly along that centre-line and onwards to the centre-line of Rockingham Road; thence southerly along that centre-line to a point situate in prolongation easterly of the northern boundary of location 416; thence westerly to and along that boundary and onwards to the shore of the Indian Ocean aforesaid, and thence generally northerly along that shore to the starting point.

Land Act, 1933-1963.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1963, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient as follows:—

Corres. 804/64.—That Reserve No. 27323 (Yalgoo Lot 34) should vest in and be held by The Agriculture Protection Board of Western Australia in trust for the purpose of a Vermin Fence Depot Site.

Corres. 1991/63.—That Reserve No. 27327 (Swan Location 7840) should vest in and be held by the Town of Melville in trust for the purpose of Recreation and Park.

Corres. 6199/11.—That Reserve No. 27329 (Wongan Hills) should vest in and be held by the Shire of Wongan-Ballidu in trust for the purpose of a Civic Centre Site.

Corres. 2729/61.—That Reserve No. 27344 (Darman Lot 48) should vest in and be held by the Shire of West Arthur in trust for the purpose of Parking.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall vest in and be held by the abovementioned bodies in trust for the purposes aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

Land Act, 1933-1963.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1963, it is, *inter alia*, made lawful for the Governor, by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient as follows:—

Corres. 2124/38.—That Reserve No. 27333 (Balwina Location 1) should, subject as aforesaid, be granted in fee simple to The Roman Catholic Vicar Apostolic of the Kimberleys to be held in trust for a Native Mission Station.

Corres. 1677/99, Vol. 2.—That Reserve No. 27339 (Perth Lot 827) should, subject as aforesaid, be granted in fee simple to the Metropolitan (Perth) Transport Trust, to be held in trust for the purpose of an Office and Depot Site (Metropolitan Transport Trust).

Corres. 1115/04, Vol. 2.—That Reserve No. 27345 (Busselton Lot 310) should, subject as aforesaid be granted in fee simple to the Shire of Busselton to be held in trust for Educational and Cultural Purposes.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall be granted in fee simple to the abovementioned bodies, to be held in trust for the aforesaid purposes, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1963.

Metropolitan Main Drainage District No. 1.

ORDERS IN COUNCIL.

WHEREAS by section 7 (a) of the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1963, it is provided that the Governor may, by Order in Council, alter or extend the boundaries of the Metropolitan Water, Sewerage and Drainage Area, or of any District, or Metropolitan Main Drainage District; and whereas it is desirable that the boundaries of the Metropolitan Main Drainage District No. 1 as at present defined should be extended: Now, therefore, His Excellency the Governor, by and with the advice and consent of

the Executive Council and in exercise of the powers conferred by the said Act, doth hereby order and declare as follows:—

That the boundaries of the Metropolitan Main Drainage District No. 1 be and are hereby extended by including therein the land described in the schedule hereto.

SHIRE OF KATANNING INTERIM DEVELOPMENT ORDER No. 1.

1.—Application.

This order applies to that part of the Shire of Katanning constituted a townsite under the Land Act, 1933-1963.

2.—Administering Authority.

The authority responsible for administering this order is the Katanning Shire Council.

3.—Approval under this Order Required for Certain Development.

The carrying out of any development (other than permitted development as set out in paragraph 6 of this order) on land within the scope of this order is prohibited unless approval is first obtained in accordance with the provisions of paragraph 4 of this order in addition to any other permission or approval which may otherwise be required by law.

4.—Application for, and Grant of, Approval.

(a) No person shall carry out development (other than permitted development as set out in paragraph 6 of this order) on land within the scope of this order until he has applied for approval from the local authority and has received the written approval or conditional approval of the local authority in accordance with the provisions of the Act and this order.

(b) Application shall be made by or on behalf of the owner of the land and shall be accompanied by three copies of a plan or plans drawn to scale illustrating the proposed development and its location and indicating the type and construction of any buildings or works proposed.

(c) The application shall be dealt with by the local authority in accordance with the terms of this order and the approval, conditional approval, or refusal of the local authority shall be issued to the applicant together with one copy of the plan or plans.

5.—Development by Public Authority.

(a) Any public authority intending to carry out development (other than permitted development) within the area covered by this order is required to consult the local authority in writing and to supply such information as may be necessary to explain the proposal.

(b) The development shall not be commenced until the local authority advise the public authority either that the development is in conformity with the proposed town planning scheme or can be co-ordinated with it; but before so advising the local authority may require modification to the development.

(c) In the event of the modification not being acceptable to the public authority, the development shall not be commenced, but the matter shall be referred to the Minister for determination by the Governor as provided by subsection (9) of section 7B of the Act.

6.—Permitted Development.

The following classes of development do not require approval under this order and are subject only to local authority by-laws and other provisions of law:—

- (i) Development by public authorities and local authorities for the purpose of their undertaking or functions on land owned by them at the time of coming into operation of this order.
- (ii) Construction, reconstruction, repair and maintenance of roads, railways, pipe lines, service mains, sewerage and drainage lines by public and local authorities on any public roadway or reserve or on any reserve or easement established for the purpose.
- (iii) Extensions of or alterations, renovating or maintenance to existing buildings within the curtilage of the land on which such buildings stand provided that the floor space of any such buildings or group of buildings is not increased thereby by more than 50 per cent.

7.—Existing Use.

No provision in this order shall prevent the continued use of any land or building for the purposes for which the land or building was being lawfully used at the time of the coming into operation of this order or shall prevent the carrying out of any development for which immediately prior to the coming into operation of this order, a permit or

permits, if any, required under this or any other Act authorising the development to be carried out had been obtained and was current.

8.—Appeals.

(a) In the event of a person being aggrieved by the refusal of approval or by the conditions subject to which approval is granted in respect of an application for permission to carry out development under this order, he may appeal to the Minister against the decision. The appeal must be lodged in accordance with the provisions of subparagraph (c) of this paragraph within sixty days after the refusal or conditional approval is served on him.

(b) Where the local authority fails to grant approval to an application for permission to carry out development within a period of sixty days after receipt of the application by the local authority, the failure shall be regarded as a refusal of approval and a person aggrieved by such refusal may appeal to the Minister against the refusal. The appeal must be lodged in accordance with the provisions of subparagraph (c) of this paragraph within sixty days after the expiration of the period of sixty days from the receipt of the application by the local authority.

(c) Every appeal shall be in writing, shall state the grounds on which the appeal is made, and must be lodged within the prescribed time at the office of the Minister.

Notice to Owners and Occupiers of Land in the Quairading Shire Council District.

PURSUANT to section 33 of the above Act, all owners and occupiers of land within the Shire of Quairading are hereby required, on or before the 22nd October, 1964, to plough, cultivate, scarify or otherwise clear of all inflammable material, firebreaks, at least eight feet wide, around all cleared

and partly-cleared land owned or occupied by them. Where holdings total more than 500 acres of cleared or partly-cleared land, additional firebreaks must be cleared to divide the cleared or partly-cleared land into areas of not more than 500 acres each surrounded by a firebreak. Where land is in crop, the area under crop shall be surrounded by a firebreak eight feet wide, to immediately encircle the crop. Where part of any cleared or partly-cleared land used for pasture or crops abuts on, or is intersected by public roads, railways, rivers or areas of uncleared land, a firebreak, eight feet wide, shall be cleared within ten feet and parallel to the common boundary between the land and the road, railway, river or uncleared land.

Buildings and Haystacks.—A firebreak, eight feet wide, shall be cleared one chain from the perimeter of all buildings, haystacks, and homesteads by the 22nd October, 1964, and the area between the firebreak and the building or haystack shall be cleared of all inflammable materials by 31st October, 1964. If it is intended to clear the area around buildings by burning, a permit must be obtained from the local bush fire control officer.

If it is impracticable for any reason to complete the clearing of firebreaks in the positions, or by the date required by this notice, application must be made not later than 22nd October, 1964, to the Quairading Shire Council for permission to place breaks in an alternative situation or to complete clearing of breaks by a later date to be determined by the Council.

All firebreaks to be maintained clear of inflammable material, up to the 1st April, 1965.
