WHEREAS it is provided (*inter alia*), by Section 5 of the Factories and Shops Act, 1963-1965, that "public holiday" means (in addition to the days therein specified) any day appointed by the Governor by proclamation to be a public holiday throughout the State and in relation to a district or locality includes any day so appointed to be a public holiday in the district or locality specified in the proclamation; and whereas it appears to me the Governor, expedient that the day hereinafter mentioned should be appointed a public holiday and a half-holiday, respectively, in the parts of the State set forth hereunder: Now, therefore, I the Governor, acting with the advice and consent of the Executive Council, do hereby appoint the 5th day of April, one thousand nine hundred and sixty-nine to be a public holiday in every part of the State, except the municipality of the Shire of Mandurah and to be a half-holiday in the municipality of the Shire of Mandurah; and all shops (except small shops and exempted shops) and warehouses, shall according to the area in which they are situated, be kept shut on that day or after the hour of one o'clock in the afternoon of that day.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1968, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by an municipality, body corporate, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order, and whereas it is deemed expedient, it follows:—

Corres. 12033/03.—That Reserve No. 1075 should vest in and be held by the Minister for Water Supplies in trust for the purpose of "Water and Conservation of Flora and Fauna".

(The Order in Council dated 8th September 1915, is hereby superseded.)

Corres. 5573/52.—That Reserve No. 29661 should vest in and be held by the Shire of Plantagenet in trust for the purpose of "Historic Museum and Art Centre".

Corres. 288/69.—That Reserve No. 29662 should vest in and be held by the Minister for Works, in trust for the purpose of "Water Supply".

Corres. 3479/49.—That Reserve No. 29668 should vest in and be held by the Shire of Augusta-Margaret River for a term not exceeding fifteen years from the date of this Order in trust for the purpose of "Aerial Landing Ground".

Corres. 3565/68.—That Reserve No. 29681 should vest in and be held by The Western Australia Wild Life Authority in trust for the purpose of "Conservation of Flora and Fauna".

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned Reserves shall vest in and be held by the abovementioned bodies, in trust for the purposes aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1968, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any municipality, body corporate, or other person or persons to be named in the Order, in trust for any of the purposes set forth in section 29 of the said Act and for the like or other public purposes to be specified in such order and with power of subleasing; and whereas it is deemed expedient, as follows:—

Corres. 3673/55, V2.—That Class "A" Reserve No. 29678 should vest in and be held by the Shire of Cockburn, in trust for the purpose of "Caravan Park".

Corres. 1158/31.—That Class "B" Reserve No. 7223, should vest in and be held by the City of Nedlands, in trust for the purpose of "Recreation".

(The Order in Council dated 16th November, 1932, is hereby superseded.)

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned Reserve shall vest in and be held by the abovementioned bodies, in trust for the purposes aforesaid with power to the said bodies, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said Reserves for any term not exceeding 21 years from the date of the lease subject nevertheless to the powers reserved to him by section 37 of the said Act.

Local Government Act, 1960-1968.

ORDERS IN COUNCIL.

WHEREAS by section 288 of the Local Government Act, 1960-1968, it shall be lawful for the Governor, on request by a Council of a Municipal District, by Order published in the *Government Gazette* to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than ten years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street; and whereas the councils mentioned in the schedule hereunder have requested that certain lands named and described in the said schedule, which have been reserved for streets within the said Councils be declared public streets: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, doth hereby declare the said lands, to be public streets, and such lands shall, from the date of this Order, be absolutely dedicated to the public as streets within the meaning of any law now or hereafter in force.

MILK ACT, 1946-1965.

HIS Excellency the Governor in Executive Council, acting pursuant to the powers conferred by section 76 of the Milk Act, 1946-1965, has been pleased to approve the regulations made by the Minister for Agriculture as set out in the schedule hereunder.

Regulations.

- Principal regulations. 1. In these regulations, the regulations made under the Milk Act, 1946 (as amended) and reprinted pursuant to the Reprinting of Regulations Act, 1954, as published in the *Government Gazette* on the 27th April, 1965, and amended from time to time thereafter by notices so published, are referred to as the principal regulations.
- Reg. 130 amended. 2. Regulation 130 of the principal regulations is amended as to paragraph (a), by adding after the word "concerned", in line three, the words "except with the consent of the Board which consent may be given only for the purpose of meeting seasonal or daily requirements."
- Reg. 131 amended. 3. Regulation 131 of the principal regulations is amended—
(a) by deleting the words "in writing", in line five; and
(b) by adding after the word "Board", in line five, the words "in exercise of the powers granted under Regulation 130."
- Part XV substituted. 4. The principal regulations are amended by revoking "Part XV. Limitation of Sales." comprising regulations 133 to 141, inclusive, and substituting a Part as follows—

PART XV.—PERMITTED DAILY QUANTITIES AND QUOTAS.

133. In this Part of these regulations, unless the contrary intention appears—

"permitted daily quantity" means the maximum quantity of milk of his own production that a dairyman may, under the terms of a contract made for the purposes of Regulation 130, supply daily in a quantity period;

"permitted quota" means the maximum quantity of milk of his own production that a dairyman may, under the terms of a contract made for the purposes of Regulation 130, supply daily in a quota period;

"quantity period" means the period from the 1st day of March to the 31st day of May in the same year, both dates inclusive; and

"quota period" means the period from the 1st day of June to the last day of February in the next following year, both dates inclusive.

134. The Board may, in respect of each year, fix the permitted daily quantity.

135. The Board may, in respect of each year, fix the permitted quota.

136. The Board may fix a permitted daily quantity or permitted quota, as the case requires, for a new supplier.

137. Where a dairyman disposes of portion of his dairy business to another dairyman he shall so advise the Board by notice in writing and include in the notice a description of that portion and the name of that other dairyman.

138. Where a dairyman acquires portion of the dairy business of another dairyman he shall so advise the Board by notice in writing and include in the notice a description of that portion and the name of that other dairyman.

139. The Board may—

- (a) reduce the permitted daily quantity or permitted quota, as the case requires, of a dairyman who disposes of portion of his dairy business to another dairyman; and
- (b) increase the permitted daily quantity or permitted quota, as the case requires, of a dairyman who acquires portion of the dairy business of another dairyman.

140. The Board may, from time to time during a quantity period, increase or reduce the permitted daily quantity.

141. The Board may, from time to time during a quota period, increase or reduce the permitted quota.

142. Except where it is fixed for a new supplier or where it is increased or reduced pursuant to these regulations, the permitted daily quantity shall be the average daily quantity of milk of his own production that the dairyman has, under the terms of a contract made for the purposes of Regulation 130, supplied during the months of November, December, and January last preceding the quantity period.

142A. Except where it is fixed for a new supplier or where it is increased or reduced pursuant to these regulations, the permitted quota shall be the average daily quantity of milk of his own production that the dairyman has, under the terms of a contract made for the purposes of Regulation 130, supplied during the months of March, April, and May last preceding the quota period.

142B. Upon fixing a permitted daily quantity pursuant to Regulation 134 or a permitted quota pursuant to Regulation 135 the Board shall, by ordinary pre-paid post, give to the dairyman notice of that quantity or quota, as the case requires.

142C. Where, within fourteen days after receiving, pursuant to Regulation 142B, notice of a permitted daily quantity, a dairyman produces evidence to the Board that the quantity is less than that to which he is entitled under the provisions of Regulation 142, the Board may adjust the quantity to conform to those provisions.

142D. Where, within fourteen days after receiving, pursuant to Regulation 142B, notice of a permitted quota, a dairyman produces evidence to the Board that the permitted quota is less than that to which he is entitled under the provisions of Regulation 142A, the Board may adjust the permitted quota to conform to those provisions.

142E. Except as otherwise provided in these regulations, a dairyman shall not, under the terms of a contract made for the purposes of Regulation 130, supply or sell to a milk vendor, on any day in a quantity period, a greater amount of milk of his own production than his permitted daily quantity for that period.

142F. Except as otherwise provided in these regulations, a milk vendor shall not, under the terms of a contract made for the purposes of Regulation 130, accept delivery of or purchase from a dairyman, on any day in a quantity period, a greater amount of milk of the dairyman's own production than his permitted daily quantity for that period.

142G. Except as otherwise provided in these regulations a dairyman shall not, under the terms of a contract made for the purposes of Regulation 130, supply or sell to a milk vendor, on any day in a quota period, a greater amount of milk of his own production than his permitted quota for that period.

142H. Except as otherwise provided in these regulations, a milk vendor shall not, under the terms of a contract made for the purposes of Regulation 130, accept delivery of or purchase from a dairyman, on any day in a quota period, a greater amount of milk of the dairyman's own production than his permitted quota for that period.

142I. Except where he is also a milk vendor, a dairyman shall not sell or supply to a milk vendor milk that the dairyman has not produced.

SUPREME COURT ACT, 1935-1964 AND FOREIGN JUDGMENTS
(RECIPROCAL ENFORCEMENT) ACT, 1963-1965.

WE, the Honourable Sir Albert Asher Wolff, K.C.M.G., Chief Justice of Western Australia, the Honourable Sir Lawrence Walter Jackson, Kt., Senior Puisne Judge, and the Honourable John Evenden Virtue, the Honourable Roy Vivian Nevile, the Honourable Gordon Bede D'Arcy and the Honourable John Hale, Puisne Judges of the Supreme Court of Western Australia, being a majority of the Judges of the Supreme Court, acting in pursuance of the powers conferred by the Supreme Court Act, 1935-1964 and the Foreign Judgments (Reciprocal Enforcement) Act, 1963-1965, and of every other power enabling us in this behalf, do hereby amend the Rules of the Supreme Court, 1909, in the manner hereinafter mentioned and declare that such rules shall come into operation on the day on which the Foreign Judgments (Reciprocal Enforcement) Act, 1963-1965, comes into operation.

The Rules of the Supreme Court, 1909 are amended by adding after Order XXXIX the following Order:—

ORDER XXXIXA.

(O.71.)

Foreign Judgments.

1. It is hereby declared pursuant to subsection (2) of section 8 of the Act that these Rules are subject to any provisions contained in the relevant Order in Council made under section 6 of the Foreign Judgments (Reciprocal Enforcement) Act, 1963-1965 (in these Rules referred to as "the Act") for giving effect to any agreement in relation to matters with respect to which there is power to make rules of Court for the purpose of Part II of the Act.
2. (a) An application under section 7 of the Act, to have a judgment to which Part II of the Act applies registered in the Supreme Court may be made on motion *ex parte* to the Court or a Judge.
 - (b) The motion paper shall be intitled—"In the Matter of the Foreign Judgments (Reciprocal Enforcement) Act, 1963-1965 and an Order in Council thereunder made the (date) relating to (country) and in the matter of a judgment of the (describing Court) obtained in (describing the cause or matter) and dated the day of 19 ".
 - (c) Where the judgment is in respect of different matters, and some, but not all of the provisions of the judgment are such that if those provisions had been contained in separate judgments, those judgments could properly have been registered, the motion paper shall state the provisions in respect of which it is sought to register the judgment.
3. (1) An application for registration shall be supported by an affidavit of the facts—
 - (a) exhibiting a certified copy of the judgment issued by the original Court and authenticated by its seal and where the judgment is not in the English language a translation of the judgment certified by a notary public or authenticated by affidavit;
 - (b) stating to the best of the information and belief of the deponent—
 - (i) that the applicant is entitled to enforce the judgment;
 - (ii) as the case may require, either that at the date of the application the judgment has not been satisfied, or if the judgment has been satisfied in part, the amount in respect of which it remains unsatisfied;
 - (iii) that at the date of the application the judgment can be enforced by execution in the country of the original Court;
 - (iv) that if the judgment were registered, the registration would not be, or be liable to be, set aside under section 9 of the Act; and

- (c) specifying the amount of the interest, if any, which under the law of the country of the original Court has become due under the judgment up to the time of registration,

and shall be accompanied by such other evidence with respect to the matters referred to in sub-paragraph (iii) of paragraph (b) or paragraph (c) of this sub-rule as may be required having regard to the provisions of the Order in Council extending the Act to the country of the original Court.

(2) Where the sum payable under the judgment is expressed in a currency other than the currency of the Commonwealth of Australia, the affidavit shall also state the amount which that sum represents in the currency of the Commonwealth of Australia calculated at the rate of exchange prevailing at the date of the judgment.

(3) The affidavit shall also state the full name, title, trade or business and the usual or last known place of abode or of business of the judgment creditor and the judgment debtor respectively, so far as known to the deponent.

4. Save as otherwise provided by any relevant Order in Council the Court or a Judge may, in respect to an application for registration, order the judgment creditor to find security for the costs of the application and of any proceedings which may thereafter be brought to set aside the registration.

5. (1) An order giving leave to register a judgment shall be drawn up by, or on behalf of, the judgment creditor.

(2) Such order need not be served on the judgment debtor.

(3) Such order shall state the period after service of the notice prescribed by Rule 7 within which an application may be made to set aside the registration.

(4) The Court or a Judge may, on an application made at any time while it remains competent for any part to apply to have the registration set aside, grant an extension of the period (either as originally fixed or as subsequently extended) during which an application to have the judgment set aside may be made.

6. There shall be kept in the Central Office of the Supreme Court a register of the judgments ordered to be registered under the Act.

7. (1) Notice in writing of the registration of a judgment shall be served on the judgment debtor. Such service shall be effected in the following manner:—

- (a) if within the jurisdiction, by personal service as in the case of a writ of summons, unless some other mode of service is ordered by the Court or a Judge;
- (b) if out of the jurisdiction, in accordance with the rule applicable to the service of a writ of summons out of the jurisdiction, save that special leave to serve out of the jurisdiction shall not be required.

(2) The notice of registration shall state—

- (a) full particulars of the judgment registered and the order for registration;
- (b) the name and address of the judgment creditor or his solicitor or agent on whom, and at which, any summons issued by the judgment debtor may be served;
- (c) the right of the judgment debtor to apply on the grounds provided in the Act to have the registration set aside; and
- (d) in accordance with the term of the order giving leave to register, within what period of time from the date of service of the notice an application to set aside the registration, may be made;
- (e) that execution on the judgment will not issue until after the expiration of that period.

8. (1) Within three days from the day of service or within such extended period as may, in special circumstances, be allowed by order of a Judge, the notice or a copy or duplicate thereof shall be indorsed by the person serving the same with the day of the month and of the week on which service was effected, and, if the notice is not so indorsed, the judgment creditor shall not be at liberty to issue execution on the judgment without the leave of the Court or a Judge.

(2) Every affidavit of service of any such notice shall state on what day such indorsement was made.

9. (1) An application to set aside the registration of a judgment shall be made by summons to the Court or a Judge supported by affidavit.

(2) A summons shall be served not less than seven clear days before the return day.

(3) On any such application the Court or a Judge may direct that an issue between the judgment creditor and the judgment debtor shall be stated and tried and may give such directions in relation to the trial of such issue as may be necessary.

10. (1) Execution shall not issue on a registered judgment until after the expiration of the period which in accordance with the provisions of sub-rule (3) of rule 5 of these rules, is specified in the order giving leave to register as the period within which an application may be made to set aside the registration, or, if an order is made extending the period so specified, until after the expiration of the extended period.

(2) If an application is made to set aside the registration of a judgment, execution shall not issue until such application has been disposed of.

(3) The party desirous of issuing an execution upon a registered judgment shall produce to the proper officer an affidavit of the service of the notice of registration and of any order made by the Court in relation to the judgment registered.

11. In the case of a registered judgment the form of a writ of execution shall be varied as follows:—

For the words "which said sum of money and interest were lately before us in our Supreme Court", etc., there shall be substituted the words "which said sum of money and interest were lately in . . . (describing the Court in which judgment was obtained)", etc., "and which judgment has been duly registered in our Supreme Court pursuant to Part II of the Foreign Judgments (Reciprocal Enforcement) Act, 1963-1965".

12. If, whether under the Act or under these rules, any question arises whether a judgment can be enforced by execution in the country of the original Court, or what interest is payable under the judgment under the law of that country, that question shall be determined in accordance with such provisions, if any, in that behalf, as are contained in the Order in Council extending the Act to that country.

13. (1) An application under section 14 of the Act for a certified copy of a judgment obtained in the Supreme Court shall be made *ex parte* to the Master on an affidavit made by the judgment creditor or his solicitor.

(2) An affidavit for the purposes of this rule shall—

- (a) give particulars of the proceedings in which the judgment was obtained;
- (b) contain a statement of the grounds on which the judgment was based;
- (c) state whether the defendant did or did not object to the jurisdiction, and, if so, on what grounds;
- (d) show that the judgment is not subject to any stay of execution and that no notice of appeal against it has been entered, and whether the time for appealing has expired; and
- (e) state the rate at which the judgment carries interest.

(3) Where an application for a certified copy of a judgment is duly made under this rule, there shall be issued a copy of the judgment sealed with the seal of the Supreme Court and certified by the Master as follows:—

“I certify that the above copy judgment is a true copy of a judgment obtained in the Supreme Court of Western Australia and this copy is issued in accordance with section fourteen of the Foreign Judgments (Reciprocal Enforcement) Act, 1963-1965.

together with a certificate as to such one or more as may be asked for of the following matters, also under the seal of the Supreme Court and certified by the Master:—

- (a) particulars of the proceedings in which the judgment was obtained having annexed to it a copy of the writ of summons or originating summons, by which the proceedings were instituted;
- (b) the manner in which the writ or summons was served; or that the defendant appeared thereto;
- (c) the objections made to the jurisdiction, if any;
- (d) the pleadings, if any, in the proceedings;
- (e) the grounds on which the judgment was based;
- (f) the rate at which the judgment carried interest;
- (g) such other particulars as it may be necessary to give to the foreign tribunal in which it is sought to obtain execution of the judgment.
