hereby declare that the limits of the Act shall extend to and include the portion of the municipal district of the Shire of Canning described in the schedule hereunder and which is outside the said circle of five miles from the General Post Office in the City of Perth.

All that portion of land bounded by lines starting from the intersection of the left bank of the Canning River with the prolongation westerly of the northern boundary of Canning Location 64, a point on the present boundary of the Perth Gas Area, also a point on the present boundary of the Shire of Gosnells and extending generally easterly and generally north-westerly along the last mentioned boundary to a north-eastern side of

Corres. 916/68.—That Reserve No. 9935 should vest in and be held by The Western Australian Wild Life Authority in trust for the purpose of Conservation of Flora and Fauna.

Corres. 8613/07.—That Reserve No. 11092 should vest in and be held by the Shire of Wagin in trust for the purpose of Gravel.

Corres. 2095/24.—That Reserve No. 21521 should vest in and be held by The Western Australian Wild Life Authority in trust for the purpose of Conservation of Flora and Fauna.

Corres. 1320/39.—That Reserve No. 22026 should vest in and be held by the Shire of Lake Grace in trust for the purpose of Recreation (Tennis Courts).

Corres. 987/63.—That Class "A" Reserve No. 26793 should vest in and be held by The Western Australian Wild Life Authority in trust for the purpose of Conservation of Flora and Fauna.

Corres. 3311/63.—That Reserve No. 27127 should vest in and be held by the Shire of Ravensthorpe in trust for the purpose of Showground and Recreation.

Corres. 447/62.—That Reserve No. 28060 should vest in and be held by the Minister for Native Welfare in trust for the purpose of Native Housing.

Corres. 1037/66.—That Reserve No. 23232 should vest in and be held by the National Parks Board of Western Australia in trust for the purpose of Tourist Lookout.

Corres. 2802/68.—That Reserve No. 30109 should vest in and be held by the Shire of Perth in trust for the purpose of Drainage.

ORDER IN COUNCIL.

Corres. 7582/07.

WHEREAS by section 33 of the Land Act, 1933-1969, it is, *inter alia*, made lawful for the Governor by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient that Reserve No. 11358 (Wagin Lot 311) should, subject as aforesaid, be granted in fee simple to Wagin Cottage Homes (Inc.) to be held in trust for "Aged Persons' Homes": Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council doth hereby direct that the beforementioned reserve shall be granted in fee simple to the aforesaid body, to be held in trust for the aforesaid purpose, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

Corres. 2462/65.—That Reserve No. 28416 should vest in and be held by the City of Nedlands in trust for the purpose of Recreation.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned Reserves shall vest in and be held by the abovementioned bodies in trust for the purpose

aforesaid, with power to the said bodies, subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said Reserves for any term not exceeding 21 years from the date of the lease subject nevertheless to the powers reserved to him by section 37 of the said Act.

Local Government Act, 1960-1969.

Shire of Bridgetown and Shire of Greenbushes.

Union and Consequential Directions.

ORDER IN COUNCIL.

L.G. 51/53.

WHEREAS it is provided in paragraph (e) of subsection (4) of section 12 of the Local Government Act, 1960-1969, that the Governor may unite two or more municipalities whose districts are adjoining, and their districts, so as to form one municipality and one district if union of those municipalities has been recommended by the Local Government Boundaries Commission appointed under subsection (6) of section 12 of the said Act; and whereas the Shire of Bridgetown and the Shire of Greenbushes are respectively municipalities under that Act; and whereas the Local Government Boundaries Commission has recommended that the two municipalities and their districts should be united to form one municipality to be named the Shire of Bridgetown-Greenbushes; and whereas it is further provided in paragraph (d) of the said subsection (4) that the Governor may give such directions as he thinks necessary in order to give effect to an alteration in the number of the members of a Council or to make the number of offices of member of a Council conform to the limits imposed by the said Act, or to give effect otherwise to the provisions of Part III or an order made under that Part; and whereas it is further provided in subsection (3) of section 10 of the said Act that the number of Councillors of a Shire is a number being not less than five nor more than thirteen as is declared by order and the number of offices of member for each ward is such as is from time to time declared by order; and whereas it is further provided in paragraph (a) of subsection (1) of section 20 of the said Act, that where the Governor exercises a power conferred by section 12 of the said Act he may direct who, if any, of the members, whose district is affected by the exercise of the power, shall go out of office and when, and may direct the holding, on a day appointed by the order, of an election of such members so affected and may order, settle, adjust and finally determine such rights, liabilities, questions and matters relating to the representation of electors on the Council of a municipality so affected as he thinks fit; and whereas it is further provided by subsection (3a) of section 12 of that Act that the Governor by order which may be made without a petition may, *inter alia*, divide a district into wards and fix the boundaries of the wards: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of the Executive Council, doth hereby—

- (1) unite the municipalities of the Shire of Bridgetown and the Shire of Greenbushes and their districts to form one municipality, named the Shire of Bridgetown-Greenbushes;
- (2) divide the united district into five wards, as follows:—
  - North Ward,
  - West Ward,
  - Central Ward,
  - East Ward, and
  - South Ward,

comprising the areas described respectively in the Schedule hereto;

- (3) direct that the number of offices of member representing the respective wards of the united district shall be as follows:—

North Ward	....	....	....	3
West Ward	....	....	....	2
Central Ward	....	....	....	3
East Ward	....	....	....	2
South Ward	....	....	....	1;

- (4) direct that members of the Councils of the municipalities of the Shire of Bridgetown and the Shire of Greenbushes, as existing at the date of this Order, shall retire from office on the 23rd May, 1970, on which day an election shall be held to return eleven members to the Council;
- (5) direct that this Order shall take effect on and from the day on which it is published in the *Government Gazette*.

The Schedule.

North Ward:

All that portion of land bounded by lines starting from the southeastern corner of Nelson Location 2315, a point on the present boundary of the Shire of Bridgetown-Greenbushes and extending westerly and northerly along boundaries of that location to the northeastern corner of Location 2357; thence westerly along the northern boundary of that location and onwards to the eastern boundary of Location 5290; thence northerly along that boundary to its northeastern corner; thence westerly and southerly along boundaries of that location and onwards to the northeastern corner of Location 11913; thence southerly and westerly along boundaries of that location and onwards to and along a southern boundary of late Pastoral Lease 2550/93 to the eastern boundary of late Reserve 11312; thence southerly along that boundary to the northern boundary of Location 619; thence westerly along that boundary and onwards to the western side of the Donnybrook-Bridgetown Railway Reserve; thence generally southerly along that side to a northern boundary of Hester Townsite; thence westerly along that boundary to the westernmost northwestern corner of that townsite boundary; thence westerly to the southernmost southeastern corner of Location 7975; thence westerly along the southernmost boundary of that location to the southeastern corner of Location 7974; thence westerly and northerly along boundaries of that location and onwards along the eastern boundary of Location 8446 to its northeastern corner; thence westerly along the northern boundaries of that location, Locations 11240, 12815 and 5244 to the southwestern corner of Location 1263; thence northerly along the western boundary of that location to the southern boundary of the Greenbushes Mining District; thence westerly along that boundary to the prolongation northerly of the eastern boundary of Location 6363; thence southerly along that prolongation to the northernmost northwestern corner of Location 5220; thence easterly, southerly and westerly along boundaries of that location to the prolongation northerly of the eastern boundary of Location 3611; thence southerly to and along that boundary to the northernmost northeastern corner of Location 1318; thence southerly, westerly, again southerly, again westerly and again southerly along boundaries of that location and onwards to the left bank of the Blackwood River; thence generally westerly downwards along that bank to intersect with the prolongation northerly of the eastern boundary of Location 946, a point on the present boundary of the Shire of Bridgetown-Greenbushes aforesaid and thence generally northerly, generally easterly and generally southerly along that boundary to the starting point.

All that portion of land bounded by lines starting from the southwestern corner of Nelson Location 1369, a point on the present boundary of the Shire of Bridgetown-Greenbushes and extending easterly and northerly along boundaries

ORDER IN COUNCIL.

L.G. 613/59.

WHEREAS it is provided in paragraph (e) of subsection (4) of section 12 of the Local Government Act, 1960-1969, that the Governor may unite two or more municipalities whose districts are adjoining, and their districts, so as to form one municipality and one district if union of those municipalities has been recommended by the Local Government Boundaries Commission appointed under subsection (6) of section 12 of the said Act; and whereas the Shire of Donnybrook and the Shire of Balingup are respectively municipalities under that Act; and whereas the Local Government Boundaries Commission has recommended that the two municipalities and their districts should be united to form one municipality to be named the Shire of Donnybrook; and whereas it is further provided in paragraph (d) of the said subsection (4) that the Governor may give such directions as he thinks necessary in order to give effect to an alteration in the number of the members of a Council or to make the number of offices of member of a Council conform to the limits imposed by the said Act, or to give effect otherwise to the provisions of Part III or an order made under that Part; and whereas it is further provided in subsection (3) of section 10 of the said Act that the number of



Councillors of a Shire is such number being not less than five nor more than thirteen as is declared by order and the number of offices of member for each ward is such as is from time to time declared by order; and whereas it is further provided in paragraph (a) of subsection (1) of section 20 of the said Act, that where the Governor exercises a power conferred by section 12 of the said Act he may direct who, if any, of the members, whose district is affected by the exercise of the power, shall go out of office and when, and may direct the holding, on a day appointed by the order, of an election of such members so affected and may order, settle, adjust and finally determine such rights, liabilities, questions and matters relating to the representation of electors on the Council of a municipality so affected as he thinks fit; and whereas it is further provided by subsection (3a) of section 12 of that Act that the Governor by order which may be made without a petition may, *inter alia*, divide a district into wards and fix the boundaries of the wards: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of the Executive Council, doth hereby—

- (1) unite the municipalities of the Shire of Donnybrook and the Shire of Balingup and their districts to form one municipality, named the Shire of Donnybrook;
- (2) divide the united district into four wards, as follows:—
  - Central Ward,
  - Preston Ward,
  - Donnybrook Ward, and
  - Balingup Ward,
 comprising the areas described respectively in the Schedule hereto;
- (3) direct that the number of offices of member representing the respective wards of the united district shall be as follows:—

- (4) direct that members of the Councils of the municipalities of the Shire of Donnybrook and the Shire of Balingup, as existing at the date of this Order, shall retire from office on the 23rd May, 1970, on which day an election shall be held to return nine members to the Council;
- (5) direct that this Order shall take effect on and from the day on which it is published in the *Government Gazette*.

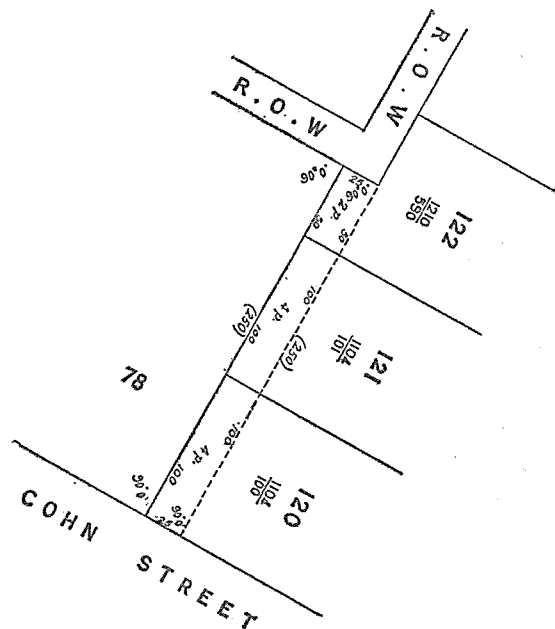
